

Preamble.

Whereas it is expedient further to amend the Assam Municipal Act, 1956, hereinafter referred to as the principal Act.

It is hereby enacted in the Forty-eighth Year of the Republic of India as follows:-

Short title, extent commencement.

- (1) This Act may be called the Assam Municipal (Amendment) Act, 1997.
 - (2) It shall have the like extent as the principal
 - (3) It shall come into force at once.

Amendment of section 14.

2. In the principal Act, in section 14, for clause (i), the following shall be substituted, namely:-"(i) has paid any tax for at least one quarter for the year preceding the prescribed date to be paid on or before the last date of filing claims for insertion of a name in the electoral roll".
