THE ASSAM CONTINGENCY FUND (FIRST AMENDMENT) ACT, 1996

AN

ACT

further to amend the Assam Contingency Fund Act, 1950

Preamble.

Whereas it is expedient to amend the Assam Contingency Fund Act, 1950, here-in-after called the principal Act.

It is hereby enacted in the Forty-seventh Year of the Republic of India as follows :-

Short title and Commencement. 1. (1) This Act may be called the Assam Contingency Fund (First Amendment) Act, 1996.

(2) It shall come into force at once and shall remain valid upto 31st March,1997.

Amendment of Secion 3 of Assam Act, IX of 1950.

2. In the principal Act, in Section 3 the following proviso shall be added, namely :-

"Provided that during the period of operation of the Assam Contingency Fund (Amendment) Act, 1996 a further sum of forty crores of rupees shall be paid from and out of the Consolidated Fund of the State of Assam into the Contingency Fund".

3. (1) The Assam Contingency Fund Assam (Amendment) Ordinance, 1996 is hereby repealed. Ordinan

Assam Ordinance No II of 1996

(2) Notwithstanding such repeal, anything ¹⁹⁹⁶ done or any action taken under the Ordinance so repealed shall be deemed to have been done or taken under this Act as if this Act had commenced on the 14th day of April, 1996.
