further to amend the Lalung (Tiwa) Autonomous Council Act, 1995.

Preamble.

Whereas it is expedient further to amend the Lalung (Tiwa) Autonomous Council Act, 1995 hereinafter referred to as the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Forty-seventh Year of the Republic of India as follows :-

Short title, extent and commencement. (1) This Act may be called the Lalung (Tiwa) Autonomous Council (Amendment) Act, 1996.

- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force at once.

Amendment of section 6 of Act No. XXV of 1995. 2.

In the principal Act, in section 6, in subsection (4), in clause (ii), the word "Three", occuring at the beginning shall be substituted by the word "six."

Amendment of section 24 of Act No. XXV of 1995. In the principal Act, in Section 24, in subsection (I), the word "three" occuring between the words "the", and, "Executive Councillors" shall be substituted by the word "six."
