THE SALARY AND ALLOWANCES OF THE LEADER OF OPPOSITION IN THE ASSAM LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 1992

AN ACT

further to amend the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly Act, 1978.

Preamble. Who room it is expedient further to Assam Act.

Whereas it is expedient further to Assam Act amend the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly Act, 1978, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Forty-third Year of the Republic of India as follows:—

Short title and commen cement.

- 1. (1) This Act may be called the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly (Amendment) Act, 1992.
 - (2) It shall be deemed to have come into force on the twenty-second day of January, 1986.

Amendment of Section 3 of Assam Act VI of 1978. 2. In the principal Act, in Section 3, for the existing provision, the substituted, namely:—

Salary of the Leader of Opposition. "3. There shall be paid to the Leader of Opposition a salary of rupees one thousand five hundred per mensem on and from the twenty-second day of January, 1986 and rupees two thousand five hundred per mensem on and from the first day of September, 1986."
