CHAPTER - I REPORT

1. MANDATE OF THE DEPARTMENT:

Information and Public Relations Department plays a significant role in disseminating information on Government policies, programmes and schemes to the citizens through various media, hence establishes smooth and uninterrupted communication between Government and people.

The main objective of the department is basically two fold i.e. Informing the public about the plans, policies and programmes of the Government on one hand and on the other hand, keeping the Government informed of the people's reaction (feedback from the public) to its policies and programmes.

The Department is instrumental in disseminating smooth and uninterrupted flow of information to the citizens including media and to promote regular feedback mechanism for the Government through the Information, Education and Communication (IEC) technologies.

1.1 VISION:

- Ensure smooth and uninterrupted flow of information regarding Government policies, programmes and schemes to the citizens including media.
- Disseminate information about the plans, policies, programmes and achievements of the Government through print, electronic and social media.
- > Establish communication links between Government and people using all types of media.
- Foster healthy Media- Government relationship and apprise the Government of the public perception and opinion.
- > Implementation of welfare schemes.

1.2 FUNCTIONS, ROLE AND RESPONSIBILITIES OF THE DEPARTMENT:

The Information and Public Relations Department is the Administrative head of the office of the Directorate of Information and Public Relations, which implements the schemes/ policies etc. The Directorate of Information and Public Relations and its Sub-Ordinate offices execute all plans / programmes and order etc. of the Department.

Functions, Role and Responsibilities:

- 1. To prepare and place the Annual Budget Plan under different Head of Accounts in the Budget Session of Assembly as per Govt. Policies/Rules.
- 2. To sanction the schemes of under different Head of Accounts and issue of FOC as per Govt. Policies/Rules.
- All establishment matters including appointment and transfer, leave, and departmental proceeding in respect of all Gazetted Officers as per the Assam Information and Public Relations Service Rules (Gazetted) 1986 and Assam Information and Public Relations Service Order 1999 (Technical).
- 4. To make policy of Govt. Advertisement and Advertisement rates from time to time as per the Assam Advertisement Policy 2008 (As amended in 2010).
- 5. Formation of committees for formulation of Policies/Rules.
- 6. Approval of Newspaper and / Periodicals for inclusion in the Govt. approved list.
- 7. Accreditation of journalists as per Assam Press Correspondents (Accreditation and Recognition) Rules, 1989.
- 8. To implement Journalist Medical Welfare Scheme.
- 9. To implement Journalists' Family Benefit Fund.
- 10. To confer Republic Day Journalism Award.
- 11. To implement the Assam Pension Scheme for Journalist.
- 12. To implement Cable Television Networks (Regulation) Act 1995.
- 13. To award Media Fellowship.
- 14. To provide One Time Grant to Media Personality.
- 15. To implement Press Tour on Goodwill Mission for the Rural Journalists of the State.
- 16. To provide assistance under Journalists Family Benefit Fund.

1.3 ACTS AND RULES ADMINISTERED BY THE DEPARTMENT:

There is no Act in respect of the Department. The Rules of the Department are as below:

- 1. Assam Information and Public Relations Service Rules (Gazetted) 1986.
- 2. Assam Press Correspondents (Accreditation and Recognition) Rules, 1989.
- 3. Assam Advertisement Policy 2008 (As Amended in May, 2010).
- 4. Assam Information and Public Relations Service Order 1999 (Technical).

1.5 ONGOING INITIATIVES OF THE DEPARTMENT:

1. Journalists' Medical Welfare Scheme

- ➤ Under this scheme, amount of Rs.1,44,46,051.00 has been granted to a total 371 journalists and their family members.
- ➤ Under this scheme, an amount of Rs.452.00 lakh has been fixed to form a Corpus Fund in the SBI, Dispur Branch.

2. Assam Pension Scheme for Journalists

- ➤ Implemented since the financial year 2017-18.
- > Till 2021-22,100 journalists have received this pension @ Rs.8000/- per month
- > Out of these 100 pensioners, 4 are receiving Family pension.

3. Journalists' Family Benefit Fund:

- The scheme has introduced in the financial year 2016-17 for providing financial assistance to the family of the deceased journalists met with untimely death while being on duty.
- Under this scheme, Rs. 132.16 lakh has been fixed to form a Corpus Fund in the SBI, Dispur Branch.
- No applicant till date.

4. Media Fellowship:

- The scheme has introduced in the financial year 2018-19 for the working journalists to improve their professional skills and upgrade their knowledge. 20 journalists every year @ Rs.50,000/- each.
- During last three financial years 54 journalists have received Media Fellowship of Rs. 50,000/- each.
- > 20 Media persons have been selected for Fellowship during 2021-22.

5 One Time Grant to Media Personality:

- The scheme has implemented since 2020-2021, this scheme is intended to support journalists in their pursuit of outstanding achievements. 20 journalists every year Rs.50,000/- each.
- During last financial year 20 journalists have been received the one-time grant of Rs. 50,000/each,
- ➤ 20 Media persons have been selected for the scheme during 2021-22.

6. Press Tour on Goodwill Mission:

- ➤ In between the financial years 2016-17 and 2019-20 four Press Tours on Goodwill Mission were conducted in the States of Gujarat, Madhya Pradesh, Rajasthan, Himachal Pradesh and Chandigarh.
- > 70 rural media persons were taken on exposure visits during these 4 Tours. During last two financial year the Tour was not conducted due to COVID pandemic situation.

7. Republic Day Journalism Award:

- > This award is conferred annually to an eminent journalist for the outstanding contribution in the field of journalism.
- The awardees are Late Radhika Mohan Bhagawati, Shri Kanak Sen Deka, Shri Dhirendra Nath Chakrabarty, Shri Jadu Kakoti and Shri Ateen Das.
- During current financial year Shri Anil Baruah, Former Editor of Dainik Asom was selected for Sconferring the award.

8. One Time ex-gratia to deceased journalists:

➤ Under this scheme, one time ex-gratia for an amount of Rs. 5 lakh each were granted to the next of kin of the 31 deceased journalists who have lost their lives or went missing while on duty in various incidents in the State.

9. State level National Press Day:

The Directorate has been organizing the State level programme of National Press Day in various Districts across the State on 16th November every year. Every year felicitation was given to senior journalists of the State on recognition of their contribution in the field of journalism.

10. Interaction programme of Hon'ble CM with the Senior Journalists on 1"January and gift to all DIPR Card holder Media Persons of the State:

The Directorate has been organizing the "Interaction Programme of Hon'ble Chief Minister" every year on 1st January with the Senior journalists on the occasion of New Year at Guwahati. On this occasion HCMs New Year Gifts are also presented to the DIPR Card holder Media Persons of the State.

11. Digital destination- Application of LED Technologies:

- In synchronization with the digitally active 'Generation X', and to meet the ever-growing demand for digital transformations, the Directorate has also taken up several initiatives to cater to the need of the current times.
- During the financial year 2020-21, two LED Billboards in Guwahati and one at Dibrugarh were installed.
- During the financial year 2020-21, altogether 12 nos. of LED Signage Kiosks with mobile charging stations were installed at Janata Bhawan, Dispur.
- It has been proposed to install 16 LED Billboards during this financial year, but sanction is yet to be accorded.

12. Public Outreach Publicity measures

With a view to garner maximum visibility and mass reach about the Government's plantspolicies, welfare schemes, initiatives and achievements, the Directorate has been incorporating following popular means of publicity measures:

- > Airport Branding at LGB Airport
- > Railway Branding of Guwahati Railway Station

13. Fixed Loudspeaker System (FLS)

Based on the Recommendation of the DRSC, the Directorate has taken the following steps for implementation of the recommendation.

- 1. FLS to be installed in 219 Development Blocks of the State (in 2 phases) except the BTAD & the Hill Districts of Karbi Anglong & Dima Hasao.
- 2. 6 units of loudspeakers per Development Blocks are proposed to be installed.
- 3. Total locations proposed to be set up are $(219\times6) = 1314$ units.
- 4. First phase location is in 165 Development Blocks.
- 5. Necessary purchase of all technical items has already been completed.
- 6. On receipt of the sanction, the Directorate will start the process for Installation & Transportation.

14. Production of Quicky, Audio Spot and Jingles

To highlight the aims, objective, polices and achievements of the government quickies, audio spot and jingles have been produced by the Directorate for telecast of the same through the local TV channels and through social media apps for mass awareness.

15. Hoarding & Branding

Use of Hoarding is a regular activity of the Directorate to highlight the plans and policies of the Government. During this current financial year Rented Hoardings were used for 6 months throughout the state to highlight the plans, policies, activities and achievements of the Government.

City Branding was done for various State level and National level events and visits of Hon'ble President of India, Hon'ble Union Home Minister and Hon'ble Union Finance Minister during the current financial year.

16. Exhibition- Guwahati Book Fair

Since 2018, every year this Directorate have been participating the Guwahati Book Fair for highlighting the achievements of the Government.

17. Editor/Accreditation and Recognition Cards to Journalists (As on 1st January, 2022):

The Directorate has been issuing Accreditation and Recognition Card to media persons of both print and electronic media. As per guidelines of PAC Rule 1989, the cards are given to them. Press Accreditation Committee at State level and District level is formed to implement the PAC Rule.

CHAPTER-II

OBSERVATIONS AND RECOMMENDATIONS ON GRANT NO.35

The Committee discussed the Budgetary provision on Grant No.35 relating to Information & Public Relations Department made in the budget documents for the Financial Year 2022-23.

1. After the threadbare discussion on the budget provision made for Information & Public Relations Department the Committee observes that smooth, efficient, timely and uninterrupted flow of information regarding Government plans, policies, programmes, schemes and activities to all section of the people is very essential.

So, the Committee recommends for installation of LED Billboards in all District Headquarters of the State in a phased manner.

2. The Committee recommends to construct a new building of the Department at Tarapur behind Lions Club, Silchar over a plot of land measuring 1 katha.

With these observations, the Committee recommends the total budget amout of Rs. 11349.07 lakhs as sought for under Grant No. 35, Information & Public Relations Department for the Financial Year, 2022-23 be approved by the August House.

The Action taken report on the recommendation made in the report may be submitted to the Committee within 90 (ninety) days from the date of its presentation to the House.
