THE SALARY AND ALLOWANCES OF THE LEADER OF OPPOSITION IN THE ASSAM LEGISLATIVE ASSEMBLY (AMENDMENT) ACT, 2003.

AN

ACT

further to amend the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly Act, 1978.

Preamble

Whereas it is expedient further to amend the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly Act, 1978, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

Assam Act, VI

It is hereby enacted in the Fifty-fourth Year of the Republic of India as follows:

Short title and commencement

- 1. (1) This Act may be called the Salary and Allowances of the Leader of Opposition in the Assam Legislative Assembly (Amendment) Act, 2003.
 - (2) It shall be deemed to have come into force on the first day of April, 2003.

Amendment of Section 3 of Assam Act, VI of 1978.

- In the principal Act, in Section 3, for the existing provisions of clause (iii), the following shall be substituted, namely:-
- "(iii) a Daily Allowance of three hundred rupees while on official tour and its halt within the State of Assam:

Provided that the Leader of
Opposition in the Assam Legislative
Assembly shall be entitled to a Daily
Allowance of five hundred rupees
whenever the Leader of Opposition
performs the official duties outside the
State of Assam and its halt;"
