**Petition No. 1 Regarding prayer for appointment in the post of Grade IV.**

1.1. Petition No.1 signed by Shri Gopinath Paul forwarded by Hon'ble Member Shri Ashwini Ray Sarkar.

**A. Petitioner's Grievances and prayer**

1.2. In the petition (See Annexure I) the Petitioner has stated that he was selected as grade -IV employee in the PHE department Dhubri and due to the over age for getting the job he had filed a writ Petition bearing WP (C) No. 4615/2015 before Hon'ble High Court, Guwahati for condonation of his age and the Hon'ble High court vide order dated 19-08-2015 passed in WP(C) No.4615/2015 that it is made clear that as and when recruitment drive to carried out by the state in terms of the persons with disabilities Act 1995 and it will be open for the petitioners to apply and participate in such section in which event their cases shall be considered on their own merit .The Petitioner again mentioned that after order passed by the Hon'ble Guwahati High Court he applied to the director of Social Welfare Department for his requirement in relaxation of his over age for appointment to the list of grade IV against Sl no.032 in the category of OH but till today no appointment was made by the concerned Department ,Therefore the Petitioner prayed before the Hon'ble Committee on petitions, to consider the case sympathetically.

**B. Comment's/Clarification by Social Welfare Department**

1.3. The latest clarification of the Govt. was forwarded by the Joint Secretary to the Government of Assam, Social Welfare Department vide letter No.SWD.3/2015/312 Dated 15<sup>th</sup> October,2020 (See Annexure -II (A) where it was stated that in 2018 Social Welfare Department initiated special drive for appointment of person with disabilities to fill up back log vacancies under various departments of Govt. of Assam but PHE Department did not show any Grade IV vacancies to accommodate Sri Gopinath Paul. Further, Sri Gopinath Paul has attained 58 years of age as per HSLC admit card. So he has crossed the upper age limit for entry into the state Govt. Service in respect of candidate with Person with Disabilities (PwD) that is 50 years as per OM ABP.6/2016/51-A dated 2<sup>nd</sup> September 2020. Though due to age limit Sri Gopinath Paul cannot be accommodated in Government Service, the Social Welfare Department may provide him the benefits under Person with Disabilities (PwD) scheme vide letter No.DSW (ICDS) G/88/2020/12 Dated 14<sup>th</sup> October,2020 (See Annexure II (B) ).

**Observation**

1.4. The Committee after threadbare discussion with the departmental representatives in its meeting held on 20-10-2020, found that the age proof certificate submitted to the SLPRB for appointment of Grade IV post was not similar with the HSLC admit card submitted to the social welfare Department which indicated that the petitioner provided wrong information to the Committee as well the Department. However the Committee directed the Social Welfare Department to take necessary steps for granting of disability pension to the Petitioner on humanitarian ground and thereby the petition has been disposed of.

**Petition No. 2 Regarding Prayer for Non Payment of Pension and other benefits.**

2.1. Petition No.2 signed by Shri Goneswar Doley forwarded by Hon'ble Member Smti Pramila Rani Brahma.

**A. Petitioner's Grievances and Prayer.**

2.2. In the Petition (See Annexure No.III ) the Petitioner has stated that he was working as an Assistant Engineer (EE) and he has retired from his service in the year 1993. The Petitioner has stated that his pension and other benefits is yet to be regularized. He is suffering from various disease. Therefore, the petitioner prayed before the Hon'ble Committee on Petitions to look into the matter for regularization of his pension and other retirement benefits.

**B. Comments of the Government  
(Public Works Roads Department (PWRD) Estt.Br.)**

2.3. The parawise comments of the Government was forwarded by the Deputy Secretary to the Government of Assam (i/c) Public Works Roads Department (PWRD) Estt. Branch vide letter No.CON 61/92 pt.111/68 dtd.30<sup>th</sup> Jan.2021 (See Annexure No.IV (A)) on obtaining the views of APSC and Pension and Public Grievances Department (P & PG).the Departmental Proceeding drawn up against Shri Goneswar Doley the then Executive Engineer Ghilamara Road Division has been closed vide notification No.CON.61/92/pt.III/65 dated 30-09-2020 (See Annexure IV(B) by imposing the penalty withholding of pension permanently.

**Observation**

2.4. After careful examination of all papers submitted by the concerned Department, the Committee observed that the concerned Department has minutely looked into the matter and after observing all procedures and Shri Goneswar Doley was found guilty and accordingly, he was imposed the penalty withholding of pension permanently. The committee, therefore, disposed of the Petition.

**Petition No.3 Regarding prayer for releasing pending salaries, provisional pension, leave salary, GIS, Gratuity and other wages.**

3.1 Petition No. 3 signed by Dr. Nagendra Nath Sarma forwarded by Hon'ble Member Shri Ghanashyam Kalita.

**A. Petitioner's Grievances and Prayer**

3.2. In the Petition (See Annexure-V) the Petitioner has stated that he has worked as a Medical Officer at DHS Assam(Ayur) upto 30-1-2004 and also worked as a Dy.DHS Assam Hengrabari and has drawn last pay upto 31-12-2003. On his service period he was worked at NICD, New Delhi, AIDS

awareness YAWS Programme, Pulse polio etc under DHS categories after that he was directed to work at Na -Kachari PHC Jorhat as a Medical Officer. But his LPC was not send to the DHS Jorhat , therefore he could not get respective pay. Again he was transferred to the Baguan of Goalpara Distt vide orderNo.HLA 591/96/288(A) dated. Dispur the 17/12/2008 by the Joint D.H.S Jorhat . As his assertion he has retired from Government services on 31-01-2013, but the concerned Department did not prepare his LPC, regularization of service book, GIS etc. Therefore the Petitioner approached to the Hon'ble Committee to procure his pensional benefits with interest.



**B. Comments of the Government**  
**(Health & Family Welfare Department)**

3.3. Speaking order of the Government were forwarded by the Joint Secretary to the Government of Assam Health & Family Welfare Department vide letter No.HLA 453/2004/458 Dated 9/12/2020 (See annexure VI ) where it was stated that the Health and Family Welfare Department vide speaking order dated 9/12/2020 has disposed of the case of Dr. Nagendra Nath Sarma with the following orders. The governor of Assam is therefore pleased to allow all pay and allowances including pensionary benefits upto 14/04/2004, which may be counted as his deemed date of retirement.

**Observation**

3.4. The Committee after going through all the evidences as well as the Speaking Order of the concerned Department observed that the petition was carefully examined and accordingly the petitioner was allowed all the pay and allowances including pensionary benefits upto 14-04-2004 only which may be counted as deemed date of his retirement.

Thus, the Committee on being satisfied with the action taken by the Department disposed of the petition.

**Petition No.4 Regarding prayer for appointment on Compassionate Ground**

4.1. Petition No. 4 signed by Shri Partha Pratim Gogoi forwarded by Hon'ble Member Shri Gautam Bora.

**A. Petitioner's Grievances and Prayer**

4.2. In the Petition ( See Annexure - VII ) the Petitioner has expressed that his father Lt. Pradip Gogoi was Ex-Sw as Grade IV under Malaria Department of Sivasagar District the Petitioner's name was recommended in the District Level Committee Sivasagar, further no action has been taken by the Department. For that reason the Petitioner prayed before Hon'ble Committee on Petitions to take necessary steps.

**B. Comments of the Government**  
**(Health and Family Welfare Department)**

4.3. The latest clarification of the Government were forwarded by the Additional Secretary to the Government of Assam Health and family Welfare Department vide letter No HLB 422/2018/265 dated 16/02/2021 (See Annexure - VIII (A) ) where it was stated that Shri Partha Pratim Gogoi S/o Lt. Pradip Gogoi has been appointed on compassionate ground against Grade IV post vide Directorate of Health service appointment letter No.HSE/ Apptt./comp/Grade-IV/11/2021/7766 dated 10/02/2021 (See Annexure VIII(B) ).

**Observation**

4.4. After examining all the relevant papers and evidences tendered by the Department in the meeting, the Committee on being satisfied with the appointment of Shri ParthaPratimGogoi in grade IV post on compassionate ground and thus disposed of the petition.

**Petition No 5. Regarding prayer for appointment on compassionate Ground.**

5.1. Petition No. 5 signed by Miss Dimpy Dutta forwarded by Hon'ble Member Dr. Numal Momin.

**(A) Petitioner's Grievances and prayer.**

5.2. In the Petition (See Annexure IX) the Petitioner had stated that her father Dimbeswar Dutta died on 4/02/2011, who was working in the post of Grade IV of Health Department. The petitioner stated that there was no any earning member in her family. After her father's death she had applied in Grade IV post. The Petitioner had stated that the DLC had recommended her name and forwarded to the SLC. After receiving the proposal from District level committee, the DHE had forwarded to the State Level Committee for consideration of appointment on compassionate Ground. But no action has been taken. Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to consider the case sympathetically.

**(B) Comments of The Government  
(Health and Family Welfare Department)**

5.3. The Latest clarification report of the Government were forwarded by the Additional Secretary to the Government of Assam vide letter No.HLB 422/2018/196 dated 17/08/2020 (See Annexure X ) where it was stated that the case of Dimpy Dutta Gogoi D/o Late Dimbeswar Dutta was placed before the SLC in its meeting held on 20-02-2020 where it was found that she is married and her marriage was solemnized prior to the death of her father. The Gaon Burah has also certified in this regard as per her application dtd.20/01/2012. Hence the candidate does not come under the definition of family as she was not a dependent at the time of death of her father as per Personnel (B) Department OM-No.ABP 357/80/137 dtd 9/9/1983 and ABP 50/2006/pt/182 dtd .01/06/2015.

**Observation**

5.4. After perusal of latest clarification submitted by the concerned Department and evidences tendered by the Govt. representatives in its meeting held on 21-08-2020, the Committee observed that as per rule the applicant should be a dependent member of deceased family. But Smti Dimpy Dutta had married prior to the death of her father and not a dependent member at the time of death of her father. Hence her application was rejected by the SLC as per Govt. guidelines and the Committee has also decided to dispose of the petition.

**Petition No. 6 Regarding prayer for release of full pension and appointment on compassionate ground.**

6.1. Petition No. 6 signed by Mrs. Anita SaikiaShyam.

**(A) Petitioner's Grievances and prayer**

6.2. In the Petition (See Annexure XI) the Petitioner had stated that her husband Lt. Abhijit Shyam who had worked as a sweeper cleaner at Jorhat Medical College & Hospital, Jorhat. She has submitted documents to the respective Department. But no action has been taken. Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to enquire into the matter.

**B. Comments of the Government  
(Health and Family Welfare (A) Department)**

6.3. The Action taken Report of the Government was forwarded by the Joint Secretary to the Government of Assam, Health & Family Welfare Department .vide letter No.HLA 445/2016/194 dated 17/12/2020 (See Annexure XII) where it was stated that Mrs Anita Saikia Shyam has been appointed in the office of the Principal cum Chief Superintendent JMCH, Jorhat in Grade IV post vide order No. SMEJ/JMCH/1184/2012/pt.II/2015/6941 dated.27/10/2020. Further Provisional Family Pension as admissible has already been sanctioned to Mrs Anita Saikia Shyam vide letter No.SMEJ/JMCH/243/2010/5524 dated 10/01/2018.

**Observation**

6.4. After careful examination of all the papers submitted by the concerned Department, the Hon'ble Committee found that Mrs. Anita Saikia Shyam has been appointed in grade IV post and also received Provisional Family Pension as admissible. Thus, on being satisfied with this action of the Department the petition has been disposed of accordingly.

**Petition No. 7 Regarding prayer for appointment on Compassionate Ground .**

7.1. Petition No. 7 signed by Shri Dipankar Gogoi forwarded by Hon'ble Member Shri Rituparna Baruah.

**A. Petitioner's Grievances and Prayer**

7.2. In the petition (See Annexure- XIII) the petitioner has stated that his father Late Padma Gogoi expired on 01-09-2014 while he was in service under the Joint Director of Health Services, Dibrugarh. The petitioner has applied before the concerned Department for appointment on compassionate ground. The DLC, Dibrugarh forwarded a letter No.DPE4 10/2009/vol-I/179 Dated 22-2-2017 to the DHS, Assam recommending his name for compassionate appointment. But no action has been taken. Therefore, the petitioner prayed before the Hon'ble Committee on Petitions to consider the case affectionately.

**B. Comments of the Government.**  
**Health and Family Welfare Department**

7.3. Action taken report of the Government was forwarded by the Secretary to the Government of Assam, Health and Family welfare Department vide order no.HLA 445/2016/194 Dated 17-12-2020 (See Annexure - XIV) where it was stated that the case of Shri Dipankar Gogoi, S/o Lt. Padma Gogoi was placed before SLC in its meeting held on 20/02/2020 and his case was recommended by SLC for appointment against grade III post. The Health & Family Welfare Department vide letter No.HLA 972/2015/pt/17 dated 18/09/2020 accorded approval for appointment of the petitioner against Grade III post. Accordingly, appointment letters were ceremonially handed over by Hon'ble Minister, Health & Family Welfare on 7<sup>th</sup> November,2020.

**Observation**

7.4. After examining all the relevant papers and evidences tendered by the Department in the Committee meeting ,the Committee found that Shri Dipankar Gogoi S/o Lt. Padma Gogoi has been appointed in grade III post on compassionate ground .Thus on being satisfied with the action made by the Department the prayed petition is disposed of accordingly by the Committee.

**Petition No. 8 Regarding prayer for appointment on compassionate ground.**

8.1. Petition No. 8 signed by Miss Banchana Das forwarded by Hon'ble Member Shri Chakradhar Gogoi.

**A. Petitioner's Grievances and Prayer.**

8.2. In the Petition (See Annexure XV ) the Petitioner has stated that her father Late Bharat Chandra Das who died on 6-2-2002 while in service in the office of the Deputy Commissioner ,Kamrup Metropolitan District. The Petitioner has stated that they tried heart and soul to get appointment on compassionate ground but no steps has been taken in this regard. Therefore, the petitioner submitted an application before the Hon'ble Committee for appointment on compassionate ground.

**B. Comments of the Government**  
**General Administrative Department and Personnel Department**

8.3. The comments of the Government were forwarded by the Secretary to the Government of Assam, Personnel Department vide letter No.ABP 98/2002/237 dt.3-2-2021 (See Annexure- XVI (A)) where it was stated that as per report of the Additional Deputy Commissioner Kamrup (M) District, Guwahati vide No.KPE 28/2014/pt/52 dtd.2-2-2021 (See Annexure-XVI (B) ) the proposal of Smti. Anjali Das, mother of Smti. Banchana Das, was considered in the DLC meeting held on 16-07-2009, but was regretted on the ground that the petitioner had already crossed the prescribed age limit. It may be mentioned here that the date of birth of Smti. Anjali Das, as per her application is 01-02-1962 and her date of making application as per available office record is 12-03-2002 hence her age at the time of applying was 40 years 1 month,i.e, she had already crossed the prescribed age limit at the time of making application.

**Observation**

8.4 While discussing the petition of Smti. BanchanaDas , the Committee observed that her mother Smti. Anjali Das had applied for appointment on compassionate ground. Within the prescribed time period after demise of his husband on 06-02-2002 while in service. But, after careful examination of the departmental submission. It has been found that Smti. Anjali Das had already crossed the prescribed age limit while making such application and hence she was not eligible for appointment as per the prevalent Government norms. Thus, the Committee disposed of the petition.

**Petition No. 9 Regarding prayer for appointment on Compassionate Ground.**

9.1. Petition No. 9 signed by Smti. Manisha Boro Mochahari forwarded by Hon'ble Member Shri Rabiram Narzary.

**A. Petitioner's Grievances and Prayer**

9.2. In the Petition ( See Annexure XVII ) the Petitioner has stated that her husband Dr. RatnaMochahari passed away on 25-2-2013 during his service who was a Lecturer of Swahid Jadav Nath Homeopathic Medical College & Hospital .The petitioner has stated that after the death of her husband, her son Shri Vishal Mochahari had applied for appointment on compassionate ground on 11-8-2013. Shri Vishal Mochahari has been recommended in the DLC but finally no action has been taken in this regard .Therefore, prayed before the committee for taking necessary steps.

**B. Comments of the Government**  
**(Health and Family Welfare (A) Department)**

9.3. The parawise comments of the Government was forwarded by the Under Secretary to the Government of Assam , Health and Family Welfare department vide letter No.HLB422/2018/254 dated 1<sup>st</sup> February, 2021 ( See Annexure XVIII ) where it was stated that the proposal for appointment on compassionate ground of Shri Vishal Mochahari was placed before the SLC but the SLC could not recommend Shri Vishal Mochahari, son of late RatnaMochahari for appointment under compassionate ground as total number of posts occupied by person appointed on compassionate ground already constituted 5% of the cadre Strength.

**Observation**

9.4. After careful examination of all relevant documents and threadbare discussion with concerned Department, the Committee observed that Shri Vishal Mochahari could not be considered for appointment on compassionate ground as per Government guidelines. The Petition is therefore disposed of.

**Petition No. 10 Regarding prayer for deprivation of due pay scale.**

10.1. Petition no 10 signed by Smti. Maya Paul forwarded by Hon'ble Member Shri RajdeepGoala.

**A.Petitioner's Grievances and Prayer .**

10.2. In the Petition (See Annexure XIX ) the Petitioner has stated that she was deprived of getting her due pay scale during entire service period. She prayed to D.I of school Karimganj, but all in vain and hence the petitioner appeal to the Hon'ble Committee on Petitions for kind consideration on this matter for justice against life deprivation.

**Comments of the Government**  
**(Elementary Education Department )**

10.3. The latest clarification of the Government were forwarded by the Joint Secretary to the Government of Assam ,Elementary Education Department vide letter no. PMA 934/2017/115 dtd.16<sup>th</sup> December, 2020 (See Annexure XX ) where it was stated that the D.I.S., Karimganj appointed the Petitioner Smti Maya Paul as Stipendiary Assistant Teacher on compassionate ground on the basis of the Government approval vide letter dated 24/6/1994

based on the Govt OM NO ABP 357/80/137 dtd.09-09-1983 subject to completion of Junior Basic Training. As such, regular pay scale was allowed to the Petitioner from the date of successful completion of Junior Basic Training w.e.f 22-11-2001.

**Observation**

10.4. Having considered the submission of the Government representatives, the Committee has been satisfied with the replies from the government in respect of Smti Maya Paul for allowing her regular pay scale w.e.f.22-11-2001 and therefore decided to dispose of the petition.

**Petition No. 11 Regarding prayer for Provincialization of post in the Department of English at Luitparia College.**

11.1. Petition No.11 signed by Shri ChamsulAlomSorowarthy forwarded by Hon'ble Member Shri Abdur Rashid Mandal.

**A. Petitioner's Grievances and Prayer**

11.2. In the Petition (See Annexure XXI ) the Petitioner has stated that he was appointed as lecturer in the Department of English in Luitparia College, Barpeta since 27-08-2001. The said college was provincialized in the year 2013 but the petitioner's post was not provincialized. In the year 18-08-2020, the Education Department had declared a list of newly provincialized incumbents but unfortunately the petitioner's name was not included again. Therefore, the petitioner prayed before the Hon'ble Committee on Petitions to take necessary steps to provincialised the post.

**A. Comment of the Government**  
**Education (Higher) Department**

11.3. The Action Taken Report of the Government were forwarded by the Under Secretary to the Government of Assam, Higher Education Department , Dispur vide letter NO.AHE 1112/2019/pt./79 Dated Dispur, the 23<sup>rd</sup> November,2021 ( See Annexure- XXII ) where it was stated that the matter of ChamsulAlomSarowarthy was examined and his service has been Provincialised as Tutor Assistant Professor in the Department of English of Luitparia College Barpeta w.e.f. 01-01-2021 as per provision of the Assam Education (Provincialisation of Educational Institutions) Act,2017 and Ammendment Act, 2018.

**Observation**

11.4. After careful examination of all papers submitted by the concerned Department the Hon'ble Committee was satisfied with the action taken by the Department that the service of ChamsulAlomSorowarthy has been provincialised as Tutor Assistant Professor in the Department of English of Luitparia College, Barpeta w.e.f. 01-01-2021. The petition is therefore disposed of.

**Petition No. 12 Regarding prayer for appointment on compassionate ground.**

12.1. Petition signed by Shri NeelimoyChangmai forwarded by Hon'ble Member Shri Rituparna Baruah.

**A. Petitioner's Grievances and Prayer.**

12.2. In the Petition (See Annexure XXIII) the petitioner has stated that her mother late Manjula Konwar expired on 28/9/2015 while she was working as a school teacher at Nirmali Gaon, Dibrugarh . The Petitioner has applied for appointment on compassionate ground. But no action has been taken, Therefore, the Petitioner prayed before the Hon'ble Committee on petitions to consider the case sympathetically.

**B. Comments of the Government  
(Elementary Education Department)**

12.3. The latest clarification was forwarded by the Joint Secretary to the Government of Assam, Elementary Education Department vide letter no PMA 934/2017/147 dtd. Dispur, the 18<sup>th</sup> February 2021( See Annexure XXIV) where it was stated that the last State Level Committee meeting was held on 28-12-2020 and the matter was placed before the State Level Committee meeting for consideration .Accordingly, the State Level Committee examined the recommendation made by the District Level Committee and selected Shri NeelimoyChangmai as Assistant Teacher in Lower Primary School in Dibrugarh District.

**Observation**

12.4. On perusal of latest clarification submitted by the concerned Department it has been observed that the State Level Committee in its meeting held on 28-12-2020 recommended the name of Shri NeelimoyChangmai for appointment as Assistant Teacher in Lower Primary School at Dibrugarh on compassionate ground. As such, the Hon'ble Committee, on being satisfied with this action of the Department, disposed of the petition.

**Petition No. 13 Regarding prayer for appointment on compassionate ground.**

13.1. Petition No.13 signed by Shri Bimal Chandra Boro.

**A. Petitioner's Grievances and Prayer.**

13.2. In the Petition (See Annexure XXV ) the Petitioner has stated that his father late Bhanu Ram Boro expired on 27-12-2002 while in service as Grade IV in the Assam Engineering college .The Petitioner has applied for appointment on compassionate ground, but no action has been taken. Therefore, the Petitioner's prayed before the Hon'ble Committee on Petition to look into the matter sympathetically .

**B.Comments of the Government  
Higher Education Department**

13.3. The latest clarification of the Government was forwarded by the Under Secretary to the Government of Assam ,Higher Education Department vide letter No.AHE 1112/2019/PT/79 dated.23<sup>rd</sup> November 2021 ( See Annexure XXVI ) where it was stated that the Government has appointed Shri Bimal Boro in Grade IV post at Assam Engineering college vide order No.E/Com.G/14/93/7952-60 dated 22-2-2021.

**Observation**

13.4. After careful examination of the document submitted by the concerned Department, it has been found that Shri Bimal Boro has been appointed in Grade IV post on compassionate ground. As the concerned Department has taken proper action on the matter, thus the committee on being satisfied with this action disposed of the petition.

**Petition No. 14 Regarding prayer for appointment on Compassionate Ground.**

14.1. Petition No.14 signed by SmtiBinita Deka Roy forwarded by Hon'ble Member Shri Pabindra Deka.

**A. Petitioner's Grievances and Prayer**

14.2 In the Petition (See Annexure XXVII ) the Petitioner has stated that her husband , Late Narnath Roy resident of Jalikhata, District Barpeta expired on 17-05-2002 while working as regular Hindi Teacher at Nilima Roy M.E School .The Petitioner has applied for appointment on compassionate Ground but no action has been taken. Therefore , the Petitioner prayed before the Hon'ble Committee on Petitions to consider the case sympathetically.

**Comments of the Government  
(Elementary Education Department)**

14.3. The latest clarification of the government were forwarded by the Special Commissioner to the Government of Assam, Elementary Education Department Dispur vide letter No.AEE 335/2020/97 dated.23<sup>rd</sup> November 2021(See Annexure XXVIII ) where it was stated that Binita Deka Roy under Barpeta district has already been appointed on compassionate Ground as Assistant Teacher in L.P School under Barpeta District vide office order No.EAA/SIU/22/2021 pt -111/378 dtd. 20/08/2021

**Observation**

14.4. After careful examination of all papers submitted by the concerned Department it has been found that SmtiBinita Deka Roy has been appointed as Assistant Teacher on compassionate ground. As the concerned Department has taken proper action on the matter, thus the committee on being satisfied disposed of the petition.

**Petition No. 15 Regarding prayer for appointment on compassionate ground**

15.1. Petition No. 15 signed by Shri Hitesh Kalita forwarded by Hon'ble Member Shri Pabindra Deka .

**A. Petitioner's Grievances and Prayer**

15.2. In the Petition (See Annexure XXIX ) the Petitioner has stated that his father Lt. LakeshwarKalita expired on 03-03-2010 while working as Grade IV at Assam Engineering College Guwahati. The Petitioner has applied for appointment on compassionate ground. But no action has been taken. Therefore ,the Petitioner prayed before the Hon'ble Committee on Petitions to consider the case sympathetically.

**Comments of the Government  
Higher Education (Technical) Department**

15.3. The action taken report of the Government were forwarded by the Under Secretary to the Government of Assam,Higher Education Department vide letter No.AHE 1112/2019/pt/79 Dated Dispur, the 23<sup>rd</sup> November,2021 (See Annexure XXX) where it was stated that Government has appointed Shri Hitesh Kalita in Grade IV post at Assam Engineering college vide Order No.E/Com.G/14/93/7943-51 Dated Dispur, the 22<sup>nd</sup> February,2021.

**Observation**

15.4. After going through the departmental submission, the Hon'ble Committee was satisfied with the action taken by the Department that Shri Hitesh Kalita has been appointed as Grade IV at Assam Engineering College. The petition is therefore disposed of.

**Petition No.16 Regarding prayer for appointment on Compassionate Ground.**

16.1. Petition No.16 signed by Shri Rakib Hussain Ahmed forwarded by Hon'ble Member Shri Ashwini Ray Sarkar.

**A. Petitioner's Grievances and Prayer.**

16.2. In the Petition (See Annexure - XXXI ) the Petitioner has stated that his mother late Rashida Ahmed died on 12-03-2013 while in service as an Assistant Teacher at Shaker Uddin Memorial L.P School .The Petitioner has applied for appointment on Compassionate Ground .But no action has been taken by the concerned Department. Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to consider the case sympathetically.

**B. Comments of the Government  
(Elementary Education Department)**

16.3. The latest clarification of the Government were forwarded by the Special Commissioner to the Government of Assam, Elementary Education Department vide letter no.AEE 335/2020/97 dated Dispur the 23/11/2021 (See Annexure - XXXII ) where it was stated that Rakib Hussain Ahmed under Dhubri district has already been appointed on compassionate ground as Assistant Teacher in L.P School under Dhubri District vide this office order no.EAA/SIU /22/2021/pt-III/457 dated 20/08/2021 .

**Observation**

16.4. After careful examination of all papers submitted by the concerned Department it has been found that Shri Rakib Hussain Ahmed has been appointed as Assistant Teacher on compassionate ground. As the concerned Department has taken proper action on the matter, the Committee on being satisfied disposed of the petition.

**Petition No.17 Regarding prayer for appointment on Compassionate Ground.**

17.1. Petition No. 17 signed by Smti. Babita Medhi forwarded by Hon'ble Member Shri Brindaban Goswami.

**A. Petitioner's Grievances and Prayer.**

17.2. In the Petition ( See Annexure- XXXIII) the Petitioner has stated that her father late Tarun Chandra Medhi was serving as an Assistant teacher at Engineering College campus ME School, Jalukbari and died on 5-10-2007 while in service .The Petitioner has applied for the post of Assistant Teacher on compassionate ground on 20/02/2008 . But no action has been taken .Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to consider the case sympathetically.

**A. Comments of the Government  
Elementary Education Department**

17.3. The latest clarification of the Government were forwarded by the Special Commissioner, to the Government of Assam,Elementary Education Department vide letter No. AEE 335/2020/97 dated Dispur, the 23<sup>rd</sup> November, 2021( See Annexure -XXXIV) where it was stated that BabitaMedhi under Kamrup(M) District has already been appointed on compassionate ground as Assistant Teacher in UP school under Kamrup ( M) District vide this office order no EAA/SIU/22/2021/Pt-III/297 dated .20/08/2021 .

**Observation**

17.4. After careful examination of all papers submitted by the concerned Department it has been found that Smti Babita Medhi has been appointed as Assistant Teacher on compassionate Ground. As the concerned Department has taken proper action on the matter, the Committee on being satisfied with this action disposed of the petition..

**Petition No. 18 Regarding prayer for up gradation to the post of U.D. Assistant.**

18.1. Petition No.18 submitted by Shri Dhruba Sindhu Das forwarded by Hon'ble Member Shri Brindaban Goswami.

**A. Petition's Grievances and Prayer.**

18.2. In the Petition (See Annexure - XXXV ) the Petitioner has stated that he worked as LDA in Lakshimi Union High School District Jorhat and retired from the post of U.D. Assistant on 30-11-2013. He had allowed to work as UDA in the scale of pay as per I.P.S but he deprived of getting the scale of pay from Rs. 3850/- to 4030/- as approved by the Finance Department. He also stated that the Directorate of Pension had raised an objection for excess drawal when his pension was settled. The petitioner has submitted an application to the concerned authority but no action had been taken. Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to consider his case sympathetically.

**B. Comments of the Government  
Pension & Public Grievances Department**

18.3. The action taken report of the Government were forwarded by the Joint Secretary to the Government of Assam ,Pension & Public Grievances Department vide letter No.PPG (P) 302 /2018/100 dated 20/06/2020 ( See Annexure- XXXVI (A) ) where it was stated that the pension case has been reviewed and revised authority of pension issued dated 31/07/2019 by re-fixing his basic pension as Rs. 7430/- pm with effect from 01/12/2013 to 31/03/2016 ( as per ROP 2010) and Rs.18430/- pm with effect from 01/04/2016 (as per ROP 2017) on the basis of the said Government letter . Further , the amount of Rs.1,17,451/- which was to recovered from the relief of the pensioner, was subsequently released by issuing a corrigendum vide No.DP/2014/06/0046 dated 27/09/2019 (See Annexure - XXXVI (B) ).

**Observation**

18.4. The Committee after examining all the relevant papers and evidences tendered by the Department in its meeting found that the pension case of Shri Dhruba Sindhu Das has been finalized and settled. Thus the petition has been disposed of accordingly.

**Petition No. 19 Regarding prayer for release of salaries and allowances.**

19.1. Petition No. 19 submitted by Shri Manoj Konwar and Mridul Rajkonwar forwarded by Hon'ble Member Shri RituParna Baruah.

**A.Petitioner's Grievances and Prayer.**

19.2. In the Petition (See Annexure- XXXVII ) the petitioners stated that they were worked as an assistant teacher at Sivasagar District from 2001.They appealed to the respective authority to increase their salary with other facilities but no action have been taken. Thereafter they appeal writ petition to the Gauhati High court to increase their salary and regularize their services. But the authority did not follow the verdict of the judgement of the Gauhati High Court and again the petitioners appealed to the Guwahati High Court for reconsideration of the judgement .In their petition they also informed that the state Education Department set out to go Supreme Court against the verdict of Gauhati High Court.Therefore, the Petitioner prayed before the Hon'ble Committee on Petitions to look into the matter and take necessary action.

**A. Comments of the Government  
Secondary Education Department**

19.3. The latest clarification of the Government were forwarded by the Under Secretary to the Government of Assam Secondary Education Department vide letter No.ASE.524/2012/pt-II/397 dated 23-11-2021 (See Annexure - XXXVIII ) where it was stated that in respect of the Petition of Shri Manoj Konwar and Shri Mridul Rajkonwar, the Government in Secondary Education Department has already obtained the approval of the Hon'ble Cabinet held on 20/02/2021 and accordingly benefits of regular time scale of pay has been allowed to the Petitioner's vide Government notification No.ELC/WP(C)763/2013/92/605 Dated 26/02/2021.

**Observation**

19.4. After examining the evidences and latest clarification of the concerned Department ,the Committee has observed that the Petitioner's claim for getting the benefits of regular time scale of pay has been allowed to the Petitioners by the concerned Department. Thus, the Committee on being satisfied with the departmental submission has decided to dispose of the petition.

**Petition No. 20 Regarding prayer for provincialisation of dropped posts of 134 newly provincialised colleges under new Provincialisation Act,2017.**

20.1. Petition No. 20 signed by Shri Arun Baruah forwarded by Hon'ble Member Shri Rituparna Baruah.

**A. Petitioner's Grievances and Prayer.**

20.2. In the petition (See Annexure - XXXIX ) the Petitioner has stated that he on behalf of all qualified teachers of newly provincialised 134 colleges of Assam would like to draw the facts regarding the provincialisation of services of eligible teachers /tutors as per Government Circular issued on 8<sup>th</sup> May, 2017 and submit its proposal for creation of posts within 10<sup>th</sup> September,2017.After the amendment of provincialisation Act,2018,the petitioners have submitted requisite documents to the concerned authority as sought for. After taking the views from the Personnel Department ,Finance Department and Legal Cell Department ,the file was finally approved by the High Power Committee and endorsed to the Hon'ble Education Minister of approval. But surprisingly no action has been taken in this regard. Therefore the Petitioner prayed before the Hon'ble Committee for justice.

**B. Comments of the Government**



**Higher Education Department**

20.3. The Action taken report were forwarded by the Under Secretary to the Government of Assam, Higher Education Department vide letter no AHE 1112/2019/pt/79 dated Dispur, the 23<sup>rd</sup> November,2021(See Annexure - XL ) where it was stated that the service of Petitioner Shri Arun Baruah has been Provincialised as Assistant Professor in the Department of Political Science of Moran Mahila Mahavidyalaya, Sivasagar with effect from 01-01-2021 as per provision of the Assam Education (Provincialisation of Educational Institutions Act 2017 and Amendment Act,2018).

**Observation**

20.4. The Committee after examining all relevant papers and evidences tendered by the concerned Department in its meeting, found that the service of Shri Arun Baruah has been provincialized as Assistant Professor and thus, on being satisfied with this action the petition has been disposed of by the Committee.

With references to the subject cited above ,I have the honour to state you that shri Gopinath Paul has applied for Gr.IV post at PHE Deptt under special drive for appointment of person with disabilities against back log vacancies under various department of Govt of Assam in the year 2005.

It may be mentioned here that no records are available in the office of the Dirtector ,Social Welfare ,Assam against sri Gopinath Paul. As per photocopy of records forwarded by Sri Gopinath Paul he was called for interview for Grade IV post by the District Social Welfare Officer,Dhubri dated 18/06/2005 in pursuance of the special drive for recruitment of differently abled persons to fill up backlog vancancy under 3% reserved quota as per PwD Act,1995. The name of the Sri Gopinath paul bearing Roll no.DHU-032 repotedly appeared in the photocopy of the select list alongwith 3(three) other candidate for Grade IV post under PHE, Dhubri. There were four numbers with no indication of any merit list against one post shown under OH category. The Sri Gopinath Paul moved to Hon'ble High Court and in response to the WP(C) No.4615/2015, Hon'ble High Court order dtd.19/08/2015 as follows:

"Accordingly and in view of the above ,the writ petition is clearly hit by delay and laches and cannot be entertained at this belated stage.However ,notwithstanding the above,it is made clear that as and when recruitment drive is carried out by the stage in terms of the persons with Disabilities ( Equal Opportunities ,protection of Rights and Full Participation ) Act,1995 including for filling up backlog vacancies since 2005,it will be open for the petitioners to apply and participate in such selection in which event their cases shall be considered on their own merit. If by the petitioners become over age respondents may consider relaxation of their age in accordance with the state policy in force".

In 2018 Social Welfare Department initiated special drive for appointment of person with disabilities to fill up back log vacancies under various departments of Govt. of Assam but PHE Deptt. did not shows any grade IV vacancies to accommodate Sri Gopinath Paul. Further ,it may be mention here that Sri Gopinath Paul has attained 58 years of ages per HSLC admit card.So he has crossed the upper age limit for entry into the state Govt.service in respect of the candidate with person with disabilities (PwD) I,e 50 years as per OM ABP.6/2016/51-A dtd,2<sup>nd</sup> Sept.2020. Though ,due to age limit Sri Gopinath Paul cannot be accommodated in Govt Service , the Social Welafre may be provided the benefits under person with disabilities (PWD) scheme.

Further, Additional Director, Directorate of Social Welfare, Assam has conducted a hearing with Sri Gopinath Paul regarding the matter on 13/10/2020.

Respected Sir,

The undersigned beg to state that the following few lines for favour of your kind consideration and favourable action.

1. That , Sir , the undersigned joined in the PWD in the year 1963 as an Asst Engineer and retired as Executive Engineer (EE) in the year 1993. During those periods, I had to serve in various places including Ghilamara PWD Division from 1990 to 1993.

2. That, Sir, while I was serving as EE in Ghilamara PWD Division which is located in very interior and insurgency-prone area, I had to face rampant armed antisocial elements prevailing in the area at that time and they were hands and gloves with most of the contractors and many of the PWD staff working there. I was harassed a lot by these bad elements in the form of demanding undue supply order, contact works payment of false bills under gunpoint . The police and the higher officers of my Deptt. were duly informed about the intimidations coming from these antisocial elements. I also caught police protection so that I could discharge my normal duties without fear and pressure but no help was coming forth from any quarter (copies enclosed). In-spite of that , I discharged my duties and selfless service for improvement of all development works for the best interest of public.

3. That , Sir, then antisocial elements and some disgruntled fellows brought some false allegations and under these basis one proceeding was drawn against me and some incomplete and partial enquiry were conducted but I was not given chance to defend myself in the enquiry even in-spite of my request (copy-enclose). After repeated requests and pursuance at my level also, no fruitful action have been taken towards releasing the pension order to the AG Deptt. (Copy enclosed).

4. That , sir, since the date of my retirement till today covering long 20 years, my pension and other benefits have been help up without intimating me except 3 year's provisional pension from 1993 to 1996.

5. That , Sir, now I am very old person suffering from various ailments such as **heart blockage** requiring **Immediate By-Pass Surgery**, In addition to other old-age diseases. Further, my wife has also been suffering from **Osteoarthritis** requiring **Immediate knee replacement surgery, multiple,rib fracture , Diabetes, severe hypertension and high blood pressure** (copies enclosed). These treatments require large amount of money. But because of financial constraints, I am not able to carry out these medical treatments till today. For want of financial support, including my family have been suffering from acute mental and financial agony. It is needless to mention that after retirement , if one is deprived of his meagre income of his due pension, he cannot perhaps survive in these difficult days.

6. In connection with the above-mentioned pension case, now I have come to know of a **Supreme Court Verdict Case No. CA 6771/2013** (arising out of SLP(C) No. 1428 of 2009) in which it is ordered that Govt. cannot withhold pension and other benefits of employees facing even some proceedings etc. and copy of which is enclosed herewith for your kind reference.

7. Sir, Under the above circumstances, your goodself is earnestly requested to look into my very long period of deprival of my pension and other benefits and take urgent steps for retrieving the same.

I was working at different places and also worked at D.H.S. office Assam up to 30-1-2004 as Medical Officer (Ayur) and I/C Dy. D.H.S. (IMS) and drawn my last pay from D.H.S. office, Assam, Hengrabari, up to 31-12-2003.

I have done many works of NICD, New Delhi, AIDS awareness, Medicinal plant, YAWS programmes, pulse polio, etc. and many other works in addition to my own duties. Sri Pankaj Sarma is now working at D.H.S. office, Assam. He knows everything.

I was directed to work at Na-Kachari PHC, Jorhat, as Medical Officer (Ayur). But my L.P.C. was not send to the Joint D.H.S, Jorhat. So, the requested Joint D.H.S. of Jorhat can not give my respective pay.

Again I was transferred to the Baguan S/D as M.O. (Ayur) of Goalpara Dist. The Joint D.H.S, Jorhat had directed me to join at Baguan S/D, Goalpara in ref. to the Govt. order vide no HLA. 591/96/288(A) dt Dispur the 17-12-2008.

The Duty of a Medical Officer is to work in the Hospital or field. But work of LPC, regularization of service book etc. are the duties of the offices. It is true that I have not gone to the table to table of office clerk. Even no reply is being sent to the Govt. letter vide PPG (G) 18/2013/06 dt 19/10/2013 by the Govt.

I know that I must work in the respective Health Institute. The respective offices must have to work about my pay, service book, LPC, etc.

I have retired from Govt. Services on 31-1-2013 and handed over the charge (Copy enclosed) in reference to the order no. GDHS/Esstt/DR./M.O./Ayur/12/137-A/ dt. 30-1-2013.

That Sir,

Govt. has circulated/ advertised as on 8<sup>th</sup> May.2017 to submit the proposal for creation of posts and provincialization of the services of the eligible teachers/tutors with 10<sup>th</sup> September, 2017 to the Govt. in the Higher Education Deptt. of Assam.

That Sir,

After struck down of the provincialization Act of 2011-2012, the High Court ordered to bring a new act with the verdict to execute the same within six months. Accordingly the Govt. has introduced a new bill in 2017.

That Sir,

We have submitted our requisite documents as per the notification dated 28th March 2018. The concerning Deptt. has successfully completed the three lawyers of scrutiny. Thereafter the file has been approved by the Hon'ble Education Minister and piled up to the Finance Deptt.

That sir,

The Personnel Deptt. has also given a positive view against these posts.

That Sir,

Unfortunately the Finance Deptt. has given two queries

- a) To take a view from Addl. Advocate General i.e. legal view.
- b) To fill up individual format against the 768 posts.

That sir,

We have come to know from a reliable source that the Legal Cell Deptt. has given positive view and that file has been lying in SIU.

And finally regarding the queries no.(b) the DHE has submitted the format with re-verification as directed by the High Power Committee.

That Sir

As per the successive approval of High Power Committee the file has been sent to the education Minister through additional Chief Secretary of higher education.

That sir,

It is to be mentioned that the file has been approved two times by Hon'ble Education Minister during this period. But, were surprised how the Govt. could violate the order of Hon'ble High Court as well as Govt. advertisement and circulation.

That Sir,

We would like to request your honour to get its justification for the pathetic and deplorable condition of the said teachers of 134 colleges, having all the requisite qualification as per the two provincialisedAct(old and new 2011-12 and 2017-18). The

deprived teachers are yet to get appointments. So sir how can we expect the quality education in the light of present scenario ?

It is our surprise that college is provincialised but most of teacher posts are yet to be provincialised. Only 7/8 teachers posts out of 30 teachers in all newly provincialised colleges were provincialised. How could a college maintain the classes?
