Debates of the Assam Legislative Assembly

Thursday, the 13th June, 1996

The House met at 9 A.M. of the Clock in the Assembly Chamber at Dispur with Shri Ganesh Kutum, Speaker in the Chair.

Mr. Speaker: Hon'ble Members present, the Governor is addressing the House today at 9.10 A.M. He is coming by the Eastern Gate of the Assembly premises at 9.05 A.M. Myself and the Secretary will be going to receive him at the Gate. The instructions as to how the Governor is to be received in the House have been laid on each Member's table. As soon as the Governor comes, I think, we should comply with these instructions. In the meantime, the Address will be distributed to the Members.

With your permission, now I leave the House to receive the Governor at the Gate.

(Hon'ble Speaker enters the House with the Hon'ble Governor. National Anthem was played. His Excellency Hon'ble Governor took the Chair.)

GOVERNOR'S ADDRESS

Mr. Speaker: Now I request the Hon'ble Governor to address the House.

Hon'ble Governor: Mr. Speaker and Hon'ble Members, it gives immense pleasure to welcome you to this first session of the newly constituted legislative Assembly. This August House has behind it a long and glorious history of having played the pivotal role in shaping the destiny of our part of the country.

It has, over the years, built up brilliant traditions of its own while paying my tributes to those beautiful traditions, I would also urge upon you not only to keep those traditions alive but also to carry them to still loftier heights. An elected legislature faithfully represents hopes and aspirations of the people and echoes their collective wisdom. While congratulating you on your being chosen by the people to represent them. I would also pay my tributes to the people of Assam whose enthusiastic participation in the recent elections was an eloquent testimony to their admirable democratic awareness. The people in their wisdom have elected the new legislature and I am confident that you, as the chosen few will live fully up to their expectations.

This first session of the House coincides with a difficult phase in the contemporary history of our State. I sincerely hope that your deliberations will fully capture the seriousness of the situation and guide the state out of the present morass. The new Government have assumed office at a time when the State has almost touched the nadir in every sphere of its life. Immediately after assuming office, the new Government has found itself facing a really unnerving situation. The State's law and order situation has been extremely dismal, marked by stepped up militancy and ethnic violence in certain areas. The lawlessness, left behind by previous government, was evident in the killings of several eminent persons including a member of the Cabinet, a Superintendent of Police and an eminent journalist as well as in the ethnic flare-up in Kokrajhar and Bongaigaon districts. The new Government's inheritance also includes a shattered economy, missive debt liability and almost total financial backruptcy of the State Government. The administrative machinery was found totally demoralised and rendered ineffective. Corruption was rampant in public life at all levels. The situation, thus, was indeed unnerving. The new Government, however, chose to grapple with it boldly and took prompt measures to match up to it fully and effectively.

The new Government have already expressed its total commitment to the task providing security to the life and property of the people in the State. Stern measures have already been initiated to contain any eruption of violence in any form. Restoration of normalcy has been given a very high priority by the new Government. The district adminstrations have been given clear directives to firmly deal with any law and order problem. The police at all levels have been properly instructed to handle any threat to law and order with tact and firmness. It is indeed gratifying to note that the fresh initiatives taken by the new government to restore normalcy in the State have already started yielding the desired results. The process is being constantly monitored and reviewed at the highest level and being further intensified wherever necessary. The availability of forces to match up to exigencies have however been totally inadequate and a sudden depletion in the strength of Central Para-military forces in the State after the recent General election has 14 left a perceptible impact on the situation. The Government have tried to tide over the situation by more insginative and effective use of the available forces and the situation has been brought well under control. Not withstanding certain sporadic and stray incidents, the State's overall situation has considerably looked up, following the assumption of office by the new Government.

While force will always be considered indispensable in the matter of containing violence, the Government have evolved a new philosophy of looking at the problems, not merely as law and order problems but also as issues, deserving a positive approach. The government have, for instance, expressed themselves in favour of initiating negotiations with an open mind with the insurgent groups of different shades and affiliations. The problem of insurgency in the State is being approached with a positive outlook, while the available force is being deployed with a view to effectively countering militance and an initiative has been taken also for starting

negotiation with the different insurgent groups including the ULFA, NSCN and Bodo Security Force outsits. Government have already approached the Union Government for taking an initiative in this respect. In sincerely hope that the Government of India will promtly respond to our request and the insurgent outfits too will favourably respond, to such an initiative in the greater interests of the State and its people. Meanwhile in keeping with its commitment to protect the life and property of the people in the State, the new Government have adequately alerted the activised the police mahinery against possible insurgent activities in order to generate the sense of confidence in the popular mind. The new Government have, at the same time, directed the police to ensure that no harassment or inconvenience is caused to the innocent people. The armed forces operating in the State as per the Armed Forces (Special Powers) Act have also been suitably advised to scrupulously avoid causing any harrassment to the innocent people. The army have been advised not to operate in the State except in total co-ordination with the civil administration at different levels and strict compliance with the laws. This is being further followed up and a system of regular coordination meeting between the army and the civil administration has also been worked out. As possession of illegal arms in the hands of a sizable section of the population has been found to be one of the main threats to the life and property of the citizens, the Government have asked all those persons, who are in possession of such illegal arms to deposit the same at their nearest police stations within 15 days and the Government have warned those, who do not deposit their illegal arms, of stern action as per law. It is really paradoxical that during the tenure of the previous Government, licened arms were seized by police from legal possessors while unlicensed and unauthorised arms swept the underworld markets leading to the rising crime rate and violence. My Government have also taken steps to stop extortion of money. by miscreants from the people, a legacy that has been left

behind by the previous Government of the State. It is gratifying to note that the problem of insurgency in the State is being approached with a comprehensive outlook and I am confident that the sincere initiative, taken by the State Government will yield encouraging results soon. It is also a matter of happiness that the new United Front Government at the Centre have also included the issue of solving the State's insurgency problem through dialogues in their common programme.

My Government is committed to adopt a new approach for viewing at all problems and issues confronting the State, in a wider perspective, different from the conventional approach with the aim of evolving effective solutions, which could be permanent, instead of short term of temporary gains. In fact, this new Governments philosophy emanates from its realisation of the fact that due to lack of an intergrated approach and adhering only to a random adhoc and isolated approach the states problems have aggravated over the past few years. finding no way of a lasting solutions. My Government will aim at correct understanding of the problems their root causes, the ethos and sentiments of the people of all sections at the grass-root level and take up a total approach for evolving a lasting and well acceptable solution to each issue or problem. Positive attitude, constructive behaviour and coordinated effort will be the guiding factors of the new total and intergrated approach. Be it law and order, insurgency, communal harmony or the developmental progrmmes-all will be seen with a broader outlook and deep insight and efforts will be made for achieving effective solutions through such a well coordinated total approach. The Government are determined to being about peace, unity and progress in the State at a faster pace and usher in that peace, which is really lasting and effective.

The legacy left behind by the previous Government also included the continuing tension in the areas along Assam's borders with its sister States. The tension erupted into violence in Merapani area on the Assam Nagaland border, which left several persons dead. The State Government immediately got in touch with Nagaland Government and took the initiative for talks between the district authorities of the bordering districts in both the States. The tension was, thus promptly defused. The State Government have expressed themselves in favour of solving these long standing issues concerning all neighbouring States through bilateral talks. At the same time, however, the State Government have arranged adequate deployment of force and strong vigil in the State's areas, bordering the neighbouring States to ensure protection of life and property of the people.

The build-up of communal in parts of the Kokrajhar and Bongaigaon districts, which led to a flare up around the time of assumption of the office by the new Government has caused to all of us, deep anguish. The disturbance left more than a hundred persons dead, several hundreds mained and thousand homeless. The situation had been brought under control and arrangments are being made to get the affected people sheltered in the relief camps return to their villages to start life anew. Step have been taken to provide ex-gratia grants of rupees one Lakh each to the families of those, who were killed in the ethnic violence in Kokrajhar and Bongaigaon districts. Those who were injured are being provided with ex-gratia grants, ranging from rupees one thousand to rupees three thousand each. Moreover, for rehavilitation of the affected families who are rendered homeless, the Government have decided to provide financial assistance to the tune of rupees ten thousand, depending upon the loss sustained. However, the State Government feel that the issue too highlights the need for a positive and sustained effort to stimulate in the popular mind, a new awareness about the cherished values of communal peace and harmony. Without proper psychological rehavilitation and restoration of the values of mutual trust and fellow feeling the scars left behind by the madness in the

peoples mind can not fully heal. Naturally, therefore the State Government have drawn up plans and programmes in this respect. A judicial enquiry has also been istituted into the ethnic troubles in the two districts for a better understanding of the causes and circumstances leading to the disturbances. The commission headed by the Hon'ble Justice Shri S. Haque, the former acting Chief Justice of Gauhati High Court has already taken up the probe and it is expected that the findings of the commission, apart from throwing light on the darker recesses of the issue at hand will also help the Government in their effort of forging a progressive unity amongst the people of the state.

My Government strongly advocates for more powers for the State as they believe that the present logic and practice of having a strong Centre and weak States have done no good in strengthening the unity and harmony of the nation. My government feel that such a situation is responsible for the present grouse against administration by many a small ethnic groups in the North east and elsewhere in the country due to the fear of losing their identities. It is in this context, that my Government supports the idea of a real federalism which is considered to be the only way to make the states stronger, more cohesive and properous and in turn, the nation as a whole. Therefore, my Government will urge upon the Central Government for transfer to the States of more powers as well as all subjects, keeping subjects like defence, foreign affairs, communiction and currency for the Central Government. Formal reference to this effect will soon be placed by my Government before the Central Government.

My Government will remain always in favour of providing to the indigenous tribal groups of population, the benfit of local autonomy in the true sense. It will oppose any attempt of misleading the tribal groups in the name of local autonomy and making them victims of political mechinations. The age old ties of communal harmony among different

sections of the people living in autonomous areas will never be allowed to be destroyed. The rights of the people belonging to other communities will be protected. The Government will evolve clear, realistic and effective policy to solve the various problems, faced in the way of providing autonomy to the tribal groups through a process of the dialogue with these groups with an open mind. Steps will be taken to solve the problems of Rabhas. The matter of giving the status of the Scheduled Tribes to the Garos of the State and the karbis living in the plains of Assam will be taken up with Central Government. Consequent to the inclusion of the Koch Rajbongshis in the list of Scheduled Tribe communities of the State of Assam, the number of Scheduled Tribe pupulation in the State has gone up. Therefore, my Government will press the Centre for proportionate increase in the plan outlay and other benefits for the Scheduled Tribe people of the State.

My Government will take effective steps for allround welfare and development of the people living in the char areas. All indian citizens living in the char areas will be given land allotment certificates in a phased manner. Drinking water and health care facilities will be provided to the char dwellers. More educational institutions will be set up and special steps will be taken to develop the existing ones. The Government will strive to wipe out any feeling of insecurity and apprehension from the minds of the minority community who has migrated Assam before March 25, 1971.

It needs no further elucidation of the fact that the tea and ex-tea comunities constitute a considerable section of the State's population and therefore, it is impossible to think of Assam's development, leaving them aside. The Government are fully alive to the problems of the communities and are going to take up soon a comprehensive programme for their welfare and development. The Government will seek whole-hearted cooperation from all tea garden owners also in the implementation of the programme.

The Government will give priority to the implementation of schemes and programmes for accelerated development of SC, ST and OBC people of the State.

My Government are committee to go ahead by taking urgent steps to complete the implementation of the different provisions of the Assam Accord, which still remain incomplete steps will be taken on the basis of the Assam Accord to deal with the problems of foreigners infiltration. Earnest endeavours will be made for overcoming legal and technical hurdles in implementing certain provisions of the Accord through mutual trust and understanding among all concerned sections of the people.

At the time of the assumption of office by the new Government, the State had been reeling under a staggering finnancial burden of Rs.5910 crores which included an amount of Rs.5095 crores as outstanding loans against the State Government, an amount of Rs.305 crores involved in Revenue Deposit, an amount of Rs.65 crores towards Central assistance received by the Government of Assam in respect of the various centrally sponsored schemes / central sector schemes. but not yet released by the Government of Assam, an amount of Rs.260 crores as the outstanding loan of Peerless Company taken by AIDE and STATFED for the Government of Assam purpose and an amount of Rs.185 crores as overdraft as on 15.5.96. This has naturally put new Government in an extremely tight position as regards the implementation of Welfare and developmental schemes for the people. Incurring minimum expenditure at least for running administration has even become difficult. As on 1.4.95 the outstanding principal amount against the various Autonomous bodies for which the Government of Assam had accorded guarantee stood at Rs.659 cores. My Government will urge upon the Central Governement to allow a moratorium of at least three years on the repayment by the State Government of all Central loans, in view of the grave problems which the

State has been passing through. A detailed proposal will also be submitted to the Central Government, requesting for an adequate amount of Central grant for revitalising the State's economy. The State Government will excerise utmost caution in Government spendings with a view to avoiding wasteful expenditure. All possible economy measures will be undertaken in incurring any Governmental expenditure. Simultaneously, all out efforts will be made to maximise all tax and non-tax revenue collection through plugging of the leakges and by ensuring better tax and non-tax adminstration. Implementation of the ongoing schemes particularly under the non-plan will be reviewed in reference to the cost benefit and affordability on the part of the State Government.

My Government will make all out endeavours to check corruption in public life as well as in all levels of the adminstration. It will leave no stone untured to present to the people a clean and efficient administration. The Government seek sincere cooperation from all in this regard. Steps will be taken for proper enquiry into all cases of financial misappropriation including the LOC scam and action will be taken against the guility ones as per law.

Considering the magnitude of the unemployment problem, which has assumed explosive propritions, the State Government will adopt a well thought-out policy in consistation with eminent economists for absorption of educated unemployed youths to the maximum possible extent in self employment avocations, particularly in sectors like agriculture, agro-based industries, animal husbandry, fisheries and others, During the first year of its tenure itself the Government will come out with a broad based comprehensive programme for widening the scope of self-employment for educated youths. Steps will be taken to ensure that at least one person in each jobless family in the State gets opportunity for gainful employment.

Assam being located in a remote corner of the country,

the Transportation costs of essential commodities generally become higher than that in other regions. In view of the need for checking rise in the prices of the essential commodities, my Government will take up the matter of allowing transport subsidy with the Central Government. The number of Fair price shops will be increased so as to ensure easier availability of essential commodities at fair rates for the people. The Government are seriously concerned at the rise in the prevailing price line in the State. In this connection suitable steps have been taken by my Government with the cooperation of the concerned authorities viz. the Railways, FCI and chambers of commerce for ensuring steady movement of foodstuff and other essential commodities to this region and also maintaining buffer stock of all these commodities within the State.

My Government will be giving top priotiy to rural development. For facilitating better implementation of rural development schemes and programmes, my Government will ensure that the elections to the Zila Parishads is held within the first year of the Government's tenure. Various suitable production-oriented schemes like fisheries will be taken up in each village to procide the villagers means to augment their income. For such production centres, every revenue village covered by the Employment Assurance Scheme will be given at least rupees one Lakh during the period of next five years. Steps will be taken to strengthen the three tier Panchayati Raj Institutions in the State. Similar actions will be take with regard to other local bodies in the State.

Adequate priority will also be given be given on the agriculture sector for raising the prosperity and standard of living of the rural farmers. Well coordinated efforts among the Departments of Agriculture, Irrigation, Power, Soil conservation, Flood Control and other allied ones will be launched to achieve increased production and self-sufficiency in the agricultural front. Adoption of modern and scientific

methods of agriculture will be encouraged among with farmers. Endeavours will be made to raise production of rice and oil seeds to the level of all India average production. Crop Insurance scheme and other economic security schemes will be taken for benefit of the poor farmers. Pathar Parichalana Samities will be revitalised. Suitable pension shemes for the farmars will be taken up. Suitable subsidy on purchase of modern agricultural tools and implements will be considered to attract the educated youths for taking up agriculture. Steps will be taken by the Government for facilitating the availability of loan assistance upto rupees ten thousand each to the interested farmers from the financial institutions.

My Government will take effective strengthening of the industrial sector by setting up small. medium and large scale industries, based on the available local resources. The cottage industries sector also will get a new boost. An export zone will be created in Assam for ensuring international markets for the cottage industry products of the State. The Activities of the tea industry in the State will be invigorated with a view to their accelerated development and meaningful contribution to the economic development of the State. Small tea growers will be encouraged with suitable incentives so as to attract educated youths in more numbers to that field. An industrial advisory Committee has already been constituted to study the matter of rapid industrialisation of the State and identify the possibilities. The sick industries both at the public sector and the joint sector will be revitalised. The pace of industrial development is linked to a large extent with the availaility of adequate power. My Government attach a high priority to power generation. If necessary, reputed organisations from the rest of the country or abroad will be invited for setting up of power generation units in the private or joint sector in the State. Necessary measures will be taken up for a more meaningful implementation of the rural electrification programme in the State.

My Government will take prompt steps for repairing all damaged roads and bridges in the State. The Central Government will be pressed for estension of the National Highway network in Assam and for its proper maintenance. The Central Government will also be urged to expedite the process of construction of fourth bridge over the Brahmaputra at Bogibeel and to extend BG railway lines upto Tinsukia and Badarpur in the South and upto North Lakhimpur in the north.

The Government are keen to explore the tourism potential in the State and to develop tourism on professional lines. Tourist lodges all over the State will be suitably renovated with modern amentities for attracting both domestic and foreign tourists. Educated unemployed youths will be encouraged to take up self employment in the tourism sector. An extensive scheme for sharing information and establishing coordination among all tourist centres in north eastern region will be implemented for attracting tourists to Assam and the region.

My Government are determined to stop the wanton destruction of the forest resources of the State and they will take up effective measures for growth and conservation of forest wealth in the reserved forests. Attractive schemes to popularies social forest will be taken up. Adequate steps will be taken to save the wild life and forest wealth from poachers and timber smugglers. Stern actions will be taken against all those found to be involbed in illegal activities in the reserved forest areas.

The State Government will make sincere endeavours for the evolving of a permanent solution to the problem of recurring flood and erosion in the State by the Brahmaputra and the Barak and their tributaries. Experts of national and international repute will be invited to suggest ways to achieve this objective. International cooperation will also be sought for utilisation of the vast water resources of the State for the economic benefit of the people. My Government will pursue

with the Central Government for the conversion of the existing Central loan Assistance of cent percent loan to the State for the Brahmaputra Flood Control Schemes in the States to one of special Central Assistance with the usual pattern of financing viz either ninety percent grant and ten percent loan or cent percent grant. Implementation of the flood control schemes State will be expedited.

My Government will take firm and effective steps to put an immediate end to the widespread irregularities in the appointment of teachers and the rampant corruption and malpractices prevailing during the tenure of the erstwhile Government. All cases of irregularities and malpractices will be enquired into and steps will be taken to punish the guilty officials as per law. No compromise will be made in the matter of qualitative standards of the candidates, while making appointments to the posts of teachers. Steps will be taken for proper development of human resource and a healthy educational atmosphere will be restored in the State at all levels. All out efforts will be made by my Government for the proper development of education in the State.

The new Government in Assam will take up a programme with a new approach for better development of health care and family welfare facilities. There will be utmost emphasis to ensure "Health for All" by the end off this century. Special attention will be given for strengthening the health care facilities in the rural areas. Regular services by doctors in the Government hospitals and primary health centres will be ensured and arrangements made for supply of medicines, free of cost to the patients there. Free medical check-up of the primary school children will be taken up.

Animal Husbandary and Veterinary occupies a place of importance in the State's economy & particularly in the rural economy. The Government will formulate suitable schemes in this sector with particular emphasis on improvement of cattle health, increased production of dairy products, popularisation

of poultry farming and widening of the network of veterinary services.

My Government will also take adequate steps for all round welfare of all sections of the people of Assam. Emphasis will be given for provision of drinking water facilities throughout the State. Attention will also be given for providing other facilities such as setting up of bus terminals, development of drainage and sewerage system in the urban areas etc. Land policy for the State will be revised to safe guard the interests of the local people, irrespective of caste, creed or religion. For development of art, culture and film industry of the State, appropriate schemes will be prepared in consultation withe concerned professionals and organisations in the line and implemented accordingly. Development of sports and youths welfare will be another area for priority treatement. Ancient monuments will be preserved and developed as attractive tourist spots. A set of special measures will be undertaken for planned development of Guwahati, the premier city of the North East. A suitable scheme will be introduced to help the old and destitute women. Stern measures will be taken to check crimes against women and children. Units of rural women will be formed in the villages which will be provided with work-sheds, looms and yarn to augment their family income. Physically handicapped persons will be given more facilities for gainful employment. Special Schemes will also be implemented for the Welfare of the litterateurs. iournalists, artistes and sports-persons.

Hon'ble Members, my Government have not yet completed even a months in office. You will definitely appreciate that it will take the Government a little while to take out the State from the myriad problems and economic stagnation and move it on the highroad of progress. Nevertheless, I would like to assure you that the activities of the new Government in every sector of the State's life and development wll be based on a genuine concern for

expeditious realisation of the people's cherished dreams for sustaind peaceful progress, which will ensure the States triumphant passage into the twenty first century. What I have attempted to give here is only a brief outline of the major policies and programmes of the new Government with the hope that it will provide to you a glimpse of its new philosophy of development. I hope you will cover the issues ingreater details during your discussions on the floor of the House. I wish your deliberations all success.

REPORT OF THE BUSINESS ADVISORY COMMITTEE
