QUESTIONS AND ANSWERS

STARRED QUESTIONS

Re: Breach of Na-Dehing Bund

*Shri DEVENDRA NATH HAZARIKA (Saikhowa) asked:

- *38. Will the Minister-in-charge of Public Works Department be pleased to state—
 - (a) Whether Government is aware that the breach of Na-Dehing bund near Dirakhmukh on the 14 miles east of Saikhowaghat in the month of July last was caused due to holes made by white ants on the embankment?
 - (b) Whether it is a fact that the breach occurred at the distance of about 2 furlongs from the place where Embankment and Drainage staff and workers were working in that night to prevent breach due to overtopping of water on that portion of the embankment?
 - (c) Whether it is a fact that the breach occurred where there was no fear of overtopping of water?
 - (d) Whether it is a fact that there were big holes in different places of the embankment made by white ants?

Shri HARESWAR DAS [Minister, Public Works Department (Flood Control and Irrigation Wing)] replied:

38. (a)—The breach occurred on 14th July 1961 due to sudden development of heavy seepage and percolation which might be due to hidden holes of white ants in the particular persion, in spite of all precautionary measures adopted by the supervising staff.

- (c)-Yes, there was 11 ft. free board in that portion of the embankment before the occurance of breach.
- (d)-Yes, but adequate action was taken to fill up the holes as soon as was detected.

Shri DEVENDRA NATH HAZARIKA (Saikhowa) : Sir what step was taken to remove the white ants which was the root cause of the breach which led to loss of human life?

Shri HARESWAR DAS [Minister, P.W.D. (Flood Control and Irrigation Wing)]: These are not always visible but wherever they were detected, the holes were filled up.

Shrimati LILY SEN GUPTA (Lahowal): এই নঠাউৰি বিলাক পোণপটীয়া সোঁতৰ পৰা ৰক্ষা কৰিবলৈ বিং বাদ্ধ নিয়াৰ ব্যৱস্থা চৰকাৰে কৰিছেলে?

Shri HARESWAR DAS: এতিয়াও প্রোজন হোৱা নাই।

Shri DEVENDRA NATH HAZARIKA: Whether it is a fact that due to non-removal of woods from that site at the time of construction of the embankment and also for not taking proper step to tighten the earth the white ants could make the holes there which caused this breach?

Shri HARESWAR DAS : That is not correct.

Re: Nadlajan of Nalbari

Shri TARUN SEN DEKA (Nalbari-West) asked:

- *39. Will the Minister-in-charge of Public Works Department (...... Control and Irrigation Wing) be pleased to state-
 - (a) Whether Government is aware that the Nadlajan under Subdivisional Officer, Nalbari forming almost a river is causing tremendous loss to the paddy field every year?

Why the embankments with necessary sluice gates have not

been completed?

(c) When regular embankments with sluice gates may be completed upto the river Buradia?

Shri HARESWAR DAS Minister, Public Works Department (Flood Control and Irrigation Wing)] replied:

- 39. (a)—Yes, to some extent by this drainage channel.
- (b) & (c)-A Scheme for construction of Flood Embankments along both banks of Nadlajan with sluice gates is no solution, in view of the fact that the flood problems of the area are not due to the flooding of Nadlajan alone but due to the floods of two or three rivers. Detailed investigation and collection of data for preparing a comprehensive scheme trothe entire area as advised by the Government of India, are in progress.

Shri TARUN SEN DEKA (Nalbari-West): Sir, what are those two or three rivers?

Shei HARESWAR DAS [Minister, P.W.D. (Flood Control and Irrigation Wing)]: The rivers are Buradia, Mara-Pagladia and Main Pagladia in the upper reaches north of the Railway line.

Shri TARUN SEN DEKA: When the investigation is expected to be completed?

Shri HARESWAR DAS: I cannot give the exact date. This requires study of the entire basin.

Shri TARUN SEN DEKA: If not the date and month, may I known the year?

Mr. SPEAKER: He cannot say.

Shri HARESWAR DAS : That also I cannot indicate.

Re: Breach of Maiahola Bund in Bokakhat Mouza

Shri HARESWAR GOSWAMI (Rampur) asked:

*40. Will the Minister-in-charge of Public Works Department (Embankment and Drainage) be pleased to state—

- (a) Whether Government is aware of the breach in the Maiahola Bund in Bokakhat Mouza in Golaghat Subdivision?
- (b) Whether it is a fact that this is the 7th bund in this area that has not been able to withstand the force of Brahmaputra to Dhansiri?
- (c) How much money has been spent for constructing these bunds?
- (d) Whether Government propose to put up spurs to divert the current here?

(e) If not, why not

Shri HARESWAR DAS (Minister, Flood Control and Irrigation Wing, etc.) replied:

40. (a) to (e)—Information catted for is awaited.

Re : Owna Bund

Shri MOHIDHAR PEGOO [Jorhat (Reserved for Scheduled Triber)]: asked

*41. Will the Minister-in-charge of Public Works Department (E. and D. Wing) be pleased to state—

(a) Whether Government is aware that the bending current of the Brahmaputra (Mohgarh Suti) is coming nearer and nearer towards Hazari Mouza in Jorhat Subdivision and the Owna Bund, protecting an area of nearly 45 sq. miles, is at the point of being eroded away by the Brahmaputra very shortly i

- (c) Whether Government received any representations from the public as well as from the questioner during the last 4-5 years regarding construction of a closing bund or a current diverting spur at Mohgarh Suti near Gohaingaon, Jorhat to protect the aforesaid area from erosion by diverting away the current of the said Suti?
- (d) If the answer to (a) and (c) above, he in the affirmative what measure Government propose to take to save the said area from such devastation?

Shri HARESWAR DAS (Minister, Flood Control and Irrigation Wing, etc.) replied:

41. (a)—Yes, to some extent.

(c)-Yes.

(d)—The closing of Mohgarh Suti which is very active and antierosion measures as defle tors near Gohaingaon are not considered desirable from both technical and economic points of views. Retirement will be done when Embank ments is croded.

Re: Compensation for 'Zirat' damaged due to construction of Embanment in North Kamrup

Shri TARUN SEN DEKA (Nalbari-West) asked:

- *42. Will the Minister-in-charge of Public Works Department (F, C. and I. Wing) be pleased to state—
 - (a) Whether it is a fact that Government has not paid any compensation for the 'Zirat' damaged in course of construction of Embankments in North Kam up area?
 - (b) Whether it is also a fact that for the lands falling towards the river side but outside the area of 100 feet no compensation has been paid to the owners?
 - (c) Whether Government is aware that the people have been demanding compensation for the damaged 'Zirat' and for the lands they lost outside the area of 100 feet?

Shri HARESWAR DAS (Minister, Flood Control and Irrigation Wing, etc.) replied:

- 42. (a)—No. Compensation for 'Zirat' is included in compensation for land during assessment under the Assam Acquisition of Land for Flood Control and Prevention of Erosion Act, 1955.
- (b)—Under the Act compensation is paid for the area acquired for the scheme.
 (c)—Yes.

Re: Shri Lakhmi Sinha Das who served as Gram Sevak

Maulavi TAJUDDIN AHMED (Tarabari) asked:

*43. Will the Minister-in-charge of Community Development be pleased to state-

- (a) Whether it is a fict that Shri Lakhmi Sinha Das was the Gram Sevak under Gobardhana Community Project during last two years?
- (b) Whether it is a fact that he is a Matriculate and belongs to a Scheduled Caste (Namasudra) family and that his services were terminated?
- (c) Whether it is also a fact that his salary for the last month has not been paid up to this time?
- (d) Why this has been done?
- (e) Whether he will get his arrear pay and if so, when?

Shri FAKHRUDDIN ALI AHMED (Minister, Community Development, etc.) replied:

43. (a)—Shri Lakhmi Sinha Das served as Gram Sevak from 4th July 1959 to 30th November 1960.

(1.) -Yes.

(c)-No.

(d) & (e)—Do not arise in view of reply to (c) above.

Maulavi TAJUDDIN AHMED (Tarabari): Why his services were terminated?

Shri FAKHRUDDIN ALI AHMED (Minister, Community Development): Because he was not a trained person. I may inform the hon. Member that it is the policy of the Government that for such untrained persons opportunity for training should be provided. Arrangements have been made for this training and this particular person has been asked to join the training from this month.

Re: Majuli Community Development Block, Stage I!

Shri MOHIDHAR PEGOO [Jorhat (Reserved for Scheduled Tribes)] asked:

- *44. Will the Minister-in-charge of Community Development be pleased to state—
 - (a) Whether Government is aware that a post of the Extension Officer-in-charge of Cottage Industry has been being valuant

in the Majuli Community Development Block, Stage II for a pretty long time causing great inconvenience to the rural public?

(b) Whether it is a fact that large number of applications for grants-in-aid for improvement of their Cottage Industry, such as tailoring, carpentry, etc., have been left unattended due to absence of the said officer and thereby depriving the applicants of their due subsidies?

(c) If the answer to (a) and (b) above, be in the affirmative, what step Government propose to take to fulfil the grievances of

the public ?

Shri FAKHRUDDIN ALI AHMED (Minister-in-charge of Community Development) replied:

44. (a)—Yes. The post has been lying vacant since 1st February 1961.

(b)—The applications when received in the Block are sent to the Assistant Director of Cottage Industries, Jorhat for disposal. The applicants are not true deprived of their due sub-sidies though the process naturally involves some inconvenience.

(c)—The post will be filled up as soon as the selected officers complete the training which they are now undergoing.

†Shri FAKHRUDDIN ALI AHMED: We cannot help it. As I already said the Extension Officer in this Block has not been appointed as there is dearth of trained person. We have already sent 5 or 6 persons for training and as soon as they complete their training, they will be posted in different blocks.

Shri NALLINDRA SANGMA [Dainadubi (Reserved for Scheduled Tribes)] asked:

- *45. Will the Minister-in-charge of Co-operative Societies be pleased to state-
 - (a) When the Mendipathar Primary Marketing Co-operative Society was registered?
 - (b) When the construction of the Men lipathar Primary Marketing Co-operative Society's Godown was completed?
 - (c) Why the said Godown has not been handed over uptil now to the said Primary Marketing Co-operative Society?
 - (d) What are the circumstances under which the Police Department is occupying the said Godown which is meant for the Mendipathar Primary Marketing Co-operative Society?
 - (e) How long they will occupy the building in future?

Shri BISWADEV SARMA (Deputy Minister, Co-operation) replied:

45. (a) to (e)-Information is being collected.

Re: School Benefit Fund Ltd. and Gaolia Bank of Dibrugarh Subdivision

Shri DEVENDRA NATH HAZARIKA (Saikhowa) asked:

- *46. Will the Minister-in-charge of Co-operative be pleased to state-
 - (a) The numbers of members of the (1) Khowang High English School Benefit Fund Ltd., (2) Dinjoy High English School Benefit Fund Ltd. and (3) Sunairam High English School Benefit Fund Ltd., in Dibrugarh Subdivision?

(b) The total amount of money deposited in each of these Benefit Funds and when the last transaction occurred there in

each?

- *47. Will the Minister-in-charge of Co-operative be pleased to state—
 - (a) Whether Phutaholla Gaolia Bank and Romai Bongali Goalia Bank in Dibrugarh Subdivision has yet been functioning?

(b) When these two Goalia Banks were formed and whether there were any transctions this year?

(c) What steps Government is taking to make them functioning?

Shri BISWADEV SARMA (Deputy Minister, Co-operation) replied:

46.(a)&(b)-Into a ion is being collected.

47.(a), (b)&(c)—Information is being collected.

Shri DEVENDRA NATH HAZARIKA (Saikhowa): Sir, in 46 (a) (3) the name of the School should be "Senairam" and not "Sunairam"

Re: Emporium Building at Mendipathar

Shri NALLINDRA SANGMA [Dainadubi (Reserved ior Scheduled Tribes)] asked:

*48. Will the Minister-in-charge of (Community Project) Development be pleased to state—

(a) For what purpose the Arts and Grafts Emporium building

was constructed at Mendipathar?

- (b) Why it was not handed over to the appropriate authority although the construction of the building was completed long time back?
- (c) What are the circumstances under which the Police Department is occupying the Emporium building since October 1960?
- (d) Whether the Police Department pays rent to the Community
 Project Department or the said building occupied by
 them?

Shri FAKHRUD IN ALI AHMED [Minister, Development Panchayat and Community Development)] replied:

48.—Information has been called for.

Sir this question was received on 27th of last month. As the information has to be collected from Garo Hills, it will naturally take some time. As soon as the information is collected, it will be supplied to the hon. Member.

Re: Purchage of machines for Silchar Polytechnic Institute
Shri DEVENDRA NATH HAZARIKA (Saikhowa) asked:

- *49. Will the Minister-in-charge of Education be pleased to state—
 - (a) Whether it is a fact that Engineering machines for Silchar Polytechnic worth over one lakh of rupees were imported from Calcutta and the Principal of the Institution delayed in taking delivery at Gauhati from the steamer company and M/s. R. S. N. Co. at Gauhati claimed a demurrage of about Rs.1,500?
 - (b) Whether it is a fact that these machines were re-booked from Gauhati by train which reached Silchar Railway station on or about 19th May 1961?

(e) Whether it is a fact that the Principal did not take any action to take delivery and the Railway authorities claimed a demurrage of about Rs.9,000 (nine thousand) in the month of August last?

Whether it is a fact that the Railway authorities served notice on the Principal that the goods would be auctioned

if no immediate delivery was taken?

Shri RADHIKA RAM DAS (Deputy Minister, Education) replied:

49. (a)—It is a fact that towards the end of the financial year booking space was not available from Calcutta to Silchar. R. S. N. Co. was agreeable to book equipment upto Gauhati by steamer. Therefore, machines, worth Rs. I lakh was booked to Gauhati by steamer. Information regarding demurrage is being collected.

(b)-Yes.

(c)—Yes, Rs,5,853.40 nP. were paid. Railway authority is being requested to refund this amount. The question of fixing responsibility will thereafter be considered if no refund is obtained.

(d)—Being collected.

Shri DEVENDRA NATH HAZARIKA (Saikhowa): Is the Deputy Minister of Education aware that machines and tools worth about a lakh of rupees meant for this polytechnic have been sent by the Railway authorities from Silchar to the Dibrugarh lost property godown for auction as unclaimed property?

Shri RADHIKA RAM DAS (Deputy Minister, Education) : want notice for that.

Shri DEVENDRA NATH HAZARIKA: Is it not a fact that machines reached Silchar on the 25th of May but no action for taking delivery was taken upto the 6th of September?

Shri RADHIKA RAM DAS: When the machines arrived at Silchar there was disturbance there. Curfew was in force. So, the Principal could not get any information about their arrival. When the situation improved and he got information about their arrival he took delivery.

Shri MOHI KANTA DAS (Barchalla): The Minister said that about Rs.5000 had to be paid as demurrage to the railway authorities and that a claim has been submitted for refund. He also said that frefund is not obtained the question of fixing responsibility will be taken up. The question is whether the Principal of that institution delayed in taking delivery of the goods when they reached Silchar.

Mr. SPEAKER: The Deputy Minister said that the goods arrived at Silchar during the period of disturbances and the Principal was in a very inconvenient position for which he could not take delivery in time.

Shi MOHI KANTA DAS (Barchalla): If that is so, the question of fixing responsibility does not arise. How can the Deputy Minister reconcile these two statements of his?

Shri RADHIKA RAM DAS: It is the report of the Principal that he did not get any information That will be enquired into whether he got information in time or not.

Shri DEVENDRA NATH HAZARIKA (Saikhowa): Is it a fact that the Principal left Silchar for Calcutta in the month of May and he did not return upto the 15th July and no charge was given to anybody during that period and it is for this that nobody could take delivery of the goods?

Shri RADHIKA RAM DAS (Deputy Minister, Education): He might have left for Calcutta, but there was somebody in charge of the

institution.

Shri MOHI KANTA DAS: When did the machines arrive at Gauhati and when did the Principal came to Gauhati to rebook that from Gauhati to Silchar?

Shri RADIKA RAM DAS: The Principal did not rebook them, from Gauhati to Silchar. It was done by the Department.

Shri BHUBAN CHANDRA PRADHANI (Golakganj): How long the machines were lying at Gauhati?

Shri RADHIKA RAM DAS: I cannot give the evact informa-

Shri DEVENDRA NATH HAZARIKA: Whether it is a fact that the goods were not taken delivery from 25th May upto 27th August and on that day the goods were sent to Dibrugarh from Silchar by the railway authorities?

Mr SPEAKER: He has already replied to that question.

Shri DEVENDRA NATH HAZARIKA: Whether it is a fact that the railway receipt had to be sent to the Principal in Calcutta for his counter-signature as nobody in the Silchar polytechnic was authorised to do so?

Shri RADHIKA RAM DAS : I am collecting this information.

Shri SARAT CHANDRA GOSWAMI (Kamalpur): The Deputy Minister said that a sum of Rs.5,843 was paid as demurrage. If delivery of the goods was taken why this demurrage was paid?

Shri RADHIKA RAM DAS (Deputy Minister, Education): Because these were not taken delivery in time.

Shri DEVENDRA NATH HAZARIKA (Sail howa): There were two consignments. One was taken delivery of paying a heavy demmurage and the other was sent to Dibrugarh from Silcher as unclaimed purposely. In it not a fact of

Shri MOHI KANTA DAS (Barchalla) : If the Principal went to Calcutta due to fear of disturbances, it was his duty, as a responsible officer, to place somebody in charge of that institution so that the latter could take delivery of the goods in time. May I know why this was not done?

Shri RADHIKA RAM DAS . I have already stated, Sir, that if he was not there somebody must have been in charge of the institution.

Shri MOHI KANTA DAS: May we know whether the Deputy Minister is going to take suitable action against the person at fauit?

Shri RADHIKA RAM DAS: Yes, this will be done.

Re: One appointment in the Industrial Institute

Shri HARESWAR GOSWAMI (Rampur) asked :

*50. Will the Minister-in-charge of Education be pleased to state-

- (a) Whether one Khageswar Saikia was appointed as a Pattern Maker Instructor in the Industrial Training Institute in 1951 2
- (b) When was his services terminated?
- (c) Whether it is a fact that he subsequently took training as Carpenter and was appointed as Carpenter Instructor in the said Institution.
- (d) Whether it is a fact that although he passed Test Examination, his case was not considered for appointment as Carpenter Instructor by the Industrial Training Institutes forhat ?
- (e) If so, what was the reason for discarding his service?

Shri RADHIKA RAM DAS (Deputy Minister, Education) replied:

50. (a)-It is not a fact.

(b)-Does not arise.

- (c)-Appointed temporarily in 1957 pending recommendation of Assam Public Service Commission and replaced after about a year on recommendation of Assam Public Service Commission as he was not recommended by Assam Pub ic Service Commission,
 - (d)-Yes, as he could not compete,
- (e)—In view of availability of a better qualified and experienced candidate.

Re: The Principal, Silchar Polytechnic Institute

Shri DEVENDRA NATH HAZARIKA (Saikhowa) asked:

*51. Will the Minister-in-charge of Education be pleased to state-

- (a) Whether the Principal of Silchar Polytechnic, Dr. B. Khastogir is on contract service?
- (b) If so, when his term of contract would expire?
- (c) Whether Government received any report that his quarters which is a Government building was used as an office of the Sangram Parishad?
- (d) Whether Government are aware that he has been observing 19th of every month since 19th May 1961 as a "Sahid Day" by lighting 11 (eleven) candles as decided by the Sangram Parishad?
- (e) Whether it is a fact that 5 (five) additional chowkidars were appointed with effect from 1st August 1961?
- (1) It so, what for these 5 chowkidars were appointed?
- (g) Whether Government received any complaints that this Principal allowed to use the Government vehicle under his charge by volunteers of Sangram Parishad?

Shri RADHIKA RAM DAS (Deputy Minister, Education) replied:
51. (a)—Yes.

- (b)—His contract would expire on 14th June 1962, but he submitted resignation which has been accepted with effect from 1st October 1961.
- (c) (d) and (g)—Some complaints were received from an Anchalik Panchayat to this effect. The matter has been referred to the Police for investigation.

1961. (e)—No, only one day-Chowkider was appointed since 1st August

(f) - For guarding Government property.

Shri RAMNATH SARMA (Lumding): Then the Principal was to have left service on 1st October, 1961.

Shri RADHIKA RAM DAS (Deputy Minister, Education): Yes

Shri PURNANANDA CHETIA (Sonari); Then how can Government take action against him.

Shri RADHIKA RAM DAS: It will not be difficult to realise. Government money by legal action.

Shri PURNANANDA CHETIA (Sonari): Has he been relieved ?

Shri RADHIKA RAM DAS (Deputy Minister, Education): I have not received any information as yet, but he was to be relieved on I-10-61.

Shri DEVENDRA NATH HAZARIKA (Saikhowa) The Deputy Minister said in reply to question 49 that the Government will take up the question of fixing responsibility for the loss due to demurrage if no refund is obtained from the railway authorities. How can Government take any action against the Principal since he has already left service?

Shri RADHIKA RAM DAS - I have already replied that it will not be difficult to take legal action against him for realisation of Government dues.

Re: Roads of Nalbari Circle

Shri HARESWAR GOSWAMI (Rampur) asked:

*52. Will the Minister-in-charge of Public Works Department (Roads

and Buildings) be pleased to state-

- (a) Whether there was lately any representation for taking over the road from Adabari and Nalbari and for taking the road from Marowa to Barnibari in Nalbari Circle through Madhapur-Charuajaha Mijbhahajani and Bagurihati?
- (b) Whether any works for these roads have been taken up?
- (c) Whether Government is aware of the condition of the road between Bahajan and Jaha?
- (d) What is the reason for not completion of this area?

Shri GIRINDRA NATH GOGOI [Deputy Minister, Public Works Department (Road and Buildings)] replied:

52. (a)—Yes.

(b) to (d)-Informations have been called for.

Re: Bridge over Gera River

MD. SAHADAT ALI (South-Salmara) asked:

*53. Will the Minister-in-charge of Public Works Department (Road and Buildings) be pleased to state—

(a) Since when the construction of bridge over Gera River near Lakhipur in the district of Goalpara was started and by what time it is expected to be completed?

- (b) Whether it is a fact that the earthwork of the bridge approach is objected to by the land owner?
- (c) If so, what steps Government have been taken in the matter ?

Shri GIRINDRA NATH GOGOI [Deputy Minister, Public Works Department (Road and Buildings)] replied:

53, (a) to (c)-Informations have been called for.

Re: Kakapathar-Tangana Road

Shri DEVENDRA NATH HAZARIKA asked:

- *54. Will the Minister-in-charge of Public Works Department be pleased to state—
 - (a) Whether Government is aware that there had been demands from the public that the Kakapathar-Tangana Road should be taken over by the Public Works Department?
 - (b) Whether Government is aware that there was a bus service from Tangana to Doom Dooma via Kakapathar and this service found difficulties as the road from Tangana to Kakapathar are not maintained by the Public Works Department?
 - (c) Whether it is a fact that the existing road from Kakapathar to Tangana is almost of the standard of Public Works Department village road?
 - (d) What amount would be required to take ever it by the Public Works Department?

Shri GIRINDRA NATH GOGOI [Deputy Minister, Public Works Department (Road and Buildings)] replied:

54. (a)--Yes.

- (b) and (c)—Government have no information.
- (d)—An amount of Rs.66,000 approximately.

Mr. SPEAKER: Yesterday I pointed out in connection with reply to a question given by Shri Radhlka Ram Das that the reply "Government have no information" is no reply at all.

Shri GIRINDRA NATH GOGOI [Deputy Minister, P. W. D (R. & B.)]: Sir, question (b) was "whether Government is aware that there a bus service from Tangana to Doom Dooma via Kakapathar and this service found difficulties as the road from Tangana to Kakapathar are not maintained by the Public Works Department?" But this is not a Public Work Department road.

Shri GIRINDRA NATH GOGOI: Government have no information.

Mr. SPEAKER: Is there any bar?

Shri RAMNATH SARMA: Yes, I think there is bar.

Shri GIRINDRA NATH GOGOI: The approach road was constructed first.

Formerly, it was agreed that the people will donate land but afterwards they did not donate. Therefore, 15 families were involved in the matter and they represented to us that if the road should go by this way they will be nowhere. These things are going on. The Deputy Commissioner at long last, on 28 August, 1961, ordered for acquisition of land and hence the delay.

Shri BISHNULAL UPADHYAYA (Gohpur): Whether '60 or '50?

Mr. SPEAKER: '61.

*KHOGENDRA NATH BARBARUAH (Amguri): Sir, what is the necessity of keeping the permit system when there is a strong demand from public of Mizo district of abolish it.

*Shri BIMALA PRASAD CHALIHA (Chief Minister): Because it goes beyond the inner line; this an important consideration. On the otherhand there is no demand atleast from the people of the Mizo district for abolition this permit system.

(c)—Steps have already been taken to form the Pradesh Shramik Advisory Committee and the Subdivisional Shramik Advisory Committees.

Powers of registration of Shramik Bahinis have already been delegated by notification to the Executive Engineers, who have also been instructed to register Shramik Bahinis as early as possible.

Shri MOHANANDA BORA (North Lakhimpur): Sir, whether the Government will utilize the man power of our country in developmental works by implementing the Shramik Bahini Act in the interest of our

Shri GIRINDRA NATH GOGOI [(Deputy Minister, Public Works

Department (R. & B.)]: Quite right sir.

Shri DEVENDRA NATH HAZARIKA (Saikhowa): Sir, the Act was passed more than an year back, why such a long time has been take for framing the Shramik Bahini rules?

Shri BIMALA PRASAD CHALIHA (Chief Minister): Sir, the rules have already been framed and these have now been scrutinized by the Sub-ordinate Legislation and when these rules will be approved it will be

Shri MOHANANDA BORA: Sir, is it not a fact that mere enactment of certain Acts is not profitable for the man power unless the provisions

Shri GIRINDRA NATH GOGOI Deputy Minister, P. W. D. (R & B.)]: Instructions are already there.

Shri BHUBAN CHANDRA PRADHANI (Golakganj) : Whether the Government is proposing to undertake work through this Organization of Sharamik Bahini and whether Government will call for tender or not?

Shri GIRINDRA NATH GOGOI: Yes, as per rules and Act. The tenders are called for, but Balinis also given works at Scheduled rates.

Mr. SPEAKER: How will you know the willingness of undertaking the works by the Sharamik Bahini without calling for tenders?

134. Will the Minister, P.W.D. (F.C.) be pleased to refer the calling attention notice given by the Questioner during the Budget Session of the Assembly, 1961 on the subject of putting obstruction to the natural course of river Pagladiya following from its original bed of Buradiya and state

(a) Whether after completion of the bund over out of Pagladiya Embankment at Chengnoi, the Department propose to provide sluice gate over Pagladiya Embankment without delay?

- (b) Whether construction work of the proposed sluice gate over Pagladiya Embankment has already been started?
- (c) If not, when it is proposed to start work and complete the sluice gate over Pagladiya Embankment?

(d) When the Department propose to provide a flood-escape at Chengnoi without delay?

Shri HARESWAR DAS [Minister-in-charge, P.W.D. (Flood Control and Irrigation Wing)] replied:

- 134. (a)—No sluice gate over Pagladiya Embankment at the site of evulsion near Chengnoi is contempleted at present,
 - (b) & (c)-Does not arise in view of (a) above.
- (d)—A flood escape channel in the upper reaches of Pagladiya river may be provided after thorough investigation. The feasibility of providing such controlled by pass in the upper reaches is under examination from technical, and financial point of view and necessary hydrological observation and surveys will be made in coming years.

Shri SURENDRA NATH DAS asked:

Shri HARESWAR DAS [Minister-in-charge, P.W.D. (Flood Control and Irrigation Wing)] replied:

135. (a)—Moinarjan sluice, was practically completed but it was since damaged by floods.

(b)—Yes, the work of sluice gate was started on 8th March 1958.

- (c)—Rupecs Eighty-nine thousand was provided for construction of the sluice.
 - (d)-Yes, the crops are damaged to some extent.

- (a) Whether it is a fact that the progress of works of the Brahmaputra Bund from Dibrugarh to Dibrugarh was slow due to the fact that the Revenue Officers of Dibrugarh did not take prompt action to acquire land for the purpose of this Embankment?
- (b) Whether it is a fact that an application from leading public of the area handed by Shri Akhoy Kumar Gogoi was submitted to the Deputy Commissioner, Lakhimpur on 17th March, 1961 pointing cut the delay by Revenue Officials?
- (c) What action Government are taking to expedite construction and completion of this Bund?
- (d) What is the present progress?

Shri HARESWAR DAS [Minister-in-charge, P. W. D. (Flood control & Irrigation Wing, etc.,)] replied:

- 136. (a)—Land Acquisition proceeding takes time, even so, advance possession was received for the first Section but due to public opposition in certain stretches work was slowed down.
 - (b)—There is no such information.
- (c)—Every possible steps have been taken to expedite construction and completion of the bund.
- (d)—The progress upto 31st July, 1961 is about 40 per cent so far earthwork is concerned.

Shri DEVENDRA NATH HAZARIKA (Saikhowa): In reply to (d) it has been said that "the progress upto 31st July, 1961 is about 40 per cent so far earthwork is concerned." Whether the remaining 60 per cent of the work will be completed during this financial year?

Shri HARESWAR DAS [Minister-in-charge, P.W.D., F.C. & I.W.]: It is expected.

Re: Embankment of Puthimari river

Shri HARESWAR GOSWAMI (Rampur) asked:

- 137. Will the Minister-in-charge of P. W. D. (E. & D.) be pleased to state—
 - (a) Whether it is a fact that the embankment of Puthimari river was eroded at 2/5 F. P. to 2/6 F. P. on the right bank in the year 1959, during the great flood of June and an earth filled palisading had to be constructed through the homestead of Late Tithiram Kalita of village Hahara to prevent flood spills and to save the embankment from complete erosion?
 - (b) Whether it is a fact that all the houses numbering five of Shri Tithiram Kalita were destroyed by the E & D. Department and a large number of standing trees were destroyed of the said Tithiram in constructing the bamboo Mohari?
 - (c) Whether it is a fact that Shri Tirhiram Kalita was supplied a list of the damaged crops and destroyed houses which he had on his periodic Patta land by the Officers of the Department and assured him adequate compensation for the loss he sustained for execution of the project?
 - (d) What was the amount of compensation assessed for the loss or damage sustained by the Pattadars?

- (e) Whether any compensation has been paid to the Pattadars?
- (f) If not, why no compensation has been paid during these three years?
- (g) How long the Government will take to settle up the matter?

138. Will the Minister-in-charge, P. W. D. be pleased to state-

- (a) How many wooden spurs have been constructed to protect the embankment of Puthimari river on the right bank at Dipteswari?
- (b) How many wooden spurs have been constructed at Kendukona?
- (c) On which date Government sanctioned the wooden spurs for Dipteswari and Kendukona?
 - (d) Who were the Contractors to whom the works were entrusted?
- (e) Whether their contracts have been cancelled?
 - (f) What penalty has been realised from the defaulting contractors?

Shri HARESWAR DAS [Minister-in-charge, P. W. D. (Flood Control & Irrigation Wing)] replied:

137. (a)—Yes.

- (b)—No. Two houses and fifty-six numbers of standing trees including one bamboo clump fell on the alignment of the Mohari.
- (c)—Yes. The list included all the houses of which two numbers were removed. The other three were outside the alignment.
 - (d)-No estimate of assessment has yet been received.
 - (e)-No.
- (f)—Land acquisition proceedings could not yet be finalised due to public obstruction to the construction of the retirement.
- (g)—Compensation as admissiable under Flood Control and Prevention of Erosion Act, will be paid after finalisation of the Land Acquisition proceedings following cessation of public obstruction.
- 138. (a)—One timber-cum-bamboo spur has been completed and the remaining two are in progress.
- (b)—Three spurs have been completed, and the remaining three are under progress.
- (c)—Dipteswari on 22nd April, 1961 and Kendukona on 4th May,
 - (d), (e) & (f)—Information called for are still awaited.

- (a) Whether it is a fact that no land compensation has been given to the owner for periodic Patta land acquired for the Bahai Bagbor Embankment?
- (b) When the Embankment was constructed?
- (c) Why no compensation has been given to the pattadars up to this time?
- (d) When it will be given?

Shri HARESWAR DAS [Minister, Revenue for Minister, P.W.D. (R and B.)] replied:

139. (a)-Yes. No land compensation has been paid to the owners.

- (b)-The embankment was constructed during 1951-55:
- (c)—The E. and D. Department took possession of the land on amicable settlement with the consent of land owners who volunteered to offer the strip of land for construction of the embankment and its maintenance, as such no formal acquisition was made and compensation paid.
- (d)—When land acquisition proceedings are started and award given.

Maulayi TAJUDDIN AHMED (Tarabari): Whether t ere is any document given by the Pattadar giving the consent.

Shri HARESWAR DAS (Minister, Revenue): এই বিষয়ে কোনো Document নাই। Consent ৌ Verbally লোৱা হৈছিল।

Shri BISHNULAL UPADHYA (Gohpur) asked:

- 140. Will the Minister-in-charge of P.W.D. (E. and D.) be pleased to
 - (a) Whether Government is aware that the public of Kalabari area upto the bank of the I rahmaputra have greatly been benefited by constructions of the Kharoi Bund?
 - (b) Whether Government proposed to maintain the bund including a few bridges over it specially the pertion from Majikuchi to the extreme west point near Gohpur?
 - (c) Whether Government are aware that even a pedestrian had to be stranded during summer near the breach of the bridge there being flood water spread to a vast low lying area?

(d) Whether steps would be taken to maintain the bund and the bridges every year for protecting the crops and habitation in the area?

Shri HARESWAR DAS Minister, P. W. D. (Flood Control and Irrigation Wing) replied:

- 140. (a)—Yes. Before construction of Brahmaputra dyke.
- adantd wo (b)—The embankment is being maintained within the limit of funds.
- (c)-Temporary bamboo bridge was provided over the breach, which could not be closed due to public opposition last year.
- ... (d)-Yes.. The embankment will be kept in proper order and bridges will be kept fit for foot traffic.

Shri MOHANANDA BORA (North-Lokhimpur): I have one question, Sir. Many of these bunds are used by the people as roads. the Government propose to maintain all such bunds so that the traffic can pass over these at all times?

Shri HARESWAR DAS (Minister, Revenue): The bunds are used by the people as roads but these are not meant for vehicular traffic until stable.

Re: Desang Bund

Shri DURGESWAR SAIKIA (Thowra) asked:

- 141. Will the Minister-in-charge of E. and D. be p'eased to state-
- (a) Whether the construction of Desang right bund from Dihingia to A. T. Road, Irrigation of Darika channel and Reclamation project of Jokaisuk Mauza in Sibsagar Subdivision were included on the Third Five-Year Plan?
 - (b) If so, what action Government have taken so far to start the works?
 - (c) Whether Government is aware that the Executive Engineer, E. and D., Sibsagar Division for warded proposal for acqui.ition of land for execution of the works?
- (d) If so, whether the Civil authorities have already acquired the land so that progress can be made within this year?

Shri HARESWAR DAS [Minister, P. W. D. (F. C. and I. Wing)] replied:

141. (a) -- Schemes for construction of Desang right bund, Drainage of Darika basin and Drainage of Jokaisuk mauza have been included in Third Five-Year Plan.

- (b)—Arrangements are being made to get approval of Government of India to take up these works for execution during 1961-62.
- (c) and (d)—Necessary formalities as required under the Assam Embankment and Drainage Act, 1953 are being done to give a start to the above schemes during the current year.

Re: Pre-extension blocks

Shri DEVENDRA NATH HAZARIKA (Saikhowa) asked:

- 142. Will the Minister of Community Development be pleased to state-
 - (a) How many of the Pre-Extension Blocks in Assam has been converted to Stage I Blocks this year?
 - (b) Whether he would give the number of Pre-Extension Blocks in Assam which could not qualify for conversion to Stage I this year although such conversions were due?
 - (c) How many Stage I Blocks have been converted this year to Stage II in the Stage?
 - (d) The number of Stage I Blocks in Assam which could not qualify for conversion to Stage II on due dates?

Shri FAKHRUDDIN ALI AHMED (Minister, Community Development, etc.) replied:

- 142. 'a)—No Pre-Extension Blocks of this State have been converted to Stage I Blocks yet. Twelve Pre-extension Blocks are due for conversion to to Stage I Block by October this year.
 - (b)—Does not arise in view of (a) above.
 - (c)-Fifteen Blocks.
- (d)—There are no such Stage I Blocks in the State which have not been converted to Stage II Blocks on due dates.
- (e)—Some such proposals have been received by the Government and the matter is under consideration.
 - (f)-(1) Dambuk-Aga M.P.C.D. Block.
- (2) Lungleh M.P.C.D. Block,

- (3) Mairang M.P.G.D. Block.
 - (4) Saipung-Darrang M.P.C.D. Block.
 - (5) Rongkhong M.P.C.D. Block.
 - (6) Diyung Valley M.P.C.D. Block.
 - (7) Morkongsell-k-Sadiya M.P.G.D. Block.

Shri RAM NATH SARMA (Lumding): What are the reasons for which these Stage I Blocks could not do the necessary progress for which extension is to be given by another year?

Shri FAKHRUDDIN ALI AHMED (Minister, Community Development, etc.): Sir, the reasons are difficult terrain, bad communication approaches and also because this Block could not be given the technical personnel in time for implementing the programme on account of such staff not being available.

Shri RAM NATH SARMA: Whether technical personnel are available for the extension of the new Blocks?

Shri FAKHRUDDIN ALI AHMED: We are trying to get as many persons possible and I think the situation has now improved.

Shri RAM NATH SARMA: Can we expect further extension again?

Shri FAKHRUDDIN ALI AHMED : No, Sir.

Mr. SPEAKER: Whether further extension will be given?

Shri FAKHRUDDIN ALI AHMED: We hope that after this extension is given, they will complete the programme and no further extension will be necessary.

Shri CHATRA SINGH TERON [Mikir Hills-West (Reserved for Scheduled Tribes)]: Is it a fact that the extension has to be given only because there is not sufficient progress in these Blocks for want of technical personnel? May I also know how this progress is being measured?

Shri FAKHRUDDIN ALI AHMED: The progress is being measured by the extent of expenditure out of the total allocation and the result it has produced.

Shri CHATRA SINGH TERON: May I know from the Minister-in-charge that there is delay in the progress of work in the National Extension Service Blocks because of lack of technical personnel and also because of the difficultty in the terrain and that it has not been possible on many occasions to spend the amount that is being allotted, whether Government propose to chalk out a different kind of programme for these National Extension Service Blocks?

Shri FAKHRUDDIN ALI AHMED (Minister, Community Development, etc.): I have already stated that because of the terrain difficulty some of the expenditure has not been in curred, we are prepared to take such advice as he hon. Members can give us to overcome this difficulty.

Shri CHATRA SINGH TERON [Mikir Hills-West (Reserved for Schedule Tribes)]: May I know from the Minister-in charge whether Government is seriously considering it because of the difficulties and also of the peculiarities of the areas to change the set programme of work in these areas?

(4) Office Staff.—It was decided that he Office Staff should be borne in the Establishment of the D. C. of the District concerned so as to facilitate better recruitment and giving the Assistants a permanent footing. Due to amalgamation of the Anchalik Panchayats and C. D. Offices, it has been decided to abolish the posts of the Upper Division Assistants after completion of the Stage II period of all the Blocks as one Lower Division Assistant and one Upper Division Assistant are maintained from the Panchayat side.

Shri BIMALA PRASAD CHALIHA (Chief Minister) replied:

233. (a)—No affidavit is required for issuing gun licences but in some districts production of land revenue receipts and other tax clearance certificates have been introduced before issue of gun licences as a step to minimise arrears of various revenues and taxes.

Adjournment Motion Re: [the Situation arising out of the recent decision of the Supreme Court declaring the State Teading (Monopoly purchase of paddy) void.

Mr. SPEAKER: I have received a motion for adjournment from some hon. Members—Shri Hiralal Patwary, Shri Ghanashyam Talukdar Shri Phani Bora and Shri Pakhirai Deka. But before I give my views about this motion I want to get the views of the Minister in-charge as to the admissibility or otherwise of this motion.

Shri FAKHRUDDIN ALI AHMED (Minister in charge Supply): Mr. Speaker Sir, I have just seen the notice given by the hon. Members and I would like to place a few facts before you. Sir, I submit that this motion is not admissible under Rule 59 of our Rules of procedure and Conduct of Business. Sir, in the case in respect of which the superme Court's decision has been given and the effect of which is proposed to be raised by this Motion two objection were raised by the petitioners before the supreme Court. One of the grounds challenging the order of Licensing Authority was that sub-clause (e) of the Licensing and Control order 5 of 1960 was u'tra vires of the Constitution. Under Sub-clause (e) of Control Order 5 of 1961, the matters to be taken into consideration for granting licenses is whether the applicant is a co-operative society or not. So far as this ground is concerned, it was contended on behalf of the petitioner that sub-clause (e) of clause 5 of the control order, 1961 is ultra vires because it goes beyond powers granted to the State Government under section 3 read with section 5 of the Essential Commodities Act, 1955.

This contention has been repeated both the minority and majority judgments of the supreme court which has held subclause (e) of clause 5 of the control order, 1961 is to be Ultra Vires. The other objection that was raised was that there was discrimination in the administration of the rule and that this was done for the purpose of achieving the ulterior motive of creating monoply in favour of the co-operative. So far as this house is concerned the majority judgement has squashed the rule of the Licensing Authority and directed the Authority to consider the application respondent No. 6, of the petitioner and other pending application for a license for the year 1961 on merits and in according with the provision of rules In dealing with these applications the Licensing Authority will have to dispose them of in accordance with the provisions of clause 5 of the control order, 1961, such other provisions of law as have a baring thereon and I submit Sir, that so far as the second ground is concerned the matter has not finally been disposed of by the supreme Court but it has been referred back to the Statutory Authority with certain directions and the matter therefore is pending. It

will not be desirable to raise any discussion at this stage as such discussion is taken to prejudice and interfare with the exercise of discretion of the Licensing Authority. Therefore I submit that under rule 59 of our Assembly Rules this motion cannot be allowed 59. This rule reads as follows: "59. Motion for discussion on matters before tribunals, commissions, etc. No motion which seeks to raise discussion on a matter pending before any statutory tribunal or statutory authority performing any judicial or quasi-judicial functions or ny commission or court of enquiry appointed to enquire into, or investigate, any matter shall ordinarily be permitted to be moved".

Shri GAURISANKAR BHATTACHARYYA (Gauhati) hon. Minister has just now said that only with regard to one point the matter has been referred back to the appropriate authority or tribunal. Now, so far as this motion is concerned, it does not want to discuss any matter which is pending before any statutory tribunal or statutory authority performing any judicial or quasi-judicial functions. The motions only wants to discuss the situation which has arisen in the State of Assam as a result of the decision of the Supreme Court on the State monopoly on trading. Now, as the motion does not seek to discuss the merits or otherwise of that decision or does not seek to discuss the particular point which has been referred back to the appropriate tribunal, I do not think Sir, that Rule 59 can be invoked in this connection because so far as the adjournment motion is concerned it only says that it seeks to discuss the situation which has arisen in the State of Assam as a reslut of the Supreme Court's decision on the Government's policy of State Trading and therefore, we have to see whether this motion covers the fundamentals that are necessary under Rule 56, that is to say, whether this matter is an urgent matter, whether this matter is a definite matter of recent occurrence and whether this matter is of great public im-

Now, naturally this question of State Trading is a matter of great public importance, there can perhaps be no doubt a out it. So I need not elaborate that point at all,

That this matter is of "urgent" public importance also does not require any explanation because as a result of the judgment of the Supreme Gourt the entire structure of our grain trade has come to a crisis. What will happen to the hundreds and thousands of co-operatives that are depending on this State Trading? What will happen to the Marketing Society which was given the monopoly of trading in paddy and rice in the State? So, this matter is of public importance and it is of "urgent" rublic importance. It is also definite because this pertains to the definite matter of grain trading. It is also of recent occurrence, namely, emai ating from the recent judgment of the Supreme Court. When we see that these three aspects are really fulfilled in this motion, without going into the merits or otherwise of the findings of the Supreme Court, I feel that this matter can be discussed. If the Minister of course, has other reasons, that is different. But taking into consideration the point which the Minister has just now given and the arguments made out by him, I do not think they are convincing enough to say that this motion is barred under Rule 59.

*Shri FAKHRUDDIN ALI AHMED (Minister, in-charge of Supply): Sir, the Adjournment Motion moved by Shri Hiralal Patwary and others says that "This Assembly do now adjourn to discuss the serious situation arises on the fact that the hon. Supreme Court has declared the State Trading (Monopoly of purchase of paddy) void recently."

Sir, my submmission is that no serious situation has arisen for the simple reason that order which has been upheld by the Supreme Court was not passed by the authority concerned. Therefore, the matter has been referred back to the authority which has passed the order.

Now, Sir, so far as the motion is concerned, it must be definite, there must be definite public importance and it must be of recent occurence. That an order has come from the Supreme Court is not enough. It will only depend after the matter has been considered by the Government in the light of Supreme Court's decision. So, Sir, it is not desirable to discuss the matter now.

*Shri HIRALAL PATWARY (Panery): Sir, I do not like to discuss the judgement of the Supreme Court. My point is, Sir, if Government issue all licences to the private parties, then what will be the position of the private parties of existing Co-operative Societies? Hence for the interest of Co-operative, the matter is most public importance.

*Shri BIMALA PRASAD CHALIHA (Chief Minister): The question of issuing licences to the Co-operatives will be taken into consideration along

with the private parties

Mr. SPEAKER: As Shri Gaurisankar Bhattacharya has pointed out that for the admissibility of a motion three things are necessary. Firstly, it must be definite, secondly, the matter must be urgent and thirdly, it must be of recent occurrence. I do n t think, the present motion, fullfils all the three conditions. There is no doubt, that it is of public importance and also of recent occurance, but regarding the urgency of the matter, I differ from Shri Gaurisankar Bhattacharyya. Because the matter is not a new thing though some information has been supplied anew by the mover of the motion. This is a matter which has been continueing for some time. The matter was in the High Court then in the Supreme Court and the Supreme Court has not finally adjudicate upon it. They have referred the matter to Government licensing authorities to review it again. May's Parliamentary Practice, at page 370, we find that-

"The fact that a grievance is continuing is not sufficient if it is not of recent occurence. The fact that new information has been received regarding a matter that has been continuing for some time does not in itself make

that matter one of urgency."

So, it is not correct to hold that the motion has satisfied all the three

conditions for an Adjournment Motion.

On the above grounds I hold that the subject matter of the motion is not sufficient for an adjournment motion. Hence I rule it as out of order.

However, if time would have permitted I would have requested the Government to give some facilities to Members to discuss this important subject in the floor of the Assembly. As our Agenda is full and tight I find no scope for that even. I hope hon. Members moving the motion will therefore kindly exc se me for not being able to accommodate them.

Calling attention to matter of urgent public importance under Assembly Rule 54 Re: Sense of insecurity growing in the minds of the people living in Naga Hills border of the State.

Shri PHANI BORA (Nowgong): Mr. Speaker, Sir. I beg to draw the attention of the House under Assembly Rule 54 on a very important and urgent matter of the public importance. Sir, the Government of Assam has extended the period of operation of the Disturbed Area Act declaring Silchar and Karimgani Sub-divisions as disturbed areas for another year and the same Act also is in operation in the Districts of Sibsagar, North Cachar and Mikir Hills and it is due to that fact that there is no peace in the minds of people and that the hostile elements from Naga Hills are constantly disturbing the peace and security of people living in the border areas. Therefore, Sir, so far as the information goes, people in the border areas are constantly sufferring from fear and insecurity of the hostile Nagas. This sense of panic and insecurity increases particularly after the murder of Dr. Ao and as the murderer of Dr. Ao could not be traced uptil now and as further looting arson etc could not be prevented. Some villagers in the Sibsagar District left their home and some are passing sleepless nights. Many people from Aham Pathar and other bordering villages have already evacuated. Immediately after splitting up of Naga Hills District from Assam, everybody expected that peace and security would be restored and people in the neighbouring areas would live in peace. I he hope by the people is belief. It was allowed the people is belief. people is belied. It was also assured in the Governor's Address delivered in this House in the last Budget Session. But due to recent disturb law and order situation in Naga Hills, peace and security in the neighbouring areas also disturbed. The question of security and insecurity in Assam should not be dependent on the situation in the Naga Hills. People of Assam are always looking forward for their own interest only. But when people see insecurity and breach of peace in the neighbouring District, naturally they will be paniky. Now, immediately after the murder of Dr. Ao many unknown factors have come to light. These are not now unknow to the public in Assam. Although administration of Naga Hills is not within the purview of discussion of this House; developments that take place in Naga Hills definitely influence the people living in the adjoining areas of Naga Hills. So I can not but refer to some of them. Attempts are being made to negotiate with these hostile elements who are considered as the causes of disturbance and in ecurity in the State of Assam also. Negotiations are going on and we find that on the opening day of the Interim Body Council the Councilars themselves complained that Dr. Ao was killed because he was not even provided with a single vehic'e and no step was taken to protect and save his life. Moreover allegations are there that the officials go and contact with the hostile people and as a result of that the Interim Body feels that.....

Mr. SPEAKER: The question of murder of Mr. Ao and whether protection was given to him by the Central Government do not come under the purview and scope of this discussion in this Assembly. Therefore you insecurity of the State.

Shri PHANI BORA (Nowgong): I have only tried to refer to the effect and reaction that is there. That the counsellors are considered as only peon, and clerks there are undermind by the officials.

Sir there is one retired Government official, and it is everywhere known that this gentleman is in direct contact with the hostiles and he is also in direct contact with the Governor who is also our Governor and who can be called the common friend of both of us. I also keow that the gentleman whose name is Mr Kevisuisha had an interview with our Chief Minister. We do not know what were the talks about. Sir, talks are also going on with regard to the bringing in of the hostile elements to the administration, and this thing has created some confusion in the minds of our prople in the State as to whether these hostile elements are to be relied upon in order to restere peace there, because restoration of peace there only creates condition for the restoration of peace and s curity in the State. So, if all these matters are left confusing and are not clearly explained by our Chief Asimister and our Governor to our people then the people cannot have a clear idea whe her in the near future peace will be restored in the Naga Hills and as a result of that we can feel secure so that our people also feel that at least in the near future this kinds of things will not happen.

Sir, I do not want to take much time of this august House. I only want that the Chief Minister should take this House into confidence and tell us what is going on. Our Chief Minister knows very well about the whole thing and so he can tell the people what is their duty, what would be their attitude towards these developments in the Naga Hills. My only concern is that there should be peace and tranquility in the Naga Hills and also there should be security and peace in the border areas of our State, and unless and until this is done then the entire people living in the border areas will have to pass sleepless nights, always apprehending attacks from the other side of the border. If this thing goes on I think it will not be good for the whole country. Great conspiracies are also suspected that attempts are being made to hand over the entire administration to the hostile Nagas. If all these things are correct then tell the people clearly as to what would be their attitude towards solving this matter. Therefore this thing has agitated the minds of the people. Everyday news are appearing in the News Papers about the Naga hostilities. Therefore, I hope that there should be claer statement from the Government on these matters.

*Shri BIMALA PRASAD CHALIHA (Chief Minister): Mr. Speaker, Sir, I had occasion to refer to the raids by Naga hostiles in the bordering districts of Assam during the Budget Session of the Assembly in March, 1961. In my statement before the House, I had given a detailed account of the incidents which took place during the year 1959-60 and upto the end of February 1961. In response to the Calling Attention Motion tabled by Shri Phani Bora, I wish to place before the House details of incidents which took place from March, 1961:

On March 13, between 0040 hours, and 0115 hrs. the Naga hostiles fired on our Army Patrol Special Down Train between Rangapahar crossing and Rangapahar siding. There was heavy exchange of fire between the Army and Naga hostiles. The place of occurrence was at mile post No.415/4-5 where two broken sleepers were found on the Railway track the next morning (14.3.61). The two sleepers were probably used by the Naga hostiles to stop the train. Special piloting of passengers trains by search light engines at night was arranged in the affected area of the Railway line.

On April 3 at 1540 hours, the Naga hostiles fired at the down empty patrol special train from the right side after it passed through the Tunnel No.5 between Mupa and Marbong. Two bullet marks were seen on the right side of the engine. It was suspected that the party stayed at Guilarg on April 2, and moved along the Mupa river towards the Railway line.

On April 28, at dawn Naga hostiles in batches of 4 or 5 wearing olive green uniform and armed with rifles and bayonets simultaneously raided Bandar Solla, Paninala, Deoghoria, Bahond and Kheremia villages, and took away ten shot guns and some cartridges belonging to inhabitants of those villages. About 40 Nagas armed with pistols, service rifles and shot guns raided the villages in batches in quick succession. They caught hold of 5 villagers and compelled them to show the houses raided, under threat of death. Besides guns, they looted cash about Rs.7464 and 28 gold mohurs of the Ahom Kings from a house at Kheromia and cash of Rs.1,708 and a wrist watch from one house at Bahoni. At the approach of the Police Patrol, the raiders retreated under cover of fire to thick jungle.

In the early morning of April 29, an armed gang of Naga hostiles dressed in olive green uniform raided Tingajan village and looted two shot guns, with four cartridges and cash about Rs.220.

On June 18, three Kabui Nagas of the hosrile par y visited Abinbasti of Manipur and demanded Rs.10 from each house as House Tax from the villagers of Abinbasti, Mandu and Kedeikabasti under threat of villence in case of default.

About 30 Naga hostiles armed with rifles were reported to be moving in Khelma area of Naga Hills bordering North Cachar.

On June 26, 10 Naga hostiles visited Prasadindik village and looted two guns and cash of Rs.200 from the villagers, after which the party left towards Langting side.

The gaonburah of village Bangkhai reported that on July 26, about 10 Naga armed with three rifles and Khukhris raided their village and decamped with booties worth Rs.778.

On the night of June 27/28, about '2 hostile Naga dressed in olive green and armed with rifles raided three Nepali houses and one Kachari Some Nepalis and Kacharit of the village were also kidnapped by the after taking them to a distance of 1 mile from the village.

The untimely death of the Naga leader, Dr. Ao, took place on the 22nd of August, 1961. As will be seen from what I have said above, it is not a fact that since the death of Dr. Ao, the Naga hostile activities have considerably increased. Though on one or two occasions in September, some information was received regarding the movements of a few Nagas has not been any raid or other incident in any of the bordering districts of Assam since the 22nd August 1961 till today. The House will appreciate

that it is not possible for me to give details of the measures taken by Government in the interest of security. I may, however, assure the hon. Members that Government are keeping a close watch on the situation and are in contact with the Army authorities, and are taking all measures which are necessary and possible in the circumstances. In particular, I may add that steps have been taken for increasing the mobility of our Security Forces by construction and improvement of border roads and increasing the number of the Border Out-posts, where called for.

Sir, in this statement I have tried to give the number of incidents which have taken place since my last statement which I made in the Budget Session of the Assembly. The hon, member has raised certain points with regard to the administrative policy in Naga Hills. Sir, I am not quite sure whether it will be proper for me to discuss the administrative matterrs relating to Naga Hills here.

Mr. SPEAKER: That is outside the scope of this House.

*Shri BIMALA PRASAD CHALIHA (Chief Minister): But at the same time I would like to tell here for the information of the House and I hope the hon. Members will appreciate that it is in the interest of this State as well as in the interest of the other neighbouring areas we are keeping ourselves informed about the various developments in the Naga Hills. I am grateful to our Governor for frequently keeping me informed about the various developments in the areas which are directly under his administration.

The hon. Member has referred to an interview or a discussion which I had with Mr. Kevichusa. Sir, it is a fact that I had an occasion of discussing with Mr. Kevichusa recently and my discussions with him were, naturally, informal. I wanted to know from him about the developments there because I have not personally gone to Naga Hills for a long time also wanted to know his views and suggestions as to how peace can be restored in Naga Hills because Naga land being a contiguous to our State we are very much interested in restoration of peace and prosperity in that area. The discussion was pretty long. At first I tried to ascertain from him as to why he, after joining Naga Peoples' Convention in its first session, could not find himself in a position to continue in the association of the Naga Peoples' Convention. The second point which I wanted to know from him is about the peace and prosperity in the Naga Hills and the present situation obtaining there. Sir, as you know, Mr. Kevichusa is a retired Government Official and he served Assam Government for a long stime and he is a very important person in the Naga Hills. Therefore, Sir, I felt that I should avail of that opportunity of discussing with him about the present situation there and also to know his views. Sir, it is not only Mr. Kevichusa with whom I discussed ab ut Naga Hills but also with others. As a matter of fact I missed no opp rtunity of discussing this matter whenever I met a Naga friend or a known person. In belief, the views of Mr. Kerichusa are that first pricrity should be to bring peace in Naga Hil's. With regard to political settlement, his view is that it is not very important at this moment. As a matter of fact his view is that negotiation for political settlement might even delay restoration of peace there. I could not, naturally, or should not, give my views in this matter because I am not in touch with this matter for a long time. There was a time, of course, when I had frequent contact with the people of Naga Hills, but for the last few years I have not been able to

go to Naga Hills. So, Sir, I did not feel myself competent to give my views in this matter to anybody. In any case, I tried to know the mind of Mr. Kevichusa and all that I could understand from him is that he wants peace to be restored in Naga Hills first and then the que tion of political

settlement might com".

As far as my knowledge goes and whatever I could know from the Governor, there is no contemplation for change of policy for the administration of Naga Hills. That is all that I have to submit Sr. I think the hon. Members will appreciate that for obvious reason for security—I have not given the details with regard to the measures which are already in force and which are contemplated to be taken in the statement I have made in this House.

Mr. SPEAKER: The motion moved is that the Assam Secondary Education Bill, 1961 as amended be passed.

(The motion was put as question and adopted)

The Sylhet Tenancy (Amendment) Bill, 1961

Mr. SPEAKER: There is no amendment in clauses 1 to 13, so I put the main question. The question is that the clauses 1 to 13 of the Sylhet Tenancy (Amendment) Bill, 1961 as reported by the Select Committee do form part of the bill.

(The question was adopted)

Shri TARUN SEN DEKA (Nalbari-West): Sir I beg to move that in in the proposed new section 217 going to be i serted by clause 14 after sub-section (1) the following shall be adde:—

"Explanation—Khanabari of the land'ords means for the purposes of this Act, the area of the homestead lands with compounds of the landlord occupying with his family uptil 3 st March, 1961."

Shri HARESWAR DAS (Minister Revenue): Sir this amendment is out of order, because the word "Khanabari" has been defied in the main Act itself under section 143 (1) (c). If this amendment is accepted then there will be two explanations.

Mr SPEAKER: Mr. Deka, will you withdraw your amendment?

Shri TARUN SEN DEKA: Yes Sir. Now I move the other amendment. Sir, I beg to move that the proviso to sub-section (3) shall be substituted by the following:

"Provided further that the occupant shall be given lands of equal area within the vicinity, with reasonable compensation for the houses."

Sir, the main object and reason of this bill is to give some right to the tenants. By this Act the right of the tenants living in the Khanabari area has denied. But here Sir, in the proviso to the Original clause it has

"Provided further that if the occupant has constructed a house in the homestead land at his own cost for his dwelling purpose the landlord shall pay reasonable compensation to the occupant before the land is actually resumed."

But my amendment seeks to protect the interest of the tenant by giving equal area of land in the vicinity. I am told there are a great number of tenants living in the Khanabari area of zamindari and they are actually landless people and if they are driven away from that area or if they are evicted from this area without giving them at least the equal area of land in the place it would be had it to them. Because these people

are living there for a long time and they have formed a community together in that area adopted the same customs and mode of living etc. If they are not given land in the same vicinity and if they are driven away to distant place the homogenous and compact living of these people might be affected and therefore I submit Sir, that equal area of land and also reasonable compensation for the houses should be given, but here, Sir, in the original Bill it has been referred to as 'if the House is constructed by the tenant' but in my amendment it has been stated that if a tentant is to be leave his place, leave his house, compensation must be the given by Zamindar even though he does not construct any house thereon. The purpose this amendment is this that if years together when a man lives in particular area or a house, though the house may belong to the landlord, still then he makes some improvement in that area, in that house, where he stays. If one fine morning if he is to leave the place and the house, it is not possible on the part of poor tenant to construct a separate house on a separate plot of land if any compensation is not given by the landlord. While this tenant is serving under the landlord surely it is from the point of view of equity and justic also, these landlords, even though the houses may belong to them, give resonable compensation to the tenants so that the tenant can erect his own house on a separate plot of land. So when the purpose of the main Bill is to give some rights to the tenants my amendment is an appropriate one and I hope it will be accepted by the Revenue Minister.

Shri HARESWAR DAS (Minister Revenue): Sir, I am unable to accept this amendment. My Friend has missed the entire thing. It is clause 217 and under Sub-clause I, he has tabled no amendment.

The existing sub-clause stands like this

"A person who holds land of another person, under the system known as "Chakran", "Kiran", Non-kar", "Etmandar", "Bhandari", or the like, shall not be deemed to have acquired any tenancy right in respect of the homestead land occupied by him within the Khanabari of the landlord."

Under the proposed amendment he has sought to pay compensation to the tenant by the landord even when no tenancy right has been acquired. That is an absurd thing.

Shri GAURISHANKAR BHATTACHARAYYA (Gauhati): How can it be, Sir?

Shri HARESWAR DAS (Minister, Revenue): Because the occupier has acquired no right over the land, the landlord cannot be comepiled to pay copensation for such land.

Mr. SPEAKER The amendment is not under Sub-clause (1) Section 217 which gives no rights to the tenants.

Shri HARESWAR DAS (Minister, Revenue): Here Shri Bhattacharyy ais making a mistake. This section deals with Khanabari land and in Khanabari land the occupier acquire no rights. Therefore this amend ment is not in order.

Shri TARUN SEN DEKA (Nalbari-West): I was saying that if the man has no land.......

Mr. SPEAKER: You have accepted Section 217/1) which gives no rights to the tenants. So this amendment is out of order.

Shri TARUN SEN DEKA: I move that in sub-clause (5) after the word "thereto" in the fifth line, a (,) "coma" and the words "and cost of improvement of the land shall be inserted; and the words "but not the value of the land used for such reconstruction" occurring in the fifth and sixth lines shall be deleted.

Shri HARESWAR DAS (Minister, Revenun): As the other two have been rejected, this is merely a consequential one, this also should be rejected.

The SPEAKER: This also stands rejected, as this is out of order. I now put the question. The question is that the Clause 14 of the Sylhet Tenancy (Amendment) Bill, 1961 as reported by the Selec. Committe form part of the Bill.

(The question was adopted)

The questions is that the short and long title of the Bill and the preamble of the Bill do form part of the Bill.

(The question was adopted)

Shri HARESWAR DAS (Minister, Revenue): I beg to move that the Sylhet Tenancy (Amendment) Bill, 1961, be passed.

The SPEAKER: Motion moved is that the Sylhet Tenancy (Amendment) Bill, 1961 be passed.

Shri TARUN SEN DEKA: I am opposing this Bill. Sir when in the objects an reasons it is stated clearly that this bill wants only to give rights to the tenants, in some sections it has denied the rights to the tenants and it has failed to protect the interests of the tenants. Sir, in the last session of the Assembly my friend Sh i Gopesh Namas drab brought a Bill to this august House and this Bill sought to give rights to the tenants. At that time the Revenue Minister assured the House and stated that a comprehensive Bill would be brought to this House. After that assurance, different corners of this House, he was compelled to bring this Bill. But, Sir, I have found that this Bill has failed to protect the interests of the tenants who live in the Khanabari area of the landlords. When we are fail to protect the interests and rights of the ten nts, we will be failing in our duty. So, Sir, when this Bill has failed to protect the interests of the tenants living in the Khanabari areas of the landlords, I strongly oppose the passing of the Bill.

Shri GAURISANKAR BHATTACHARYYA (Gauhati): Sir, I see that my friend Shri Deka is rather indignant and I think rightly indignant; because a very important omission is there in the Bill in that so far as the tenants, or rather I would say so far as the persons remaining in the 'Khanabari' area of the landlords are con erned, they will be denied all the facilities that are sought to be given by the amending Bill. That of course, makes the Bill a very week one because the purpose of this Bill was a laudable one. Even after so many years Indepen ence we see that there are serfs in some parts of our State, namely in Karimganj subdivision, in the name of chakran, kiran, monkar, etmandar, bhandari etc., this is the worst type of feudalism and it is still there in the State and therefore, when there was a move from the side of Government to do away with these remnants of dirty feudalism we were really very happy and if I remember alright, when my friend Shri Gopesh Namasudra came forward with a Bll, the Minister was pleased to say that he very much appreciated the idea which prompted Shri Namasudra to come with the proposed Bill. The Minister said that he would come with a more comprehensive Bill whe eby all the remnants of feedalism would be removed from the subdivision of Karimganj and it must be admitted that the present Bill is wider in its scope than the Bill which was brought by Shri Namasudra. To that extent the Minister should get our congratulations and thanks.

Now Sir, I am rather in a tight corner and that is because of this omission of the homestead land in the 'khanabari' that keeps some people in a difficulty, as the sections in a difficulty as they were in the past. I see that some oppressed sections of the people like those with the past. I see that some oppressed sections of the people like those who are in the system of chakran, kiran, nankar, Bhandari etc. will be who are in the system of chakran, kiran, nankar, Brandari etc, will get some benefit under the Bill. We cannot, therefore, oppose it. We cannot also whole-heartedly support it because of the omission of "Khanal also whole-heartedly support it because of the Rill This omission of "Khanabari" occupiers from the benefits of the Bill. This Zamindar or the land, a personal estate of the Zamindar wherein the Zamindar or the landlord has his own house also. Unlike us poor people who keep small and lord has his own house also. who keep small orchards or compounds or kitchen gardens, these landlords are in the habit of landlords or compounds or kitchen gardens, these landlords are in the habit of keeping very big plots of land where they can have their "khana" and for their "pina" and many other things also. Therefore, this area is not their "pina" and many other things also. fore, this area is not to be construed as one which is absolutely necessary for the innocent personal purposes of the landlord. But, of course, technically the Minister was right when there were no amendments in some clauses. What I do not understand is why the Minister himself cannot say that the amendment is a consequential one. I do not want to impute any motive to the M nister; but I want to say that this attitude towards the khanabari should not have been taken by him. At any rate, we shall be happy if we get an assurance from the Minister that so far as the other actors are concerned at least those factors in the Bill, when it is enacted, will be implemented at least those factors in the Bill, when it is enacted, will be implemented quickly I have to make this request because in Karimganj the people there are in great difficulty. The Acquisition of Zami dari Act was a transfer of the control of t Zami dari Act was passed in 1951 or something like that, at any rate it is now ten years. The zamindaries exist ng in Goalpara have been taken over by the Government of Karingani over by the Government; but up till now the zamindaris of Karinganj subdivision have not been taken over by the Government. Even the preliminary surveys have not yet been completed, they are still in the process and if I remember aright, during the last session the Minister was pleased to say that this can be completed by now because there are certain special complications and one of such complications was that there are some petty zaminders who have got only some bighas of land and yet they go by the name of zaminders. If that is so, it is all the more necessary that

there should be taken particular care by the Government to settle up the issue promptly because if the zamin ler be a big one he can go on with his luxuries even at a lower rate of rent from the tenants, he can satisfy all his needs taking a lower rate of rent from his tenants. But if the zaminder is comparatively a small one, he will require a bigger rent because he also shall have to maintain him elf in Zamindar like luxury. If a zamindar is a small one, if he has only, say, 30 bighas of land, he cannot afford to live in the style of the Raja of Gour pur taking only a small rent from his tenants. Therefore, it is very necessary that the issue be settled quickly. Let us hope, therefore, that Government will take steps to settle these things quickly, urgently and speedily and whatever good provisions are there in this Bill will be implemented forthwith and without any further delay.

Shri KHOGENDRA NATH BARBARUAH (Amguri): Sir, I also oppose the passing of this Bill While supporting the observations made by my Friends from Nalbari and from Gauhati, I want to say that this word 'Sylhet' is a misnomer. Sylhet as we all know is in the jurisdiction of a foreign country. If in tead of this name Sylhet, the name of Karimganj is put, I would have accepted this Bill.

Shri HARFSWAR DAS (M'nister, Revenue): It is not the name of a country here. It is name of the Act. This procedure is followed all over the world. As for example, we have the Bengal Court of Wards Act, the Bengal Public Demands Recovery Act and many such other Act in force in our State.

Shri KHOGENDRA NATH BARBARUAH: However, Sir, that is my only objection.

Shri GAURISANKAR BHATTACHARYYA (Gauhati): We have also so many instance in Bengul.......

Mr, SPEAKER: Mr. Das, how long will you take to conclude your speech? It is already 11-30 A. M.

Shri HARESWAR DAS (Minister, Revenue): Sir, I will not take more then 6 or 7 minutes to finish my speech.

I assure the hon. Members that actually there is no cause for misapprehension. We cannot confer rights on one section of people divesting another section. The Bill provides that a person, who occupies land of another person under the system of non-kar, chakran, etc., does not acquire any tenancy right within the Khanabari of the other person. Now what is Khanabari? Khanabari is cefined in Section 143 (i)(c) of the Act—it is an area, whether cultivated or not reserved by the proprietor for the accommodation of his family and relations or of his personal and estate staff for which no rent is realised and this must be so recognised at the time of passing of the main Act, i. s. in 1936. A landlord cannot point out any plot as his Khanabari now. This is a very reasonable provision.

As regards area of Khanabari, my friend Shri Gaurisankar Bhatta-charvya has made a reference. Sir, all Zamindars in Sylhet are not very big landlords. They cannot be compared with the Zamindars of Goalpara. In Goalpara two third of the District is under Zamindary covering an area

of 18 lakhs acres. There were actually six families of Zamindars though there are 19 entries in the Torji. But in Karimgan, 1,82,000 acres of land are under Zamindari but the number of Zamindars is 5,063. From this, you will realise that they are not so big as Shri Gaurisankar Bhattacharyya said. So, those areas kept reserved for Khanabari under these Zamindars are naturally not very big. Now, if a laddord keeps an area for his own people and does not realise any rent from the occupier, if any, because he does not want another man to acquire any right over it, it will be unreasonable to allow acquisition of right by a permissive occupier, over such land.

Shri Gaurisankar Bhattacharyya has again raised another point. He said that we have uptil now not acquired a single Bigha of land in Karimganj. This is not correct. We have acquired over 50,000 acres of Zamindari land and some land will be acquired in the next year. Besides the biggest Zamindari, Dewan Manikchand Estate is under the management of the Court of Wards. I assure my friends that we want to implement this Act immediately.

Shri Gopesh Chandra Namasudra's name has been referred to. I like to say in this connection that I have had discussions with him two or three days back. He wanted the d finition of Khanabari and when he was told hat it was in the main Act, he opined that he had no other objection. He is no here in this House, but he is in the visitor's gallary.

This is the position. So, I request the hon. Members to withdraw their objections and allow the Bill to be passed.

(The objection was withdrawn).

Mr SPEAKER: The question is that Sylhet Tenancy (Amendment) Bill, 1961 be passed.

(The question was adopted).

Adjournment

The Assembly was then adjourned till 10 A. M. on Saturday, the 7th October, 1961.
