DEBATES OF THE ASSAM LEGISLATIVE ASSEMBLY

Ruling from the chair fath December

The 14th December 1992.

The House met at the Assembly Chamber at Dispur, at 9 A.M. on Monday the 14th December 1992 with Shri Debesh Chandra Chakravarty, Deputy Speaker in the Chair,

Shri Promode Gogoi: Mr. Deputy Speaker sir, we have a point of order.

Mr. Deputy Speaker: Please listen to me.

Mr. Deputy Speaker: Honourable Members Shri Prafulla Mahanta, Shri Chandra Mohan Patowary, Shri
Hitendra nath Goswami have requested me to suspend
the Question Hour. I have also received such letters
from various groups to suspend the Question Hour. So
in difference to their wishes, I suspend to-day's Question
Hour and adjourn the House till 10 a.m. to-day.

I request leaders of all the Legislative Groups, Parties and Honourable Parliamentary Affairs Minister and Law Minister to come to my chamber to discuss the issue.

RULING FROM THE CHAIR DTRATES OF THE ASSAMILEGISLATIVE ASSEMBLY

The House re-assembled at 10.00 a.m. with the Honourable Deputy Speaker in the Chair.

Mr. Deputy Speaker: I called a meeting of the Leaders of all the Legislature Parties/Groups in the Speaker's Chamber and in the discussion two decisions were taken unanimously:

- (1) The House in exercise of the powers under Rule 299 of the Rules of procedure and Conduct of Business in Assam Legislative Assembly will stand adjourned for one week till 9 A.M. of 21st December, 1992 (Monday). 12 Youngel : Mr. Deputy 1. (Monday). have a point of order.
- That from 21st December to 24th December, 1992, (2) the House will sit in two Sessions every day from 9 A.M. to 1.30 P.M. and from 2.30 P.M. to 4.30 P.M.

In the meantime, I inform the House that I have just received information from the Leader of the House that the Government has decided to held a judicial enquiry by a sitting or retired judge of the Gauhati High Court into the happendings in Nagaon District from the 7th December, 1992 including the administrative failure, if any.(interuption)...... (Many honourable members in the oppostion were on their legs demanding that the enquiry should be held not only in Nowgong district but also throughout the entire state). Mr. Deputy Speaker: I also called a meeting of the Business Advisory Committee in the Speaker's Chamber immediately after the sitting of the House is over. I also invited Dewan Jainal Abedin MLA as a special invitee

Accordingly, I adjourn the House till 9 A.M. on 21st December, 1992.

ADJOURNMENT

The House then rose at 10.05 A.M. and stood adjourned till 9 A.M. on Monday, 21st December 1992.
