Proceedings of the Fifth Session of the Assam Legislative
Assembly Assembled after the Seventh General
Elections under Sovereign Democratic
Republican Constitution of India.

Shri Purna Boro asked:

- \*63. Will the Minister, P.H.E. be pleased to state-
  - (a) Whether Government is aware of the fact that Piped water supply projects at Tengajhar Pukhuripar and Debok village under Goreswar and Rangia Circle.

have not yet been completed?

- (b) If so, when would the project be completed?
- Shri Darsing Teron (Minister, P. H. E.) replied:
  - 63. (a)—Yes.
  - (b)—Efforts are being made to commission the Debik and Tengajhar piped water supply Schemes by March, 1985. Works on Pukhuripar piped water supply scheme could not be commenced as the drilling Rig to drill the Deep Tube Will can not be taken to the site due to damaged condition of three Bridges.

  - (a) Whether Government is aware that the B. D. O. Matia Development Block distributed T. S. P. grants to persons living outside the T. S. P. area during the year 1983-84?
  - (b) If so, the reasons thereof?
  - (c) What are the schemes undertaken inside the T. S. P. area showing the amount involved in each?
  - (d) What are the Schemes undertaken outside the T.S. P. area showing the amount involved in each?
- Shri Raghunath Pamegam (Minister, Rural Development etc.) replied:
- 64. (a)-No, Sir.
  - (b)—Does not arise.
  - (c)—Only one scheme under Group Housing amounting to Rs. 24,000 was adopted in the Steering Committee meeting on 22nd December, 1983.
  - (d)—A statement showing the Schemes undertaken outside the T. S. P. component is laid on the table of the House.

# Re. Appointment under Regulation 3(f)

Shri Binoy Kumar Basumatari, asked:

- \*65. Will the Minister, Panchayat and Community Development be pleased to state—
  - (a) The member of persons appointed under various posts, under regulation 3(f) of Assam Public Commission, in Panchayat and Community Development Department?
  - (b) Whether the Government will lay a detailed statement of persons and posts filled up under such arrangement on the table of the House?

- (c) Whether population pattern has been reflected on these appointments?
- (d) Whether, Departmental Officers have also been upgraded to fill up such posts?
- (e) If so, on what basis?
- Shri Tilok Gogi (Minister, Panchayat) replied:
  - 65. (a)—32 numbers of Block Development Officers were appointed under 3 (f) of the Assam Public Service Commission (Limitation of Functions), Regulation, 1951.
    - (b) Yes, A list of the persons has been placed on the table of the House.
    - (c)—Yes, as far as practicable, every endeavour has been made to reflect the population pattern in the matter of such appointment.
    - (d)—Yes, 48 posts of Block Development Officers were filled up by Department promotion under 4 (d) of the A. P. S. C. Regulation out of which 29 posts has already been regularised by the A. P. S. C. and the names of others are being sent to A. P. S. C. for regularisation.
    - (e)—On the basis of seniority cum merit. However due preference was also given to fill up the promotion posts with S. C/S. T. (P)/S.T. (H)/Tea Garden Labour, Minority and O. B. C. Community.
  - Shri Binoy Kumar Basumatary—Mr. Sir, in reply to 65 (a) out of these 32 BDOs how many are ST., SC and

Backward Class people and in reply to 65 (d) how many are ST, SC and Backward class people?

Shri Tilok Gogoi (Minister)—Mr. Speaker, Sir, I want to give information to the House about the entire position of the Department.

In the year, 1976 the APSC recommended 66 candidates on requisition of this Department and all these 66 candidates were appointed as B. D. Os in the same year. Out of these 66 candidates, 6 did not join and these 6 posts were proposed to be filled up under regulation 3 (f) of APSC as urgency demanded. Meanwhile, personnel Department were moved to allow recruitment of BDOs under regulation 3 (f) of APSC which they agreed and suggested to adopt resolution lying down procedure for recruitment in the absence of service Rules. Accordingly, a reslution was drafted in consultation with APSC which was approved by the Executive Committee on 9-10-82 (during Presidential Rules).

Meanwhile, the vacancies increased to 80.

Shri Binoy Kumar Basumatary—Sir, with due apology I want to interrupt and say that the Hon'ble Minister is reading out something which I did not want. My point is, out of this 32 how many are scheduled castes and Scheduled Tribes and other backward classes also with reference to Question (d) how many are S. C. and S. T. and Other Backward Classes?

Shri Tilok Gogoi (Minister, Panchayat)—Sir, I tried to

- give the exact picture so that other Hon'ble Members may also know the position.
- Shri Binoy Kumar Basumatari—What is the position about Question (d)?
- Shri Tilok Gogoi (Minister, Panchayat)—Scheduled Caste-5, Scheduled Tribe (Plains) -4, Scheduled Tribe (Hill) -2, Muslim -8 and General -29.
- Shri Binoy Kumar Basumatari—Sir, if we go through the list that has been placed on the table of the House I can locate only 1 Tribal, by title of course and with reference to Question (d) we have not been favoured with a list on the table of the House. Therefore, Sir, it is not possible for us to ascertain whether out of these 48, 5 actually belong to Scheduled Caste, 4 to Scheduled Tribes (Plains) and 2 to Scheduled Tribes (Hills) and so on. Now, Sir, I think, by this list of 32 as per reply (a), the job reservation provisions have not been honoured. What is the reason Sir?
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, total No. of vacancies was 88. Out of this some are to be filed up by promotion and some are to be filed up by direct recruitment. The figure is like this: SC-6, ST (P) -6, ST (H) -3, Muslim-16, Labour-2 and General-47. This is the entire picture. We have got some more appointment to be made later on.
- Shri Binoy Kumar Basumatari—Sir, with reference to Hon'ble Minister's reply, if we add up the figures

- shown at (a) and (d) it comes to 80 whereas the Minister now says there are 88 posts. Will the Minister kindly clarify?
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, this is because of the backlog. We are trying to fill up all these positions.
- Shri Binoy Kumar Basumatari-Sir, when will it be done?
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, it is under active consideration of the Government.
- Shri Hemen Das—Sir, will the Minister clarify the difference between 4(d) and 3(f)?
- Shri Tilok Gogoi (Minister, Panchayat)-4 (d) is meant for departmental promotion and 3(f) is meant for direct recruitment.
- Shri Hemen Das—Sir, whether promotion posts are to be regularised by the A. P. S. C.?
- Shri Tilok Gogoi (Minister, Panchayat)-Yes.
- Shri Hemen Das—Sir, I think Minister is not correct. When a person is promoted in that case if the post is a promotion post then the question of 4 (d) does not arise but if it is a new post out side the cadre probably it will be required. Will the Minister kindly clarify this?
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, nearly for all cadre posts approval of the A. P. S. C. is necessary.
- Shri Prosad Doloi—Sir, may I know from the Hon'ble

  Minister who are these 5 persons belonging to the

scheduled Caste who have been appointed?

Shri Tilok Gogoi (Minister, Panchayat) - Sir, the list has been placed on the table of the House.

- Shri Debesh Chandra Chakravarty—Sir, the Hon'ble Minister has stated that the population pattern has been reflected but it has not been stated whether any candidate from the linguistic group such as Nepali speaking person was appointed because if population pattern is to be reflected the linguistic minority should not be left out.
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, there are so many candidates from so many minority communities that it is difficult to consider preference in all cases.
- Shri Debesh Chandra Chakravarty—But not a single person was appointed from the linguistic minority; or, were they not qualified?
- Shri Hiteswar Saikia (Chief Minister)—Sir, linguistic minority falls under many categories like Scheduled Caste, Scheduled Tribes and O.B.C. etc.—under many categories.
- Shri Hemen Das—Sir, I want another clarification from the Hon'ble Minister. If persons appointed under Regulation 3 (f) and 4 (d) are to be regularised by the A.P.S.C. then why 32 B.D.Os appointed under Regulation 3 (f) and some others under Regulation 4 (d)?
- Shri Tilok Gogoi (Minister, Panchayat)—Sir, there are different provisions. 50% posts are to be filled up by promotion and 50% are to be filled up by direct recruitment.

Shri Hemen Das—Sir, my point was—when all appointments are to be regularised by A.P.S.C. then why 32 persons were appointed under Regulation 3 (f) and another 48 posts were filled up Regulation 4 (d)?

Shri Hiteswar Saikia (Chief Minister)—Sir, in the matter of fresh appointments, Regulation 3 (f) is applicable and in the matter of promitions, Regulation 4 (d) is applicable.

  - (b) Does not arise in view of (a) above.
  - (c)—There is no such proposal at the moment.

- Shri Sirajuddin—How may schemes have been undertaken by the Government during this financial year?
- Shri Mukut Sarma (Minister)—We have one scheme this year and that is at Bangaigaon.
- Shri Altaf Hussain Majumdar—Sir, does the Hon. minister know that large number of students from Brahmaputra valley even with high marks go to Silchar for admission in the polytechnic there and also for ITI?

  In view of this will the Minister see that seats in the polytechnics and ITIs are increased?
  - Shri Mukut Sarma (Minister)—We have increased seats in the Silchar Polytechnic from 120 to 180.
- Shri Altaf Hussain Majumdar Sir, this increase of seats from 120 to 180 has been done earlier. Even now there is possibility to increase seats further as large number of students from Assam valley are going to Silchar for admission which will naturally deprive the students from Cachar and Karimganj districts. So, in view of the situation, will the Minister examine the question of increasing the seats further in the Silchar Polytechnics and ITI? The buildings and other facilities are there and only decision to increase seats further is to be taken.
- Shri Mukut Sarma (Minister)—Sir, we may examine it.

  Shri Umaruddin—Sir, the hon member has said that students from the Brahmaputra valley are going to Silchar for admission in Polytechnic and I. T. I. So,

- can't the need be met by establishing more Polytechnics and more ITIs here in the Brahmaputra Valley?
- Shri Mukut Sarma (Minister)—Sir, the Government has decided to examine the question of increasing some more Polytechnics throughout the State.
- Shri Hemen Das—Sir, last year some high schools have been upgraded into Higher Secondary schools and I do not object to such opening of Higher Secondary schools. But why can't we increase the number of Polytechnics and ITIs in Assam?
- Shri Mukut Sarma (Minister)-Sir, this is a personal opinion.
- Shri Hemen Das-No, Sir. In these trades there is a great rush by our youths. I do not object to the opening of Higher Secondary Schools. But in view of great demands for admission in Polytechnics and ITIs, what is the harm in opening more Polytechnics and ITIs in Assam?
- Shri Mukut Sarma (Minister)—Sir, I have already said that we are examining the question of opening more Polytechnics and ITIs.
- Shri Hemen Das—Sir, we want to know from the Minister about the proposal regarding opening of more Polytechnics and ITIs.
- Shri Mukut Sarma (Minister)—Sir, this is under examination stage.

  - Shri Mukut Sarma (Minister)—Sir, Director of Technical Education is examining the feasibility of establishing more Polytechnics in different parts of the State and and his report is yet to come.
- Shri Hemen Das—Sir, this is a serious matter and this should not be left to the Director of Technical Education. We want that a political decision should be taken in consideration of the youths of our State.
  - Shri Mukut Sarma (Minister)—Sir, the Government have already decided to have more polytechnics in Assam and the technical aspect of this is being examined by the Director of Technical Education.
  - Shri Altaf Hussain Mazumdar—Sir, what examination is necessary? Sir, it is known to everybody that large number of persons are coming from West Bengal and have been employed in Paper Mills because there is shortage of personnel in Assam who are trained in ITIs and Polytechnics. So, political decision to have more ITIs and Polytechnics in Assam is to be taken. The fact remains that there is need to have more polytechnics and ITIs in Assam as trained people from outside the State are coming and getting into the jobs. Are we going to sleep over this problem? Let the government take a political decision.

Shri Mukut Sarma (Minister)—Sir, the ITIs are not under the Education but under Labour department and so they can say.

Shri Hiteswar Saikia (Chief Minister)—Sir, the upgradution of High Schools into Higher Secondary schools has been done here with the introduction of 10 plus 2 plus 3 system of education in India. As you know Sir, we could not introduce this system of education earlier as a result of which many of our talented students had been refused admission in Delhi and other universities. So, the Government of Assam decided that we must introduce 10 plus 2 plus 3 system of education here and so we have upgraded some High Schools into Higher Secondary Schools. Regarding the opening of more Polytechnics in Assam we had examined and we propose to open more Polytechnics in Assam during 7th Plan period. We have now made elaborate schemes to see that more Polytechnics can be set up in the different districts of Assam.

The plan allocation will come from the Government of India. Regarding the ITIs we have proposed to the Govt. of India because these are set up by the Govt. of India only and so it depends on the Govt. of India. The Government of India sets up ITIs in every districts and now with the creation of more districts in Assam, we have proposed to the Govt. of India to set up more ITIs.

Shri Muhammad Umaruddin-So far as the Polytechnic

and ITIs are concerned, these come under the Technical Education, but it appears here the ITI has come under the Labour department. In many States in India, ITIs come under Technical Education. There are teachers in ITI who remain stagnant in service and do not have scope for promotion. So, ITI and Polytechnic should come under Technical Education.

Shri Hiteswar Saikia (Chief Minister)—For admission in the Polytechnics, the minimum education differs from that of ITI, in ITI there are some trades for which a non-matriculate is eligible for admission, we have proposed to have more Vocational Institutions in Assam and that would go a long way in meeting the demands of our students.

Shri Md. Umaruddin—The ITI standard of education is based on the technical education programme in India and so the ITIs will have to depend on the Technical Education and not on the Labour department.

Shri Hiteswar Saikia (Chief Minister)—Sir, the ITIs are set up by the Govt. of India in the Labour department and so we cannot bring this under Educational Umbrella. These are managed at the State level.

But the setting up of ITIs and even grants and other things come from the Govt. of India.

Shri Md. Umaruddin—Sir, I made a study. There are as many as 24 States of which 6 ITIs come under Labour Deptt. and others belog to Technical Education deptt.

Shri Hiteswar Saikia (Chief Minister)—We have no such information and we shall collect the same.

Shri Ranendra Narayan Basumatari (Mirister, Flood Control) replied:

4, (a) Yes.

It is a fact that Flood Control Department has taken up a scheme to divert the Borolia river along Bhoiratalajan leading to Brahmaputra through Hajo channel. But it is not a fact that the scheme has been taken up to drain out the water—logging of Borbhag Mouza.

(b) The Scheme of diversion of Borolia has been drawn up to channelise Borolia river along the Hajo channel leading to Brahmaputra which was once abandoned course of river Borolia. By bifurcation of Borolia and Pagladiya river it is estimated that flood levels in rivers will be cut down and if necessary, embankments on both banks of Borolia from Bhoiratalajan will be extended right up to the Brahmaputra embankment to stop any spilling from Borolia river and stop spilling from Back water of river Brahmaputra.

Shri Barkat Ullah—Mr. Speaker, Sir, there is an erosion, 34 villages have already been eroded completely. Sir, Hon'ble Minister has expressed his inability to take up permanent protection work. May I know from the Hon'ble Minister why the matter has not been taken up with the Central Government to save the area?

Shri Ranendra Narayan Basumatary (Minister, Flood Control)—Mr. Speaker, Sir, we have already sent three schemes for permanent protection work and so far, Sir, not a single scheme has got clearance. We still hope, Sir, that clearance will come in case of one or two schemes. The matter is still under correspondence for three schemes viz. Palasbari, Howli and Moriholla. Sir, all these three schemes will cost about Rs. 35 crores taken together. Therefore, Sir, the Hon'ble Member's request for drawing up schemes for permanent protection work does not seem to be appropriate. So far, we have not received approval to our schemes sent to them earlier.

Shri Barkat Ullah—May I know from the Hon'ble Minister as to what is the reason for not according approval by the Central Government to our schemes?

Shri Ranendra Narayan Basumatary (Minister, Flood Control)—Sir, the main constraint is the finance. The

Central Government, according to the norms, have already approved scheme costing Rs. 15 crores because the Flood Control work in the Brahmaputra Valley is entirely central assistance, cent percent loan basis. Therefore, Sir, we cannot contemplate these three schemes for permanent protection work to be approved by the Central Government. Sir, I have said that the matter is under correspondence with the Central Govt. and we have reached the stage of being finalised; finalised in the sense that the scheme have to go to Central Water Commission. They will process it technically. Then they will sent the scheme to the Planning Commission for approval.

Shri Barkat Ullah—Sir, I fail to understand why the schemes could not be sent to the BFCB for approval.

Shri Ranendra Narayan Basumatary (Minister, Flood Control)—Sir, I have already said that finance is the main constraint.

Re: Constitution of Sub-Committee

Shri Binoy Kumar Basumatary asked:

7. Will the Minister, W.P.T. & B.C. be pleased to state:











- (a) Whether it is a fact that a sub-Committee to look into the grievances of Plains tribals within Forest Reserves of Assam has been constituted by the Advisory Council for Welfare of Plains Tribes in Assam?
- (b) If so, the provisions thereof?
- (c) Whether it is a fact that the Conservator of Forests and D.F.O. Rangiya did not co-operate between 20th and 23rd August, 1984 and if so, the reasons thereof?
- Shri Ranendra Narayan Basumatary (Minister, W.P.T. & B.C.) replied:
  - (a) Yes.
  - (b) It was constituted under Rule 18 of "The Advisory Council for the Welfare of the Scheduled Tribes living in the Plains Districts of Assam Rules 1967."

    The terms and conditions of the Sub-Committee are—
    - (i) The Committee will make spot varification as to the eviction/other harrasment given to the tribal inhabitants of the forest villages viz. cadestral villages and unclassed forest villages etc. with the help of the District/Sub divisional Revenue and Forest officials and project officers I.T.D.Ps.
    - (ii) While making enquiries the Committee will invariably associate the local project Implementation Committee of the I.T.D.Ps and Sub-Committee Development Boards for ST (P).
    - (c) The Tour Programme of the Sub-Committee from 16th

to 30th August/84 was communicated to all concerned D.Cs/S.D.Os/P.O., ITDPs/S.D.W.Os./D.F.Os by W. T. Message on 10.8.84. The C.C.F. was also requested to issue instructions to all concerned D.F.Os to render necessary assistance to the sub-committee on 10.8.84. The C.C.F. had accordingly issued a circular to all concerned D.F.Os requesting them to give full cooperation vide his letter No. FG.13/16/18 (A), dt 14.8.84.

The Sub-Committee has not yet submitted their report to the council and it is not known to this Department, whether any D.F.O. did not extend co-operation to the members of the Committee. If there is any D.F.O./Conservator of Forest who did not render co-operation, this will be looked into, but there is no complaint about such non-cooperation. Besides, the report of the sub-committee will be discussed in the Council and then only the final decision will be taken for recommendation to the Govt. for appropriate action.

Shri Binoy Kumar Basumatary—Sir, whether the Advisory Council is a constitutional requirement?

Shri Ranendra Narayan Basumatary (Minister)—Sir, the State Govt. in consideration of the socio-economic problems of the Plain-tribals has passed the executive orders for the constitution of this Tribal Advisory Council. Sir, this Tribal Advisory Council has also constituted a Sub-committee for making spot verification etc. and the Hon'ble Member is also in the Sub-committee. Sir, I understand that the Sub-comm-



ittee have also visited some places. The report of the Sub-committee is not yet submitted. When the report will be submitted, we will certainly consider the recommendations of the Committee.

Shri Binoy Kumar Basumatary—Sir, my question is not replied to. My question is whether the Advisory Council is the constitutional requirement?

Shri Ranendra Narayan Basumatary (Minister)—Sir, it is not a direct constitutional requirement.

Shri Binoy Kumar Basumatary—Sir, whether the Hon'ble Minister is aware of the fact that the Conservator of Forests and D. F. O. Rangia did not cooperate with the Sub-committee. In view of this may I know from the Hon'ble Minister what action is contemplated by the Govt. in regard to the non-cooperating officers?

Shri Ranendra Narayan Basumatary (Minister)—Sir, this is the first time the Hon'ble Member has brought this matter to my knowledge and to the notice of this August House. The C, C. F. has issued necessary instructions to all the Conservators of Forests and D. F. Os to cooperate and if any officer did not comply with the instructions, certainly action will be taken. But, Sir, this is the first time such a matter is brought to my knowledge. I will certainly enquire into the matter.

## MISCELLANEOUS

Snri Binoy Kumar Basumatary-Mr. Speaker, Sir, I call

the attention of the Hon'ble Chief Minister to the Mass-rally on 5th September 1974 in all the predominantly Bodo inhabited areas relating to the role of assyciate official State language; then I also bring it to the notice of the Hon'ble Chief Minister that in Darang District teachers are in strike because they have not received their salaries for more then 3 months. Then, Sir, I also bring it to the Notice of the Hon'ble Chief Minister that at Tamulpur there is also a movement against the Principal of Tamulpur Higher Secondary School who was involved in a murder case and was suspended but later on he was reinstated on 3rd July last. This movement was started on 16th July but the Govt, have failed to respond to this public demand.

Shri Hiteswar Saikia (Chief Minister)—Sir, as regards the first point raised by the Hon'ble Member, a Committee is enquiring into the matter and the report of the Committee is not yet made known to the Govt. when the report of the Committee will be given, we will surely communicate it to the people. There are two other points which will be replied by the respective Ministers.

### STATEMENT BY MINISTER

Shri Mukut Sarma (Minister)—Sir, at the call of Man aldoi District High School Teachers & Employees Association, the teachers and employees of Provincialised High Schools of Mangaldoi Sub-Division have resorted to cease work from 1.9.84 to 5.9.84 as a protest against irregular payment of monthly salaries of teachers and employees. The Inspector of Schools, Sonitpur, Tezpur received the strike notice on 30.8.84.

The teachers and employees recorded their attendance in their respective institutions but abstained from taking up classes during this period. Besides, they also decided to boycott the Teachers' Day on 5.9.84.

The Inspector of Schools, Tezpur made an enquiry and consulted with Treasury Officer, Mangaldoi on 3.9.84. As per statement of Treasury Officer, Mangaldoi, the letter received LOC for two quarters i. e. from March/84 to May/84 and from June/84 to August/84 amounting to Rs. 49,21,942.66. These two L.O.Cs. were meant for 26 High and Higher Secondary School under Non-plan budget. But, there an excess payment of Rs. 10,45,780.87 upto 30.6.84. With this excess payment of salary, the Treasury Officer, Mangaldoi refused to pass the bills for July and August, 1984. The Treasury Officer, however agreed to pass the bill for July, 1984 on request of Inspector of Schools, Sonitpur.

The Inspector of Schools also met some representatives of Teachers' Association and requested them to withdraw the strike and observe Teachers' Day on 5.9.84.

The Inspector of Schools, Sonitpur put up a demand to D. P. I. for allotment of fund of Rs. 16,43,

040:16 on 20.8.84 for 22 schools under plan budget. The case is now under progress and the additional allotment will be made in a day or two. With the sanction of L. O. C. for the additional demand, the pay will be released to the teachers and employees soon.

Shri Luis Islari (Minister of State)-Mr. Speaker, Sir, the Principal, Tamulpur Higher Secondary School Shri K. N. Sarma and Shri Raghu Nath Kakati, Asstt. Teacher of the same school were arrested by Police in connection with Tamulpur P.S. case No. 4 (10) 80 u/s 302 I. P. C. (Murder of one Shri Umesh Boro) and consequently they were put under suspension vide Government letter No. (1) ESS. 10/81/4, dated 11.2.81 and (2) U/O. No. ESS. 19/81/6, dated 4.4.81 and D.P.I.'s letter No. G (B) Prov. 3/80/85, dated 25.2.81. The Judicial Magistrate, Nalbari (1st class) has since discharged the accused vide his verdict dated 11.6.84. The Inspector of Schools, K.D.C., Gauhati has reinstated the above mentioned persons under instruction of Government and D.P.I. vide letter Nos. ESS. 19/81/22, dated 29.6.84 and G (B) Prov. 3/80/134, dated 30.6.84 respectively, A second case came up against Shri K. N. Sarma, Principal, Tamulpur Higher Secondary School while he was under suspension. Shri Sarma had drawn scholarship money amounting to Rs. 15,484/and arrear pay of teachers amounting to Rs. 17,666/during 1979-80. These amounts were not disbursed by him. The Department after knowing the position directed the Principal to disburse the same immediately.

An audit report showed clearly that the amounts were diverted for some other school purpose without any authority. It has now been learnt from a report of the Inspector of Schools, KDC that after his recent reinstatement Shri K. N. Sarma has disbursed scholarships to 21 students out of 27. The rest 6 students are yet to turn up to collect their scholarships. The teachers have also been paid their arrears as reported.

However, a section of Tribal students are reported to have been agitating against the reinstatement of Shri K. N. Sarma on grounds of his past misdeeds. As reported by the I/S, K.D.C. a group of ex-students of the school been leading the agitation while the students of the school have remained passive on the whole. The last agitational action took place on 17.8.84 when a batch of 14 students tried to picket the Principal's office. But they were removed by the police soon, and there has been no agitation in the school since the.

Shri Benoy Kumar Basumatary—How is it, in regard to point No. 3, that after reinstatement the principal could disburse Rs. 33,000/- from his own source?

Shri Luis Islari (Minister of State)—Since he was under suspension he was not in a position to disburse the amount: As soon as he was reinstated he got the money disbursed to the students and to the teachers:

Shri Benoy Kumar Basumatari—The question is whether Rs. 33,000/- was disbursed from his own fund or from the school fund? It could not be in the school fund

because he misappropriated the amount and was suspended and he paid the amount after he was reinstated.

- Shri Luis Islari (Minister of State)—He was suspended not because of the misappropriation, but on the ground of a murder case of one Umesh Boro.
- Shri Hemen Das-I want one clarification. The principal was suspended; whether he could be allowed to keep the Government money in his own custody?
- Shri Luis Islari (Minister of State)—As a rule he cannot.
- Shri Benoy Kumar Basumatari-If as a rule he cannot how the Govt. allowed it and what was the Govern ment doing?
- Shri Luis Islari (Minister of State)—Sir, since he was under suspension, as I stated earlier, he was not in a position to disburse the money. As soon as he was reinstated the money was disbursed.
- Shri Hemen Das-My point is, the principal was suspended, but the office of the principal was not suspended. So whoever was in-charge he could have disbursed the amount had the money been there. My point is, as per report it is clear that during the period of his suspension the entire amount was with that person and not with the principal. How Government could allow a suspended person to keep the Government money in his own custody?
- Shri Luis Islari (Minister of State)—When the principal was suspended certainly there was another acting

principal. Perhaps he did not want to involve himself in the case. So he did not disburse the money.

Shri Benoy Kumar Basumatari—It was detected that the principal had misappropriated Rs. 33,153 73. When it was misappropriated money this was known that it was not in the school fund. So immediately after reinstatement how could be get this amount for disbursement?

Shri Luis Islari (Minister of State)—Whether he misappropriated the money we will make an enquiry.

Shri Henen Das-Yes, say that.

Shri Md. Idris—Mr. Speaker, Sir, I beg to move that the Assam Electricity Duty (Amendment) Bill. 1984 be taken into consideration.

As per estimate made, our State is likely to lose above Rs. 2 crores annually due to abolition of excise duty on electricity. In order to compensate this loss of revenue, it is proposed to increase the existing rate of electricity duty of 3 paise per unit to 5 paise per unit making it equal to the combined incidence of Central Excise Duty and existing electricity duty. The increase is likely to yield an amount of Rs. 70 lakhs to the State without any increase in the existing electricity.

শ্রীমহম্মদ ইজিত (মন্ত্রী) – মাননীয় অধ্যক্ষ মহোদয়, মাননীয় বন্ধু দাস ডাঙৰীয়া আৰু ডেকা ডাঙৰীয়াই যিখিনি কথা আমাৰ এই বিলখনৰ সম্পূৰ্ক কৈছে এই গোটেইখিনি কখাত প্ৰায় অলপমান ছুল বুঞাবুজি হৈছে। এই যিখন বিল মই আনিছো ভাত আমাৰ যি তিনি পইচা দিউটি আছিল ভাত পাচ পইচা কৰিব থুজিছো। এই কথাখিনি আলোচনা কৰাৰ উদ্দেশ্য হৈছে যে, আৰু পৰিষ্কাৰ কৰি কৈ দিয়া হৈছে যে, চেন্টাৰত একচাইজ দিউটি আছিল ২ পইচ৷ আৰু আমাৰ ষ্টেটত আছিল ৩ পইচা। এই তুইটা মিলি ৫ পইচা হ'ল। এই ছুইটা ইলেক-ট্ৰিচিট বৰ্ডে আদায় কৰি দিয়ে। এইটো নিয়ম সলনি কৰিবলৈ আনি প্রস্তাৱ লোৱা নাই। এইটো ইলেক্ট্রিচিটি বর্ডেছে পাচ কৰিব লাগিব। আমি যিটো ইলেক্ট্রিচিটি হিচাবে মিটাৰ লগাও সেই হিচাবে আমি পাৰ ইউনিট ৩ পইচা কৰি দিব লাগে। আৰু এই ধৰণে ১০০ ইউনিট ব্যৱহাৰ কৰিলে ও টকা হব। আগতে আমি • পইচা পাইছিলে। আৰু চেণ্টাৰে ২ পইচা পাইছিল। আৰু চেণ্টাৰে পোৱা একচাইজ দিউটিতো আমাক ফিবাই দিয়ে। আমি এই সংক্রোন্তত ২ কোটিমান টকা পাইছো। এইদৰে আমি প্ৰতি বছৰে পাই আছে। কিন্তু যি ২ প্ৰচা আমি চেন্টাৰক একচাইজ দিউটি দি আছো, সেইটো অহা অক্টোবৰ মাহৰ ১ তাৰিখৰ পৰা চেণ্টাৰক হিদি আমাৰ ইয়াত লোৱাৰ ব্যৱস্থা কৰা হৈছে। ইয়াত ৰাইজৰ কোনো ধৰণৰ অস্বিধা নহয়। এইটো বৃদ্ধিও হোৱা নাই আৰু কমাও নাই। এংদৰে এই টকা আমি ললে লাভবান নহও বৰ্ঞ আমাৰ লোকচানহে হব । কাৰণ আমি চেণ্টাৰৰ পৰা ২ কোটি কৰি টকা পাই আছিলো৷ আমি ভবা মতে এতিয়াৰ পৰা ৭০ লাখমান টকাছে পাম। ইলেক্টি,চিটিৰ জেনাবেটৰ ভপবত নিৰ্ভৰ কৰিছে কিমান মেগাৱাট হব তাৰ ওপৰতহে ২ পইচা কৰি লোৱা হব । তা'ৰাপৰি ৰাইজে ব্যৱহাৰ কৰাৰ ওপৰতহে এই টকা পোৱা হব । গতিকে জেনাৰেটৰ আৰু কনজুখাবৰ মাজত এটা পাৰ্থক্য থাকিব। তাৰোপৰি আমাৰ বহুত মাতুহক ৰেহাই দিয়া হৈছে। এই সম্পর্কত আমি নটিফিকেচন কৰা হৈছে। গতিকে এই ৭০ লাখ টকা

পাম বুলি ভাবিছো। আমি ইলেক্ট্ৰিচিটিৰ ৰেট বঢ়াই দিয়াৰ বাবে কোনো ব্যৱস্থা লোৱা নাই। ৰেট একে থাকিব বঢ়া নাই। ইমান দিনে একচাইজ দিউটি ভাৰত চৰকাৰে ২ পইচা লৈ আছিল। গতিকেই মই ভাবো যে, এই বিলখন বিবেচনা কৰাত একো আপত্তি থকাৰ কাৰণ নাই।

Mr. Speaker—Now I put the Motion before the august House that The Assam Electricity Duty (Amendment) Bill, 1984 be taken into consideration.

(The motion was passed by the House)
Now Item No. 6 (b). There is an amendment to Clause
2 of the Bill in the name of Shri Binoy Kumar Basumatary. Now Shri Binoy Kumar Basumatary will
move.

\*Shri Binoy Kumar Basumatary—Sir, I beg to move that after the proposed Sub-Section (1) (c) to clause 2, the following provise shall be inserted as follows—

"Provided that not more than 3 Paise per unit shall be paid for the consumption or sale of energy which is consumed by or sold to the agriculturists for the purpose of irrigation and to the small scale industries."


Sir, we have already seen in the Statement of objects & Reasons that there is an uncovered amount of rupees one crore and thirty lakh because it is clearly stated that the State is likely to lose about Rs. 2 crores and in place of Rs. 2 crores the Govt. now proposes to bring in actualy seventy lakhs of

rupees. So this amount of Rs. 130 lakhs are vered amount. While replying to the objection, Hon. Minister of Finance has said that the State Govt. was paid back by the Central Govt. the amount of Central Excise Duty collected at the source of generation of electricity and there is a difference in the amount of State Electricity Duty which is collected from consumers. Where is a difference in the amounts collected from the source of generation and that from the source of censumption. Now when the power comes from the source to the consumers, by this transfer Govt. has already subsidised and unspecified amount-will lose, and this has already been admitted. Now if the Central Govt. has taxed the source of generation which in fact they paid back to the State amounting to Rs. 2 crores, the State Govt. will now get Rs. 70 lakhs as sought by this bill in replacement of the Central Excise Duty. Then the question is as per the explanation, how it is proposed to increase the existing rate of electricity duty from 3 to 5 paise per unit making it equal to Rs. 130 lakhs. Then this loss of power from the source of generation to the consumption is itself.... (interruption).

Shri Md. Idris (Minister)—It is not the loss due to the loss of power from generation to consumption. It is due to exemptions we have granted. We have large number of exemptions.

\*Shri Binoy Kumar Basumatary-Well, even if large number



case with small scale industries and I do not wish to speak elaborately on small scale industries because we know Assam has potential but we are lacking in using it. As far as I remember there was a survey conducted some years back about the hydre-electric potential of north east India and it was found that the hydroelectric potential in north east India is the best in the entire country and if this potential is tapped not only the north east but even to such States as U.P. and Bihar the Govt. Assam can sell power. Now this Govt, has failed to tap this source of power and with this Bill it shows that it is trying to be dependent on whatever power that is now available. Now. if the Govt. really wishes to turn Assam into a grapary then Sir, we must make this power available for the farmers and it should be the Govt. to lead the way. I therefore move this amend that by collecting this petty amount of Rs. 70 lakhs in place of Rs. 2 crores, it does not appear to be a sound argument, when they have already decided to forego Rs. 130 lakhs, I propose to move this amendment that the entire amount should be foregone in favour of agriculturists and small scale industrialists.

\*Shri Mohammad Idris (Minister)—Sir, I wish my hon'ble friend had taken a little bit of labour in going through the existing Act and Rules of ours, that is the Assam Electricity Duty Act. 1964 and Assam Electricity Duty Rules 1964. Sir, as per provision of the Acts and

Rules this amendment could be disposed of by a lineonly. Sir, my friend has brought this amendment under section 3 but this I cannot accept because Section 3 is a charging section. The provision is only to charge, to bring money by taxation and if I want to give any exemption it should be under Section 12. I will read Sir; Section 12-Power to Exempt. That is the fit section under which exemption should be sought. So, it is already there, only the Govt. should issue a notification and give exemption to whosoever it likes. My friend is interested about agriculturists and small scale industrialists. Govt, has already considered those two things. They are exempting upto 50,000 units and only I paise per unit we charge. Now with the levy of this 2 paise it will be 3 paise in case of small scale industries. Agriculture is already exempted. Anybody drawing power for use of agriculture, that means for irrigation, he is exempedted. Now with this my friend additional levy it will be 3 paise but I assure this is engaging the attention of the Govt. and the entire problem will be reviewed. by the Govt, and a decision will be taken very soon; Therefore, I hope my hon'ble friend, his purpose was to seek some sort of benefit for the agriculturists, who are fully protected, and small scale industrialists, where some sort of reliefd is already there and for further relief Govt. is thinking. Sir, one point he has said does not sound nice to think or consider Rs. 70 lakhs to be nothing for the State. As a Fin-

ance Minister to me a paisa is also very important for the State and Rs. 70 lakhs is not a small amount. I have found out via media only for Rs. 70 lakhs... If I read out the Speech of the Union Finance Minister, the doubts of my friend will be removed. This he delivered during the last Budget Session of the Parliament. "Hon'ble Members would recall that excise duty was levied on electricity as a revenue measure in the 1978 Budget. The net proceeds from the duty collected on electricity are wholly distributed to the States. It is proposed to abolish the excise duty on electricity leaving it to the State Govts. to tap this source, to whatever extent and in whatever manner they like. This will give to the States one. more area for resource mobilisation. To give the State some time to take appropriate action this abolition will be effective from 1st October, 1984."

Therefore Sir, resource mobilisation is very important factor and along with it Rs. 70 lakhs is also very important. There is an apprehension in the mind of my friend Shri Das that we are increasing the burden of the consumers by this. I would like to say that we are not increasing the burden in any way. If the Electricity Board in their sphere declares an increase in their tariff that is a different thing. But for the time being I hope there is no such fear. I hope this will satisfy him and he will be pleased to with draw his amendment.

Shri Benoy Kr. Basumatary—The hon. Minister has tried to say that my amendment is inappropriate in relation to this Section. I do not agree with him. Sir, Govt. has brought an amendment to a certain Section and my amendment is a counter to whatever they sought by an amendment and therefore, my amendment is absolutely in order. The Finance Minister also remarked that Section 12 provides for exeption. Now, if he wants to put the whole Act under discussion, I have an objection. I want to ask the Finance Minister how did they put this clause 12 as an exeption clause. There must be a door since everything is interconnected. My point is that without proviso, we cannot make this exemption. Therefore Sir, I say that my amendment is mitter redundant nor improper.

Shri Md. Idris (Minister)—Sir, in the face of the specific provision in the Act which I have referred to, I do not know how he could arrive at this conclusion. I have said that this amendment is not acceptable to the House as there is such provision in the main Act. I have read out the specific provision of the Act. Sir, his purpose will be served, as to the giving relief to the Agriculturists by the Act as per its provision: They are to pay 1 paisa upto 15,000 units of consumption. I think Sir, in view of this he should withdraw his amendment.

Shri Benoy Kr. Basumatary-It is alright, I might withdraw

but the way the amendment has been brought is not tolerable to us. I am not happy with it. What is the use of collecting this two paise—why not Rs. 2 crores then? I am not going to withdraw Sir.

Mr. Speaker—So, I put that after the proposed sub-section 1(c) to clause 2, the following proviso shall be inserted;

"Provided that not more then 3 paisa per unit shall be paid for the consumption or sale of energy which is consumed by or sold to agriculturists for the purpose of irrigation and to the small scale industries".

(The amendment is lost)

Now, I put clause 2. Clause 2 does form part of the Bill.

(The motion is adopoted)

I put then, Clause 1, preamble, enacting formula and short title do form part of the Bill.

(The motion is adopted).

Shri Md, Idris (Minister)—Sir, I beg to move that the Assam Electricity Duty (Amendment) Bill 1984 be passed.

Mr. Speaker—I put motion before the House—that the Assam Electricity Duty (Amendment) Bill 1984 be passed.

(The motion is passed, the Bill is passed)

The House stands adjournment sine die.

## Adjournment

The House rose at 12-30 p.m. and stood a djourned sine die.
