Re: Deputation of Assam Government Official to Meghalaya Government

HE SIMULOY

Shri Dulal Chandra Barua: asked:

- *87. Will the Chief Minister be pleased to state—
 - (a) The principles followed by the Government of Assam in deputing the Officers of the Government of Assam to the Government of Meghalaya after the creation of Meghalaya on 2 d April, 1970?
 - (b) Whether the Government of Assam is proposing to fill up the vacancies caused by such deputation and transfer?

Shri Mahendra Mohan Choudhury (Chief Minister) replied:

87. (a)—The principles of deputation are provided under Section 65 of the Assum Reorganisation (Meghalaya) Act, 1969 which lays down that a member of an All India Service or of a Class I service of the State of Assam may be required to serve in the affairs of the Government of Meghalaya. In regard to members of other services, they may be required to serve in the Government of Megha-

- laya and the legislature of Meghalaya or the Governor may determine the conditions of service provided this will not vary to the disadvantage of the employees except with the previous approval of the Government of Assam.
- (b)—The action is being taken in the light of the circulars of the Finance Department on the subject which have laid down that all categories of personnel of the offices transferred or transferable to the Meghalaya Government will go to Mehgalaya and the moment such people are sent for service under Meghalaya Government the cadres in question shall get reduced automatically and proportionately.
- Shri Dulal Chandra Barua: May I know from the Chief
 Minister whether the service conditions of the
 officers deputed to Meghalaya will be determined
 by the rules of the Government of Assam or by
 the rules of Meghalaya Government?
- Shri Mahandra Mohan Choudhury: Their service conditions will be governed by the rules of the State Government.
- Shri Dulal Chandra Barua: Whether the officers deputed to Meghalaya Government are getting deputation allowance?
- Shri Mahandra Mohan Choudhury: No deputation allo-

wance has been given. They have been simply transferred.

- Shri Dulal Chandra Barua: How the quantum of officers to be deputed to Meghalaya has been fixed?

 Whether on their requisition officers are sent or the quantum has been fixed by the Government of Assam.
- Shri Mahandra Mohan Choudhury: These things are being done by mutual consultations.
- Shri Dulal Chandra Barua: Whether the service rules of the Government of Assam in respect of efficers deputed to Meghalaya will continue, or the Meghalya Government will be their own service rules?
- Shri Mahandra Mohan Choudhury: The Government of India is framing rules and they have sent us the rules for comments. We have already sent our comments. I believe the Meghalaya Government have also sent their comments. After receiving the comments Government of India will finalise the rules.
- Shri Dulal Chandra Barua: The quota of I. A. S. officers
 I think, is fixed on population basis and on work
 load. When some officers of the I. A. S. cadre have
 alrady been sent to Meghalaya Government, whether there will be reduction in the I. A. S. cadre
 in the Government of Assam to that extent?

- Shri Mahendra Mohan Chaudhury: Yes, Sir.
- Shri Dulal Chandra Barua: Whether the same policy will be followed in respect of the A. C. S. Officers also?
- Shri Mahendra Mohan Choudhury: The service cadre will be reduced to that extent. It is in the Act and also in the rules prepared by us.
- Shri Dulal Chandra Barua: Whether it is a fact that some of the junior officers who have been deputed from here to the Meghalaya Government have been appointed to senior posts by the Meghalaya Government?
- Shri Mahandra Mohan Choudhury: I am not sure about it, but I can look into it. so far as my information goes the status of the officers which they had in our State cadre is being maintained by the Government of Meghalaya.
- Shri M. A. Musawwir Choudhury: May I know whether the Government will modify the rules regarding the filling up of vacancies caused by deputation of I. A. S. and A. C. S. officers?
- Shri Mahandra Mohan Choudhury: There is no question of modification of the rules. Appointments will be done according to the existing rules.
- (Starred Question No. 88 was not put and answared as the hon.Questioner was not present)

Re: Demands of the A. C. S. I Officers

Shri Dulal Chandra Barua asked :

- •89. Will the Chief Minister be pleased to state—
 - (a) Whether the Government is aware of the acute discontentment prevailing among the A.C.S. I Officers due to non-fulfilment of their demands placed before the Government on several occasions through their Association?
 - (b) If so, the reasons for the delay in redressing their genuine grievances?

Shri Mahendra Mohan Choudhury (Chief Minister) replied:

- 89. (a)—Government is aware of the demands of the A.C.S.I Officers.
 - (b)—Some of these demands have already been fulfilled, while there are others which are still under the consideration of Government.
- Shri Dulal Chandra Barua: Sir, what are the demands already fulfilled by the Government?
- Shri Mahendra Mohan Choudhury & The demands were (1)

 Selection grade of pay in the senior scale. The

 Selection grade in the Junior scale of A.C.S. (1) in
 the scale of Rs. 1000-1200, is admissible after 20

 years of service. A proposal for proving a selection
 grade in the senior scale is under consideration

of the Government.

- (2) Posts of Heads of Department to be made available for A.C.S. (I) officers: The general principle of making a larger number of posts available for A.C.S. I) officers has been accepted. The following four posts previously held by I.A.S. officers have been made available to A.C.S. (I) officers
- 1. Commissioner of Relief & Rehabilitation
 - 2. Director of Land Acquisition Requisition & Reform.
 - 3. Director of Tourism.
 - 4. Inspector General of Prisons.

been filed up by A. C. S. officers. Appoinment Department has taken up the matter with Finance Department about the special pays to be given to the Heads of Department which schould be admissible equally to I.A.S and A.C.S, officers. As per rule, an I.A.S. officer is entitled to get a special pay of Rs. 250/—as a head of the Department. Question of decadrement of some of the I.A.S. Cadre Posts will be taken up when the matter relating to triennial review is finalised.

The post of Managing Director, Assam, Agro Industries Development Corporation, has also been made available to A.C.S. (I) officers.

The post of Managing Directorw it: Holding, has also been made available to the A.C.S.

(I) offlicer. Both these posts were held previously by I.A.S. officers. The posts of Director of State Lottery and Director of National savings and Director of Municipal Administration are held by A.C.S. (I) officers.

- ation demands that the posts of Deputy Commissioner, North Cachar Hills, be filled up by an A.C.S. officer. Since all the posts of Deputy Commissioners are held by I.A.S. officers, the Deputy Commissioner of North Cachar District has been filled up by an I.A.S. officer. However, Government is collecting information from other states whether such p sts have been decadred in other states.
 - (4) S.D. Os of Independent Subdivisons
 As regards the posts of S.D. Os in independent Subdivisions, at present a fair number of A.C.S. officers have been posted as Subdivisional officers.
 Out of 10 subdivisions, v.z. (1) North Lakhimpur, (2) Sibsagar, (3) Golaghat, (4) Mangaldoi, (5) Goalpara, (6) Barpeta, (7) Kokrajhar, 8) Nalbari, (9) Karimganj, (10) Hailakandi, (excluding Mizo district), A.C.S. officers are now holding charge of 7 subdivisions, viz. (1) North Lakhimpur, (2) Sibsagar, (3) Mangaldoi, (4)

- Goalp+ra (5) Karimganj (6) Kokrajhar, (7) Nalbari
- As regards the demand of giving automatic promotion to Senior Scale after completion of 7 years of service, steps have been taken to give relief by increasing the number of posts in the Senior scale. Now in the cadre of 200, 67 officers are in the Senior scale, of which 24 are permanent posts. At present after 12 to 14 years of service, an officer is promoted to Senior scale. Steps are being taken to consider increase in the number of permanent posts in the senior scale.
 - (6) Exemption from passing Departmental Examination: On promotion to A. C..S. (I) from A.C.S. (II) exemption from passing Departmental Examination is granted to officers who have reached 50 years of age.

On receipt of the representations on 28.1.70 from the Association of A.C.S. (1), the Chief Secretary discussed the matter with the representatives of the A.C.S. (I) Association on 25.7.70. He recorded the minutes of the discussion and ordered for examination. The demands are mentioned above.

Shri Dulal Chandra Barua: The Chief Minister stated that they were collecting information from other States and after examining the position obtaining in those States, Government will take a decision. But may I draw the attention of the Chief Minister to the fact that the circumstances and local environment are quite different here than in other States and by putting Deputy Commissioners from the I.A.S. cadre, who are not well-conversant with local conditions, Government are doing more harm than good to the people. Do not Government, therefore, consider the desirability of appointing at least a few Deputy Commissioners from the A.C.S. cadre, at least on an experimental basis?

Shri Mahendra Mohan Chaudhury: The demand is only for the post of Deputy Commissioner of the North Cachar Hills District, which has been created newly. That matter is under consideration. While considering the matter we are also to consider the sentiments of the people of that district. They may feel that by putting an A.C.S. Deputy Commissioner there while the other districts are manned by I. A. S. officers, we are treating that district as inferior to other districts.

Shri Gauri Sankar Bhattacharya: Without specifically stating which district may be administered by an A.C.S. Deputy Commissioner, is it not possible to keep a few posts of Deputy Commissioners cum District Magtitrates reserved for officers of A.C.S. Class I, who prove extraordinarily efficient in the discharge of their duties.

- Shri Mahendra Mohan Chaudhury: I was speaking about the demands of the A.C.S. Class I officers' Association. Their demand was very specific; they wanted that the post of the Dupty Commissioner of the North Cachar Hills District should be reserved for their cadre. But whatever suggestions have been made by the hon. Members may also be considered.
- Shri Gauri Sankar Bhattacharyya: It is correct that the people of that particular district may feel that probably the Government consider us to be a little inferior, that wereas the other districts have go I.A.S. Deputy Commissioners, we are being administered only by an A.C,S. officer. That feeling may be there and it may be a genuine feeling also. But apart from this, is it not possible, as a whole, to keep a few posts of Deputy Commissioners reserved for extraordinarily efficient A.C.S. Class I officers?
 - Shri Mahendra Mohan Chaudhury: Generally, the extraordinarily qualified A. C. S. officers are promoted to I.A.S. However, when the matter is under consideration, the suggestion given by the hon. Member may also be taken into consideration.
 - Shri Dev Kant Barooah: Is it ,the experience of the Government that in terms of educational attainment and administrative competence the members

of the provincial civil service are inferior to the I.A.S. officers ?

- Shri Mahendra Mohan Chaudhury: I cannot give a reply off-hand, but I have scrutinised the academic and other qualifications of some of the I.A.S. officers and from that I can say that some of our A.C.S. officers are superior to them.
- Shri Dev Kant Barooah: In that case do the Government consider the desirability of entrusting these provincial civil service people with a larger measure of responsibility, especially in view of the fact that they have experience of local conditions?
- Shri Mahendra Mohan Chandhury: Yes, Sir, that is a very pertinent question.
- Shri Debeswar Sarmah: Would the Government concede
 that due to a stupid action of the Deputy Commissioner of the Sibsagar District, trouble with our
 Naga brethren arose in Namsoi? The misplacement of a junior officer with lack of experience
 led to this situation.
- Shri Mahendra Mohan Chaudhury: That question does not arise here. If a separate question is put about the alleged stupid action of a particular Deputy Commissioner I can give a reply.
- Shri Debeswar Sarmah: The question is about placing I.A.S. officers in charge of districts. My friend

immediately before me asked whether the provincial class 1 civil service people were in terms of education and efficiency in any way inferior to the I. A. S. officers. The Government gave a liquid answer and, therefore. I just butted in and asked was it not due to the rank stupid action of the Deputy Commissioner of Sibsagar District that the Namsoi township had come up?

Shri Mohendra Mohan Choudhury: As I have said already that question has no bearing with the question before us, which is a general question regarding service conditions and demands of the Assam Civil Service Class I officers. The hon.member has brought in a particular action of a particular Deputy Commissioner. That does not arise as a supplementary to this question. If a separate question is put about the action of a particular D. C. I shall be too glad to reply.

Shri Dulal Chandra Barua: One of the demands of the A. C. S. officers is that the percentage fixed by the Govt. of India for promotion to the I. A. S. cadre should be raised. By considering the local conditions, do not the Government consider it proper to ask the Government of India to reduce the general quota of I. A. S. officers to be deputed to this State and to increase the percentage of promotion from the A. C. S. Class I officers?

- Shri Mahendra Mohan Choudhury: When a demand like this comes it will be considered.
- Shri Dulal Chandra Barua: The damand is already there.

 The complaint is that due to manipulation by a section of people the I. A. S. cadre of this State to be direct recruits has been inflated to a great extent.

 In view of this do the Government not consider it proper to take up the matter with the Government of India in order to reduce the number of newly-recruited I. A. S. officers and increase the percentage of promotion from the A. C. S Class cadre?
 - Shri Mahendra Mohan Choudhury: That may be looked into.
 - Shri Sailen Medhi: One of the demands of the A. C. S. officers in that some A. C. S. cadre officer should be placed at the helm of Gauhati Development Authority. The Gauhati Development Authority has not been functioning properly because of the fact that all along retired I. A. S. officers have been placed there, who have got no interest in developing the town of Gauhati. In view of this does not Government consider it proper to place an A. C. S. officer at the helm of the Gauhati Development Authority.
 - Shri Mahendra Mohan Chaudhury: This post is open for all as far as my information goes. Shri Kamaleswar Barua, retired Chief Engineer was holding that post

for some time. The suggestion given by the hon. member may be examined.

- M. Shamsul Huda: Sir, whether the Chief Minister of the Government of Assam is aware that some Chief Minister, Mr. Brahmamannda Reddy in the meantime has pleaded for increase of promotion of provincial Civil Service quota to the IAS cadre by 50%?
- Shri Mahendra Mohan Choudhury (Chief Minister): I have seen a Paper report like that.

M. Moinul Haque Choudhury & Mr. Speaker, Sir, I have got a supplementary. May I know from the hon. Chief Minister whether this kind of changes i,e. to say, in the first week of last month on the eve of his taking oath and there being a caretaker Ministry changes were made, is confined not only to Rangiya alone but the same happened in many other places? It is not correct that the care taker Minister on 4th communicated to the Regional Board of Silchar its decision knowing full well that on 6th he might not be the Education Minister , Is it not correct that in Haila kandi two or three changes regarding the nomination of the Chairman took place between the dates from 4th to 8th when this gentleman knew that he was a caretaker Minister? So far as Silchar is concerned is it also correct that Mr. Chaliha held up the file for a discussion with the local M.L.As of the District and since he knew that Mr. Chaliha was no longer going to be the Chief Minister Mr. Hagier communicated telegraphically the order which was held up by Mr. Chaliha so long; despite the promise given by Mr. Chaliha that he would consult with them particularly about the welmine of a person who was alleged to be not a national of India?

Shri Mahendra Mohan Choudhury : About the allegations

made by the hon. Member I think the pipers are in your possession. Only from that notice I have come to know that some persons who are not Indian nationals are nominated in the Silchar Board. That matter is pending and being looked into.

- Mr. Speaker: This question refers to the Mijuli Anchalik Panchayat. If specific instances are given to the Minister then he will submit the report afterwards.

I think there is no rule therefore these Boards which were constituted 2 years back are not functioning now.

But it is a matter of great regret that in nominating the Chairman and other members of the Board this has been done whimsically and capriciously just to suit the political interest of the party. Will the Government fix up certain principles on the basis of which this nomination would be made?

- Shri Mahendra Mohan Choudhury: Sir, such principles are already there. Principles are to give due representation to all community interest and taking that perspective in view the nominations are done.
- Shri Dev Kant Barooah: Will the hon'ble Chief Minister be pleased to enquire regarding the time of the day when the former Education Minister passed the orders as I understand his mood changes according the to time of the day.
 - Shri Mahendra Mohan Choudhury: Sir, I can find out the day; but I cannot find the time. Because I shall have to find out the day from the file and in the file no time is recorded while passing an order.
- M. Moinul Haque Choudhury: Sir, it is not deregatory

on the part of a Minister in the care taker Government to change an order before about 24 hours of his going to lose that particular portfolio? In this the way, changes have been made not only in the case of Hailakandi, in the case of Silchar and other places. Is it not cannect same thing had been done.

Shri Mahendra Mohan Choudhury: Sir, I cannot accept the statement of the houmembers. But I feel once an order is passed unless there is some strong ground, it cannot be modified later.

(Many hon. Members rose to speak)

Shri Joy Bhadra Hagjer (Minister, Education): As for Silchar I made no changes. There was a difficulty as regards Chairmanship in Hailakandi. On the recommendation of certain people, the Anchalik Panchayats Presidents I selected Shri Himgangshu Chakravorty. I made no change thereafter. As for Silchar the selection was made once for all. But when these were communicated, I do not know.

(Several hon. Members rose to ask supplementaries)

Mr. Speaker: If you consider it very much important then you can have an half an hour discussion on this.

Re: Separate District for North Lakhimpur

Shri Dulal Chandra Barua asked:

- * 91. Will the Chief Minister be pleased to state—
 - (a) Whether there is any proposal for creation of a separate District for North Likhimpur area comprising of Dhemaji and North Lakhimpur Subdivisions?
 - (b) If so, when the decision is going to be implemented?
 - (c) If the reply is in negative whether Government consider it necessary to make immediate arrangement for creation of the above mentioned District by considering its administrative and other inconveniences?
- Shri Mahendra Mohan Choudhury (Chief Minister)
 replied.
- 91. (a)—A memorandum from the President, Dhakuakhana Anchalik Panchayat and Member, North Lakhimpur and others regarding creation of a separate District at North Lakhimpur has been received by the Government.
 - (b)—The matter is difficult to concede at this stage.
 - (c)—Does not arise in view of (b) above,
- Shri Dulal Chandra Barua: What are the difficulties standing on the way for creation of a separate district for North Lakhimpur?
- Shrl Mohendra Mohan Choudhury: Mainly financial

ildfflcuty andthero administrative reasons for which North Lakhimpur subdivision has not been considered fit to be a district.

- Shri Dulal Chandra Barua ir, I feel for the administrative convenience there should be a separate district for that particular area. Otherwise, great injustice will be done to the people of that area. If the Govt. think that area is within the map of Assam then they must create a district.
- Shri Mahendra Mohan Choudhury; Sir, there are also some more demands from other divisions For example, from Barpeta. The Bar Association of Barpeta has taken a resolution unanimously and forwarded to me that Barpeta should be declared a district. There is also another demand from Nalbari subdivision to declare them a district. Therefore, we must take a decision on principle taking into consideration, the population, area and other things plus the financial implication.
- Shri Dev kant Boroah; Are the districts formed only on the population or on size? The size of many districts in this country are either very small or very big. It is the administrative convenience, accessibility and other things that should also to be taken into consideration. Place like Dhemaji in North Lakhimpur being out of the way, will the Minister consider the desirability of taking into account the accessi-

bility as well as geographical isolation of that area for creation of a separate district there?

- Shri Mahendra Mohan Choudhury; Sir, North Lakhimpur was once geographically isolated from Assam. Now, it is well-connected by rail, road and Air. As such, the area is not isolated. But what Mr. Barua has said that for administrative reason, the area and the population that may not be taken into consideration. These two criteria should not be the guiding factor in the matter..... we have accepted a principle as regards population it should be not less than 60,000 while declaring North Cachar Hills a district. The case of North Lakhimpur will be considered at a later stage.
- Shri Premadhar Bora: Sir, whether the newly elected Chief Minister is aware of the fact that six M.L, As sent a representation to the then Chief Minister, Shri Chaliha, who was kind enough to assure the deputationists that an enquiry would be made? Is it also not a fact that the Plains Commissioner, Mr. Sarao, conducted an enquiry and submitted his report to the Government recommending formation of a separate district with headquatrers at North Lakhimpur?
- Shri Mahendia Mohan Choudhury: His report has been placed on the table of the House and in that report something like that has been stated.

Shri Debeswar Sarma : Sir, the other aspect of the question has been answered. But there is yet another aspect of the matter which I propose to ask. In view of the fact that the head-quarters of North Lakhimpur is at Dibrugarh with the mighty Brahmaputra in between. During the rains few officers go there and the North Lakhimpur Forest Department is administered from Tezpur. Furthermore, North Lakhimpur is a frontier area in the sense that its boundaries are contiguous to the sensitive area and this area is being neglected till now. Until and unless a separate district is created with headquarters at North Lakhimpur and a competent administrator is placed there, North Lakhimpur and for the matter 'of that Assam will be facing trouble, and I think the Chief Minister knows it. Considering all these aspects will Government create a separate district with headquarters at North Lakhimpur as soon as possible for political reasons at least?

Shri Mahendra Mohan Chaudhury: It is difficult for me

to give an assurance at this stage. However, as I have already said, the matter may come up at a later stage and not immediately.

(Starred Question No. 92 was not put and answered to as the hon. Questioners was not present)

Re: Erosion in and around Neamatighat

Shri Dulal Chandra Barua asked:

- * 93. Will the Minister-in-charge of Public Works Department (Flood Control and Irrigation) be pleased to state—
 - (a) Whether the Government is aware of the heavy erosion in and around Neamatighat causing great and immediate threat to the safety of Jorhat town and its suburbs?
 - (b) Whether Government has decided to take up the protection work like construction of spurs, etc., immediately?
 - (c) If so, when the work will be started?
- Shri Syed Ahmed Ali (Minister of State, Flood Control)
 replied:
- 93. (a)—Yes, but there is no immediate threat to Jorhat town.
 - (b)—Majority of the investigations have been made and scheme will be formulated as soon as the investigations are completed.

- (c)—The work will be taken up after the scheme is approved by the Brahmputra Flood Control Board subject to the advailability of funds.
- Shri Dulal Chandra Barua; Sir, the Minister has been pleased to state that there is no immediate danger to Jarhat town. The erosion is still continuing in that area, and if so, how the Minister can say that there is no immediate danger to Jorhat town?
- Shri Syed Ahmed Ali: I said that there is no immediate danger because Jorhat town is about 7 miles away from the eroded place, that is, Niamati Ghat. There was erosion in the down stream last year and we have raised 8 spurs there and that protected the area. Now investigation is going on and we are collecting data. Majority of the investigation has been completed and more are under way, and I hope within a month we will get full data and the scheme will be prepared and we hope to take up the work if fund is available. We have alread asked for funds.
- Shri Gaurisankar Bhattacharyya Sir, if I have heard him aright, the Minister has referred to a Board, viz:

 Brahmaputra Flood Control Board. Is there any such Board? We have heard about Brahmaputra Commission.
- Shri Mahendra Mohan Choudhury: Yes there is a Board called Brahmaputra Flood Control Board. It is

a policy making body and the Brahmaputra Commission is an executive body. Brahmaputra Board is presided over by the Union Minister, Dr. K. L. Rao, and the Chairman of the Brahmaputra Flood Control commission is Shri P.N. Kumra.

- Shri Gaurisankar Bhattacharyya: Should we understand that the matter is still in the policy level and not yet come to the execution level, that is to say, to the agency which executes the work?
 - Shri Mahendra Mohan Choudhury: Yes. I think the hon.

 Member Shri Barua knows that the Chairman of
 the Brahmaputra Commission visited the area
 twice and also an officer from the Poona Research
 Station came and visited the area They have
 taken preliminary data and further investigation
 is goin; on. As soon as these things would be
 completed, I think the work may be taken up
 provided the fund is there.
 - Shri Dulal Chandra Barua: May I request the Chief Minister, who is the Minister-in-charge of the Department that unless the work is taken up immediately, we will face crisis in that area. May I therefore request the Chief Minister to take up protective measures urgently?
 - Shri Syed Ahmed Ali: We will take up the work if the fund is available. This much I can assure the

hon. Member that we cannot allow Jorhat to be washed away, otherwise our Assembly proceedings will be dull.

Re: Appointment of Engineers and Technicians in Brahmaputra Commission

Shri Dulal Chandra Barua asked:

- * 94. Will the Minister-in-charge of Public Works Department (Flood Control and Irrigation) be pleased to state—
 - (a) Whether it is a fact that nearly 40 Engineers and Technicians of different cadres have been brought by the Brahmaputra Commission from the Farakka Barrage and Port Commission, Government of India for manning the same though quite a good number of such qualified personnels are available within the State of Assam?
 - (b) Whether it is a fact that the Government of India and also the Government of Assam have committed in principle to man the Brahmaputra Project by the local qualified Engineers and other technicians if necessary even by giving advance training to the local talents?
 - (c) If so, the reasons for deviation from this committed principle?
- Shri Syed Ahmed Ali (Minister of State, Public Works Department (Flood Control and Irrigation)] replied;

- 94. (a)—No.
 - (b)-No.
 - (c)—Does not arise.
- Shri Dulal Chandra Barua: Whether it is a fact that the Chairman of the Brahmaputra Commission has already submitted a proposal to the Government saying that there is no technical personnel available in the State and therefore it is better to start the work with 40 engineers who should be brought from outside the State from other projects?
- Shri Syed Ahmed Ali: There is no such proposal.
- Shri Dulal Chandra Barua: Then are we to understand that the Commission will be manned by the local engineers?
- Shri Syed Ahmed Ali: There is already a bifercation of our Department and all the officers necessary for the Commission has been transferred from the Flood Control Department. At present we are not feeling any necessity to recruit new people. If qualified persons are available within the State, there is no question of bringing people from, outside.
- Shri Dulal Chandra Barua: Then are we to understand definitely from the Government that no person will be appointed from outside and that none except the local people will be appointed in the Commission?

- Shri Syed Ahmed Ali: If local qualified people are available to serve our specific purpose then we will certainly appoint local people.

ADJOURNMENT MOTION

Removal of Documents from the Survey of India office at Shillong by Pakistani spies'

- Mr. Speaker: Now, I ask Mr. Dulal Chandra Barua to beg leave of the House to move his Adjournment Motion.
- *Shri Dual Chandra Barua: Mr. Speaker, Sir, I beg leave' of the House to move an Adjournment Motion which is a definite matter of urgent public importance and which is also of very recent occurrence:

"Pakistani spy decamps with secret maps and documents from the survey of India office at Shillong with the help of a Senior official."

Mr. Speaker: Has the hon' Member leave of the House to move the Adjournment Motion? (Voices · Yes)

The Adjournment Motion is moved.

*Shri Dulal Chandra Barua: Sir, Under Rule 56 of the
Rules of Procedures and Conduct of Business in
Assam Legislative Assembly, I want to move the
following Adjournment Motion which is a definite
matter of urgent publice importance and which
is also of very recent occurrance:-

"Pakistani spy decamps with secret maps and documents from the Survey of India office at Shillong with the help of a Senior official".

This incident indicates the failure of the security arrangement of the Government in the border State of ours, and hence this Adjournment Motion.

Mr. Speaker: I fixed 10.00 to 11.00 for the Motion.

*Shri Dulal Chandra Barua: Sir, at the very outset I must offer you my hearty thanks for allowing this adjournment Motion to be discussed in this House because you have realised the gravity of situation and what are behind all this. Sir, my intention to table this Motion before this House is that this is not a matter of ordinary law and order and you also ruled like that. Now Sir, this is a border State. The police department that we maintain is paid from the public excheaquer and this depart-

ment is paid much more in comparison to other department., It is paid with a view to maintain law and order and also to maintain the security of the border State of? ours - but in that regard there has been a complete failure on the part of the police administration particularly, it is failure of the intellingence Branch. All the Heads of Departments and the heads of the Police Department are stationed here in Shillong but I am surprised to know that people from Pakistan can come and go away taking valuable documents with them, undetected, from the Confidential Branches of the State and the Central Governments. Are they meant only to draw their salaries and live in luxury and comfort? They are being paid from the public excheaquer and the people expect that they perform their duties properly in order to maintain law and order and the security of the State. But the Intelligence Branch has completely failed in doing their duty, Now? I will explain, I raised this Adjournment Motion on the 5th of this month and only after then this came to the notice of the Intelligence Branch. May I pose a question to the Hon ble Chief Minister? Whether this Intelligence Branch is also in collusion with the saboteurs? My impression is that directly or indirectly they are involved in this. Because they are trying to misguide the Chief Minister and misguide the people of the State and this

House. Sir, I have specifically referred about two ladies who are not from Shillong. I repeat, they are not ladies from Shillong but in yesterday's paper I read that some of the tribal girls were arrested. I do not know whether somebody was arrested or not but I read it in paper. I really surprised to find that the Department is trying to shift the responsibilities to the two tribal young girls who are innocent, who are in no way connected with this. The actual girls who were involved in this have acted in such a way that they have befooled the intelligence Department of the State and just to save their skin just to patch up their inefficiency they are doing this way or that way. But this is not going to be tolerated. Sir, I am going to disclose now that there is a ring which is working here. Sir, the Govt. of India has made it, a national policy that the refugees can come and stay here. Because they are the minority community in Pakistan and to avoid harrassment in Pakistan they can come here but there are some who have come here leaving their relatives in Pakistan. They always come and go without any valid passport. There are some who have no source of income but are living kings and monarch. Sir, the Pakistan Government do encourage such things in order to collect information. As I have already said Sir, there is a ring which is working here and they

are finance from two sources; one is the C.I.A. and the other from the Pakistan Government. Sir. there is one gentleman by the name of Chinu Miah, a business man supplying fish.

He is a wholesale trader in fish. This man has got various camps. In Dawki he has a tea stall. He is a man from Pakistan and he has his family in Pakistan. He has married some of the local girls also. He has as many as eight wives. That shop of his at Dawki is the place of contact and information is sent from this place. Sir, it is a fact that the two ladies stayed there on that particular night after taking the documents in the survey of India Trunk No.211. The Police Department should not try to befool us by saying that no map has been taken away. I can give the number of the maps taken away. One is No.4 (a) M-9 concerning NEFA; another No.7 (a) -7-3 concerning Burma Border; another No.8' (d)—8-10 concerning Pakistan and the other 3 (d)-2 concerning Pakistan. All these were put into Survey of India trunk No.211 and had been taken away by the two ladies. How these people then can say that no maps were taken away. It could be imagined in what mood the high ranking Officer was with the two ladies in the protected area. He was drunk. How could he say that no map had been taken away. How this Government and the Police people can say that no

map had been taken away. This is the state of affair going on in our country. For such things we had to face the NEFA debacle. Military secrets and State secrets were given to the Chinese at that time. C.I.A. and Pakistani spying activities are going on and we are conniving at it. Sir, you will be surprised to here that there is one Office here in Shillong-Entomological Office. One big gun is in charge. His headquarter is at Bangalore. He has got a good car and a nice bungalow. This Entomologist is also within the ring of Major Kohli and Puri and others. These people are not here to serve the country or to do good to our people, they are here for their own nefarious business acting as C. I. A. agents. This organisation is financed by an American agency, and our Govt. do not care to know about the activities of these people. Sir, I have gone through the Lok Sabha proceedings. By raising a issue like this we are not going to create bad blood between neighbouring countries. But when we are not in very friendly terms with coun-China it is our Pakistan and tries like bounden duty to bring to the notice of the Government to such activities of persons working for and on behalf of such countries to the detriment of our own country. If we do not do so it will be betrayal of the country. Sir, I am not placing before these things on the basis of rumours or on the basis of

anonymous letters. I have verified facts and I personally went upto Dawki to check up things for myself and I am convinced that the statement given by the Chief Minister regarding the latter part is not quite true. I can challenge the Government and the Chief Minister in this respect. This man Chinoo Mia is not only financig this ring but some other rings also. Now that law and order would be given over to Meghalaya Government, I hope that they will also take precautionery measures against such activities of enemy agents because Meghalaya is also a part and prcel of Assam. Unless strict security measures are taken this capital town of Shillong may be the headquarters of such spy rings. Sir, as regards the activities of this Entomologist information was given long before to the Department and also a formal complaint was lodged in the Police Station. My information is (I do not want to cast aspersion on any individual) that the Police Department is heavily bribed and as such no action has been taken in this complaint. It appears that the Police organisation is in league with these people why should not they take otherwise action inspite of the fact that a formal complaint Station. was made at the Police As I have already said, they are not in a position to detect cases and I am told the Chief Minister called some top ranking Police officials and rebuked them for their failure. Sir, the people in

the Intelligence Branch, have no intellect at So, how they could detect the case. It is the duty of the Police to go to places and collect information but it is not my duty to collect information and detect cases. Even then I went upto Dawki and collected facts as far as I could at the risk of my life because I consider that my country is much more valuable than my life. Sir, on that day that Shri Kohli came to certain place but I do not know at whose instance he went there. My suspicion has been confirmed some how or other. Sir the day before yesterday, I went to a certain place and I have done some sort of intelligence work myself. Sir, the people who are in charge of Intelligence Branch are inactive and corrupt for whom we are spending lot of money for their maintenance, sir, are we to act as police officers and to give information to the Govt. Is it not shameful. Sir, I have collected some information and I am still collecting the same. Sir, after I have raised this matter here, then the Chief Minister submitted a statement; the Director or the Deputy Director, they forcibly asked the drunk man to issue a statement. Sir, he does not know English an so later on he submitted another statement in Hindi. Sir, the statement made in English and in Hindi by that man does not tally. In the Hindi statement he has given the true picture. The statement given in English is a concocted statement and it was

done taking advantage of his ignorance in English by some of the officers. Sir, Shri Khemlal of that Organisation, he was the Security Guard there; he was asked by some of the officers to give false statement but he refused and he was threatened; he was given some sort of inducement and ultimately he refused to give false statement. As a result of this he was transferred overnight to the Polo Ground depot. So, you can easily understand as to how the investigation is going on in the matter which is of highest national importance.

I have said that let the Chief Minister or the Government challenge the facts; in our turn I am also challenging the facts placed before this House. I have collected information to the best of my ability and the information are found to be true. I have got some other information how this link is working in the State of Assam, So. it is the duty on the part of the Chief and on the part of the Police Adminis-Minister tration to see that these things are stopped forthwith. Another important aspect of the matter I am trying to bring to your notice and to the Government. I must tell you very frankly that where the military camps are stationed, it has become a centre of anti-social activities in Upper Shillong. So many harrassment and so many illegal acts have been committed by the Army personnel; they have completely demoralised themselves

and thereby they have also demor lised our people. Sir, the people who are stationed near happy valley, Gura Line and Umpling, you go there and you w ll see what is going on there. Many things are happening in our State in the military camps in the Survey of India and in other quarters as well. I want to say that there is no confidential or secret thing in the tate of Assim. If when a decision is taken by the Cab.net, within a few minutes these are e ked out and all confidential things are leaked out overnight, even before the issue of correspondences addressed to verious quarters,. In view of this, it is clearly proved as to how the Government departments are functioning. Sir, I am thankful to you for having allowed me to table this Motion. My intention in bringing this Moti n is not to create any ill-feeling between these countries. Afterall we are to see to the welfare of both these countries. We are brothers and we want to remain as brothers always. My Motion involves the quest on of the security of the country which is most important. By bringing this motion, I want to caution the Government to tighten the security measures and to bring to book those who were found negligent in discharging their duties. Sir, the Government should re-organise the Police administration so as to meet the situation that are being cropped up today. With these words, Sir, I commend my Motion.

Mr. Speaker; The debate on the motion should continue upto 11-15 and the Chief Minister is given 15 minutes to reply.

* Shri Phani Bora: Sir, this is a very important and delicate matter. To me, the importance of this matter which is under discussion is from the point of view of security of our country, and as a citizen, every one of our country is bound to be anxious to find out the truth. That there are CIA agencies functioning in our country is known to everybody. That there are spy-rings belonging to foreign countries is also a fact. No country today functions without espionage ring. The bigger countries have bigger rings and the smaller countries have smaller rings. It will not be surprising if we find that there are foreign espionage agencies functioning even in this border State of Assam. On the other hand, it swould be rather correct to apprehend that this kind of foreign agencies are very much active in the State like Assam. Sir, the importance of the question deserves thorough enquiry before one jumps to a sort of conclusion. After all I must make one point clear that so far as we Indian government or the Indian citizens are concerned, we are very much in favour of briging about a good friendly relationship between our country and our neighbours. Pakistan, China and with all the neighbours, we want to be in a very

good relationship. We should not do anything here which hampers our relationship or which a feeling or a stuation when our neigh creates might feel embarrassed and from that bour point of view I would rather say and I would rather request everybody that nothing is said and nothing in done which brings about a kind of antagonism between our neighbours. Here I do not have facts at my disposal to say that the girls who were with Mr. Kohli within the sprecints of that protected area of Survey of India were Pakistani spies or not. I cannot say that they are at the behest of Pakistan. I cannot also say that they are not at the behest of Pakistan. But the fact that it was a prohibited area which is not allowed to be tresspassed by anybody or everybody. There were two strangers who are found to be sleeping for two nights that itself is a very serious thing which deserves special attention of our Govt. who is incharge of law and order and security of the State. The Govt: of India who is in overall charge of the security of the country should also consider this respect very seriously. To my mind from the fact that are placed before us by the hon. Chief Minister and hon. my friend Shri Dulal Chandra Barua, I am inclined to believe that these two girls are call girls. But even if they are simple call girls that they cannot be utilised by certain agencies for spying activities cannot be said. That they cannot be utilised for taking away certain

papers relating to the security of the country cannot be ruled out. Therefore, as I said earlier it is a matter which deserves special and thorough enquiry. It is good that Govt. of India has taken certain steps very promptly. But in this connection my friend Shri D. C. Barua has very correctly put the question why a protected area which is to be guarded by our Police Deptt. and for which our Govt. is responsible should work up only when a question was raised on the floor of the Assambly. This deserve a censure. The Police Deptt, and the Home Deptt. should be censure because it is their primary responsibility to see that nobody enter there. From that of view I agree with my friend point Shri Barua that it is a failure on the part of the Police Deptt. of the Govt. of Assam when they failed to detect those people, apprehend these people beforehand. They should have done it even before question was raised in the floor of the Assembly. But nothing was done at all. Our Chief Minister took up the case and called for a report only after the question was raised in the flood of the Assembly. How the Govt. was sleeping over such matters and wake up only when they were pushed up by somebody when we are living in a state surrounded by foreign countries. It is a very serious thing.

Now, Sir, with regard to the carrying away of certain papers I do not know whether any paper has been transported to Pakistan or not. I want a

thorough enquiry and a thorough enquiry alone can reveal facts and on the basis of those facts one can come to some conclusion and before such an enquiry is made I do not want to say thing about it. I also want to request the Govt. to make an enquiry because it is not impossible on the part of some agency to place somebedy as a scape goat. I can not rule out such a possibility that somebody who are really doing spying activity on behalf of foreign countries who are allowed to pass over certain papers belonging to the security of the country they might put somebody as scape goat in order to hide themselve. I urge the Govt. to investigate the matter properly. Because there are instances in many countries of the world that the spies- they made ring and spread not in order to divert the attention of the enquiring agent or the Govt. and they try to put somebody to the net to make a scape goat. This type of things heppened in many cases. Therfore, it is good that a very important net or of secority is discussed in the floor of the House and this will help our Govt. to investigate and find out the real culprits. Therefore, at the end I again urge upon the Govt. and say that nothing is done in a haphaxard manner and nothing is done in a of plecemeal manner which might create complications in our relationship with our neighbours. But we must find out the truth and if that truth

goes against any country then also we should not be hesitating. We should not care whether that country is angree or not. But on our own we must be able to find out the truth and we must punish those who are responsible for it. Not only that follows who are engaged for this kind of things with call girls or spy girls should also be punished. The State Police Deptt. also should be taken into consideration in this connection. If it is only a biological thing then it is very simple but if it is done for spying activity then it deserves a very thorough enquiry. This is what I am to say.

Shri Moinul Haque Choudhury; Mr. Speaker, Sir, The matter which has been raised in this adjournment motion is an important one. In fact, I myself supported on the other day for accepting it as a motion. But in doing so I was impelled by certain facts given by the Chief Minister. One fact he gave was that this Survey of India building was a protected place and hence I made out a point before the House that in a protected place if a man could entertain outsiders two nights successively and if these outsiders were call girls then this was really a serious failure of administration and it should not be taken as an ordinary faileur. Since I made my speech on the basis of the facts given by the Chief Minister I have come to know that

this place had not been delcared as a protected place. Therefore, I am sorry that I had to speak certain things in this House on certain wrong facts. Therefore, my first regret is that I made a mistake on the basis of wrong facts. But that does not end the matter. Mr. Speaker, Sir. Because this brings in a very important question. That question is that Survey of India building under all canons of administration and all canons by which the security of a country is to be guarded must and ought to have been a protected place. In fact, if such a place is not delcared a protected place and unless there is a notice prohibiting the entry then of Course, the public has a right to enter into that place within the office hours. It is a pity. Whose fault it is, I do not know that the Survey of India building had not been declared to be a protected building after the Defence of India Act had lapsed. This is a matter which needs a thorough enquiry. It might be deliberate. It might not be deliberate. But in all circumstances it is a case of serious administrative lapse. But I conscious again for that lapse the Govt. cf India is responsible and this House has got nothing to disscuss now of an adjournment motion. It has limited our scope so far as the adjournment motion is concerned. In fact, I am in great doubt, if this information of mine is correct, how far this adjournment motion would be admissible, because

it relates to the internal administration of the Survey of India which is a Govt. of India administration The only question therefore, would be limited to us for a discussion is whether there was a failure on the part of this administration in any manner. Because, Sir, if in a particular office of the Govt. of India, its security guards do not prevent the call girls to enter if its officer uses a place unlawfully after entering lawfuly or unlawfully which means a tresspass within the purview of the Penal Code and then it becomes a matter within the jurisdiction of that administration. This House has nothing to do with it. In that case the only question that would remain for us is a general worry which as a citizen living in this part everyone of us will share is about the security of ourselves. Whether it is for the failure of the Survey of India or of the Govt. of India—to that extent certainly we can express our views and this may be forwarded to the Govt. of India. After knowing about the case whether the Police failed or not the Cnief Minister will have to answer us categorically. An impression both in this House as well as outside is these that Police moved only after there were certain agitation in this House, If that be so, this was unfortunate. Whether that failure amounted to a real failure, and the failure of a nature which brings the Police administration within the purview of the ajournment motion, is to

be considered. On this question there may be difference of opinion. But then, that point the Chief Minister will have to clear. Again I am not one of those that merely because a banner headline would come out in newspapers I will take a clue from certain employees of the Survey of India sending a telegram saying that some girls had been raped and make all kind of statements. If they were really spies and if they were call girls and if they came there at the instance of Mr. Kohli or somebody else, then there could not be any question of rape. Therefore, there was an exaggeration of fact to start with. It was alleged that they were Pakistani spies. Here I am one with Shri Phani Bord who wanted to leave the matter to the Govt. and to the Govt. of India to tell us after an enquiry whether they are Pakistani spies or not or whether somebody is trying to make them Pakistanis. calls for an answer from the Chief Minister.

Mr. Speaker, Sir. Our endeavour should always be to maintain a good relationship with our neighbours. Sir, I should not be misunderstood or mis-construed in this manner. I am one with those who feel that safety and security of the country is to be guarded at all costs. If any sacrifice is called for in this regard we should be prepared for this sacrifice. But that does not mean that in the name of safety and security every occasion should

be exploited to create a chaos in the country. The names of those people who are outside this House should not be brought in, in this House as they have got no right to defend themselves. Hon. Member, Shri Dulal Barua has brought in many names describing them either as Pakistanis or as spies. In fact, he should have handed over the names to the Chief Minister instead of speaking about them. After all, he is neither a Police Chief of India nor a Police Commissioner of Assam that he would know who is a Pakistani spy.

M. Moinul Haque Choudhury: Mr. Speaker, Sir, this gentleman is going too far. I am talking of the rules of the House. Rule of the House is that we cannot normally bring the name of anybody.

who is not in the House because he can not defend himself before the House. Therefore, the practice is the name should be passed on to the Chief Minister.

If he had done so already he has no duty to repeat them. I do not know Chinu Mian or those call girls. He said that the two girls arrested were not actually those two girls who were involved in that incident, I do not know Chinu Mian, Binu Mian or Punu Mian nor do I know those two girls, whether they are call girls or good girls. I know none of them. What I have been telling is about the rules of this House that it would be a bad precedent if in a debate like this we try to introduce some persons who would not have any chance to defend themselves. Neither he nor anyone of us knows about the antecedents of these people, whether right persons have been arrested by the Police or wrong persons. If anybody knows that wrong persons have been arrested then it should be his duty to go to the officerin charge of the Police Station help in the isvestig ation and say "look here, according to my information these are not the right persons you have arrested." Sir, I am not here for the defence of anybody; I am here for the defence of truth.

Shri Dulal Chandra Barua: Sir, on a point of order. I have followed the rules and regulations of this

House I have not brought any names here and those names which I have mentioned, I have already informed you accordingly. Sir, I have not come here to learn things from the hon. Member like a school boy. Whether I have followed the rules of this House, it is for you to decide and he has no right to say that I have not followed the rules.

- Mr. Speaker: In the name of point of order, you are discussing the matter. The point of order is not for discussing things. A point of order is raised for interpretation of the rules of the House in respect to a matter under discussion of the House.
- Shri Dulal Chandra Barua: He should not drag my name that I am not following the rules. He himself has not followed the rules because he brought the name of an individual who has no excess to this House.
- M. Moinul Haque Choudhury: Sir, this is mis-representation of facts. This morning I did not bring the name of any individual. I said a gentleman who is not a citizen of this country has been made a member. I did not mention the name as such. Therefore, Sir, I say that so far as the question of security of the country is concerned, we want an assurance from the Chief Minister that this aspect of the matter will be considered supreme and that under no circumstance the security of

the country should be jeopardised by anybody, whether it is Mr. Kohli or anybody, and it is for this reason I have intervened here to tell the Chief Minister that this incident has brought to our notice a weakness in the administration that even a place like the survey of India where our maps and other important papers are lying is not well protected. This matter should receive not only the attention of the Chief Minister, it should also draw the attention of the Government of India and let them take steps so that in future such a thing does not occur.

With regard to the present incident I would certainly request the Chief Minister to help the law to take its own course without any fear or favour.

*Shri Mahendra Mohan Choudhury (Chief Minister): Mr. Speaker Sir, we all are thankful to Shri Barua for bringing this fact to the notice of the House as the fact is very important and very much so for the security of the cuntry. I am thankful to him for bringing up this matter before the House. Sir, the other day while I made a statement on this incident I made certain wrong observation for which I regret. At that time I was given to

erstand that the area now occupied by the Survey of India campus is a protected area. I did not verify that information because I always go to my residence by that side and find a significant hung up there declaring it as a protected area and therefore I had no occasion to ascertain that matter further. After that I made certain enquiries and come to understand that the area has long ceased to be a protected area. This information I have got in this connection.

The Survey of India is a Central Government institution under the Ministry of Education and youth Service. In the context of the Chinese aggression the Survey of India campus in Shillong was declared as a protected place under the Defence of India Rules somtime in 1963. After the lapse of the Defence of India Rules when the Emergency was lifted in 1963, however, no fresh notification under any other law declaring the Survey of India campus as protected place has so far been issued. According to the Deputy Director he received instructions from the Survey of India authorities to treat the campus as "vulnerable place", Therefore, Sir, it is not protected area and suggestion as given by Shri Moinul Hague Choudhury that steps should be taken to declare it as a projected area, because in that area valuable records are maintained, I shall take up the matter with the Govt of India immediately;

Then again, Sir, some information have been given by Shri Barua in this connection, that some information have been despatched. I shall pass on this information to the Government of India for a proper enquiry. As the House knows, Sir, the matter has been seized of by the Parliament also. In both the Houses of Parliment the matter come up for discussion and in the course of discussion it has been revealed that Major Kohli has been suspended and a high power committee has been sent to Shillong to investigate into the matter. The committee is there and they are conducting this enquiry since 8.12.70. Sir, now, about the espionage and other things, I am not very sure about it. The matter requires further enquiry. But whatever information I have received up till now from that I can say that no document neither maps nor any other paper from the Govt of India Survey Department have been removed. These have been found in other,

*Shri Dulal Chandra Barua ? Sir, the Chief Minister may say so, but I have got doubts about it. If necessary I can give him more links. Shri Moinul Haque Choudhury has said that I am a Commissioner or a Chief Commissioner of police otherwise I could not have got these information. I do not know (interruption). Sir, the information that has

been given by the Chief Minister here that no document has been stolen is not correct: Chief Minister of course said that he is not sure.

Shri Mahendra Mohan Choudhury: I am not sure.

*Shri Dulal Chandra Barua: Sir, I have given only a part of the information. I will give you more about this, Sir and these are so very important and so very dangerous that the Chief Minister will tremble on this. I am not going to disclose these now.

Shri Mahendra Mohan Choudhury: Sir, I am glad that these information have been passed on to me and to the House but I have not received these as yet.

Therefore, Sir, from our side we requested the Govt. of India, Home Ministery to get the matter thoroughly enquired into by the Central Bureau of Investigation. Day before yesterday I had a talk with the Home Minister in Delhi and on his request we have sent him a talegram requesting him that the matter should be enquired into by the C.B.I. because the facts that have come before us are much more serious than it has been considered to be. And, I believe, very soon investigation will be made over to the C.B.I.

There is also a suggestion given by Shri Bora that the matter should be thoroughly investigated. We have taken steps to get the matter thorough-

ly investigated. All these information I do not want to discuss now for two reasons. One is that the time at my disposal is very limited and secondly, Sir, when we have requested to have an enquiry by the highest investigating authority, it is better that we do not discuss all these matters at this present juncture as Shri M. M. Choudhury has rightly said that these are matters more or less within the jurisdiction of the Central Government and they are seized of the matter. The matter was discussed in both the Houses of the Parliament and they are taking necessary steps. Therefore, Sir, on this score the Adjournment motion does not lie against this Government.

Now, Sir, about the failure of the Intelligence Branch, I do not say whether the girls are innocent or not. Allegations are there against two girls and steps have been taken against them. As regards the failure of the Govt. of Assam I would like to submit that the security of the place is the responsibility of the Survey of India. Since sometime past we have been requesting the Govt. of India that the security part of the campus should be handed over to the Govt. of Assam.

Shri Dulal Chandra Barua: When it was asked?

Shri Mohendra Mchan Choudhury: I cannot give you the date but that is the position and on the point of incurring expenditure some correspondence is going

on from our side, we are prepared to take up the security charge of that campus provided funds are given by the Government of India because it is Government of India's property. Therefore, whatever we spend for the security of that institution must be borne by the Government of India. That matter is still under correspondence and as soon the security charge is handed over to us, I believe we shall give a good account of ourselves.

Sir, now about the incident and whether there is any failure on the part of the Government of Assam or not. Whatever had taken place inside the campus was not known to us. One of the staff members of the Survey of India sent a telegram to Shri Bhakta Darshan, Minister of State of Education and Youth Welfare, who, I believe, is also in charge of that Department. While the Survey of India did not formally report the matter to the State Government, a copy of the telegram from a staff of the Survey of India, Shillong, to Shri Bhakta Darshan, Minister of State, Education and Youth welfare, was received by the Superintendent of Police, Shillong. The massage reads: "Major Kohli Survey of India Shillong raped girl in his office room on 21st at 23 hours Deputy Director suppressed incident security guards threatened resentment prevails security of nation in danger enquiry solicited". That was the telegram sent to Shri Bhakta Darshan by one

of the staff of the Survey of India, Shillong

(A Voice: What is his name?)

No name is given, it is anonymous. A copy of the same was sent by post to the Superintendent of Police, Shillong

(A Voice: When was it received by the Superintendent of Police?)

On 27.11.70. The telegram Shri Bhakta Darshan was dated 26.11.70 and the Superintendent of Police got a copy on the following day. On that post copy of an anonymous telegram I think no action could be taken. It must be admitted that as the matter was reported to be a sex matter, the Police were not very vigilant. But when the matter came up before the Assembly and when a story was linked with it involving the security of the State, then from our side we gave instructions to the Superinendent of Police to investigate into the matter and register a case under section 447 because except that section no other section of the Penal Code applies. My friend Shri Chaudhury said that there was a charge of rape.

Shri Moinul Haque Chaudhury: I did not say that. How could a call-girl be raped?

Shri Mahendra Mohan Choudhury: Therefore, it was taken by the Police that the girls were of bad character and went there voluntarily and there was no case to

rape. But on the score of trespass a case has been registered and the girls have also been arrested. Major Kohli has also been arrested and he is under military custody. He has been suspended by the Survey Department of the Government of India.

Shri M. A. Musawwir Chaudhury: Only to save the skin of the Police they have arrested two Khasi girls.

* Shri Mahendra Mohan Choudhury: I cannot discuss the merits of the case, which is only in the investigation stage. I do not know what will come out of it. These are all the facts which I have to place before the House. When the Government of India, who are the right authority in the matter, have taken action of the mettea when they have taken action on our request to get the enquired into by the C.B.I. and that enquiry will be instituted soon, and when the Government of Assam's case has been registered and the persons arrested and put into custody, when a high-power enquiry commission is investigating into the matter I think, Sir, adequate steps have been taken in this regard. The credit goes to Shri Barua for bringing this matter to the notice of 'the House and the country and alerting the Government to be vigilant in such matters of security. In view of what I have said I hope he will withdraw the motion.

*Shri Dulal Chandra Barua; Sir discussions have taken place on this motion and the Chief Minister has also replied. It is also the convention in the Lok Sabha that either the mover withdraws he motion or it is talked out. I just want to say one thing. As the House is taking the matter very seriously, my earnest request to the Chief Minister is that the State Government must play their role effectively instead of leaving everything at the hand of the Central Government. Apart from the facts which have come to light, I have in my possession some more information which, if necessary, I shall furnish to you and to the Chief Minister. It is not proper to bring all these facts before the House at this stage. I have in my possession very serious type of facts which can be disclosed to the Chief Minister. I hope the Chief Minister, as he has assured, will take all possible We are not concerned with the private life of anybody, we are only concerned with the security of our country. On this point the Chief Minister will please alert the Police machinery to be up to the mark. All this time they were sleeping. I hope they will wake up now and effectively look to the security of this State.

With these few words, I beg leave of the House, to with draw my motion.
