Shri Durgeswar Saikia asked :

- #87. Will the Chief Minister be pleased to state-
  - (a) Whether it is a fact that to reach the nook and corner of the area under Demow Police Outpost conveyance is a necessary?
  - (b) If so, whether Government propose to take necessary steps to remove the difficulties?
  - Shri Mahendra Mohan Choudhury replied : (Miniter, Parliamentary Affars)
  - 87. (a)—For quick movement a motor vehicle necessary is but for normal Police work a bicycle is considered adequate.
    - (b)—In view of the difficult financial position of the State, it is not possible to provide any vehicle at present to all Police Stations and Out-posts:

#### Re: Mao Posters in Gauhati

Shri Maneswar Boro asked:

- \*88. Will the Chief Minister be pleased to state-
  - (a) Whether the attention of the Chief Minister has been drawn to the news item published in the Assam Tribune, dated 29th November 1969. under the caption "Mao posters in Gauhati again"?
  - (d) If so, how far this statement is correct?
  - (c) What action has been taken by the Government in this regard?

Shri Mohendra Mohan Choudhury (Minister Paliamentary

Affairs) replied:

88. (a)—Yes.

(b) & (c)—It is revealed from enquiry that a few Naxalites from West Bengal have been operating in some parts of Assam including Gaubati. They have enlisted co-operation of some local extremists and have been indulging in clandestine display of posters carrying Mao's slogans to capture the imagination of discontent people including unemployed youths, poor peasants, agricultural workers, office employees and others and to cause an impact of the situation arising out of Naxalite activities in other parts of the

Country. Some such elements have already been located and kept under close watch.

- \*90. Will the Minister-in-Charge of Education be pleased to state—
  - (a) The total amount of money collected by the State Social Education Officer from various agencies as subscription or donation for hol-

- ding the adult education conference held at Gauhati during the last week of October 1969?
- (b) Whether receipts were issued to the persons or institutions from which subscriptions or donations were collected?
  - (c) The total amount collected as subscription from the B. D. Os and the S.E. Os for holding the conference?
- (d) How many delegates from within and outside

  Assam attended the conference and the number

  fo V.I. Ps attended?
  - (e) The total expenditure incurred in connection with holding the conference along with the expenditure incurred on reception of delegates including the V.I Ps?

Shri Joy Bhadra Hagjer (Minister, Education) replied:

- 90. (a)-Rupees 11,815'00 only was collected.
- (b)—Yes. Receipts were issued on behalf of the Association.
- (c)—Rupees 50 only from one B.D.O. and Rs. 8,358 only from the members of the Alt-Assam Social Education Organisers' Association which includes the District Social Education Officers and the Social Education Organisers.

(d)—Ninety-one delegates from outside the State and 31 from within the State attended Seminar from 26 th October to 28th October 1969 and 91 delegates from outside the State and 155 from within the State attended the Seminar Conference from 30th to 31st Oc ober 1969.

Among the V.I. Ps the Union Minister of State for Social Welfare, Sri Jayaprakash Narayan the Sarvodaya leader and a few high officials from the Government of India attended the Seminar and the Conference. The Chief Minister of Assam inaugurated the Seminar and the Governor of Assam inaugurated the Conference.

- (e)—The total expenditure incurred for the Seminar and the Conference is Rs. 15,745 only which has been met from the collection as stated at (a) above and from the Boarding charges realised from the delegates. No expenditure has, however been incurred for reception of the delegates including the V.I. Ps. from the Government.
- Shri Pitsing Konwar: What was the purpose of holding this conference? Is it a fact that the canference was held only to convince the Government to maintain the Social Education Wing separately?
- Shri Joy Bhadra Hagjer : It was an All India Conference sponsored by the All India Council for Adult Education.

#### Re: Social Education Organisers

Shri Romesh Mohan Kouli asked;

- \*91. Will the Minister- in-charge of Education be pleased to state—
  - (a) Whether Government have made arrangement to absorb the Social Education Organisers in some other Departments or to allow to continue in Social Education Wing in the Education Department?
  - (b) Whether Government has maintained any list of Social Education Organisers on seniority basis for their promotion?

Shri Joy Bhadra Hagjer (Minister, Education) replied:

- 91. (a)—A proposal for amalgamation of the Social Education Wing with the Inspecting Wing of the Education Department is now under ac ive consideration of Government.
  - (b)—Yes.
- Shri Romesh Mohan Kouli: The answer to b) is "Yes".

  But is it a fact that some of he senior Social

  Education Organisers have not been recommended

  for promotion?
- Shri Joy Bhidra Hagjir: I do not know the particular cases, but generally speaking, all who are consi-

dered fit for being made permanent will be made permanent. That is the general policy.

Shri Prabhat Narayan Chaudhury: Have Government considered the fact that the social education organisers placed under the Panchayats will be required for the Publicity Wing of the Panchayats even after the winding up of the Social Education Department?

Shri Joy Bhadra Hagjer: It is difficult to say.

Shri Romesh Mohan Kouli: The Minister has said ihat the cases of all social education organisers, who are considered fit, are recommended for promotion. But I know there are some cases of senior social education organisers who have not been recommended by State officers. I want to know from the Hon'ble Minister such specific cases. Though he says that he does not know of specific cases, but I know he is aware of one particular person whose case has not been recommended.

Shri Joy Bhadra Hagjr: I know the case, Sir. It is being looked into.

Shri Nakul Chandra Das: Are Government aware that there are some allegations that lady social education organisers are deprived of their proper right of promotion or confirmation? I mean

there is reported discrimination against lady social education organisers in respect of promotion and confirmation.

Shri Joy Bhadra Hagjer: The position is this: lady social education organisers are being maintained by the Planning and Development Department purely on a temporary basis. Others who are paid out of the Education budget will be confirmed in due course. There are, of course, ladies who are holding posts of social education officers. But if you say 'lady social education organisers", they are borne by the Planning and Development Department purely on a temporary basis. So, there are two categories.

Shri Dulal Chandra Barua: So far as we know, the social education organisers are appointed by the Education Department and then placed at the disposal of the Planning and Development Department or the Panchayat Department. If that is so, which Department is responsible for looking into their interest? This is question. No 1

No. (2)—Whether it is a fact that Government have decided for amalgamation of this particular Social Education Wing with the Education Department? If so, what are the principles for safeguarding their service conditions, promotions etc.

- Shri Joy Bhadra Hagjer: So far as the Social Education
  Organisers who are borne in the books of the
  Education Dedartment, they will be made permanent and their inter seniority will be decided later on. As for the Lady Social Education
  Organisers, it is not for me to reply.
- Shri Nakul Chandra Das: Since the Lady Social Education Organisers are performing the same duties as the Social Education Organisers, is it not incongruous to place these Lady Social Education Organisers in another department just to deny them their rights?
- Shri Joy Bhadra Hagjer: Lady Social Education Organisers are appointed purely on temporary basis and not by the Education Department.
- Shri Nakul Chandra Das: Do the Govt. be pleased to consider their security of service and other facilities?
  - Shri Joy Bhadra Hagjer: We can take up the matter with the Planning & Development Department.
- Shri Prabhat Narayan Choudhury & The Minister replying to the original question admitted that there is a proposal for amalgamation of the Social Education Wing with the parent Education Department. In view of the fact that there are many

underguaduates serving as Social Education
Organisers and in view of the fact that Government has deicded not to continue the undergraduates, how do the Government propose to fit
in the undergraduates in the parent Education
Deptt.?

Shri Joy Bhadra Hagjer: They will be made A.S.Is.

Shri Prabhat Narayan Choudhury: Is there a proposal to do away with the S.I.S, in the Education Department?

Shri Joy Bhada Hagjer: I am not aware of it.

Shri Promode Chandra Gogoi: The Minister has replied

that there is already a proposal to amalgamate the Social Education Wing with the Education Department. May I know from the Government as to how these officers of the Social Education Wing will be accommodated in the Education Department? Whether according to their educational qualifications, or according to seniority?

Shri Joy Bhadra Hagjer: Both.

Re: Appointment of social Education Organisers

Shri Pitsing Konwar asked:

- 92, Will the Minister-in-change of Education be pleased to state—
  - (a) The minimum educational qualification required for the post of Social Education Organisers according to the advertisement made for recruitment to the posts?
  - (b) Whether conditions have been laid down in the advertisement to the effect that the Graduates who are appointed as Social Education Organisers will be given the benefit of seniority and will be given promotion earlier?
  - (c) If not, why seniority of the Social Education
    Organisers has not been counted sine; the date
    of their appointment by considering their minimum educational qualification for the post of
    Social Education Organisers?
    - d) The reasons for depriving the undergraduate Social Education Organisers the benefit of seni-ority and promotion?

Shri Joy Bhadra Hagjer (Minister, Education) replied:

- 92. (a)—The minimum educational qualification required for the post of the Social Education Organisers is a degree from any recognised University.
  - (b)-No.
  - (c)—The seniority of the Social Education Organisers

- who possess the minimum requisite qualification is counted from the date of their appointment.
  - (d) As they do not possess the min mum requisite qualification for promotion to the post of a District Social Education Officer.
- Shri pitsing Konwar: Is the Govt. aware that there are some Social Education Organisers who are not matriculates? If so, how they can be absorbed as A. S. Is in the Education Department?
- Shri Joy Bhadra Hagjer: Does the questioner mean that there are non-matriculates also?

Shri Pitsing Konwar: Yes.

Shri Joy Bhadra Hagjer: In the beginning there was no clear cut policy laid down, whoever was available was appointed. Since then a policy has been laid down that only graduates would be appointed.

#### M. Shamsul Huda asked:

- \*93. Will the Minister-in charge of Education be pleased to state—
  - (a) Whether appointments of Headmasters/Headmistress, Assistant Headmaster/Assistant Headmistress, Principals and Vice-Principals of Government Schools (M. E., High and Higher Secondary) are made on the basis of seniority?
  - (b) If not, why?
  - (c) Whether these appointments are made on State basis or locality-wise?

- 35. (a)—(1) In the Draft Fourth-Five Year Plan Programme of Rs. 12 crores there is a provision of Rs. 136 lakhs with an expanded Programme of Rs. 200 lakhs for construction of major Bridges.
  - (2) Rupees thirty-six lakhs with an expanded programme of Rs. 54 lakhs, which is 45 per cent of the total amount of allocation as per the decision of the 10 th A. R. C. B., has been provided for metalling and black-topping of roads under State Level Schemes.
  - (b)—Yes, two lists are placed on the Table of the House
  - (c)—The State Level major bridge Schemes were selected considering the importance and urgency of the proposals for improving the efficiency of the road communication in under-developed areas for replacing the ferries and for reconstruction

of weak and narrow bridges, to the extent possible with the limited funds. For the State Level metalling and surfacing Scheme the importance of the roads from various aspects like traffic needs and requirements of industries, etc., were taken into consideration.

Shri Dulal Chandra Barua: Sir, I have got one supplementary only. Whether it is a fact that the project which has been sanctioned by the Govt. of India and when the administrative approval and other things have been sanctioned by the State Govt. But that could not be taken up. It due to certain political pressure? If so, how is this?

Shri Altaf Hossain Mazumder: Sir, the Govt. of India has not sanctioned any bridges.

Shri Prabhat Narayan Choudhury: There was a recommen dation by the Assam Road Comunication Board to the Government of India to extend a lateral road from Chapanguri to North Lakhimpur via Kumarikhata. Sir, there was a recommendation from the Assam Road Communication Board to the Government of India to extend the Lateral Road from Serfanguri to north Lakhipur via Kumarikata and in doing so there is a consensus of opinion in the Road Communication Board that funds will be made available from the State fund to divert the road via Hudukata and Mainamati.

Sir, may I know whether the Government was pleased enough to provide fund for formation of the road before it is taken up by the Government of India as defence road?

Shri Altaf Hossain Mazumdar: Sir, before replying to the hon. Member Shri Chaudhury I would like to reply to Shri Dulal Barua's question. As regards the project referred to by him the State Government proposed to construct a bridge there and about the selection of sice there was some representation.

These are being 're-examined and will be decided on merit.

Shri Dulal Chandra Barua: My question is what is the reason for the delay? Because technically it has been already finalised. The project reports have been already finalised and administrative approval has also been obtained. Now whether it is a fact that it is not from the technical point of view but from the political point of view this has been delayed. If so, may I know from the Government when the project is going to be taken up?

Shri Altaf Hossain Mazumdar: It is not from any political point of view. But as I have stated already regarding the selection of site public made some representation and it is from that point of view the technical aspect of the matter is being reexamined by the Department.

Shri Prabin Kumar Chaudhury (Minister of State, Transport): Sir, regarding the petition filed by the Dibrugarh Industrieal and Commercial Co-operative Society Ltd., before the Finance Minister I have already stated that C. M. Secretariat is said to have delivered the petition to some one who does not belong to my Department.

On 3rd April, 1970 I got the matter referred to the P. P. S. to the Chief Minister. My Department has received a reply from the P. P. S. to the chief Minister on 8.4.70. In reply, it is stated that the peon, Shri S. C. Das cannot remember specifically as to whom he served the petition in question and he requested that he may be excused

as he cannot remember now as to whom he delivered the petition in question. Further, the P. P. S. to the Chief Minister has intimated my Department that he has referred the matter to the C. I. D. for and investigation and he will let my Department know about the further result.

I got a duplicate copy of the petition filed by the Dibrugarh Industrial and Commercial Cooperative Society Limited before the Finance Minister on 6.4.70 from the Under Secretary, Legislative Assembly. Immediately thereafter, my department has called for a report from the D. C. Dibrugarh whether Shri Abdul Majid was ever externed from Jonai transferred area. My department also referred the matter to the Political Department on 8.4.70 seeking the same information.

Political Department has reported on 9.4.70 stating that it has no such information available in its record and therefore it is collecting the same from the local authorities concerned.

However I contacted the D. C., Dibrugarh over phone at my own initiative on 9.4.70. I sought information from him as to whether Shri Majit was arrested by police during Indo-Pak hostilities in 1965 or ever externed. I received a telephonic call from the Additional Deputy Commissioner, Dibrugarh and he informed me that he collected the

information from Shri P. K. Mahanta, Addl. S. P., Lakhimpur. This Additional S. P. informed the Additional D. C., Dibrugarh that as per D. S. B's records, Shri Majid was neither arrested during Indo-Pak hostilities under D. I. Rules nor was he externed.

Lastly I may be allowed to inform the august House that the same Society filed a civil Rule No. 263 of 1970 in the Assam High Court on 7.3.70. This Society had prayed for the stay of the orders of settlement of this ferry in favour of Shri Majid. While the High Court had admitted the Civil Rule on 31.3.70, it rejected the prayer for stay on 1.4.70. The Civil Rule is still sub judice in the high Court.

Bhattacharyya : Sir, the Minister Shri Gaurisankar has just now said that a communication which was duly received in the Secretariat of the Chief Minister was delivered to a person who is unknown and wao is unidentified and unidentifiable. This is a very grave matter because when a communication goes from one Ministry to an other there is a procedure of sending it through a Dak Book and that dak or that letter or communication is to be received by a properly authorised person putting his signature in the Dak Book or the Peon Book. How is it that a paper like this is delivered by the in charge of the Chief Minister's Secretariat (Shri Debeswar

Sarma-what was this paper ?)-probably the Hon'ble Member has heard that this paper was regarding a serious matter; that a particular person was considered to be anti-national, that a particular person was considered to be anti-national, that a particular peason was considered to be undesirable and dangerous for the safety and security of the State in the border area like Jonai which is a very delicate area linked with China. Therefore, the question is not whether during the Indo-Pak conflict this man was externed or not. very fact that the man was not externed not from the Pak border but from the Indo-China border, the allegation is that he was externed from the Indo-China border or near about-Jonai area-it is not enough to get some information over the phone because an information received by air vanishes in the air. If the Minister was to rely on the report of the Deputy Commissioner he ought to get it in writing. That only would have been authentic. Otherwise, the Deputy Commissioner is alleged to have said something over the phone but the next day when the matter becomes serious he may deny having said such a thing. Anybody may impersonate him also over the phone. Therefore, it is dangerous to rely only on a telephonic talk without relying on records. This is one point. The other point is that the paper was lost from the Chief Minister's Secre ariat is a very dangerous thing and this gives an indication of more dangerous thing that might be coming. I therefore request the Government, Sir, through you that there should be a thorough investigation into the matter by the Chief Secretary himself and anybody who is responsible for this either for commission or for omission should be properly dealt with. Will the Minister in charge of the Government now be pleased to give an assurance to the effect that an investigation or an enquiry will be caused into this matter by no less then the Chief Secretary himself?

Shri Debeswar Sarmah: Mr. Speaker, Sir, this is a serious matter and further more from some quarters it is observed that certain families collect funds for assistling the Azala Kashmir fund, I mean, the Pakistan areas through their secret agencies; Pakistani flags are hoisted by some people in certain pockets and these are being favoured by some of the Ministers of our Government. I am not talking of the present occasion. Certain families do some nefarious, anti-social things but they are being given contract or some such facilities by our Ministers. Certain families in Dibrugarh who are alleged to be (we do not know but the Government may know of it) not of very clean reputation, are alleged to be in contact with people who are not friendly to our country or

our State, are being favoured by our Government directly or indirectly. One particular family in Dibrugarh is favoured with important fisheries. They are favoured with the Sonarighat Ferry, although they do not carry good reputation, at the cost of the our national secutiry. Even I am told that one of the brothers of this lessee is sitting in a certain Minister's house this morning

Shri Probin Kumar Choudhury: Who is the Minister?

Shri Debeswar Sarmah; Some Minister, not you. I know next to nothing. I am not insinuating anybody. I have simply been told about an hour ago, some people have come from Dibrugarh and they have told me, that in Sonarighat Ferry the toll is charged 3 rupees which officially is only 0.70 paise. And that is being done for the last several years. Only the year previous to ihis vear this ferry was settled with another party. This year the cnot. shall has been settled with an Abor gentleman. Some men of these brothers to beat him the other day. Sir, this is a very troublesome affair. We want this matter to be investigated and the Government should place all matters before the House, because it is a matter of great concern to us.

Shri Dulal Chandra Barua: Sir, in addition to what his been stated, I want to say something more. I am

not so much concerned with the reports or externment of a particular gentleman from a particular area. I am concerned only with the official procedure. When an important paper is sent either the Finance Minister or the Chief Minister-to a respective Department, the Dpartment which receives that letter must put a signature in the dak book. I would request the hon. Minister incharge of Transport as wall as the Deputy Leader of the House to investigate into that part cular signature. I have been told that instead of sending this paper to a particular Department, the very same letter was handed over on the way to a particular person against whom an allegation was lodged. This letter was brought from the Chief Ministers secretariat and straightaway it was handed over to a particular person. This is my point No.1. My second point is that the Minister incharge of Transport has informed this House on the basis of a telephonic report received from the D.C. Lakhimpur that there is no such record from which they can acertain that the said person was extern from Jonai area some time back. But our information is very much different. I want to tell you that some hobnobbing or such other things are going on here in the Secretariat Departments. The Confidential Branch and the C.I. Department are there. Records of such kind of arrest must be there. Even when we have been arrested under the P. D. Act all our records and doss ers were

maintained by the Confidential Branch and the C.I. Deptt. May I know whether on the basis of such dossiers Government can come forward and tell us that this is not true. I am saying that the dossier of that particular family and that particular person is there and so far I know one of his brothers was also arrested last time during the Pakistani Aggression and the entire family record was kept in the Confidential Branch. Now the Minister stated that the Confidential Branch and the Criminal Investigation Department are not in a position to bring out the records. Are we to understand that these two Departments are not in existence? Therefore, I fully agree with our Leader, Shri Gaurisankar Bhattacharjya when he said that a through investigation should be conducted and the full report of the matter shoul i be placed before the House. No less a person than the Chief Secretary himself should be entrusted with the enquiry and the full report of the matter should be placed before the House including the Peon Book so that the House can be convinced about the action and decision taken by the Government. My another suggestion is that pending decision in this matter, and as expressed by the Honble Member Mr. Sarma, as the antecedents of that particular family are questionable and doubtful and as we have raised a discussion in this Honse about the matter which will automatically creates public apprehension, so pending all the enquiries.

Shri Mahendra Mohan Choudhury (Minister, Revenue):
Sir, I fully agree with Shri Gaurisankar Bhattacharyya
that the talk between the Deputty Commissioner
and the Minister, Transport is not a conclusive
proof on this point. The Minister has already stated
that the matter was referred to the Political Department and in the office there must be some records
on this point. Therefore, he is sending the papers
to the local authorities. We know the Minister has
contacted the Deputy Commission because the hon.
Members are pressing for this information from
him for the last three days. Therefor, for the

purpose of an interim reply he has collected the information from the Deputy Commission. I hope the information which has been given by the D. C. and furnished to the House will be reduced in writing by the Deputy Commission. Sir, as soon as the Political Department submit its report regarding the antecedents of this particular person that report will be placed before the hon. Members and will be laid on the Table of the House as early as poossible

## (Voices: When, when)

It must be during this Session. The next serious thing is about the paper forwarded by the Chief Minister's Secretariat to a particular Department which is missing during transit. This is a very serious matter. This matter should be thoroughly enquired into. The Honble Minister in his statement has stated that the P. P. S. to the Chief Minister had informed him that the matter had been referred to the C. I. D. for investigation. As has been suggested by the hon. Member, Shri Gaurisank ar Bhattacharyya, I shall surely ask the Chief Secretary to be seized of the matter and to conduct the enquiry by himself or under his direct supervision (Applause from the Opposition).

Sir, about staying settlement of the Ferry, this is impossible because the law does not permit it and at the same time the matter is seized by the High

Court and is sub judice. Therefore, at this stage, the order of Government cannot be revised.

The points which have been raised by Shri Sarma are very important but he has not brought any specific instances. Sir, certain allegations are somtimes based on facts and sometimes they are not based on facts. Even then it is desirable that we become careful about all such activities and from the side of the Gevernment we should see that such persons of doubtful loyalty should not get any favour from the Government.

- Shri Debeswar Sarmah: Will Government be pleased to take effective steps to prevent this lessee from charging Rs 3/—in place of 70 paise? This has always been done and this Government cannot plead ignorance of that.
- Shri Mahendra Mohan Choudhury: Sir, there was such allegagation some time back and as far as I can remember (Of course I am subject to correction) an enquiry was instituted to go into the allegation. Honble Member Shri Ramesh Mohon Kouli brought these charges that the lessee was realising Rs 3/—instead of 70 paise by engaging private boats by this lessee. I do not know whether this was in regard to the lessee of Sunarighat or orther lessee but from the enquiry it transpired that was not a fact.

- Shri Debeswar Sarmah: So it was not a fact, and it is also not a fact that it is not 10,20 A. M. now but 10.20 evening.
- Shri Mahendra Mohan Choudhury: No it is not a fact. I am speaking from my memory....

Adjournment Motion-Strike by the employees of the Assam Co-operative Apex Bank Ltd.

of this coworful party because

Shri Dulal Chandra Barua: Sir, under Rule 56 of the Rules of Procedure and Conduct of Business in the Assam Legislative Assembly, I want to move an Adjournment Motion on a definite matter of urgent public importance and of very very recent occurrence. It is a definite matter because I have placed before you only one matter of recent occurrence for which the intervention of the House

is essential. The strike that has been resorted by the employees of the Apex Bank Branches of the State has paralysed the monetary transaction of the State and has caused great inconvenience disadvantage to the people in general. Moreover, Sir, this motion is free from the restrictions that were laid down under Rule 57 as it is only one motion which I have placed before you which seeks to discuss only one definite matter. The motion is also not anticipating anything it is a definite motion. It is also not a motion which can come in the form of a resolution. It is not also a motion which is dealing 'with a matter which is under adjudication by a Court of Law: it is not also a question for raising privilege. My motion is also free from the restriction of Rule 57 (viii) 'that a motion must not relate to a matter which is not primarily the concern of the Government of the State. 'Sir, in this connection, I would like to that though the Apex Bank is conducting its business independently, its management is controlled by the Government because the Govt. becomes the share-holder of the Apex Bank. The Co-operative Department of the Govt. has got direct control over this Bank. Therefore, it is primarily the concern of the Government of the State.

Sir, this strike has caused great enxiety in the minds of the employees serving in different branches of the Bank. Though they have placed their

demands before the authorities times without number, nobody cared to look after their grievances. Finding no other alter native, the employees have chosen this constitutional means to press forward their demands. So, Sir, when the House is in session, I feel that this matter should be discussed through this abjournment motion in order to find out a solution and that the decision of the matter brooks no delay. That is why I consider it a very definite matter. This strike is going on from to-day and it has become a matter of great public concern causing great hardships to the public as the transaction has also been stopped. This has caused great inconvenience to the businessmen, and if this strike is allowed to continue, many people will suffer. Therefore, to put an end to this important matter, I submit that the House should intervene and find out a solution so that the demands of the employees serving in those branches of the Bank can be settled amicably and the function of the Bank can also run smoothly for the benefit of the people. With this end in view, I submit that this motion has fulfilled all the conditions of Rule 56 and is also free from the restrictions laid down under Rule 57 of the Rules of Procedure and Conduct of Business in the Assam Legislative Assembly. Considering the gravity of the situation and also considering the legitimate grievances of the Bank employees, I consider it a fit case to be discussed in this House through this adjournment motion so that we can decide the matter inside the House just now without further delay.

Shri Lakshmi Prasad Goswami (Minister Co-operation) Sir, I have also received information that the employees of the Apex Bank have observed protest day to-day by abstaining from work. It is a dispute between the employers and the employees of the Apex Bank which is managed by a Board of Management and it is an autonomous body. The hon. Member, Shri Barua, has rightly pointed out the sub-rule (viii) of Rule 57 of the Rules of Procedure and Conduct of Business in the Assam Legislative Assembly. It reads: "that it must not relate to a matter which is not primarily the concern of the Government of the State". It is primarily a matter concerning the Board of Management and such disputes are regular features. There is also provision that for the grievances of the employees, the employees can observe protest day and after serving notice according to the provisions of the law, they can also go on strike.

Now, another point, Sir, at the time when this motion was submitted, there was no strike—because to-day the Assembly met at 9 a. m. and at that time there was no strike at all, though I have seen that there were some posters displayed somewhere on

the street that there will be a 'protest day'. So, it could not be anticipated at the time giving notice of this motion. Therefore, the contration of the hon. Member that there is dislocation of transaction of the bank causing inconvenience to the traders and the general public is not tenable. There its also no administrative failure on the part of the Government. Under the circumstances, I do not think, Sir, the motion is admissible.

Shri Dulal Chandra Barua: Sir, I have heard the argument put forward by the hon. Minister. Refering to subrule (viii) of Rule 57 of Rules of Procedure and Conduct of Business in Assam Legislative Assembly, the hon. Minister tries to assert that the matter is not primirily the concern of the Government, but I would like to say that the matter is directly concerned with Apex Banks of the State and the Bank is conducted by a Board which is controlled by the Co-operative Department of the Government, that means, this is a matter which is primarily the concern of the Government. again, Sir, the hon. Minister has just said that there is no scope of Government failure in this case. Sir, in this connection I would like to draw your attention to the fact that the employees of the organisation have submitted a memorandum demanding redress of their grievances

( Voice—No, No )

but no action has so far been taken due to which there is agitation and as a consequence the Apex bank administration is going to be collapsed, or in other words, the Government is not in a position to function properly and effictively. So, it may be taken as a failure on the part of the Government. Again, Sir, the hon. Minister wanted to show that while we served the notice, there was no strike and how could we anticipate whether actually there will be any strike. In this connection, I want to draw the attention of the honourable Minister to Rule 58 of Rules of Procedure of the Assembly where it is stated that—

"Notice of an adjournment motion shall be given before the commencement of the sitting on the day of which the motion is proposed to be made to each of the following:

- (i) the Speaker
- (ii) the Minister concerned : and
- (iii) the Secretary

Therefore, according to the rule, we are to give notice before commencement of the sitting of the House. The Minister cannot say that the strike is not going on. Actually, it is going on and the bank is not functioning at all thereby causing inconvenience to the traders and public at large. Therefore, the argument advanced by the hon. Minister is not tenable. Sir, considering the gravity of the

situation and urgancy of public importance, you will be kind enough to allow us to discuss the matter through an Adjournment motion.

Shri Sailen Medhi: Mr. Speaker, in support of the contention put forward by my friend Shri Dulal Chandra Barua, I would like to add a few points. Sir, so far as sub-rule (viii) of Rute 57 is concerned, the hon. Minister has categorically said that the matter must not relate to a matter which is not primarily the concern of the Government. But, Sir, my submission is that as a result of this strike not only the employer or the employees of the Cooperative Apex Bank are bady affected. but all sections of people of the State will be directly, or indirectly affected. So, the argument advanced by the hon. Minister that Government is not primarily concerned with the matter, is not correct. Moreover, this is a specific matter and it has not been discussed in the same Session of the House. Therefore, the motion is perfectly in order and the matter can be discussed through an adjournment motion. I therefore request the honourable Spkeaker to allow us to discuss this matter of urgent public importance through an adjournment motion.

Shri Dulal Chandra Barua : Sir, I would like to add further that this is a specific matter of recent

ssed before in this Session of the House. This is only the matter of this kind put forward for discussion in the House during this Session and all the conditions laid down in sub-rules (ii) and (iii) of Rule 57 of the Rules of Procedure and Conduct of Business of Assam Legislative Assembly, are satisfid, I, therefore, request you kindly to allow us to discuss this urgent matter of public importance through an Adjournment motion.

Mr. Speaker: Order, order please. I have heard both sides of the House: Today is the last day of this short Session and the time at our dispesal is very limited. We have already crossed 10-30 A. M. As we have committed that the Minister would start winding the debate on Governor's Address from 10-30, I donot like to waste any more time now. Therefore, I defer my ruling till first day of the next Session.

Shri Mohendra Mohan Choudhury (Minister, Revenue etc.): Mr. Speaker, Sir, for more than six days this august House has discussed the Governor's Address and a sizeable number of Members have participated in the discussion. The hon. Members have not only offered very many valuable suggestions but also have brought to the lime light some of the pressing problems facing solution in our State.

I congratulate them on these scores.

The Governor has prefaced his address by a reference to the creation of the autonomous state of Meghalaya. The creation of Meghalaya has been received with a mixed feeling. Sir, here I must submit that in an address of this nature all points cannot be brought in and only the salient points have been brought in the address. Therefore, any omission on this score, the hon'ble members will excuse. We should accept the birth of Maghalaya gracefully and give our whole hearted co-speration and support so that the experiment launched by the creation of the Meghalaya autonomous State receives with full success. Let us march forward in shoulder with the people of Meghalaya to develop this eastern region of Iadia inhabited by varities of people having distinct civilization and culture. We should not forget that we are bounded by foreign countries which are not friendly with us. Our security and the security of India can only be strengthened if we work cohesively and with a unity of purpose.

I may not be able to meet all the points raised by the Hon'ble members, but that should not be taken that we are not mindful to them. I have taken notes of them and we shall take into consideration all of them for their redress. I shall take only the salient points the Hon'ble members have raised and shall try to satisfy them with the other man's point of view on those points.

While dealing with the subjects I have clubbed together the speeches of the hon. Members have drawn out the common points they have raised. I shall deal these points one by one. Hno'ble members will execuse me if I have omitted their names. Assam has not marched forward along with other State of our country during the last two decades. This is because of certain historical reasons. The British ruled our country for about two hundred years. During the British regime the Britishers did not do much to develop this region lying in the eastern most corner of our Big Country. The International Border in this sector was badly neglected. Industrial development was completely

ignored. In education both technical and general we were made subservient to other sister states. Communication and other social service did not get much attention. Except in a very limited ten garden areas road communication was at the lowest ebb. In the circumstances the State Government had to invest more than sixtythree crores of rupees in order to meet the basic need of the State for development. In this amount could have been made available for productive purposes most of the imbalances such as industries, employment etc could have been made up.

I cannot be said that financially Assam has been neglected. In the matter of shares of the Central taxes, Assam had been given what has been recommended by the successive Finance Commission on formulae aplicable to the whole of India. It is a question of opinion whether the Finance Commissions should lay more emphasis on some aspects in preference to other aspects. For instance, in the matter of the sharing of the income tax we lay more emphasis on the origin of the assets leading to the income. Some other states lay more emphasis on collection. Others emphasise the question of the population. As such, the Finance Commission has always to strike a balance having regard to all the aspects prevailing through a vast country like India.

In the matter of subventions again, it is not possible to say that Assam has been neglected. For instance, the only States which get higher subventions than us are Orissa and West Bengal. Orissa has been given Rs. 24.5 crores a year and West Bengal Rs. 22.29 crores a year as against Assam's Rs. 20.80 crores in 1969-70. In subsequent years, the position is that only Orissa will get about rupees two crores more than us in 1970-71 and a few lakhs more in 1971-72. In the subsequent year, we will be topping the list.

In the matter of plan assistance also, Assam has been grouped along with Nagaland and Jammu and Kashmir as three backward States requiring special assistance. Hence, out of the Central kitty of Rs. 3,600 crores, Rs. 400 crores have been set apart for the three States and Assam has been given Rs. 220 crores as Central assistance for the Fourth Plan.

From time to time since 1964 the Government of Assam have been taking up with the Government of India the question of extending the Broad Gauge line from New Bongaigaen to Gauhati via Goalpara in addition to the extension to the Broad Gauge Line to Gauhati along the existing metre gauge line. It was pointed out that the whole of the lower Brahmaputra Valley, south of the river Brahmaputra, the N. F. F., the States

of Nagaland, Manipur and Tripura are connected with the rest of the country by the Saraighat bridge only. It is needless to reiterate that if a Railway line is constructed to connect New Bongaigaon with Gauhati via Goalpara in the South bank of the river Brahmaputra it will greatly facilitate tapping of natural resources of the Garo Hills District which has atundant coal reserves besides connecting the states and Union Territories mentioned above by alternative from enriculture. Unless we improve the property

The Government of India have ordered an economic survey of the transport needs of the Lower Brahmaputra Valley by University of Gauhati and it is requested that they would soon go into the question of extending the Broad Gauge line from New Bongaigaon to Gauhati via Goalpara, also for the safety and security of the people of Assam and the neighbouring States and Union Territories.

To connect the two railway terminus at Jogighopa and Pancharatna and to save the recurring cost of ferrying, it is suggested that a new rail-cum-road bridge be built at Jogighopa.

> As soon as possible the Railways may also take up the construction of the railway line from Darugiri (Garo Hills and connect it with the railway line coming from Pancharatna-Ghat to

Gauhati near Dudnai. This area is very rich in natural resources. Coal reserve to the extent of 100 tons is estimated to exist near Siju and in Darangiri, and about 3 lakhs tons of coal can be produced here annually after a few years of mining operation. Gypsum, which is one of the principal requirements of cement factory has also been found in this area,

Ours is an agricultural State: 80% of our people live in the villages and earn their livelihood from agriculture. Unless we improve agriculture it is a far distant cry to improve the economic condition of our people. From the side of the Government very many schemes for improved and scientific agriculture are in operation. The people now have become fertiliser minded. The consumption of fertilisers is on the increase. Irrigation was unknown to our State till few years back. . In the first two Plans no irrigation scheme was taken up. At that time our main concentration was for flood control and drainage. As the land holdings are becoming smaller and as the people have now become multicrop minded, irrigation has become an imperative necessity. We have not been able to progress in this respect much but a beginning has been made. The Jamuna Irrigation Project is expected to irrigate about 44000 acres of land. Similarly, Patradisha and Harguti irrigation Projects also, on commission, will be able to irrate a sizegeaqle area of land. The Sukla Irrigation Project and a few other minor irrigation projects have been taken up and when completed people of a big area will be supplied with irrigation facilities. The minor irrigation schemes taken up by the Agriculture Department which includes power pump facilities and shallow filter tubewells and deep tubewells will also go a long way to meet the demand of the people for water for irrigation.

We most welcome the decision of the two autonomous districts of Mikir Hills and North Cachar Hills for having chosen to remain within Assam. This has added to our responsibility and obligation. The Governor in his address has rightly observed that the pace of development in these two districts will not only be maintained but accelerated. This assurance can only be realised by putting more funds for development for these two districts and implementing the developmental projects in right earnest and with efficiency. The respective District Councils also will have to be up and doing to see that the aims and aspirations of the people of these two districts are fully realised. I repeat the same thing also for the Mizo Hills district. The Mizo Hills district is passing through an unhappy state of affairs but it is a welcome augary that things are gradually being improved. I hope good sense will dawn on the Mizo rebels and very soon they will give up their destructive activities and take to constructive activities and with the help of the State Government and the Govt. of India the back-log of the development in that district will be made up.

The recent Namrup incident which his been referred to by many hon. Members is a very deplorabble one. I do not want to go into details of this unfortunate incident but only hope that such incidents do not recur in our State. There is a section of people who make capital of this kind of incident and taking advantage of the situation try to blackmail the people of Assam without knowing the genesis of such incidents. It is the general grievance of the people of Assam that the Assamese youths are not getting their due share in matters of employment and other facilities from such an enterprise. That impression can only be eliminated if the management of such projects act wisely and respect the feeling and sentiment of the people of the State. This matter has been discussed on the floor of the Assembly on many occasions and, therefore, I do not want to repeat it here. I simply hope and trust that the lessons from the incident in Namrup will be taken note by all concerned. Hon. Members Shri Bhattacharyya and Shri Upen Sanatan have refeunfortunate affair and we express our deep sympathy for the family of the deceased. We should try our best as to how we can avoid repetition of such incidents in future.

The problem of housing is not the problem for the police housing alone but a problem for all Government servants and also a problem concerning the entire population of the country. The Constabulary is entitled to get rent free accommodatio according to the service condition. Although there is no hard and fast rule regarding percentage of provision for family accommodation, normally 30% of them are supposed to get family quarters. This percentage could not be maintained because of the increase in the personnel. Government is seriously thinking to increase housing accommodation for the police personnel. It is also the intention of the Government to provide housing facilities to all categories of Government servants but it will be appreciated that it is not possible to do so all at once.

The hop. Member, Shri Gaurisankar Bhattacharyya has raised one point regarding collection of funds by Minister. The Ministers are not debarred from collecting funds for the party as well as for other social, cultural and religious institutions. A rule has deen laid down that funds can be collected by Ministers only with the remission of the Chief Minister and only by giving receipt for the

collection. I do not know instances whether any Minister was collecting funds without fulfilling these conditions.

My colleague Shri Biswadev Sarma, Minister, Industries yesterday, with your permission, Sir, made a statement in the House regarding the position of establishment of a second Refinery in Assam. I do not want to take the time of the Hon'ble House by repeating the same thing again.

We have discussed, on many occasions, in the course of discussions in the augus. House about the rate of premium of conversion of Annual Patta land to periodic. Day before yesterday, during the Question Hour I had given an assurance in the House that this matter of fixing rate of premium is being re-examined.

The question of unemployment has posed a very great problem before us. This matter has been discussed by a special motion by this august House. I did not want to take it up anymore.

Sir a demand has been advanced by Hon'ble friend Shri JalaIuddin Ahmed regarding more salaries for Judicial officers but I may point out that it is difficult to consider the case of a single class of people excluding the claims of other classes, When one section of people is given a higher salary, on the same analogy, other people from other cla-

sses also will demand the same benefit. Therefore, the cases of other officers cannot be excluded from the list. That has been the difficulty with the Government for taking up the case of Judicial service people separately.

During the last visit of the Prime Minister to our State Capital a memorandum has been submitted by the Govt. of Assam where the tea crisis prevailing in the State has been brought to her notice. Our Finance Minister also, on many occasions, has taken up this matter with the Government of India and we are expecting that something will be done by the Government of India to remove the discrimination that our tea industry is suffering from.

Shrimati Lily Sengupta has charged the Government that the Mahila Samities are being neglected. I believe, she had made a little exaggeration in this matter. The Mahila Samities are being looked after so that the organisation can become stronger and be of service to the people, more particularly, to the women and children.

Employment of girls in services has been accepted as a policy but beceuse of the dearth of vacancies and also of the nature of the job sufficient number of girls have not been employed. I think, with the increase of employment potentialities the strength of girls in service will increase.

It is true that there is dearth of nurses and Midwives in our hospitals and dispensaries. There is a scheme for training of Nurses and Midwives in greater numbers so that the hospitals and dispensaries can be adequately manned. In this respect the girls will surely receive prior consideration.

The shifting of the capital from Shillong has been raised by many Hon'ble Members. This matter has been mooted not only today but this has been discussed from a very long time past. The Government have already decided to shift some of the Heads of Department offices to the plains and a beginning has already been made in that connection but because of housing and other difficulties the progress of shifting the departmental offices have been rather slow. The Government desires to accelerate the process.

- Shri Dulal Chandra Barua 1 The question is wehther the Government has decided to start shifting of the capital to some other convenient place. Whether the Government of India has been moved for financing that particular action.
- Shri Mahendra Mohan Choudhry: I reserve the reply for a future occasion. The Assam Nagaland border is causing anxiety to all of us but this is a matter which cannot be solved unilaterally. Cooperation of the Government of the Nagaland also

is necessary to come to a peaceful solution. From our side we are doing our best so that an early demarcation of the boundaries takes place according to the provisions of the Nagaland Act. We have also brought this matter to the notice of the Prime Minister and the Home Minister and we have been pressing them to intervene in the matter and allow the demarcation to take place. The deployment of the C, R. P. by Nagaland Government in the boundary dispute is an unfortunate thing. We are pressing he Government of India that the C. R. P. personnel should not be allowed to operate in that area. In recent interview with the Prime Minister this matter was brought to her rotice and as far as I could assess she reacted favourably. While doing further discussion with the Home Minister on the 13th of April I shall convey the reaction of the Honble Members on this very vital matter.

Improvement of the lot of the Scheduled castes and Scheduled tribes, other backward classes and the tea garden labours including the ex-tea garden and surplus labour population is a special concern for this Government and the Government is pledged to do their utmost and see that their interest are properly served:

In the matter of distribution of social service activities of the Government of Assam, neither

1

Goalpara nor Cachar has been neglected or deprived of their due share. But it cannot be denied that due to geographical reason and the inherent lack of potentialities of the two districts the economic condition of the two districts do not compare favourably with the rest of Assam. Cachar has of course the tea gardens but then due to the condition of the soil and the state of communication to a industry has not been able to bring about that economic development which is got by some other districts of Assam Valley. Gcalpara unfortunately do not have either resources-tea or minerals. As a result, the intrinsic and the commercial development of Goalpara had not been keeping pace with the rest of Assam. This is, however, not due to any neglect of the Govt Assam. The Govt of Assam have been exploring possibilities of doing whatever is possible. Even the location of the paper mill at Jogighopa is an instance in point. There is no instance of any opportunity for development of Goalpara offering and of being neglected by the State Government.

For years Assam had been trying to develop Cachar industrially. Several paper mills and sugar factories were licenced for Cachar. Unfortunately, for what ever reasons, the people did not start the industries. It is well-known that in the public sector Assam has not been able develop any industry worth the name. It is not

that public sector industries have been developed by the Government of Assam in the rest of Assam neglecting Cachar. Wherever opportunity arises to develop public sector enterprises in Cachar, Government of Assam will only be too anxious to grip that opportunity. So also the Govt have already built the infea-structure of having plenty of power available for Cachar for private sector industries to come in. If and when private sector enterprises do intend seriously to come to Cachar any other assistance from the Government of Assam will not be lacking within the limited means of the State Government.

It may be noted that despite having two Medical Colleges in Dibrugarh and Gauhati, the State Government has developed the Medical College for Cachar: Even though the existing two Engineering Colleges do not have the full complement of admission, consequent on unemployment among Engineers, the State Government have not hesitated to take action to start a Regional Engineering College in Cachar. It cannot be denied that the project has been delayed which is not due to any fault of the State Government. reasons beyond our control, there For been some delay in finalising the Master However, the State Government have repeatedly given directive that the work must be expedited,

Under the Official Language Act 1960, the Assamese Language has been introduced upto the level of Subdivisional Officers in the Brahmaputra Valley districts and Bengali language in the Cachar district on 13th September 1965. After this in the same way the Assamese and Bengali languages were introduced under this Act upto the district level on 15th April 1966. After this the next phase has been taken up and the State Language has been introduced with effect from 4th December 1969 for use for all official purpose at the level of the heads of the department while communicating with the public and other officers. Steps to train up language typists and language stenographers are also being taken. After this introduction in the heads of the department is complete. The next step to introduce at the Secretariat level will be taken. In the Hill districts, however, under the Act English language continues as the District Council or the Regional Councils have not asked for any change as required under Section 4 of the Act. Glossaries in Assamese language have been printed and steps to print more have been taken. Regarding Bengali, we have accepted the Glossaries of West Bengal Govt and as such there will be no difficulty. Steps to bring out Glossaries in Tribal Languages is also being taken up. The Translation Wing in the Law Department is taking step to translate the laws.

A point has been made that there has been increase in the number of I. A. S. officers in the State. At present, we have a cadre strength of 118 I. A. S. officers in the State out of which there are only 114 officers in position and out of them 24 are on deputation to the Centre, 15 officers we have earmarked for Meghalaya. The cadre strength of 118 has been fixed a few years ago and we have made no increase in that. So it cannot be argued that we have been taking more I.A.S. officers. In fact during 1968,-1969, we have taken 3 & 2 of officers respectively. The Government are quite aware of the need to give more promotion opportunities to A. C. S. officers. Some steps have been taken recently to make some posts available for A. C. S. I officers hitherto held by I. A. S. Officers.

The 'Jyoti Chitraban' Film Studio at Kahilipara near Gauhati which has been set up with a view to promoting the film industry in the State and thereby to fill up an important communication gap in eastern region is almost complete. The total expenditure envisaged in the execution of the project was Rs 15 lakhs approximately. Against this estimated expenditure Rs 11,80,000/—lakhs approximately has been increed in the construction of the buildings.

Some other essential equipments such as Eastern Densito Meter, Photographic Step Tablet for the Laboratory and Recorder Motor Selsin Type

and Selsin Master Motor etc for the sound Department and a Mitchell Camera are still to be imported from abroad.

For these items the Govt of India was pleased to sanction the release of foreign exchange to the tune of Rs 1.71 lakhs during 1967-68. Unfortunately the sanction lapsed as the required licence was not issued by the Controller of Imports & Exports in time. After persistent efforts we succeeded in getting the sanction revalidated and licence is sued. When orders were placed with the firms, we were informed that the specifications and price etc of these equipments had changed in the mean time and we were asked by the firms concerned to get the changed specifications etc endorsed by the Chief Controller of Imports & Exports. This has lnow been done recently and the Directorof Information & Public Relations is taking action to renew the order with the supplying firms in Bombay. As soon as these vital equipments can be obtained and installed, the Studio will be fit for operation fully. This is likely to take another six months approximately

The main reasons for nationalisation of the leading banks are that there had been interlink between the big banks and the big business houses. There had been occasionally been allegations of improper use of finances of the banks under the

direct or indirect control by big business houses. Secondly, the interlink facilitated perusal of certain policies which may not have priority from the point of view of public importance.

On the other hand, the aim of a socialistic society is the provision of opportunities for betterment on wider scale and to cater more to the needs of the weaker sections of the community. The growing unemployment also made it obligatory to divert attention to development in the agricultural and the smal industrial sectors. Despite directives given by the Reserve Bank to the leading banks to invest more liberally on such projects, the performance has not been satisfactory. Apart from other reasons, the main reason had been that the commercial Banks owned and managed with a view to avoid risk and profit making insisted on appropriate security. The criteria for financing were the economic returns and the quantum of risk and not creditworthiness of the borrowers and the causes.

In this background, the leading Banks had been nationalised. The immediately expected benefits are:—

- (a) the snapping of the link between big business housess and the big banks;
- (b) the avoidance of mal-practices and favouritism in the matter of institutional finances;

- (c) making financial assistance available on large scale to meet the financial requirements for small businessmen, small farmers and those coming for trade and commerce in a smaller way;
- (d) achievement of the socialistic end of society; and
  - (e) generation of greater public confidence in the banks so as to enable greater saving efforts of all sections of the community.

The Flood Control & Irrigation Department
has undertaken a scheme for Brahmaputra Basin
survey costing Rs, 98 lakhs and investigation of
two medium Irrigation Schemes namely Pagladia
Irrigation Scheme and Champamati Irrigation Scheme
costing Rs. 15 lakshs as employment-oriented
investigation schemes as sponsored by the Govt. of
India. These will provide employment to about
43 Degree Holders and 111 Diploma Holders
in addition to 129 ministerial and Grade IV staff.
The Engineers and other staff are being recruited
very shortly.

The Koliabor Lift Irrigation Scheme in Nowgong district is estimated to cost Rs. 152.54 lakhs
and provide irrigation to 21,200 acres net. The
scheme has been initially approved by the
C. P. P.C. and the Planning Commission.

Land required for the canal system headworks

etc. have been surveyed and steps for acquisition are being taken by the Department.

Meanwhile, a scheme for opening the mouth of Kullong at Borghup through a sluice has been taken up. Tennders have been invited for construction of the structure and work will start in next dry season.

The suggestion for constituting consultative Committees department wise will be surely considered. For myself I support the suggestion.

There has been criticism on the law and order Situation of the State. The Governor has given briefly in his address the general position of the law and order of the State. There is reason to believe that it requires more tightening. Govt. is mindful of it. The technique of crime has changed. Low and order Machinery needs gear up to Meet the situation. The violent activities being indulged in by some of the political parties are a new challenge to us. The Govt. will meet all violent activities with iron hand so that the peace and tranquility are not jeopardised by their activities. I appeal to all hon. Members of this House and through them to allpeace-loving people of our country to render all cooperation to curb such a activities.

In matters of general administration also there has been a lot of criticism by the hon. Members. We have taken note of the suggestions put forward by the hon, Members and we shall do our best to implement them. This subject will come up before the House on a later occasion. We shall get opportunities to discuss them in greater detall then, I do not want to dilate upon this matter any more.

The land settlement policy of the Govt. has been always on the fire of criticism. Hon. Members should appreciate the anxiety of the Govt. for settlement of land with landless tillers. Government have been threatened with dire consequences by many hon. Members including my esteemed friend, Shri Phani Bora, if the policy of eviction is not abandoned. I am sorry my friends have not appreciated the situation. We have list of landless tillers and we allot land to these from that list. But if someone else goes and occupies lands allotted to them what else Govt. can do than evicting the encroacher and putting the allottees. The land problem can be solved only with the cooperation of all and I appeal to the hon, Members to lend their support and cooperation towards solving this problem in a planned manner,

New land reform bills which have been introduced in this session if passed into law will go a long way to solve the land problem. The tea garden surplus we hope by the implementation of the proposed Act we shall be able to

prevent from selling and shall be in a position to set le them with ex-tea garden and surplus labour population beside settling them with other landless tillers.

Before I conclude I want to make a personal reference. I do not want to reply afresh to the charges levelled against me by my hon. friend, Shri Moinul Haque Choudhury. They are being repeated frquently. I have replied to those charges on more then one occasion. I simply beseech him to realise that motivated allegations carry nor too far.

I thank all hon. Members for giving me a patient hearing and I conclude:

Shri Hiralal Patwary: Sir, when the debate on the Governor's Address was replied by the Chief Miniter, Mr. Chaliha last time, he has categorically said that the Govt. of Assam is seriously considering the question of giving social security to the tea garden labourers. To day, when the Chief ministerin charge replied he has mentioned about the tea garden labourers, his reply is vague. So, we would like to know from the Minister whether Social security will be provided to the tea garden labourers so that they are really protected.

Speaker: Mr. Patwary, please sit down. The Mr. rule is that when the Govt. reply is given, the Chair will ask the hon. Member who moved the motion to speak. Here, Mr. Gaurisankar Bhattacharyya moved the motion. So, if he has anything to reply, I will ask him to reply. That is the practice.

- Shri Mahendra Mohan Choudhury: Sir, it is unusual procedure. In the past after the reply is given, no questions are put. However, I am prepared to answer the questions. I am only pointing out you that this is an unusual practice.
- Shri Gaurisankar Bhattachrayya: If there is very important matter which needs clarification, and if that matter is pressed, and if the Minister be pleased to consider that the reply can be given then and there, that may be given. That is for the mutual benefit. So, I do not think there is much harm either to our procedure or will create any inconvenience to the House.
