Shri Subankar Sinha: Whether the Govt. have appointed some S. Is of schools for Elementary Educations?

Shri H: N. Talukdar (Minister): Wee have appointed so many S. Is.

Shri Subankar Sinha : I mean this year, some two months back.

Shri H, N. Tafukdar (Minister): Yes Sir.

Shri Subankar Sinha: If so; how many of thems are appointed from the Manipuris community?

Shri H.N. Talukdar (Minister): We have appointed number of persons and two of them are Manipuris.

Shri Subankar Sinha: S. Is, are not treated as teachers.

Shri H.N. Talukdar (Minister): No Sir.

Shri Kabir Roy Pradhani: Whether so many vacancies are there and Assistant Sub-Inspectors of schools are appointed to those posts?

Shri H. N. Talukdar (Minister): Sir, the total strength is about 290 and to complete that strength we have recently appointed 21 persons and more will be appointed in due course. A. S. Is will not be appointed newly.

- Shri Kabir Roy Pradhani: Posts are kept vacant for more than 5 years and A.S. Is are posted in those posts. Are they going to appoint S. Is, in those posts?
- Shri H. N. Talukdar (Minister): We have already appointed 21 persons and there are more to be appointed,

The letter no. is GM.S.C. 3/66/74, dated 27.4.66 from the D.P.I., Assam to the Inspector of Schools, S.A.C., Silchar. Reference, your D.O.No. 5 dated 31.3.66. With reference to the above, I have the honour to state that the quallification of a Manipuri language teacher in the schools be graduate with Manipuri as one of the subjects in his degree course and in M.E. Schools, Matriculate with Manipuri as one of his alternative subjects.

Re: Reservation of Posts for Scheduled Caste/Scheduled Tribes

Shri Digendra Chandra Purkayastha asked:

\*344 · Will the Chief Minister be pleased to state-

- (a) Whether it is a fact that the posts under the Government of Assam are always advertised through APSC or otherwise by mentioning only general reservation without indicating specific number of posts reserved for Scheduled Castes/Schedule Tribes?
- (b) Whether it is a fact that Government of India while advertising the posts through UPSC or otherwise always mention the posts earmarked for Scheduled Castes/Scheduled Tribes?
- c) If so, whether this Government will adopt the procedure of Government of India mentioning clearly the posts reserved for Scheduled Castes/Scheduled Tribes in their advertisement?
- (d) If not, why not?

Shri Sarat Chandra Sinha (Chief Minister) replied :

344. (a) Yes.

- (b) Yes.
- (c) Yes, Govt. propose to comply with it.
- (d) Does not arise.
- Shri Mal Chandra Pegu: How Government propose to fill up the back-log for the Scheduled Castes / Scheduled Tribes people?

Shri Sarat Chandra Sinha (Chief Minister) By extending more facilities for appointment

- Shrimoti Renuka Devi Barkataki: There is a difference, Sir. Suppose in the previous Notification the quota about the number of Scheduled Castes/Scheduled Tribes was not Specified and now it will be specified. But the quota is already fixed. Is there any new Notification changing the quotas?
- Shri Sarat Chandra Sigha (Chief Minister) Suppose 40 posts are advertised, out of these 40 posts, 10% of the posts should be reserved for the Scheduled Castes and Scheduled Tribes. As suitable candidates were not available, previously posts, were filled up by candidates belonging to other communities. But now as we want to fill up the quota, even if candidates are not available for this 10% reserved quota, these posts will not be filled up by other General candidates. Shri Mal Chandra Pegu: Suppose there is one post only advertised for a particular office. Then whether in that case also
- that particular post will be reserved for Scheduled Caste Scheduled Tribe candidates?
  - Shri Sarat Chandra Sinha: Yes, Sir, when we are determind to fill up the back-long. In certain cases it may be necessary and in certain others it may not be so. But as we want to fill up the back-log it will be generally recessary even if there be only one post.

Shri Dulal Chandra Barua: As per the provisions of the Constitution reservation for the various posts is generally made for Scheduled Castes and Scheduled Tribes. I want to know from the Chief Minister the reason for which the reservation quota was not filled up. Was it due to suitable candidates not being available or intentionally they were not filled up?

### Shri Sarat Chandra Sinha (Chief Minister)

Sir, the question relates to social attitude and also the administrative expendiency and convenience. It is the general grievance that there are efficient and qualified candidates yet for one reason or another Scheduled Caste and Scheduled Tribe candidates are not getting their due share. It is a very difficult questions to answer categorically either 'Yes' or 'No' Because appointments are done through a series of processes and in a particular stage of such a process that might happen. But the intention of the Government is to see that qualified candidates are appointed. It is also true that in the earlier stage suitably qualified candidates were not available to the extent as it is to-day, Therefore, there has been back-log specially due to non-availability of suitable candidates and partly also due to the attitude of the society which we want to rectify.

- Shri Digendra Chandra Purkayastha: Mr. Speaker, Sir, in reply to Question No. 344 (c) Hon. Chief Minister has kindly agreed to adopt the proceedure of the Govt. of India. May I know Sir, when he proposes to do it?
- Shri Sarat Chandra Sinha (Chief Minister): From now on.

- Dr. Surendra Nath Das (Minister of state Health) replied :
- 345. (a) All the A. N. Ms. trainees in Nowgong and Jorhat Civil Hospital have received stipends except 4 trainees in the Jorhat Civil Hospital.
- (b) Due to delay in receipt of the required authority from the Accountant General.
- (c) The following trainees did not receive the stipend:
- 1. Miss Tuleswari Pegu.
- 2. Miss Punyeswari Pegu.
- 3. Miss Joyanti Doley.
- 4. Miss Purnima Bordoloi.
- Shri Pitsing Konwar: I want to know whether Miss Joyanti Doley received training till to-day? Will the Govt. be pleased to give stipend?
- Dr. Surendra Nath Das (Minister of State): Sir, I have already replied.
- Shri Subhankar Singh: Sir, will the Minister be pleased to enlighten us as to whether A.N.M troinees and Midwifery trainees are identical? If so, whether those who have taken Midwifery training will be appointed?

- Dr. Surendra Nath Das (Minister of State): Yes, they will be appointed.
- Smti. Renuka Devi Barkataki; Sir, the Minister has replied that due to non-receipt of pay slip the trainees are not getting stipend. Sir, may I know whether the pay slips are issued from the Accountant General's Office at Gauhati or Shillong or from Delhi?
- Dr. Surendra Nath Das, (Minister of State): Sir, this is a new question.
- Smti. Renuka Devi Borkataki: Sir, it is not a new question It is in connection with issue of authority from the Accountant General in absence of which the trainees did not receive their stipend. By saying it is a new question they want to avoid it.
- Dr. Surendra Nath Das Minister). Authority slips are issued from the Accountant General's Office.

- (a) The utility of a refrigerator in a Pharmacy were serum and vaccines are not kept?
- (b) Whether Government will instruct the Regional Office of Drugs to register the Pharmacies without a refrigerator?

- Dr. Surendra Nath Das (Minister of State, Health) replied :
- 346. (a) The refrigerator in a Pharmacy is necessary not only for keeping serum and vaccines but also for certain other drugs which require to be stored in a cool place whose temperature should not exceed 250 C.

### Shrimati Renuka Devi Barkataki asked:

\*347. Will the Minister, Tourism be pleased to state-

- (a) Whether Government is aware that 1975 has been declared as the South Asia Tousism Year ?
- (b) If so, what steps the Directorate of Tourism have taken to attract foreign and domestic tourist to Assam during this year
- (c) What is the financial assistance this Department has received from the Centre during 1973-74 and 1974-75 for development of tourism in the State?

### Dr. Lutfur Rahman (Minister, Tourism) replied :

347. (a) Yes.

- (b) Several steps have been taken to attract foreign and domestic tourists to visit Assam during the South Asia Tourism year. Some of the important steps taken are as follows:
  - (i) The South Asia Tourism Year was formally declared open on 15th January, 1975 at a small inaugural function about which widest publicity was given.
  - (ii) Wide publicity about Assam Tourism was given during the Would Table Tennis Championships held in Calcutta in February, 1975 through distribution of publicity literature.
  - (iii) On 19th February 1975 a cultural programme was arranged at Kaziranga for the benefit of the foreign tourists present there on that day, in the interest of international publicity.
  - (iv) The Department also participated in the Eastern India Cultural Conference held at Gauhati in January last when banners and other materials giving publicity about tourism in Assam were displayed.

## 14 [ 14th March, 1975 ] Questions & Answers

- Smti. Renuka Devi Barkataki: Sir, the publicity the Tourism Department has given to attract tourist to Assam during this International South East Asia Tourism Year was (1) the Conference was held on 15th January at Kaziranga about which wide publicity was given (2) Wide publicity about Assam Tourism was given during the World Table Tenn's Championships held in Calcutta (3) A Caltural programme was arranged at Gauhati where publicity was given. But that cultural conference was attended by person from Orisa, Bengal, Manipur and Tripura. This is the publicity the Department has given. I am asking the Minister incharge of Tourism what publicity they have given to attract international tourists to Assam?
- Dr. Lutfur Rahman (Minister): Sir, so far as the function at Kaziranga, there were some foreign tourists also present there. I shall have to look into it. But so far as publicity outside, our publicity is limited and the Govt. of India, Tourism Department they have agreed that they will publice Assam Tourism in international field.
- Smti Renuka Devi Barkataki: Sir, it is the 3rd month of the South
  East Asia Tourism year and to-day the Minister has come forward to the Floor of the House that they have taken up with
  the Govt. of India for giving publicity in foreign countries.
  I want to know from the Minister what concrete steps they
  have taken to attract foreign tourists to Assam?
- Dr. Lutfur Rahman (Minister): Sir the Govt, of Assam had issued some publicity folders and materials, We suggested, to Govt, of India to publicise particularly the folders and other materials of Assam's Wild Life and the Govt, of India had also agreed to do so.
- Sri Dulal Ch. Barua: Sir, I am asking whether the Govt. of Assam had any information whether these folders and other materials

or the mode of publicity of attracting tourists from foreign countries were displayed by the Govt. of India. So far as Assam is concerned, Govt. of India has not issued literature and publicity. Whether these things were displayed. This thing we want to know from the Minister.

- Dr. Lutfur Rahman (Minister): So far as publicity of tourism of Assam was concerned, I am also of the same opinion as the hon'ble member. I took it up with Govt. of India when this question was discussed and I showed them the publicity materials. So far publicity of Assam was very poor and Govt. of India people after having discussion with us, agreed to make all endeavours to publicise Assam in countries like America and Europe.
- Sri Dulal Ch. Barua: I want to know from the Minister that he has explained about publicity of this Tourism Year. Does he mean only taking round of the tourist to Kaziranga and Mana or whether Govt. is taking any other specific scheme?
- Dr. Lutfur Rahman (Minister): Sir, not only in Kaziranga and Mana, we are publicising other centres like Sibsagar and other places where there is ancient and old materials in Assam worth seeing is available and we are publicising everything including Kaziranga and Mana.
- Sri Dulal Ch. Barua: Is Govt, aware of the fact that very recently tourist, a German came here and wrote an article that Assam is a State which will top the list in proper scheme is drawn up and it will be unique in all respects. Whether Govt, has gone through it and drawn up any scheme and acted accordingly?
- Dr. Lutfur Rahman (Minister): Sir, I do not know about any article written by a German gentleman but I know of a comment by a Russian who came here and visited the whole of Assam. It will be seen.

- Sri Atul Ch. Saikia: Sir in order to encourage the tourism, there is an organisation called Indian Tourists Development Corporation. They have been putting cars for hire purposes and bunglows in different parts of India. I want to know from the Non'ble Minister, why these facilities have not been extended to the State of Assam for the tourist of over sea countries.
- Dr. Lutfur Rahman (Minister): Sir, the same question I put to the representative of the Govt. of India when he came to the Eastern Asia tourism Conference. I asked him why the headquarters of the organisations at Calcutta could not shifted to Gauhati to look after the whole zone and they assured that they will examine it,

Shri Atul Ch. Saikia: What is the reason?

Dr Lutfur Rahman (Minister): Reason is not known.

- Dr. Lutfur Rahman (Minister): It is not publicity regarding the tourists' centre, it is publicity regarding the facilities that will be made available to the tourists.
- Sri Bulal Ch Barua: Sir, it seems that the Minister incharge is very much keen to develop the tourism here in Assam. If so, may I know what is the financial allocation?
- Dr. Lutfur Rahman (Minister): Sir, this figure is not with me,
- Shri Dulal Ch. Barna: Then are we to understand that the Govt. of Assam could not impress upon the Govt. of India the necessity of development of Tourism in Assam.
- Dr. Lutfur Rahman (Minister): Because there was everything given in the plan and there was a drastic cut in the plan.

- (b) Whether a service Association which was formed prior to 1947 i.e before the Constitution of India came into force can continue unless it is recognised by the Government?
- Association which was formed prior to 1947 is still functioning as a recognised Association although many provisions of its own constitution are quite contradictory to the provisions of the rules and that this Association did not move Government for amendment of its constitution at any time and thus suppressed facts from Government?
- (d) If so, whether Government will make a thorough enquiry and take appropriate action against this Association and its office-bearers for concealments of facts from Government?

## Shri Sarat Chandra Sinha (Chief Minister), replied:

- 351. (a) Rule 23 of the Assam Civil Services (Conduct) Rules, 1965. These Rules came into force with effect from 12th February, 1966.
- (b) The Constitution of India came into force in January, 1950.

  As per the Assam Government Servants Conduct Rules, 1937 which were in force until the 1965 Rules were promulgated, the Service Associations were not specifically required to be recognised. Technically speaking the Associations formed prior to 12th February, 1966, require a formal recognition.
- (c) & (d) For all practical purposes the Assam Veterinary Association is functioning as a recognised Association. The matter as to whether any of the provisions in the Constitution of the Association is not in conformity with the Rules and whether at any stage the Association had misrepresented fact is being looked into.

Shri Dulal Chandra Barua :- Mr. Speaker, Sir, while moving my cut motion from this side of the House I want to make certain observations. Sir, under this particular head we are going to vote near about Rs. 18,14,00,000 in three demands with a view to spend this huge amount for the betterment and efficiency of the Police administration in the State. Sir, we have been hearing agguments put forward by the Ministerin-charge of Home about the improvement and efficiency of the Police administration, and the steps taken by Government in the matter of implementation of the recommendations of the Police Commission, Sir. it heartening to note that the Government is proposing to improve the efficiency of the police administration on the basis of the recommendations made by the Police Commission. But the moot point is whether by implementing the recommendations of the Police Commission Government will be able to bring about efficiency in the Police administration, My answer

to this question is 'No'. Sir, there is a large number of high officials in the police Department. There are 8 D.I.Gs. 2 Additional LGs. one LC. and several Superintendents of Police in different branches of the Department, and a major portion of the amount that we are voting is eaten up by the fat salaries of these officers. But have we been able to utilise their services for the efficiency of the administration? Sir, it is a wrong motion that by increasing the number of top officials in the Department we can improve the efficiency of the Department. In support of my argument I would like to draw the attention of the Minister for Home to the number of crimes committed in the State. Of course, in the present atmosphere in the country and in view of the change in the modus operendi it is difficult to stop crimes but at least it can be reduced to minimum. But instead it is increasing day by day and the Police administration seems to be helpless. Sir, I have collected the figures of crime committed in the State which show that the number of crimes is on the increase. According to Government statistics, in the year 1970-71 the number of cases registered in different Police Stations in the State was 5,391. in 1971-72 the number was 7,242, in 1972-73 the crime position increased to 9,344 and in 1973-74 it rose to 12.237. Sir, on the one hand we are increasing the expenditure on Police administration and on the other the number of crimes is increasing year after year. I quite agree that it is not possible to stop crimes totally but I cannot understand why the number should increase when we have such an elaborate Police organisation in the State. Therefore, Sir, the efficiency of the Police administration is not increasing; it is decreasing day by day though we have a large number of officers in the Department, Sir, by implementing the recommendations of the Police Commission we cannot bring about

efficiency in the administration unless we change the entire outlook of the administration. The Police should be friend, philosopher and guide to the people but unfortunately the police Department has been converted into an anti-people administration. The people are afraid of the police and they are even afraid of approaching the high police officers with their cases. Sir, it is disappointing to note that even after independence the people consider the police as their foes and not friends. During the British regime we were afraid of the Police because the British used the Police to suppress us oppress us just to safeguard their own interest Sir, the police should be there to guide people and help people in their distress but in our State the police is there to harass people and oppress people at the instance of the Govt. Sir, the Police has been let loose on the people and they have become stooges of the party in power and they have brought disgrace to the entire administration. Sir, I do not say that all the police officials are bad and inefficient and I do not also say that these are the people who have come from outside. They are our own people and they they have the same social background. But how is it that people do not consider the Police as their friends but foes? Sir, I visited Mangaldai and Kokrajhar when the Bodo movement was going on. I do not like to discuss the merits of the movement but the way the police harass the people, it cannot be tolerated. The 8th A.P. battalion was deployed there and they are the people..... from their own Bodo community. They have been engaged to create a reign of terron against their own people, to molest their own sisters in the name of maintenance of law and order. This has brought disgrace to the entire State, You could imagine, Sir, what faith the people could have on the Police force. We have come across various instances of letting loose a reign of terror amongst the people. Who has

created the problem at Bhurbandha, who has created the reign of terror in Sibsagar, Barpeta in Kokrajhar and other places; Sir, we are still continuing the British tradition. Sir, yesterday the Chief Minister while replying to the debate on grants that we are still having the old british bureaucracy. Why no attempt has been made by the Government to remove this bureaucracy? Sir, during the quit India movement in 1942 the Britishers used our own people to kill our own people. It were the Assamese police who were responsible for killing Kanaklata, Tilak Deka and others. Sir, we had great hope that under the leadership of the young Minister-in charge of Home will bring in change in the police administration, but I am sorry to say that all our hopes have been belied by the performance. I do know who is misguiding or misleading him. I feel that the old type of bureaucracy which is continuing should, be immediately abolished, and a new outlook should be created. The police force should be friends of the people, their services should be requisitioned for maintenance of law and order and to protect the weaker sections people from exploitation. To create this the Government must be sincere otherwise by implementing the recommendation of the police Commission alone will not have any fruit. Apart from implementing the recommendations of the Police Commission, there should be a high power Committee to see to what extent it is possible to implement the recommandation, what would be the financial involvement, in what way corruption could be eradicated, in what way the efficiency of the force could be increased. My friend Shri Barua was quite right when he said that the Police people should not be used for every purpose. They should be used only for purpose prescribed in the Manual. I do not know why Police force has to be used for procurement of rich and paddy. It is not good to use police personnel for each and eyery work, This creates had blood between the police and the people. This also breeds corruption. I will give one instance. Recently in the month of February, one M. L. A. from Nagaland came to Jorhat. He went to the Rowriah bazar and purchased 5 kgs. of rice. The constable who was on duty in the bazar approached the M. L. A and demanded money. Even after giving his identity he could not escape the constable. The gentleman after coming back to Jorhat reported the matter to the D. C.; and the D. C. with the help of the S. P. took action.

Sir, in the Police Commission recommendation preference has been given to housing facilities to the lower rank officers. Sub inspectors and below. Sir, some houses were constructed to accommadate subordinate officers at Gauhati, but these are now under the occupation scime high ranking Officers. When asked the Minister state that the quarters are under the occupation of those who are entitled to it: But our information is otherwise. Sir, mobility is one of the most important to aspects to increase efficiency, and to have mobility there should be housing and other facilities. There decades have passed since attainment of independence, but no housing facilities and other essential amenities could be provided. To start with we must start from the bottom. My suggestion is that the constables should be given all facilities enjoyed by our jawans in the Army.

No attempt so far been made to improve the condition of those people. Unless the root of the Police Administration is reformed nothing tangible is going to happen. Only a reformation in the top most cadre will not do. I. G. P. or D. I.Gs. do not go to investigate cases, it is the Inspector or Sub-Inspector or Assistant Inspectors who do this job. Hence they must be made satisfied. When he is not satisfied he

will definitely ask for a k.g. of rice from somebody. It is human nature, In other countries the police administration is a different footing. The police administration in those countries is standing on a very dignified footing and the police people are a very dignified people. They are much more dignified than the officers. Therefore, I would request the Govt. to keep the police administration away from politics and the party in power should not use] the police force for their political gains.

Regarding the Intelligence Branch of the Govt. I would speak a few words, Sir, you will be surprised to bear that the Chief Minister has engaged an Intelligence cell to detect crimes and misappropriation, but actually the C. I. Deptt. itself is including in such crimes. I want to point out here that a big misappropriation has taken place in the C. I. Deptt. of the D. I. G. This misappropriation involved about 7 lakhs of rupees. seems that the people appointed in this Branch are all thieves and decoits. They have been appointed to protect us from exploitation. But ultimately it was found that the protectors have become exploitors. If protectors become the exploitors then Sir, we can simply imagine the social structure of the State. I would say here that the C. I. Deptt. who had been entrusted with certain delicate matters to be handled, have completely failed. We have been telling in this House that we are going to be outnumbered by the outsiders, such as people from Bangladesh, and other neighbouring States of India, yet no effective steps have been taken to get rid of this danger. Sir, there is a conspiracy going on against the interest of the people of the State. I have also told the Minister Incharge of Home to reorganise the inteligence Branch with good people, who think themselves to be Indians and who think that if anything adverse happens to the State it will go against the people of the State and hence will go against themselves. I want to draw the

attention of the Minister incharge of Home that the Intelligence Branch used to send two reports, one to the State Govt, of India and you will be surprised to know that this Intelligence is sabotaging the cause of the people of the State, because of these varied reports. This Deptt. has got a Branch at Jorhat and another at Gauhati and due to their collaboration the interest of the people of the State is marred. Their main duty is to make all endeavours to black list the efficient officers of the State who are very much keen to safeguard the interest of the people of the State and also to safeguard the interest of the future generation. These things are going the State and these facts were brought to the notice of the Govt. and yet no effective action was taken in this respect. There are various loopholes in the administration and I will try to dilate on those in brief and I am not willing to take much time of the house. Sir; the Govt, was very much active in arresting Mr. Biswa Goswami who was alleged to have been carrying some ballot papers. I want to know from the Govt. where were their intelligence Branch and its people? Why they could not detect such cases earlier? Why they did not arrest the Govt. officers who were involved in this case? Why they did not arrest the Returning Officer who was to be satisfied with all papers at the close of the day? Sir, the Intelligence Branch should find out the cases within 24 hours of their happendings and to achieve that objective the Department must be well equipped with necessary materials and efficient people. Otherwise the main purpose for which this Branch was set up will be frustrated. To my utter surpirise, I have found that the people who are posted in that Branch are the people who could not satisfy the big boses and therefore, they have been put there. I would therefore urge upon the Govt, to revitalise the Intelligence Branch and C. I. Deptt., and people with brillient careers should be placed there. All the good people have been put in the Executive jobs and this branch has been completely ignored. I therefore, feel that his branch should be tone up properly with vehicles, housing facilities, and supply of essential commodities to the persons posted there.

He knows it better. Sir, now I come to the allegations against one of the Cabinet Ministers. Here is a big leftet on the allegations against the Minister. It reflects even upon the Members of the House and the State as a whole. This has been publis hed in Gauhati. If the allegations are true, where is the C. I. D. hidding. These are very serious allegations, very dangerous allegations. Here it has been pointed out very serious-ly (papers showed).

Hon'ble Speaker; Is it signed or anonymous?

Shri Dnlal Chandra Barua: It is signed... ' আমি আচৰিত হৈছো চৰকাৰৰ চি আই ডি বিভাগ জীৱিত নে মৃত।

Shri Sarat Chandra Sinha: Chief Minister Sir. we have received it.

Shri Dulal Chandra Barua: Sir, my question is, if the allegations, the serious allegations, embodied herein are. true there is no point on the part of the Chief Minister or the Government to defend. He is to quit immediately and if not true, why the Govt. could not detect the persons who are responsible for giving such kind of propoganda against the Minister, incharge and the Members of the House also? These are printed, well printed here at Gauhati. Why the Govt. cauld not take steps? Sir, is not the allegation of a murder of a small child serious? I want a through probe into the case. If it is not the public, then I think from the side of the House it has been published or by certain people with certain authority. There

fore, Sir, I want to request the Chief Minister, and the Minister, incharge, Home to enquire into the allegations and prove that these are not true.

Shri Sarat Chandra Sinha C. M.: Sir. we are allready taking steps.

Shri Dulal Chandra Barua: It is not dangerous to the democracy and that we have to blamed and our positon has been merred before the eye of the public? May I request the Minister, Home to give details on this kind of incidence and place the report before the House within this Session.?

Now. Sir, I submit that the police organisation, specially the Intelligence Brance Brench is to be reorganised in a proper way to do justice in its own ahiective for the betterment of security of the entire Stats. Sir, coming to the other small aspect, i. e. yesterday we have seen that there is no Cut-Motion on the Head of Account of Fire, Protection and Control, I want to say it is ofcourse, difficult to say or comment on it, that our experience on Fire Services shows that the Fire organisation in this State has been neglected by the Govt. Their service conditions have not been taken into account by the Govt. It is for this, yesterday a have took place throughout Gauhati and the role of the Fire Brigade was disappointing. I must say the Fire Brigade Organisation at Gauhati and throughout the State is near collapse or going to be collapsed. So, it should be reorganised-more vehicles, more experts, more recruitments are to be placed to meet the situation, to meet the emergency so that they can come in time of need.

Sir, coming to the other points, i. c. Civil Defence and Home Guards, I should say this organisation is a part and parcel of the police organisation. But it has been neglected like anything, I have seen the Home Guards are engaged in Check Gates for checking vehicles but without food, without clothes, without any payment. They are supplied

no clothing, no ration nothing of the sort. I demanded S. P., Jorhat "If you cannot give them anything, if you cannot supply food, clothes or payment, you should withdraw them." Therefore, I feel that this organisation should be made a part and parcel of the Police Organisation and their service condition should be made permanent, they are to be given all the facilities as the Police Organisation is getting. Sir, the Civil Defence Orgamisation is now converted to a political organisation. I say this organisation is to be reorganised in proper perspective for the benefit of the people to achieve the objective for which it has been organised earlier. Therefore, at last not the least, I submit that we are speaking here to reform the Police Organisation. We are speaking, we are suggesting some means to improve the efficiency of the police administration. As I have already said, unless the outlook of the Police Organisation, outlook of the Police personnel are changed there cannot be any improvement, any efficiency and any reform in the Police Organisation. Therefore, I submit it is high time on the part of the Govt. and the high Police Officials to reform the Police Organisation. We are an independent country, we have our national Govt. We cannot allow the British Bureaucracy to continue. To achive that objective the Police High Officials must be diciplined at all costs and at the same time they must look after the welfare of those officers in respect of transfer and promotion. We are to see that proper justice is done. The other day, the Minister, Home denied that there is no high ranking promotion. Promotions should not be ....... made on political consideration or any other consideration. Promotion is to be given on the basis of merit and efficiency. Unless we follow the theory and if we always conceive of the political ideology or work for the benefit of our own political end I feel that the Police Department will collapse. Therefore,

bottom and reduction in the expenditure on top officials is necessary and thereby we can use the money for the benefit of the other officials in the lower level. If we cannot do that then everything will go in vain. With this observations I hope and believe that the Minister incharge will not do a thing with political consideration, with a view to create terror throughout the State as we have done before. With these observations I comment my cut motion.

Smti. Renuka Devi Barkataki : Mr. Speaker, Sir, there are 3 young Ministers, the names of the 3 young Ministers are (1) Hiteswar Saikia (2) Kumar Bishnu Prasad and (3) Harendra Nath Talukdar. Now Bishnu Prasad is no longer a Kumar. These are the 3 Ministers, new blood introduced by the Chief Minister Mr. Sarat Ch. Sinha. But it seems that 2 other Ministers Bishnu Prasad and Harendra Nath Talukdar are facing heavy bowling, though it is difficult to say whether it is the reflected bowling of these 2 persons. I do not know this. But so far as Mr. Hiteswar Saikia, Home Minister is concerned, atleast we hoped that the young blood who entered in the political field very recently and immediately given a large post, we expected that this young Minister would do something for which this Cabinet, after somtime would be proud of their activities. Now that these two Ministers are practically out of the field because of the heavy bowlings, only now Mr. Saikia who is holding a very important portfolio remains and the younger generation would be proud that Mr. Saikia has been given such an important port folio and he is such a young Minister. But after taking charge of this Department as a fullfledged Cabinet Minister, I am going to give some examples how he misused the whole Department to fulfil his political aim. Sir, in the name of the reorganisation of this Department

as per Prasad Commission's report, yesterday he said he promised to do the reorganisation in phrased manner and accordingly this Govt, has agreed to accept Prasad Commission's recommendation in phrased manner. He has not done justice to the Department, rather in the matter of promotion, as it is reported, there is favouritism. As Mr. Barua said they are working against the interest of the State.

Mr. Speaker, Sir, the Home Minister is a young Minister and we took him to be a very promising Minister. But after he became a full fledge Minister, certain things were reported in the news paper and we felt very bad about it. According to the news item a big pilot car and many people waited to welcome him near Jagiroad and in the paper it was published. I asked Mr. Saikia the reason of using the pilot car and other vehicles and Mr. Saikia replied that "I am entitled to get it." But in the As am history we have never seen any Home Minister using pilot car. That practice has been stopped now.

Sir, regarding police atrocities, I am not going back to speak about the atrocities when he was Minister of State, I confine myself only when he is Home Minister. Atrocities to the public has been increased and it is beyond imagination and on the other day the Govt. could not give proper explanation why the Bodo people were beaten, why police beat them? They demanded Bodo script. The Bodo people wanted to develop their standard of living, they wanted to be brought at par with other people. It is their crime. So they should be punished. Yes, I admit that they should be punished according to the law but the Home Department has failed to distinguish what is the political and socio-economic demand. They have failed to understard that it is not a crime. They are demanding economic betterment. On the other day also something happened on the students of Mangaldoi. Under the leadership of Mr, Sinha

this State has been divided not only into institutions and organisations or political organisations, there is even division amonst Ministers. Social institutions and organisations have been divided, culturally and socially and economically everything is divided and this is the survival policy of divide and rule and Mr. Sinha is encouraging this and it is reported that for this purpose the Govt. fund is being used. Sir, one of the organisations, the Ujani Assam Sangram Parishad is making a demand and Mr. Hiteswar Saikia's political carrier will be doomed if he does not concede to their undue request. Their demand is for separation from Assam but even then there is no action against them, rather I am informed that they are being encouraged. Sir, some other organisation that is, P. T. C. It is a political organisation and if it is anti-State, if it is anti-National, why the Government sit with them across the table and try to bring a recenciliation?

Sir, another thing is this, you will be surprised to know, how communalism was being encouraged by this Government. Not only the Hindu and Muslim communalism, Bengali muslims and Assamese muslim communalism was also involved in this election. It was preached that a Bengali muslim has been given the Congress nomination so the Bengali Muslims should vote for him. And in the Assamese Muslim areas it was preached that Congress has given nomination to an Assamese Muslim so they should favour this Muslim candidate, In the same way Sir, Schedule castes and non-Scheduled castes and Hindu and Muslim communalism was preached in this election. This affair was encouraged by this Government.

Sir, regarding the police atrocities, I am not going to give a long list about the failure of the police to curb the crimes. Sir, Mr. Dulal Barua has given the statistics of crimes that took place in the State and showed how it incressed. The

allotment of money has also increased for this Department. But police failed in controlling the crime. Sir, I want to draw the attention of the House to a few cases which happend in the very nose of the Government. It is about one murder case, that took place at tokobari, the murder of kanti Bedi. In this House Sir, more than once I have drawn the attention of the Minister of Home when he was Minister of State about the functioning of some hotels like. Sunrise Hotel, Calcutta Hotel, Punjab Fish fry Sir, these hotels and restaurants are nothing but unauthorised bars where all crimes are committed including wine, women and anything and this is happening in the very nose of the Police, D.I G., Police and the S.P. Sir, I will tell you the exact date of murder. It happened on 24th June and kanti Bedi was shot dead. But up till now the Police could not trace the murderers. They say it was a family affair connected with their property. But if some body is shot dead the police has to find out the criminal. Similarly Sir, his father Amar Bedr's death was also very suspicious. He was found dead in the bathroom. Then his younger brother is also missing for one year and the police could not find out any trace of him, Assam police, the Gauhati police totally failed to find out the criminals. Sir, the police have got partner ship with this Sunrise Hotel; they go there and have their drinks. The local people and the Municipel Commissioners demanded that this hotel should be closed and the Govt closed it. But many brass-hats of Government and many brass-hats in in the Congress party and also in the police are in favour of opening this hotel immediately. This is one of the cases Sir, where the Government failed.

No. 2 Sir, the Home Minister was telling about the procurement business. In the procurement the police has created a lot of trouble but the Home Minister was kind enough to tell us that so far as police is concerned whatever power law has given,

they are utilising that and the police are acting within the limit of the law. But how much power law has given them, Mr. Saikia could not explain. The people should not bring paddy from one zone to another zone; if they do they are liable to punishment. But Mr. Speaker, Sir, we have brought to your notice that cars of some of the members of this House, were cheeked and we were misbehaved by the police officers. We should not mind that; we should be ready for shoes and garlands because we are politicians. If the voters say why a tubewell is not given and you are our MLA we should not mind that even if somebody commits some crime and if he belongs to their own party by which run the Govt, no action is taken against him. Here is one case, Sir, One nominated member of the Barpeta municipality who is also the Vice-President of the Barpeta Town Congress Committee, that gentleman is having an unauthorised liquor shop only four miles from Barpeta and the name of the place is Bhera. He has four shops within Barpeta and he was allowed to take rice to feed the voters within the Barpeta Parliamentary Constituency. It was not official, it was non-official. The voters were demanding rice and to feed the voters he was asked to take rice and that gentleman got a bus also name of which is 'Bhavahari' and the number of the bus is ASZ 5543 and about 22 q sintals of rice he took to Gauhati. It was intercepted in Saraighat by the checkpost, most probably without knowing that this belongs to that gentlemen and we should say it is a funny thing that the driver and the conductor of the bus were arrested but the bus was not ceased and it is still running in the Burpeta-Bansbari and Barpeta Road carrying passengers

Shri Ataur Rahman: The Vice-President of the Barpeta DCC is one

Shri Renuka Devi Barkataki: There is a difference between the DCC and the Town Congress Committee. Sir, why this type

of discrimination? Where law is concerned, before law everyone should be equal. I want that this case should be enquired, Sir.

Sir, if he is sincere he may make an enquiry. But uptil now no enquiry has been made. Then, sir, another very interesting thing I would like to mention here and in this connection I would also like to draw the attention of the Hon, ble Minister Mr. Saikia and the Hon'ble Chief Minister. Sir. these newsitems were sent by one Shri Bishnu Ram Tamuly, a petition writer in S.D.Cs Office in Lanka. Then, sir, this letter was issued to the correspondent.

Then sir, where is the dentocracy? where is the freedom of presss? This gentleman may be a petition writer in the Court of the S.D.C. of Lanka but he has got an independent means and as a free citizen he has got certain rights and privileges. If he cannot enjoy that then what is this democracy.? Then again, sir, this Govt. is the pioneer of democracy and Mr. Saikia is the real pioneer of such democracy in the State. They have arranged a save democracy week' and in the name of save democracy week our Ministers have visited different places. They went from one place to another-one town to another town to organise the save democracy week. So, sir,

113.3.59 Voling On Demands for C this is the characteristics of our save-democracy week. So, sir, this letter has been issued to this petition writer asking him to show casue for giving the news. Otherwise his licence as petition writer in the court of S.D.C. Lanka will be cancelled. Sir, this was issued under the signature of the D.C. of Nowgong. But, sir, I could not understand why this has been issued to this poor petition writer in this way. If the Govt. wants to challenge the news published in the papers, this can be done in the Court of law. Govt. could have very well filed a case in the court instead of issuing such a show-cause notice to this correspondent and petition writer. Then, sir, I would like to make certain observations about another two or three important cases and we want that the Home Minister should give the reply. Sir, these are the cases regarding the activities of Tinsukia outpost and in this outpost the brother of our Home Minister is posted.

Shri Hiteswar Saikia (Minister):—Sir, my brother is not in Tinsukia.

He was never in Tinsukia. I shall be glad if all the papers are given to me by the Hon'ble Member.

Shrimati Renuka Devi Barkataki:—Yes, sir, I will give it to you and you will get time for explanation. Sir, there was a strike in Bharat Timber Company and the police made lot of harassment to its workers and even to the ladies who went to meet and have a 'darshan' of the O.C. of Tinsukia Outpost. Sir, police made lot of arrests in this connection. Sir, some wives of the workers came to the Tinsukia Outpost and they wanted to see the O.C. They waited there for the whole day but they did not get the 'darshan' of the O.C. They wanted to protest against the harassment made to the workers and their wives. Sir, the O.C. instead of giving his 'darshan, he asked the officer to use the fire-brigade against those women

who were waiting there for O.C. Sir, yesterday our Fire brigade could not be provided to extinguish the fire which broke out here at Gauhati and damaged quite a good number of houses. But here the O.C. Tinsukia outpost has ordered his staff to use the fire brigade against the ladies who went to meet the O.C. Then, sir, about the relationship with the army-personnel of our local people and officers, I would like to make certain observations. Sir, our Chief Minister himself probably knows that our Prime Minister is very keen regarding this and in this connection some committees have also been formed and our Prime Minister is also heading Central Citizen Committee regarding the welfare of our troops. There was a similar committee in our State also. But as soon as Mr. Sinha took over this has been dissolved and now I do not know whether any such committee is functioning in our State or not. Sir, in this connection I would like to refer to the misbehaviour of our two police officer. Sir, in Digboi two army captains were harassed by two of our Police officers-one is Mr. Saikia and the other one is Mr. Bora. Sir, the Home Minister has rightly stated that his brother was never in Tinsukia and this is correct. It is not a case of Tinsukia; it is a case of Digboi. These two Captains were also there in the Digboi club and after having drinks etc., these two police officers misbehaved with them and they took them to the Police outpost. Another Mr. Bhupindra Singh who was with them was also warned not to follow them. Otherwise he will also have the same fate. The Police officer .....

Mr. Saikia, instead of showing the courtesy to a human being he asked Mr. Bhupindar Sing that unless he left the place his condition also would be the same. Mr. Bhupinder Sing being a civilised man. instead of getting tortured by the Police officers, he went to the Army Headquarters to inform about what was

happening. In the meantime, these two Captains were mercidessly beaten. When the army came in the next morning at about 11 A. M. they found about 20 injuries in the bodies of these two captains. Then there was an enquiry held by the army officials as well as by the State police officers and the S. P. also went there. But uptil now the report of the enquiry has not been made known to anyone. Nobody knows why these two army officers were mercilessly beaten inside the police outpost and no action has been taken against anyone. Sir, these army officers have registered cases against these two police officers under sections 385, 325, 342, 375 and 34 of the I. P. C.

- Dr. Rabindra Kumar Goswami: Sir, may I ask, if cases have instituted then is it not sub judice?
- Smti Renuka Devi Barkataki: My question is if cases have been instituted against these two police officers why they have not been placed under suspension?
- Shri Hiteswar Saikia, Minister · Sir, to give a piece of information, when an S. I. is involved in any case, the D. I. G. makes enquiries. In this case we appointed the Commissioner of Plains Division and his report is here.
- Shri Dulal Chandra Barua: Sir, the Commissioner of the Plains
  Division was entrusted with the enquiry and he has submitted
  his report. In that report it has been said that the Police officer
  was at fault but surprisingly the police officer has not been suspended till today. Why?
- Smti Renuka Devi Barkataki: Because he interfered, that is why.

  My question is in a small and petty thing like somebody misusing the vehicles of the Cooperative the whole union was suspended including M. P., M. L. A's and here is a police officer against whom two cases are pending yet he has not been suspended. Is it because he happens to be the elder brother of

Home Minister and it is also because of this that a special Commission was appointed? Why ordinary procedure should not apply in his case? What makes him so big? What does it matter whether he is the younger brother or the elder brother of the Home Minister?

- Shri Hiteswar Saikia, Minister: Sir, I have not tonched a single page of this Enquiry report as yet.
- Shri Dulal Chandra Barua: Sir, this police officer had committed a crime, he has been guilty of breach of discipline. An enquiry has been conducted and one year has passed since then, yet no action has been taken till today.
- Smti Renuka Devi Barkataki: Sir, the Home Minister has said that he has not touched a single page of the report. Here I am not saying that he is interfering in this case. The person is the O/C of a particular thana. There are hundreds of O/cs, Will the Government set up commission if any case is registered against any D/C? Why a departure in this case? Why a high powered commission was to be set up in this particular case that is my question.
- Shri Sarat Chandra Singha, Chief Mininter: Sir. may I interfere? Sir, in the ordinary course there was no necessity to appoint any high powered committee but this being a case where the brother of the Home Minister was involved a high ranking officer was asked to conduct an enquiry. It is only to allay the suspicion. If the ordinary course was followed then also same type of questions would have been asked that why a petty officer has been asked to enquire into the case involving the brother of the Home Minister and how dare he submit a report against the brother of the Home Minister? Therefore, a high ranked officer of the rank of the Commissioner of Division has been asked to make an enquiry. Is there anything wrong in this, sir?

Smti. Renuka Devi Barkataki: Sir, the Chief Minister has given a beautiful explanation. We could understand the sincerity of purpose of the Government if that particular police officer was suspended immediately. On the one hand they are dealing the whole matter by appointing a Commission and on the other hand they are keeping the officer in office only to destroy all the evidences.

Now, Sir, on another important matter. In Jorhat there is one Rajasthani person named Kandelwal. He is a business man. He has an Assamese Peon working for him at a salary of Rs. 110/- per month, That Mr. Khandewal also has a Munimji of the name of Pannalal Choudhury. The name of the Peon is Prabhat Sharma. One day this Prabhat Sharma and the Munimji, Pannalal Choudhury were going to the bank with Rs. 63,000/-. It was later reported that Shri Prabhat Sharma was missing with the money. After 4/5 days this Prabhat Sharma returned and joined his duty. When asked why he went away he said that the Munimji asked him to go on leave and he went on leave. On this issue this Pannalal Choudhuri was arrested. He was put inside lock up and continuously for three days he was mercilessly beaten and later he was taken to hospital. Than a case was filed against him. But he was not allowed to appear before the court by the S. I. of the Jorhat Thana saying that he was not well. Then the relatives of the Peon, Shri Prabhat Sharma filed a case against this S. I. The trying Magistrate observed that there is a prima facie caee against the O/C but even then the O/C was not suspended. And the O/C said that nobody can suspend him. In Assam police there was nobody to suspend him. These are the state of affairs.

Yesterday Mr. Saikia has given a statement that because the two firebrigade vehicles were more busy in Brahmaputra Jute Mill, the fire brigade vehicles were not available to fight the devesting fire. Sir, you will be surprised to hear that two fire brigade vehicles were stationed in the Brahmaputra Jute Mill area when there was very little fire to be fought and they were not allowed to be brought to fight a devastating fire in the Chandmari area where human lives were involved and there the properties of the poor were involved.

There was none to be given food because no public was involved excepting a big capitalist. In another place near about 400 houses were burnt and yet no fire brigade was there to render service. Sir, you also know the position because many people came to you and they told you how fire broke out and how the fire brigade failed to render service. I would request Mr. Saikia not to live in a castle but to come to the reality. He must know where he is; he must know his own limitations and capacity, and he must do what he can do. If he cannot do anything, he should not say high sounding words. Sir, everybody says that he has become very proud. Why should they say so? Afterall he was a good worker, and he is the Home Minister and therefore, he should be above suspicion. Shri Hiteswar Saikia:— Sir, regarding yesterday's statement I want

## STATEMENT BY MINISTER

Sri Bhumidhar Barman (Minister of State):

कि श्री माहि अबिहा विका का

I beg to draw the attention of the House to the devastating fire in the Chandmari area of Ward No. 27 of the Gauhati Municipal Corporation on 13.3.75.

Preliminary estimates show that as many as 156 houses have been completely gutted making at least 105 families homeless. The value of damage according to preliminary estimates has been assessed at roughly Rs. 7 lakhs 60 thousand.

A magisterial enquiry into the cause of this devastating fire and the extent of actual damage has already been ordered.

Considering the devastating nature of the catastrophe and the acuteness of suffering to a large number of persons belonging to the poorer sections of the population a Relief Camp has been started in the nearby Engineering Institute.

Cooked food has been supplied to those families who have nothing to go by as a result of this devastation. Needy families have also been provided with blankets, dry food etc. according to need.

It has been decideed to sanction immediately cash relief upto Rs. 250/-per family according to need. Govt. will consider further measures necessary to help in quick rehabi-

litation of such a large number of families rendered suddenly homeless in extremely distressing circumstances.

Shri Dulal Chandra Barua : Sir, I have very better experience about delay in sanctioning finance to the needy. Will the Chief Minister please consider advancing money to the victims immediately so that they can stand on their own legs without going though the lengthy formalities:
