#### **Subject**

1)Shri Kamalakhya Dey Purkayastha:

This House urges upon the government to take immediate steps to prohibit the practice of printing images of Hindu Deities by the manufacturers on packets containing incense sticks and candles.

2) Shri Akhil Gogoi:

Having regard to the fact that-

(i) with effect from 1<sup>st</sup> February, 2005, instead of Old Pension Scheme, a New Pension Scheme was implemented for government teachers and other government employee;

(ii) the Central Government as well as the Government of Assam have declared about implementing the Unified Pension Scheme,

this House urges upon the government to restore the Old Pension Scheme for all government teachers and other government employees in order to secure their future, ensure social security and to give recognition for dedicating the active period of their lives to serve the public and the

Government as well.

3) Shri Debabrata Saikia:

This House urges upon the Government to take up the matter of granting schedule tribe status to Moran, Matak, Ahom, Chutia, Koch-Rajbongshi and Tea Tribes, with the Union Government without cutting any benefits of the existing declared tribes of Assam, keeping in view that the Joint Parliamentary Committee formed in 1996 also recommended for this.

4) Shri Ashraful Hussain:

This House urges upon the Government to take steps for construction of a bridge over the Brahmaputra river at Dongra to Kholabandha or Sontoli to Bahori in Chenga constituency under Barpeta district.

5) Dr. Rafiqul Islam:

This House urges upon the Government to take steps to establish a University in the Barpeta district.

6)Shri Abdur Rashid Mandal:

This House resolves that the services of the non-teaching staff of the venture educational institutions in the State of Assam, which were provincialized, be regularized with effect from the date of provincilization of such institutions and all benefits as applicable to the State Government employees of corresponding rank be given to non-teaching staff as well.

7)Shri Abdul Batin Khandakar:

This House urges upon the Government to come forward with a Bill to provide rehabilitation and resettlement of families affected by river erosion in Assam.

8) Shri Nurul Huda:

This House urges upon the Government to take immediate steps to remove all sorts of discrimination in land related transaction between individuals in the interest of strengthening the constitutional and democratic system.
