*13. Statement made-regarding promulgation of an ordinance

On behalf of Shri Jayanta Malla Baruah (Minister, Skill Employment and Entrepreneurship etc.), Hon'ble Parliamentary Affairs Minister Shri Pijush Hazarika made a Statement under Rule 69(1) of the Rules of Procedure and Conduct of Business in Assam Legislative Assembly Explaining the Circumstances which has necessitated immediate legislation by The Assam Skill University (Amendment) Ordinance 2024.

14. Statutory Resolution- adopted

"Whereas the Parliament had enacted the Water (Prevention and Control of Pollution) Amendment Act, 2024 (No. 5 of 2024) notified on 15.2.2024.

AND WHEREAS the Amendment Act shall apply, in the first instance, to the whole of the States of Himachal Pradesh and Rajasthan and the Union Territories and it shall apply to such other States which will adopt this Act, by passing a resolution in their legislative assemblies and legislative councils (if any) under clause (1) of article 252 of the Constitution read with clause (2) thereof, with effect from the date of such adoption.

AND Whereas, the aim of this Amendment Act is to decriminalize the provisions of the original Act "Water (Prevention and Control of Pollution) Act, 1974" (6 of 1974) to facilitate ease of doing business in the country and to streamline the process of nomination of Chairman of State Pollution Control Boards.

AND WHEREAS it appears to this Legislative Assembly/legislative council to be desirable that the aforesaid Amendment Act should be adopted in the State of Assam by passing a resolution in this house.

NOW, THEREFORE in exercise of the powers conferred by Article 252 of the Constitution of India, this House hereby resolves that the amendments with respect to the Water (Prevention and Control of Pollution) Amendment Act, 2024 (No. 5 of 2024) be adopted in the State of Assam as enacted by the Parliament."
