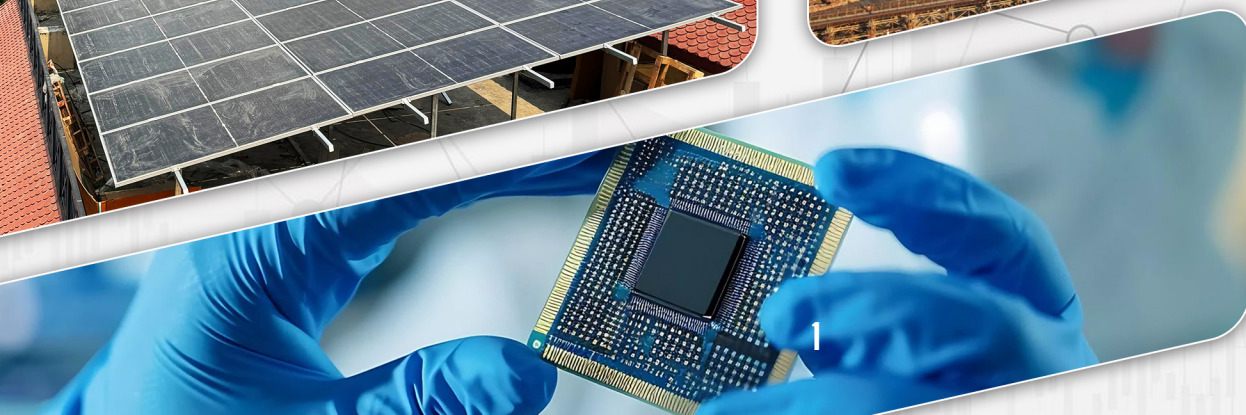

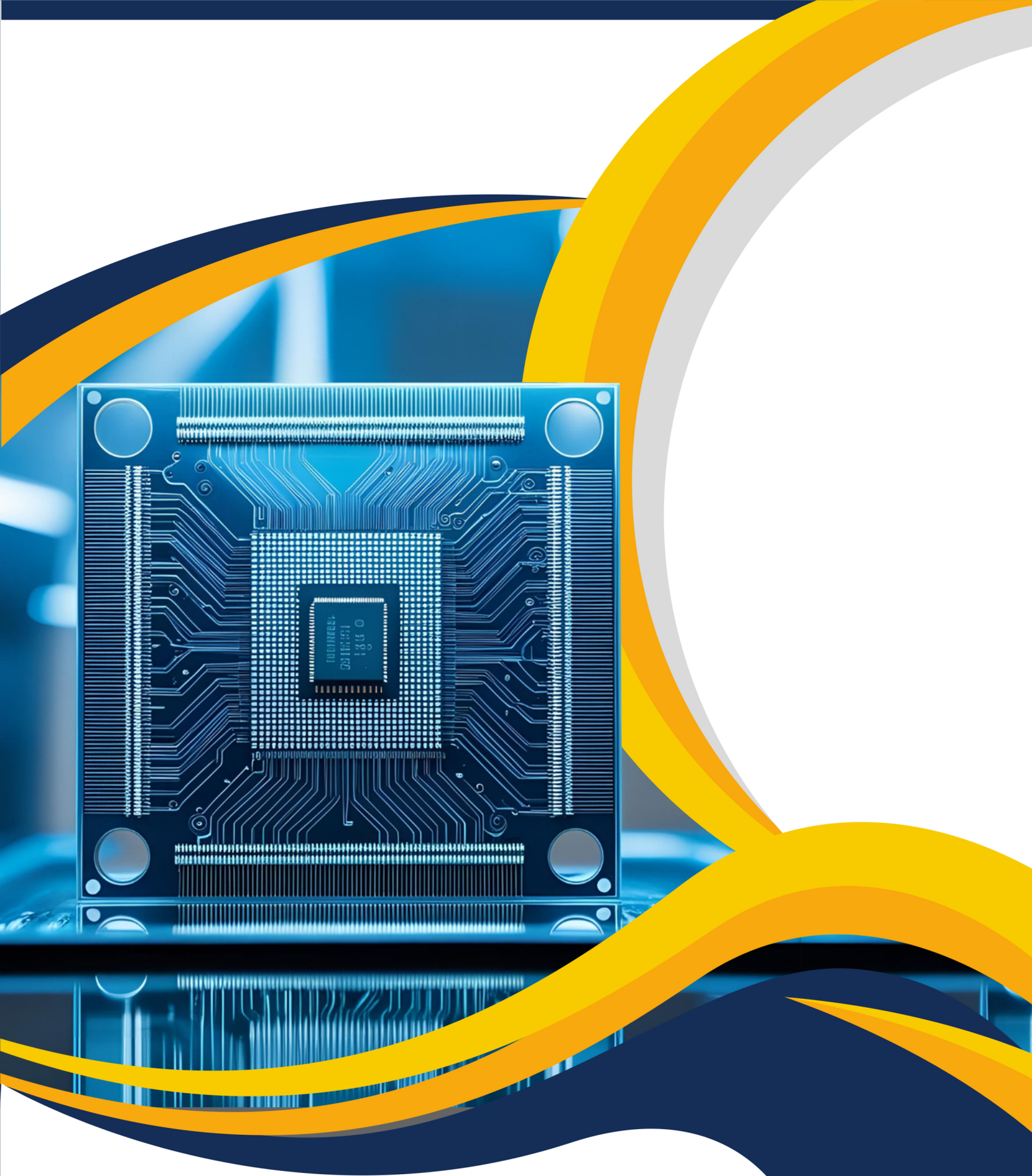

Section I

Introduction to Outcome Budget

Budgeting in governance is not just about allocating funds; it is about ensuring that public resources translate into meaningful outcomes that improve the lives of citizens. While conventional budget documents primarily focus on financial allocations and expenditures, there is an increasing need to shift towards a more **results-driven approach**—one that links spending with measurable outputs and development outcomes.

The **Outcome Budget Statement (OBS)** serves as a crucial instrument in this transformation. By moving beyond mere financial outlays, it aims to establish a clear connection between budgetary allocations, the services delivered, and their broader impact on society. This approach fosters **transparency, accountability, and efficiency** in public spending by setting well-defined performance indicators for government schemes and programs.

The primary objective of the Outcome Budget is to enhance **monitoring, evaluation, and decision-making** by systematically tracking the progress of government initiatives. It enables policymakers, stakeholders, and the public to assess whether planned expenditures are effectively contributing to desired social and economic improvements.

Through this framework, Assam's Outcome Budget for the current year aims to **prioritize performance-based governance**, ensuring that every rupee spent delivers maximum value and drives sustainable development for the state.

Outlay - Output - Outcome Framework

Outlays

The financial resources deployed for achieving certain outcomes.

Example: Funds for Swachh Bharat Mission - Gramin (SBM-G)

Outputs/Services Delivered

These are tangible products and services that are delivered to the beneficiaries as part of the scheme / programme.

Example: Number of household toilets, community sanitary complexes constructed.

Outcomes

These are the short to medium-term effects, which is a precondition to accomplishing the long-term goal/objective.

Example: Reduction in waterborne diseases, Improve quality of life.



Section II

Outcome Budget Framework in Assam

Recognising the Outcome Budget as a vital instrument for enhancing governance by connecting financial allocations with measurable results; Assam introduced the Outcome Budget Statement alongside its traditional budget in the financial year 2017-18. By emphasizing the impact of government spending rather than just the outlays, Assam's Outcome Budget ensures that financial planning is outcome-focused and aligned with developmental goals.

A distinctive aspect of Assam's Outcome Budget is its integration with the Sustainable Development Goals (SDGs). In 2016, Assam became the first Indian state to formally adopt the SDG framework, pioneering the incorporation of these global objectives into its financial planning. This alignment was institutionalized through the Assam Agenda 2030, which ensures that state budgets directly contribute to achieving the 17 SDG targets.

Assam is one of the first Indian state to have adopted the guiding framework of the Sustainable Development Goals (SDGs) in structuring its Outcome Budget.

The SDG Cell of the Government of Assam plays a crucial role in guiding departments to align their budget allocations with specific SDG targets. This integration has streamlined governance by ensuring that public spending fosters sustainable and inclusive development. Assam's Outcome Budget not only monitors expenditures but also evaluates whether these funds lead to tangible progress in critical areas such as education, healthcare, infrastructure, and environmental sustainability.

Assam's Outcome Budget is designed around key performance indicators and measurable targets assigned to various government departments. The framework ensures:

- **Clear Objectives:** Departments establish specific, time-bound goals for their budget allocations.
- **Measurable Outcomes:** Performance indicators track the effectiveness of spending and assess whether desired results are achieved.
- **Accountability Mechanisms:** Departments are required to report on progress, enabling policymakers to make informed decisions about resource allocation.
- **Stakeholder Engagement:** Workshops and consultations with officials, civil society organizations, and experts are conducted to refine the framework.

As per the SDG India Index 2023-24 by NITI Aayog, Assam has been classified as a "Performer State" with a score of 65, reflecting its dedication to sustainable development through effective budgeting and policy implementation.

To strengthen the Outcome Budget process, Assam has organized a series of workshops and training sessions for administrative departments. These initiatives aim to build awareness about the framework and ensure that departments set realistic and measurable targets for each financial year. For the upcoming 2025-26 fiscal year, efforts are underway to further refine budget planning by aligning financial decisions more closely with measurable developmental outcomes.

Since its introduction in 2018-19, Assam's Outcome Budget Statement has undergone significant evolution, reinforcing evidence-based policymaking and results-driven governance. By integrating the SDG framework, Assam has emerged as a leader in sustainable and accountable budgeting. This approach ensures that public spending delivers tangible benefits to citizens, ultimately promoting inclusive growth and long-term development in the state.

The **Outcome Budget 2025-26** serves as a critical tool for ensuring that **budgetary allocations are aligned with measurable development goals**, particularly in the context of **Assam Vision 2030** and the **Sustainable Development Goals (SDGs)**. Beyond detailing **financial allocations** across departmental schemes, the Outcome Budget also outlines the **expected outputs and outcomes**, ensuring that resource utilization is linked to tangible **developmental progress**.

To facilitate a **structured assessment of progress**, government departments have been categorized under **thirteen budgetary thematic areas**, enabling a **comprehensive mapping of sectoral advancements** and ensuring a focused approach to achieving **socioeconomic and environmental sustainability**.

Mapping Schemes to Sustainable Development Goals

Every scheme or program in Assam has been mapped to one or more Sustainable Development Goals (SDGs) to assess its contribution to Assam Vision 2030. Budgetary allocations are linked to specific outcomes aligned with the State Indicator Framework, ensuring a structured approach to tracking progress. Expenditure items directly contributing to one or more of the 17 SDGs are appropriately labelled with their corresponding SDG and Target. This mapping is applied to State-Owned Priority Development (SOPD) schemes, Centrally Sponsored Schemes (CSS), and other development programs, excluding Establishment Expenditure (EE).

Through departmental reporting under each thematic area, the Outcome Budget highlights the inter-connections between thematic priorities and multiple SDGs, offering insights into Assam's progress toward sustainable development.
