CHAPTER-I

Brief Note of Judicial Department with structure and functions

Judicial Department was established in the year 1976 vide Appointment (B) Departments Notification No. ABM.23/67/60, dated 18.05.1976. It is located in Assam Secretariat, Block-E, Second Floor, Dispur, Guwahati-6. The business of the Judicial Department is transacted by the Legal Remembrancer-cum-Commissioner & Secretary (L.R.-cum-Commissioner & Secretary) and assisted by other officials of the department. Judicial Department is responsible for over all Administration of Justice in the State. It acts as the Administrative Department of Govt. of Assam in the sector of Administration of Justice.

History reveals that Judicial Department was created as an independent Department together with Revenue and General Department under Assam Secretariat in the year 1874, headed by B.N.Rau as Legal Remembrancer who was also the Constitutional Adviser of the Drafting Committee of Indian Constitution and thereafter a Judge of International Court of Justice. Judicial Department has also the glorious history of being headed by Fakaruddin Ali Ahmed, as Legal Remembrancer who later became the President of India. Apart from the above, another notable legal luminary who headed this department as Legal Remembrancer was B.L.Hanasaria, later Judge of the Supreme Court. In 1976, as separate Judicial Department was created by bifurcating the Law Department into Judicial and Legislative Departments.

The vision of Judicial Department is facilitating Administration of Justice that ensures easy access and timely delivery of Justice to the litigants in Assam.

Judicial Department is entrusted with overall responsibility for 'Administration of Justice' in the State. Moreover, Judicial Department is also responsible for tendering views to other departments on legal matters as and when requested.

However, unlike other Department's where Directorate is subordinate to the Govt. Department in case of Judicial Department, High Court being autonomous body under Art 225, Judicial Department's role as Administrative Department is limited. The Registry of Hon'ble Gauhati High Court, on its turn looks after the implementation of Justice delivery measures.

Judicial Department transacts the following business:

- Establishment matters of officers of Assam Legal Service and subject to constitutional provisions, officers of Assam Judicial Service.
- Establishment matters relating to Subordinate Judiciary including all Tribunals and Courts like Motor Accidents Claims Tribunal (MACT), Industrial Tribunal, Labour Court, Family Court, Central Bureau of Investigation Court etc. coming under subordinate judiciary.
- Matter relating to appointment of Advocate General, Assam, Additional Advocate General, Assam, Senior Government Advocate, Additional Senior Government Advocate, Junior Government. Advocate, Panel advocates,

Public Prosecutors and Additional Public Prosecutors for the Gauhati High court and payment of their fees, remuneration etc.

Matter relating to appointment and payment of remuneration or fees etc. of Government Pleader, Assistant Government Pleader, Public Prosecutors, Additional Public Prosecutors and Assistant Public Prosecutors for the subordinate district Judiciary in Assam.

Matters relating to appointment of Standing Counsels etc. for conduct of Government cases in Supreme Court and payment of their fees etc.

Administrative Control of the office of the Advocate General, Assam and the Senior Government Advocate, Assam, Gauhati High Court, office of Senior Government Advocate, Assam Administrative Tribunal (AAT) and Central Administrative Tribunal (CAT).

Matter relating to appointment of Senior Government Advocate and Junior Government Advocate for the Assam Board of Revenue and payment of their fees, remuneration etc.

Maintaining liaison between the High Court and the Government in matters as prescribed in the Constitution.

Matter relating to appointment of Notary Public in Assam.

Matter relating to Rules regulating recruitment, conditions of Service etc. of officers of Assam Legal Service and the Assam Judicial Service and staffs of Subordinate Judiciary, subject to constitutional limits.

Matter relating to Legal Remembrancer's establishment.

Maintenance of Legal Remembrancer's Library of the Department. Purchase of Law Books and Journal for the library of the Department.

All matters pertaining to appointments, posting, transfers, promotions, conduct, grant of leave, pensions etc. in respect of all Gazetted officers and Non-Gazetted Government servants under the administrative control of the Department.

Legal Views on matters referred to by other Administrative Departments including Governor's Secretariat and Assam Legislative Assembly Secretariat.

Development of Infrastructure relating to Judiciary including High Court particularly construction of Court Buildings, High Court Judges Bungalows. Residential quarters of Judicial Officers etc. throughout the State.

Matter relating to National Law University and Judicial Academy Assam.

Establishment matters relating to Law Research Institute, Gauhati High Court.

Matter relating to North Eastern Judicial Officers Training Institute.

Appointment of Special Public Prosecutor under any existing law and in cases of importance.

Formulation and implementation of Policies, Guidelines, Standard Operating Procedure in regard to conduct of state litigation or Government cases and functioning of Notary Public.

Periodical performance review of Government Advocates and Public Prosecutors at all level.

- Fixation of fees structure for contempt cases.

 Review of pending Government litigation from time to time.

Brief Note on Grant No. 3 (Administration of Justice)

Grant No. 3, titled "Administration of Justice," is a budget allocation in Assam aimed at covering the expenses related to the Administration of Justice in the State of Assam. This grant encompasses funding for various components essential to administering justice, including the judiciary, legal aid services, and judicial infrastructure. The budget is divided into revenue and capital expenditures, with specific allocations for different regions, including the General Areas, Karbi Anglong Autonomous Council, North Cachar Hills Autonomous Council, and Bodoland Territorial Council

Key Components of the Grant

- Judiciary Expenditure: A significant portion of Grant No. 3 is allocated to cover the
 operational costs of Gauhati High Court and also the subordinate courts throughout the State of Assam. This includes the salaries of Judges and staffs of Gauhati
 High Court, judicial officers and staff of subordinate courts including MACT,
 industrial tribunals and Labour Courts, maintenance of court buildings, and other
 administrative expenses necessary for the smooth functioning of the legal system.
- Legal Aid Services: Access to justice is a fundamental right, and Assam ensures legal support for underprivileged and marginalized communities through legal aid services. Funds from this grant are used to support free legal assistance, enabling individuals who cannot afford legal representation to seek justice effectively.
- 3. Infrastructure Development: To improve the efficiency of the judiciary, investments are made in court infrastructure, including the construction of new court buildings, judicial quarters, renovation of existing structures, and modernization initiatives such as digitization of court records and implementation of e-courts. These developments help in reducing case backlogs and making judicial services more accessible.
- 4. Grants -in Aids: A portion of Grant No. 3 is allocated to providing Grant-in-Aids (both salary and non-salary) to some of the premier Institutions /University viz. National Law University & Judicial Academy, Assam, Judicial Academy, Assam and North Eastern Judicial Officers' Training Institute (NEJOTI), Assam.
- 5. The office of the Advocate General, Assam, Office of the Senior Government Advocate, Assam, Gauhati High Court, Office of Senior Government Advocate, Assam Administrative Tribunal (AAT) and Central Administrative Tribunal (CAT) being under the administrative control of Judicial Department, the salaries for staff and administrative expenses are borne from Grant No.3. Further, the professional fees of Advocate General/Additional Advocate General, Assam, Standing Counsels of Supreme Court, Sr. Govt. Advocates, Public Prosecutors and Govt. Pleaders are borne from Grant No.3

Centrally Sponsored Schemes of Judicial Department

Two numbers of Centrally Sponsored Scheme is currently being implemented by Judicial Department, viz:

- i. Development of Infrastructure Facilities for Judiciary
- ii. Scheme for setting up Fast Track Special Courts (FTSCs), including exclusive POCSO Courts

Development of Infrastructure Facilities for Judiciary:

Judicial Department is the single Nodal Agency and PWD (Building) is the implementing agency for the Centrally Sponsored Scheme (CSS) for the Development of Infrastructure Facilities. The Centrally Sponsored Scheme (CSS) for the Development of Infrastructure Facilities for the Judiciary aims to strengthen judicial infrastructure across India. It provides financial support to State Governments and Union Territories for constructing court buildings, residential units for judicial officers, lawyers' halls, toilets, and other essential amenities. The Scheme does not cover construction of High Court Buildings. The Scheme allows new construction and upgradation or renovation of such existing court buildings but does not allow routine maintenance or upkeep. Fund sharing is applicable in the ratio of 60:40 between Centre and the State except North Eastern States, Himachal Pradesh and Uttarakhand where the ration of 90:10 applies.

Scheme for setting up Fast Track Special Courts (FTSCs), including exclusive POCSO Courts

Incidents of rape and gang rape of minor girls below the age of twelve and similar heinous crimes against women shook the conscience of the entire nation. To prevent such crimes, stricter laws were introduced through "the Criminal Law (Amendment) Act, 2018". It strengthened the relevant provisions of Indian Penal Code (IPC), Criminal Procedure Code (Cr.PC), Evidence Act and Protection of Children from Sexual Offences (POCSO) Act and provided for stringent punishment for rape of children and women.

The key motive behind introducing harsh punishment is to create deterrence against such crimes, but it is only possible if the trial in the court is completed within the time frame and justice is delivered expeditiously to the victims. The Amendment to

Criminal Procedure Code in 2018 and the POCSO Act prescribe strict timelines for completion of investigation and trial. However, despite the existence of strong law and policy framework, large number of rape and POCSO Act cases are pending in various courts in the country.

The Hon'ble Supreme Court of India took up the issue of "completion of timely investigations and consequential trials in the offences under POCSO Act" in suo moto Writ Petition (Criminal) No. 1/2019 and issued several directions in this regard on 25/7/2019. The relevant portion (pertaining to the present Scheme) provides that in each district of the country, if there are more than 100 cases under the POCSO Act, an exclusive/designated special court will be set up which will try no other offence except those under the POCSO Act.

To implement the Criminal Law (Amendment) Act, 2018 and comply with the directives of the Supreme Court, the Government devised a Scheme in August, 2019. This Scheme aimed to establish Fast Track Special Courts (FTSCs), including exclusive POCSO Courts nationwide for expeditious disposal of rape and POCSO Act cases.

The Scheme has been launched w.e.f. October 2, 2019.

In pursuant to the direction of Hon'ble Supreme Court of India regarding establishment of exclusive POCSO courts in those districts of Assam where the pendency of POCSO cases are more than hundred (100), 16 districts were identified namely, Baksa, Cachar, Kokrajhar, Nalbari, Sonitpur, Karbi Anglong, Nagaon, Barpeta, Dhubri, Golaghat, Kamrup (M), Kamrup, Lakhimpur, Morigaon, Sivasagar and Tinisukia. Out of 16 these districts, in Nagaon district there were more than 300 POCSO cases, hence, two exclusive POCSO courts were proposed for Nagaon district, thus total number of exclusive POCSO courts which were required to be established became 17.

As of now in the State of Assam 17 nos. of designated exclusive POCSO Courts in the districts of Baksa, Cachar, Kokrajhar, Nalbari, Sonitpur, Karbi Anglong, Nagaon (2 Courts), Barpeta, Dhubri, Golaghat, Kamrup (M), Kamrup, Lakhimpur, Morigaon, Sivasagar and Tinisukia are operational under the Centrally Sponsored Scheme.

FINANCIAL YEAR (2021-2022):

- a) Inauguration of District Judiciary of South Salmara-Mankachar on 6th November, 2021: On 6th November, 2021, Justice Achintya Malla Mujor Barua, Judge, Gauhati High Court-cum-Portfolio Judge for the Dhubri district inaugurated the District Judiciary of South Salmara-Mankachar (Assam). Sri Thaneswar Kalita, District and Sessions Judge, Dhubri; Syed Imdadur Rahman, newly appointed District & Sessions Judge, South Salmara Mankachar; Sri H. N. Gautam, Deputy Commissioner, South Salmara Mankachar; the President, Bar Association, Dhubri; and the President, Bar Association, South Salmara-Mankachar were present on the occasion. The officials of the Registry of the Gauhati High Court, the officials of Office of the District and Sessions Judge, Dhubri and other dignitaries were also present on the occasion.
- b) Inauguration of Legal Aid Clinic at Sarupathar, Golaghat: On 27th December, 2021, Hon'ble Justice N. Kotiswar Singh, Judge, Gauhati High Court and Executive Chairman, Assam State Legal Services Authority inaugurated a Legal Aid Clinic at Sarupathar in Dhansiri Sub Division in the district of Golaghat, Assam in the presence of Sri Vinod Kumar Chandak, District & Sessions Judge, Golaghat-cum-Chairman, District Legal Services Authority and Sri Nayan Shankar Baruah, Member Secretary, ASLSA.
- c) Inauguration of E-Sewa Kendra at the Principal Seat of Gauhati High Court on 3rd March, 2022: On 3rd March, 2022, Hon'ble the Chief Justice Sudhanshu Dhulia of the Gauhati High Court inaugurated an e-Sewa Kendra in the Old Block of the Principal Seat of the Gauhati High Court in presence of Hon'ble Mr. Justice N. Kotiswar Singh, Judge, Administrative Department, Gauhati High Court; Justice Suman Shyam, Judge, Gauhati High Court and Chairperson, ICT Committee, Gauhati High Court, other Hon'ble Judges of the Gauhati High Court, learned Advocate General of Mizoram, the Standing Counsel of the Gauhati High Court, Chairman, Bar Council of NE States, Lawyers and officials of the Registry.
- d) Inauguration of Judicial Court Building at Golaghat on 27th March, 2022: On 27th March, 2022, Hon'ble the Chief Justice of Gauhati High Court Sri Sudhanshu Dhulia inaugurated the Court building in the august presence of Justice Suman Shyam, Judge, Gauhati High Court and the Portfolio Judge of Golaghat District.

B. Technological Accomplishments:

- (i) E-Sewa Kendra: Establishment of e-Sewa Kendra is being carried out in 80 Court Complexes of Assam, under the Phase-II of the e-Courts project. Till 31st March, 2022, work has been completed in 20 locations.
- (ii) Virtual Court: Since its inauguration, the Virtual Court for the State of Assam has been operating smoothly. Till 31st March, 2022, 52,217 cases has been received and fines amounting to Rs. 96,92,581/- has been collected.

- (iii) FASTER: As per the direction of the e-Committee, Supreme Court of India Faster and Secure Transmission of Electronic Records (FASTER) has been implemented in the district courts of Assam.
- (iv) Implementation of Case Information System (CIS): KIOSKs are provided in all the Court Complexes for dissemination of Case Information to the Public, Litigants and Advocates. The Data are also replicated from the Court Complexes to National Judicial Data Grid, wherein all can avail the services from www.ecourts.gov.in. Data of 196 Establishments and 502 Courts is available at the NJDG. Automated SMS and e-mail services are also made functional for information dissemination.
- (v) Replication of Data to National Judicial Data Grid (NJDG): CIS NC 1.0 is implemented in the High Court, Principal Seat. Periphery modules viz. consolidated cause-list, various reports, case tracker, etc. developed by the Gauhati High Court are also integrated with the CISNIC 1.0 for usage. CIS NC 1.0 is already implemented at the Kohima Bench, Aizawl Bench and Itanagar Bench of Gauhati High Court.
- (vi) e-Filing: e-Filing of cases has already started in the Principal Seat of the High Court. After 18.01.2022, all the State Government departments are filing all types of cases through e-Filing in the Principal Seat of the High Court. e-Filing has been carried out as per the Gauhati High Court e-Filing Rules, 2020. Steps for rolling out e-Filing in all the district courts are under process.
- (vii) Digitization of Case Records: Digitization of Case Records of Gauhati High Court, Principal Seat and all the District Courts of Assam is already in progress. Till 31st March, 2022, 2,92,97,965 images (439382 files) have been scanned for High Court, Principal Seat, and 15,24,84,020 images (1670399 files) have been scanned for the District Courts of Assam.
- (viii) Video Conferencing between District Courts and Jails: Video Conferencing between District Courts and Jails have started in the State of Assam. Courts are encouraging the Jail Authorities to avail the benefits of Video Conferencing. The hardware made available under the e-Courts Project. All the 31 Jails of Assam are connected to the District Courts via the Assam Judicial Network.
- (ix) Installation of Solar Energy Panels under e-Courts Project: Solar energy panels are already installed in 66 (sixty six) District Courts of Assam. These solar energy panels will help in backing up the network/server rooms. Installation of Solar energy panels is also going on in some Court Complexes of Nagaland, Mizoram and Arunachal Pradesh. The works are being carried out under the phase-II of the e Courts Project.

FINANCIAL YEAR (2022-2023):

A. Administrative Achievements:

- a) Inauguration of New Judicial Court Building at Barpeta on 19th August, 2022: On 19th August, 2022, the New Judicial Court Building at Barpeta was inaugurated by Dr. Himanta Biswa Sarma, Chief Minister of Assam and Justice R. M. Chhaya, Chief Justice, Gauhati High Court in the august presence of Justice N. Kotiswar Singh, Judge in-charge, Administrative Department, Gauhati High Court and Justice Ajit Borthakur, Portfolio Judge, Barpeta District. The sophisticated building with all the modern amenities is not only a dream come true but also a strong base of judicial infrastructure which will help in dispensing quick justice to the litigants in the coming years.
- b) Inauguration of Justice Clock Justice Clock-an electronic display database: Justice Clock-an electronic display database, which will provide real time information regarding disposal and pendency of cases was installed and started functioning in the District of Dibrugarh on 21.1.2023 Similarly, within the Cachar District Judiciary, Justice Clock- was inaugurated by Justice Suman Shyam, Chairperson, ICT Committee of the Gauhati High Court, within the premises of District Court Complex, Silchar on 11th February, 2023 in the august presence of the District & Sessions Judge, Cachar, Judicial Officers, representatives of the District Administration and the members of the Bar. The programme was also attended by the District & Sessions Judges and Chief Judicial Magistrates of Karimganj and Hailakandi Districts.
- c) Inauguration of Gauhati High Court Museum on 10th September, 2022: On 10th September, the Gauhati High Court Museum was inaugurated by Justice Surya Kant, Judge, Supreme Court of India in the august presence of Shri Kiren Rijiju, Minister of Law & Justice, Government of India; Dr. Himanta Biswa Sarma, Chief Minister, Assam; Justice Hrishikesh Roy, Justice Sudhanshu Dhulia, Judges of the Supreme Court of India; Justice R. M. Chhaya, Chief Justice, Gauhati High Court, the sitting & former Judges of the Gauhati High Court. - d) Inauguration of District Judiciary of West Karbi Anglong on 15th September, 2022: On 15th September, 2022, the District Judiciary of West Karbi Anglong was formally inaugurated at Hamren within the old court building by Justice Achintya Malla Bujor Barua and Justice Malasri Nandi, Judges, Gauhati High Court in the presence of Shri Raktim Duarah, Shri Abdul Hekim and Shri Aditya Hazarika, District and Sessions Judges of Nagaon, East Karbi Anglong and Hojai respectively. Shri Binod Kumar Chetri, Legal Remembrancer cum-Commissioner & Secretary, Judicial Department to the Government of Assam; Sri Prabhat Ch. Taro, Executive Member, Karbi Anglong Autonomus Council and Sri Rupsing Teron, MLA also graced the occasion.

- e) Inauguration of Vulnerable Witness Deposition Centre at Nagaon on 15th September, 2022: A Vulnerable Witness Deposition Centre was inaugurated on 28.08.2022 in the District of Dibrugarh by Justice R. M Chhaya, Chief Justice, in presence of Justice N. Kotiswar Singh, JAD, Justice M.R Pathak and Justice Suman Shyam in the District Court Complex at Dibrugarh constructed in collaboration with Social Welfare Department, Government of Assam. The inaugural ceremony, attended by Judicial Officers of Karbi Anglong, marked a significant step towards prioritizing the health and well-being of the judicial fraternity.
- d) Foundation Stone Laying ceremony for Judges' Guest House at Kaziranga, Golaghat, Assam on 02.03.2024: On 2ind March, 2024, amidst divine blessings invoked through Bhumi Pujan, Justice Sandeep Mehta, Judge, Supreme Court of India, ceremonially laid the foundation stone for the "Judges' Guest House" at Kaziranga, making the inception of a haven for esteemed judges from High Courts and the Supreme Court of India during their visits to the region. The auspicious event witnessed the august presence of esteemed dignitaries, including Justice Vijay Bishnoi, Chief Justice of the Gauhati High Court, alongside several other esteemed judges from the Gauhati High Court, namely Justice Lanusungkum Jamir, Justice Manash Ranjan Pathak, Justice Michael Zothankhuma, Justice Suman Shyam, Justice Soumitra Saikia, Justice Parthivjyoti Saikia, Justice Devashis Baruah, Justice Arun Dev Choudhury, Justice Kardak Ete, Justice Budi Habung, and Justice Kaushik Goswami. f) Inauguration of the Judicial Court Building at Sivasagar on 15.06.2024.: On 15th June, 2024, Hon'ble Mr. Justice Vijay Bishnoi, Chief Justice, Gauhati High Court inaugurated the new Judicial Court Building at Bishnu Nagar, Sivasagar in the august presence of Hon'ble Mr. Justice Suman Shyam, Hon'ble Mr. Justice Devashis Baruah, Hon'ble Mr. Justice Arun Dev Choudhury, Judge, Gauhati High Court. Besides them, dignitaries of the Gauhati High Court, District Administration of Sivasagar, Police Administration of Sivasagar, Judicial officers and staff of the Sivasagar District Judiciary were also present on the occasion.

TECHNICAL ACCOMPLISHMENTS:

- a. MACT Portal: The Motor Accident Claim Information Portal stands as a beacon of citizen-centric service, providing a comprehensive platform for accessing vital information pertaining to motor accident claim litigations. On the 11th day of May, 2024, Hon'ble Mr. Justice Vijay Bishnoi, Chief Justice, Gauhati High Court, Guwahati inaugurated the Motor Accident Claim Information Portal. The portal is designed to assist victims, legal representatives, and advocates in navigating the motor accident claim process efficiently.
- b. <u>Virtual Court for Traffic Related Cases:</u> Gauhati High Court has set up the Virtual Court for traffic violations, which has offered remote access to justice and reducing travel burden. Virtual Court is a concept aimed at eliminating presence of litigant or lawyer in the court and adjudication of the case online.
- c. AI-Assisted Legal Translation of Iudgments from English to Assamese: The Gauhati High Court has engaged the Indian Institute of Technology (IIT) Guwahati to undertake a pioneering project titled "AI-Assisted Legal Translation of Judgments from English to Assamese." The project is backed by a substantial budget of Rs. 307.322 lakhs, which has been sanctioned by the Government of Assam. The key objective of this project is to address the language barrier in the legal domain, ensuring that legal documents and judgments are accessible to Assamese-speaking individuals.
- d. <u>Digital Law Report:</u> The Gauhati High Court has already taken proactive steps by launching e-HCR in the name of Digital Law Reports (DLR), making it accessible on the official website. In addition to this, GHC is in the process of making these DLR available in the regional language to ensure that they are accessible to a broader audience.
- e. <u>e-Office implementation</u>: The implementation of an e-office system to the digitization and automation of office processes, including workflows, management etc. to improve efficiency and reduction of paper usage. Gauhati High Court will soon be implementing an e-office system to streamline the office processes in the coming weeks.

f. e-SCR: e-SCR is the Electronic version of Supreme Court reports. It is an initiative to provide digital version of judgements. The Gauhati High Court has already launched e- SCR, making it accessible on the official website. The important and historically significant judgements are translated in regional language and uploaded in e-SCR.

Withdrawal of petty/minor criminal cases pending in subordinate Courts throughout the State of Assam by invoking Section 321 CrPC, 1973

In order to reduce pendency of cases in courts and reduce congestions of jails, this Government has approved withdrawal of petty/minor cases by invoking Section 321 of CrPC, 1973. Under this policy till March 2024, **81,000 (approx)** no's of petty/minor cases has been withdrawn in the State of Assam.

After presentation of the Budget Estimates to the House on 10th March, 2025, the Departmentally Related Standing Committee on Development (B) Departments, Assam Legislative Assembly has scrutinized the Demands for Grants for the Financial Year, 2025-2026.

Voted Budget provision of Rs.78532.96 Lakhs made for the Financial Year 2025-2026 where Rs.65036.80 Lakhs and Rs.13496.16 Lakhs have been earmarked under the Revenue and Capital Head respectively. It seems that for the Financial Year 2025-2026, an amount of Rs.15311.31 Lakhs has been decreased in Voted amount than that of the previous year's Revised Budget Estimates (2024-25).

However, in Charged Budget, Rs.11601.69 Lakhs in Revenue Head and Rs.1220.58 Lakhs in Capital Head with a total of Rs.12822.27 Lakhs have been earmarked in the Budget Provision for the Financial Year, 2025-26. It seems that for the Financial Year 2025-2026, an amount of Rs.1350.88 Lakhs has been increased in Charged amount than that of the previous year's Revised Budget Estimates (2024-25).

OBSERVATIONS AND RECOMMENDATIONS

JUDICIAL DEPARTMENT

The Committee thoroughly discussed Grant No.03 and made the recommendations as under:

GRANT No.03

The Committee recommends the department to take immediate steps to initiate the works to preserve the erstwhile Gauhati High Court building which is presently used as District and Sessions Judge Building of Kamrup(M) district at Guwahati near Dighali Pukhuri as Heritage Building to maintain its historical significance and glory. Further, ancient and antique articles/items, books related to this Heritage building may also be preserved.

The Committee recommendations that the budget allocation provided under Grant No.03 for the Financial Year 2025-26 for Judicial Department be approved by the August House.

The Action Taken Report on the recommendations made in the Report may be submitted to the Committee within 90 (ninety) days from the date of presentation (21-03-2025) to the House.
