CHAPTER - I

REPORT

WATER SECTOR

The Assam Public Health Engineering Department (APHED) was created in 1956 as Public Health Engineering (PHE) Organization under the Directorate of Health Services to look after the implementation of Rural and Urban Water Supply throughout the State. This PHE organization started functioning as a full fledged Department since 1981 and a separate Secretariat was created for APHED in the year 1989.

Presently, the APHED has been working as the nodal department of the Government of Assam to deal with the aspiration in the rural areas of Assam with regards to Drinking Water Supply and Sanitation Sector.

Aims & Objective

The main object of APHED is to improve health of the rural population by ensuring Drinking Water Security (Availability, Accessibility and Water Safety) and safe Sanitation status through improvement in the environmental hygiene in rural perspective. To achieve this objective, the department undertakes planning, execution, operation and maintenance of work related to water supply and sanitation in rural areas.

Activities of PHED

To achieve the Departmental aims and objectives, the APHED is presently implementing mainly two Flagship Programmes of Government of India, namely Jal Jeevan Mission and Swachh Bharat Mission (G) in rural areas of Assam.

In this connection, the Department is involved with necessary planning, execution, operation and maintenance of work etc. related to water supply and sanitation sector in rural areas. These activities can be broadly categorized as follows:-

- a. Rural water supply activities.
- b. Rural Sanitation activities.
- c. Quality control activities.
- d. Monitoring and Evaluation activities through MIS.

1. Rural water supply activities under Jal Jeevan Mission:

Schemes for providing drinking water supply through 100% Functional Household Tap Connections (FHTCs) to every rural households in villages / habitations are taken up under Jal Jeevan Mission (JJM), a flagship program of the Ministry of Jal Shakti, Government of India with cost sharing pattern involving community contribution (5%) and Govt. share jointly by the Central and State Government on 90:10 basis.

JJM aims to provide a minimum of 55 lpcd of water of prescribed quality as per BIS: 10500 Standards and also aims to provide safe drinking water to all rural government schools and Anganwadis, etc.

Key Achievements of Jal Jeevan Mission in FY- 2024-25:

- Provided 3,91,524 Functional Household Tap Connections (FHTC), reaching a cumulative progress of 81.4%
- Handed over 4,815 Schemes.
- Introduced e-Bill, an online system, facilitating digital processing of bills for schemes in Assam, with 11737 e-Bills approved, totalling Rs. 3703.785 Cr. across 46 PHE Divisions.
- Implemented Electronic Measurement Book (e-MB) for automated progress tracking, linking draft e-MBs to e-bill progress.
- Developed Contractor Task Management Application for real-time monitoring of PWSS activities.
- Established Jal Doots (Water Ambassadors) through Jalshala workshops, with 1094 Jalshalas conducted 42,094 Jal Doots trained and 36,019 Activities completed by Jaldoots across Assam.
- Trained 4,339 Jal Mitras for the regular operation and maintenance of JJM schemes, engaging a total of 17,217 across the state.
- Partnered with ASRLM, involving 636 Cluster Level Federations as Implementation Support Agencies.
- Utilised ASHA network to emphasize safe drinking water to various demographics.
- Implemented QR Codes for transparency and accessibility in scheme details.
- Instituted Jal Seva Awards in 11 categories on monthly basis to promote and ensure proper O&M of the respective PWSSs' in villages, with incentives for GPs, WUCs, AWC, Schools, FTK groups, Jaldoots, Jal Mitras, contractors, ISA/CLF , FHTC Holders (individual), and ASHAs.

Public Health Engineering Department

Sanitation Sector (Swachh Bharat Mission- Grameen)

Assam was declared as ODF state on 5th March, 2019 as per BLS (Baseline Survey) 2012. Now the state is currently working on the implementation of SBM (G) Phase-II ensuring ODF sustainability of Phase-I, management of Solid and Liquid waste through proper and scientific mechanism. The State has declared 19247 nos. of villages are ODF plus Model village. Among these villages, 21176 nos. of villages have arrangements of solid waste management, 24928 nos. of villages have arrangements of liquid waste management. For management of plastic waste, 219 nos. of Plastic Waste Management Units at block level are under construction. Further 34 nos. of biogas plants have been constructed which are functional.

Assam has approved 674656 nos. of beneficiaries for construction of Individual Household Latrine under Direct Beneficiary Transfer Mode and first instalment was transferred to 106305 nos. of beneficiary under DBT 1.0 and for another 1 lakh, the first instalment was transferred under DBT 2.0 on March 2023. Moreover, approximately 23000 nos. of DBT beneficiaries have received their second instalment.

After presentation of the Budget Estimates to the House on 10th March, 2025, the Departmentally Related Standing Committee on Development (B) Departments, Assam Legislative Assembly has scrutinized the demand for Grant no. 30 for the financial year 2025-2026.

Budget Estimates under Grant No. 30 for the financial year 2025-2026 is as follows:

Voted Budget provision of Rs. 518025.75 lakhs made for the financial year 2025-26 where Rs. 89459.79 lakhs and Rs. 428565.96 lakhs have been earmarked under the Revenue and Capital Head respectively. It seems that for the financial year 2025-26, an amount of Rs. 301290.25 lakhs has been increased in voted amount than that of the previous year's Revised Budget Estimates (2024-2025).

However, in Charged Budget, Rs. 959.23 in Revenue Head and Rs. 0.00 in Capital Head with a total of Rs. 959.23 have been allotted in the Budget Provision for the Financial Year 2025-26.

OBSERVATIONS AND RECOMMENDATIONS**PUBLIC HEALTH ENGINEERING DEPARTMENT****GRANT NO.30**

The Committee discussed the budgetary provision made in the budget documents for the financial year 2025-2026. At the outset, the Committee considered the Action Taken Report submitted by the concerned department. After threadbare discussion on the budget provision made for Public Health Engineering departments relating to the Grant No. 30, the Committee recommends the following:

1. After discussion on the recommendation no. 2 of 26th Report (2024-2025), the Committee observes that the reply submitted by the department is inadequate.

Therefore, the Committee recommends the department to furnish an elaborated status report and list of the schemes on 13 (Major Works) and 01 (Normal) Head of Account for the financial year 2024-25 and to complete the schemes at the earliest.

2. The Committee observes that in many parts of Assam, water pressure is seen low at the ending point of water taps installed under Jal Jeevan Mission Scheme.

Therefore, the Committee recommends the department to survey in this regard and to take necessary steps for redressing the problem.

3. The Committee recommends the department to survey relating to water supply disruption in several areas specifically at West Guwahati area including Rani and to submit a detailed report with reasons for closure of water supply to that area.

4. The Committee recommends the department to take necessary steps for wide and extensive publicity on the Schemes of drinking water supply and role of User Committee throughout the State.

5. The Committee recommends that the Department should include uncovered population/areas of various district with mini schemes under Jal Jeevan Mission or other schemes of the Department.

6. The Committee recommends that as JJM Schemes were implemented by the Department on DPR basis, the department do not have any budget for repairing of schemes, once the completed schemes are handed over.

Therefore, the Committee recommends the department to make adequate provision of Budget to repair and maintenance of Schemes.

The Committee recommends that the budget allocation provided under Grant No. 30 for the Financial Year 2025-26 for Public Health Engineering Department be approved by the August House.

The Action Taken Report on the recommendations made in the Report may be submitted to the Committee within 90 (ninety) days from the date of presentation (21-03-2025) to the House.


