The Committee has been befitted with the assistance rendered by the Government representatives during the course examination of the Budget estimates under the aforementioned Grant for the year 2025-26. The Committee has formulated its observations taking into consideration the valuable submission tendered by the Official witnesses, during the course of consideration of the Budget Estimates.

The committee wishes to keep in record the genuine services rendered by the Government Officials to the Departmentally Related Standing Committee on Development (C) Departments, Secretary as well as the concerned Officers and Staff of Assam Legislative Assembly Secretariat for their unstinted service devoted to the Committee during the preparation of this Report.

### **PRELIMINARY STATUS PAPER**

The Information Technology Department is leveraging the Digital Technologies for efficient public service delivery and is dedicatedly engaged in working towards the technology upliftment of Assam along with the entire North Eastern Region.

1. The Sewa Setu portal now hosts 805 citizen centric services, of which 472 services are RTPS services. This number is proposed to be further increased to 1,000+ citizen centric services under the World Bank funded "Assam Governance & Smart Delivery Program," under which mobile app based service delivery, kiosk based service delivery, one-stop shops etc., have been planned.
2. DITEC has become an Aadhar Authentication User Agency (AUA/KUA) for facilitating e-KYC Services, verification & validation Services, Aadhaar Enabled Payment System (AEPS), Direct Benefit Transfer (DBT) through Aadhar etc., pertaining to various State Government Departments of Assam.
3. The IT Department developed a web portal and mobile application for compilation of more than 43 lakh essays in 25 languages on the 17th-century Ahom General, Lachit Borphukan, on his 400th Birth Anniversary which resulted in a Guinness Book World Record for the "largest online photo album of handwritten notes".
4. The Assam State Wide Area Network (ASWAN) project had been completed in the year 2012. ASWAN network as a state wide area network is very critical and important to ensure reliable connectivity and data security for various state government applications. Currently, several key applications such as e-District, Revenue (Basundhara /Dharitree/Bhumiputra), Finance, Treasury, Tax, PWD, Health, CCTNS etc. are running through ASWAN network.
5. The e-District project is functional in all 35 districts of the state which can be availed through the Public Facilitation Centers at the district, sub-divisional offices and Circle offices, Common Services Centers available at the village levels and online through the web. A total of 100.19 lacs certificates have been issued through e-District Portal.
6. The 'State Portal & State Service Delivery Gateway' is envisioned as the informative, interactive and trusted service delivery channel for all the G2C and G2B services of the State which will render all the e-forms available for various Government services to the citizens through the State Portal. The 'SP-SSDG' will ensure delivery of request from the citizens to the government department, receipt of acknowledgement of successful submission of application from department to the citizen and also enable the citizen to query the status of his/her application/request at any point of time. So far 46 e-forms have been developed.

7. The Information Technology Department has undertaken digitization of the "XasipaathPuthi", manuscripts, "Tamra Patra" and other historical documents of the "Satras" and other historical places of Assam to create a Digital Archive. The digitisation process has started from the Bardowa Satra, and will include the Barpeta Satra and Satras in Majuli, 843 manuscripts (comprising 50,267 pages) from Bardowa Satra have been digitized so far.
8. Assam State Data Centre is considered as a shared reliable and secured infrastructure for hosting and managing e-Governance Applications of state and its constituent departments. AMTRON being the State Implementing Agency for SDC had established a robust cloud and co-location infrastructure to enable the Government to deliver the services quickly and effectively to its stakeholders with funds received from MeitY, Govt. of India and Govt. of Assam. The State Data Centre, connected to the State Wide Area Network (SWAN), National Knowledge Network (NKN), NICNET, APConnect, Tax and Treasury Network etc. is providing access to the e-Governance applications & Services to Government employees through Intranet/Internet and to the citizens through public Internet/CSCs etc. Through such a Shared Service Centre implemented and managed AMTRON, the individual departments can focus more on the service delivery rather than on the issues surrounding the Infrastructure. It has been enabling various State departments to host their services/applications on a common infrastructure leading to ease of integration and efficient management, ensuring that computing resources and the support connectivity infrastructure is adequately and optimally used. SDC has become a critical information infrastructure of the country delivering secure cloud hosting services from the same region, ensuring seamless citizen centric application delivery service. Presently, SDC is offering cloud and co-location services and presently hosting almost 600 websites/applications of almost all the Departments of Govt. of Assam. Several departments had migrated their websites/applications from various services public cloud service providers.

**OBSERVATIONS AND RECOMMENDATIONS**

**INFORMATION TECHNOLOGY, 2025-26**

**GRANT NO-75**

1. The Committee after careful observation recommends to provide sufficient budget provision for boosting the IT Sector, combination of infrastructural development, policy support and for skill enhancement.
2. The Committee recommends for infrastructural Development & Digital connectivity to ensure high speed internet, establish dedicated IT hubs and Technology parks to improve transportation and logistics to attract tech investments.
3. The Committee recommends for Skill & IT Educational development through updated curricula and industry aligned courses, setting up specialised training centres for AI, cyber security, cloud computing and blockchain introducing government sponsored IT certification programmes in schools and colleges to bridge the skill gap.
4. The Committee recommends to start-up Ecosystem and Entrepreneurship support for techbased ventures, establishing mentorship programme connecting local entrepreneurs with global IT experts.
5. The Committee after consideration recommends for more budget provision for the expansion of 'Xewa Setu' in Assam to enhance services for the general public and improve user-friendliness.

6. The Committee after careful observation recommends for the collection and digital preservation of historical books, manuscripts, Xaasi-Paat Puthi, Tamra Patra, and similar artifacts.
7. The Committee recommends the Department to research actively on these materials from various entities such as Satras, Educational institutions, and private collectors for digitizing and archiving these invaluable resources to safeguard Assam's rich culture and heritage and to ensure broader access for future generation.

**THE COMMITTEE, HOWEVER, RECOMMENDS THAT THE BUDGETARY ALLOCATION PROVIDED UNDER GRANT NO-75 FOR THE YEAR 2025-2026 be VOTED FOR THE DEPARTMENT OF INFORMATION TECHNOLOGY BY THE AUGUST HOUSE.**
