### REPORT CHAPTER -I Grant No. 52

1.1 Animal Husbandry is potentially one of the most important sectors of rapid socioeconomic development of the country. Rapid growth in this sector is essential to achieve higher productivity levels in livestock production as well as increase in rural household economy.

Among the primary objectives of the department is to build a strong rural economy by encouraging scientific rearing of livestock and the control and prevention of infectious diseases in livestock and poultry. Thus, the state aims to achieve self-sufficiency in milk, meat and egg production as well as to create profitable employment opportunities for unemployed youth and the underprivileged of the state.

The per capita availability and consumption rates of animal protein by the people is needed to be boosted up through successful implementation of different schemes.

Considering the above facts, the department embarks upon a renewed strategic shift in its functioning style and delivery of Veterinary services. This renewed strategic shift and functioning style is designed to improve the productivity of indigenous cattle and pig population through up gradation with superior germplasm. This shift also emphasizes upon imparting training on livestock management, skill up gradation, building/rejuvenation of infrastructure, technical guidance, use of departmental infrastructure, functioning of demonstration farms of the department, backward and forward linkage and creation of marketing avenues.

To carry forward the above activities, the department has five mandates, namely,1) Disease treatment, prevention and control 2) Breed up gradation 3) Skill Development and training 4) Infrastructure Development and 5) Credit linkage for economic upliftment. These mandates are supported by 11 Strategy Papers and 4 Policies. The policies are 1) Cattle breeding policy 2) Goat breeding policy 3) Pig breeding policy and 4) Private Investment Promotion Policy.

#### THRUST AREAS OF THE DEPARTMENT

- 1. CATTLE DEVELOPMENT FOR SELF SUFFICIENY IN MILK PRODUCTION
- 2. POULTRY, GOAT & PIGGERY DEVELOPMENTFOR SELF SUFFICIENCY IN EGG AND MEAT PRODUCATION.
- 3. SELF EMPLOYMENT GENERATION AND LIVELIHOOD SUPPORT THROUGH LIVESTOCK AND POULTRY ACTIVITIES.

#### 1.2 Vision:

The main vision of the Department is – Sustainable growth and increased productivity of livestock and poultry (milk, meat and egg) for enhancing the standard of living of farmers and ensuring nutritional security and economic prosperity.

- 2) Breed up gradation
- 3) Skill Development and training
- 4) Infrastructure Development and
- 5) Credit linkage for economic upliftment.

#### Some of the key priorities of the AH&Veterinary Department:

- 1. Prioritizing the need for increasing livestock production in a sustainable manner.
- 2. Doubling farmers' income in line with the vision of the state.
- 3. Ensuring food security through promoting locally sourced meat, fish and other animal by-products.
- 4. Improving the quality of nutrition in the state by ensuring access to nutritious food especially in high poverty pockets and low income families (targeting areas with high maternal/infant deaths, anaemia and other low health indicators).
- 6) Mitigating risks to climate change by reducing green-house gases emitted by livestock sector.
- 7) Using our natural resources efficiently for rearing and livestock production.
- 8) Improved veterinary services.
- 9) Increased training, linkages to value chain and capacity building of farmers, animal rearers on updated techniques, use of organic/ bio-pesticides for improved health, financial management and small scale loans, efficient use of land and resources.

- 1) To cover all breed able livestock population through Artificial Insemination (AI).
- 2) To facilitate poultry farmers/rearers for introducing genetically improved varieties of poultry for increased production capacity.
- 3) To provide health care facilities even up to the door steps of Farmers for prevention and control of animal diseases.
- 4) To produce requisite quantity of feed and fodder.
- 5) To build capacity of farmers in management of livestock and poultry.
- 6) To create adequate collection, processing and marketing infrastructure.
- 7) To make producers and consumers aware of the benefits of clean and hygienic animal products.

- 8) To make available insurance and credit facilities to support livestock and poultry activities.
- 9) To build capacity of Veterinary professionals for providing better extension facilities to the farmers.
- 10) Improving internal efficiency/ responsiveness/ service delivery of the department
- 11) Ensuring compliance to financial accountability frame work.

#### 1.5 Functions:

The department is responsible for all matters relating to improvement of livestock, poultry including availability and better management of extension services like Veterinary Hospitals, Dispensaries, Sub-Centers, Livestock processing infrastructure, Departmental farms, Semen production Centres, Training institutes, Vaccine production centre, Diseases diagnostic laboratories etc.

#### **BRIEF NOTE IN RESPECT OF GRANT NO. 52**

The activities of the Animal Husbandry & Veterinary Directorate are covered under the Grant No. 52 of the budget. This is one of the most important departments of the State Govt., which looks after the development of animal health of the State, besides animal husbandry matters like development of Dairy, Poultry, Duckery, Piggery, Goatery, Fodder etc. and is of late receiving very high priority from the Govt. as a potential development sector of the State. This sector has great potential towards rapid socio-economic development, increasing rural income through creation of gainful employment in the rural areas and maintaining fair standard of living through supply of animal protein by increased production of meat, milk and eggs. Besides these, the sector offers great employment opportunities for the unemployed youth and hence Animal husbandry sector has assumed great importance as a potential developmental sector in recent times. In spite of agricultural mechanization, bullock is still used for ploughing of agriculture field; dung is extensively used as manure for production of organic food, bullock cart is still used in some part of the State thereby saving fuel and also produce of gobar gas. Moreover, bullock cart, gobar gas etc. are eco-friendly which helps in environmental conservation.

At the same time, the committee considered the Action Taken reports on the recommendations made in its twenty sixth report in the year 2024-25 and in addition to the scrutinization of the Budget provision.

#### **GRANT NO. 52**

#### **OBSERVATIONS AND RECOMMENDATIONS, 2025-26**

The Committee after holding a threadbare discussion and on close scrutinization of the Report related to Grant No. 52 of the Animal Husbandry and Veterinary Department, on the evidences provided by the Department representatives made the following observations and Recommendations.

1. The Committee observes during the course of discussion that the Govt. Live Stock farms, under the AHVD are in a dilapidated condition.

The Committee therefore, recommends that these farms should be upgraded to ideal demonstration farms and incubation centre for respective sector with bio security measures so that the farmers and live stock entrepreneurs may be imparted training with most modern technologies and innovations in Veterinary Sector.

Having perused the departmental suggestion, the Committee recommends an amount of Rs. 5 crore to provide the Animal Husbandry and Veterinary Department and directs the department to take-up the matter with finance department.

2. The Committee observes that the vocational training centre at Dalgaon, which is at a prime location with full boundary wall is lying unutilized due to lack of infrastructure and logistics.

The Committee therefore, recommends that the department take necessary steps this centre should be converted to farmers incubation centre for all sector viz. cattle sector, poultry sector, piggery sector, goatery sector and fodder sector with all modern facilities for pertaining hands on training to farmers and live stock entrepreneurs of nearby districts.

Having perused the departmental suggestion, the Committee recommends an amount of Rs. 2 crore to provide the Animal Husbandry and Veterinary Department and directs the department to take-up the matter with finance department.

3. The Committee observes during the course of discussion that the multicare and pet care hospital constructed in different districts of Assam is a good initiative by AHVD.

The Committee therefore, recommends that the Department should take necessary steps the Hospital should be well equipped and have sufficient man power.

4. During the course of discussion, the committee observes that many dispensaries and sub-centres are in very dilapidated condition and could be renovated for paucity of funds.

The Committee therefore, recommends that RIDF trench should be released to AHVD for renovating all the dispensaries, sub-centre and Hospital etc.

5. The Committee observes during the course of discussion that the construction of raised platform on pilot project at Disoi in Golaghat district has been successful to protect live stock during the flood period.

The Committee therefore, recommends that the department should take necessary steps for making raised platform/highland in all flood prone districts of Assam so that animal can take shelter during the flood period.

6. The Committee observes during the course of discussion that pig production in Assam is not satisfactory, which may be a good sources of employment generation.

The committee therefore, recommends that the department should take proper steps to increase Budgetary Provision with credit linked subsidy schemes to strengthen pig production/piggery units, keeping in mind the rising demands.

7. The Committee observes during the course of discussion that the fund allocated Rs. 54795.64 lakhs only in the Budget to the Animal Husbandry and Veterinary Department for the financial year 2025-26. The committee felt that this amount was too insufficient to implementation various project.

The Committee therefore, recommends that the Govt. should increase the amount in the budget.

8. The Committee observes during the course of discussion that the Veterinary hospital at Amguri, Sorbhog constituency is in a very dilapidated condition and requires immediate renovation.

The Committee therefore, recommends that the Department to take necessary steps for renovation of the above mentioned Veterinary hospital.

9. The Committee observes during the course of discussion that the building of Veterinary Dispensary under Khowang Constituency in Dhemechi Block is in a very dilapidated condition and required immediate renovation.

The Committee therefore, recommends that the Department to take necessary steps for renovation of the above mentioned Veterinary dispensary.

10. The Committee reiterates its earlier recommendation No. 5 of twenty sixth report (2024-25) regarding that feeds and fodder are the major input for animal husbandry production and implementation of comprehensive further production programme will pave the way to meet the fodder scarcity to enhance the dairy production.

The Committee recommendation for implementation of a comprehensive fodder production programme with necessary fund allocation to support the dairy farmers of the State.

11. The Committee reiterates its earlier recommendation No. 6 of twenty sixth report (2024-25) regarding the goatery project is also one of the major sector with ample potentiality of growth in economy of the State. The committee also observe that there is a necessity of encouraging the Goatery project to enhance the rate of production of Goat by implementing various well designed programme to meet the rising market demand.

The committee therefore, strongly recommends for implementation of a well designed programme for encouraging Goat production in the state as a prominent rural economic activity by allocating necessary fund.

#### GRANT NO. 53

#### **OBSERVATIONS AND RECOMMENDATIONS, 2025-26**

The Committee after holding a threadbare discussion and on close scrutinization of the Report related to Grant No. 53 of the Animal Husbandry and Veterinary Department, on the evidences provided by the Department representatives made the following observations and Recommendations.

1. The Committee reiterates its earlier recommendation No. 1 of 26<sup>th</sup> Report (2024-25) regarding the Milk Processing Unit at Bebejia is not functioning.

Heaving perused the departmental suggestion, the Committee therefore recommends that the allocation for SOPD / RIDF should be increased in the Budget preferably around Rs. 4.00 – 5.00 crores for the Financial Year 2025-26 for revitalization of the Milk Processing Plant at Bebejia of 5000 Litres Per Day Capacity (expendable to 10000 Litres Per Day) at the earliest.

2. The Committee reiterates its earlier recommendation No. 2 of 26<sup>th</sup> Report (2024-25) regarding dairy productions are influenced by the production of milk directly. The demands of dairy products are increasing day by day for its nutritional value. Therefore, there is a necessity of sufficient fund allocation under the dairy scheme to encourage the farmers to produced sufficient milk to meet the demand of the market.

The Committee expressed satisfaction that the Department is undertaking Milk Subsidy Scheme approved by the Hon'ble Cabinet and concurred by Standing Finance Committee held on 28/02/2025 for implementation of the scheme which will help in encouraging the Dairy Farmers under organized milk production sector in the State to meet the demand of the market.

3. The Committee reiterates its earlier recommendation No. 3 of 26<sup>th</sup> Report (2024-25) regarding there is a huge gap in milk production and demand in the State.

The Committee therefore, recommends that the department should take necessary steps for awareness and capacity building training of the Dairy Farmers in all districts of the State that would help in encouraging the dairy farmers to adopt new methods for enhancing milk production by allocating additional funds to the tune of around Rs.1.00 crore for conduct of workshops, hands on training, exposure visit to the successful dairy units (within and outside the State).

The Action taken Report on the recommendation may be submitted to the Committee within 90 days from the date of presentation of the report in the August House.
