THE ASSAM MEDICAL COUNCIL (AMENDMENT) ACT, 2014

further to amend the Assam Medical Council Act, 1999.

Preamble

Whereas it is expedient further to amend the Assam Medical Assam Council Act, 1999, hereinafter referred to as the principal Act, in the Act manner hereinafter appearing; No.XXVI

of 1999

It is hereby enacted in the Sixty-fifth Year of the Republic of India as follows :-

Short title, extent and commencement 1. (1) This Act may be called the Assam Medical Council (Amendment) Act, 2014.

(2) It shall have the like extent as the principal Act.

(3) It shall come into force at once.

Amendment of Section 3 2.

In the principal Act, in section 3,-

- (i) in sub-section (1),-
 - (a) in clause (a), in the second line, the word "three" shall be deleted,
 - (b) in clause (b), for the words "concerned University of that College", the words "Srimanta Sankardeva University of Health Sciences" shall be substituted.

(c) for clause (d), the following shall be substituted, namely:-

"(d) three members who are Registered Medical Practitioners with the Council are to be nominated by the State Branch of the Indian Medical Association and out of them one member shall be woman."

Renewal of Registration

32B. Every registered medical practitioner under the Council shall have to renew his Registration at every 5(five) years interval with his updated academic and professional credentials and such renewal shall be granted upon payment of such renewal fees as may be prescribed and revised by the Council from time to time. Grant of Academic to betoplet abrow Credit Point

32C. The Council shall award academic credit point to registered medical practitioners for scientific Continuous Medical Education (CME)/ Conference as per guidelines framed by the Medical Council of India from time to time.

Ethical bobbleb ed Committee

32D. Ethical Committee shall be Constituted by three (3) Members of the Council and they shall be elected by the members of the Council and this Ethical Committee shall function as per guidelines laid down by the Medical Council of India from time to time. If any doctor is found guilty of violation of ethics by the Ethical Committee, his/her Registration may be withdrawn for a period of time as may be decided by the Ethical Committee."
