# THE ASSAM PANCHAYATI RAJ (THIRD AMENDMENT) ACT 1975

An

Act

FURTHER TO AMEND THE ASSAM PANCHAYATI RAJ ACT, 1972.

Preamble

Whereas it is expedient further to amend the Assam Panchayati Raj Act, 1972 here-in-after called the Principal Act, in the manner hereinafter appearing.

It is hereby enacted in the Twenty sixth year of the Republic of India, as follows:—

Short title, extent and commence-ment.

- 1. (i) This Act may be called the Assam Panchayati Raj (Third Amendment) Act, 1975.
  - (ii) It shall have the like extent as the Principal Act.
  - (jii) It shall come into force at once.

Amendment 2. At the end of clause (a) of sub-section (1) of Second Section 9 tion 9 of the Principal Act, the following paragraph shall be added, namely:—

XI of 1973.

"Any dispute arising out of any election aforesaid shall be dealt with in the manner prescribed."

Insertion of 3. After Section 11 of the Principal Act, the following new Section shall be inserted as Section 11 A namely:—

"Remuneration, allowa ncese, etc., to President and members of Gaen Panchayat. 11 A (1) The President of the Gaon Panchayat shall be entitled to such remuneration as may be fixed by the State Government from time to time:

Provided that the Gaon Panchayat by a resolution authorises payment of such a remuneration and payment is made from its own fund:

Provided further that the Gaon Panchayat may authorise payment of remuneration to the President of the Gaon Panchayat at a rate lower than the rate fixed by the State Government and also with effect from any retrospective date.

- (2) Travelling expenses and other allowances for journey performed by the President of the Gaon Panchayat in his official capacity shall be admissible at such rate and under such conditions as may be fixed by the State Government from time to time provided that payment is made from the Gaon Panchayat's own Fund. Such travelling expenses and other allowances may be paid with effect from any retrospective date.
- (3) Members of the Gaon Panchayat except the ex-officio members who are Government officers, shall be entitled to such sitting allowance and travelling expenses for attending meetings of the Gaon Panchayat as may, from time to time, be fixed by the State Government provided that payment is made from Gaon Panchayat's own Fund. Such sitting allowance and travelling expenses may be paid with effect from any retrospective date."

Amendment of Section 20 of the Principal Act, the following paragraph shall be added, namely:—

"Any dispute arising out of election of a Councillor to the Mohkuma Parishad shall be dealt with in the manner prescribed."

Insertion of new section 5. After section 22 of the Principal Act, the following shall be inserted as Section 22 A, namely:—

"Remuneration, allowances, etc., of the Chief Executive Councillor, President Stading Committees and Councillors of Mohkuma Parishad.

22 A. (1) The Chief Executive Councillor and Presidents of Standing Committees of Mohkuma Parishad shall be entitled to such remuneration as may be fixed by the State Government from time to time:

Provided that the Mohkuma Parishad by a resolution authorises payment of such a remuneration and payment is made from its own fund:

Provided further that the Mohkumz Parishad may authorise payment of remuneration to the Chief Executive Councillor or Presidents of the Standing Committees at a rate lower than the rate fixed by the State Government and which may be paid with effect from any retrospective date.

- (2) Travelling expenses and other allowances, for journeys performed by the Chief Executive Councillor and President Standing Committee of the Mohkuma Parishad for journeys performed in their official capacities shall be admissible at such rate and under such conditions as may be fixed by the State Government from time to time provided that payment is made from the Mohkuma Parishad's own Fund. Such travelling expenses and other allowances may be paid with effect from any retrospective date.
- (3) Chairman and Councillors of the Mohkuma Parishad except the ex-officio Councillors who are Government officers, shall be entitled to such sitting allowance and travelling expenses for attending meetings of the Mohkuma Parishad as may be fixed by the State Government from time to time provided that payment is made from the Mohkuma Parishad's own Fund. Such travelling expenses and other allowances may be paid with effect from any retrospective date."

Amendment
of Section
25 of the Principal Act, after sub-section (5),
25 of Assam
the following shall be inserted as sub-sections (6) and (7),
Act XI of viz.—
1973.

"(6) President of a Santding Committee shall immediately cease to hold office if a motion of no-confidence is passed by a majority of total number of members of the Standing Committee concerned in a meeting convened and held for the purpose in the manner prescribed:

Provided that at least fifteen days notice shall be given in writing by not less than two members of the Standing Committee concerned:

Provided further that if the meeting so requisitioned is not convened by the President of the Standing Committee concerned within fifteen days of receiving of such notice the Chief Executive Councillor shall call the meeting.

(7) The term of the Standing Committee shall be for a period of two years."

Amendment of Section 37 of Assam Act XI of 1973.

- 7. In Section 37 of the Principal Act:-
  - (i) in clause (a) for the words and figures "subsection (1) above" the words and figure "Section 36" shall be substituted.
  - (ii) in clause (c) for the words "sub-section" the word "Section" shall be substituted.

Amendment 8. In sub-section (1) of Section 39 of the Principal 39 of Assam Act, for the figures "73" and "74", the figures "68" and Act XI of "69" respectively shall be substituted.

Amendment of Section

9. In clause (ii) of sub-section (1) of Section 62 of 62 of Assam the Principal Act, between the words "Chief Executive Act XI of Councillor of the Mohkuma Parishad" and "subject to control" the words "with the assistance of the Secretary, Mohkuma Parishad who shall operate the account of the Fund with the Bank and" shall be inserted.

Amendment of Section 64 of Assam Act :— Act XI of 1978

- 10. In sub-section (1) of Section 64 of the Principal
  - (i) after the figure and brackets "(1)" at the beginning, the following shall be inserted, namely:-"The following shall be credited to the Mohkuma Parishad Fund:—"
  - (ii) for clause (x) the following shall be substituted, namely:-

"All sums received from the State Governworks or ment on transfer of institutions, schemes along with funds under Section 37 of the Act including the funds for payment of deputed to salaries to officers and staff Monkum's Parishad

Amendment of Section 67 of Assam Act XI of 1973.

- 11. In Section 67 of the Principal Act.-
- (i) in sub-section (1) for the Second proviso to clause (b), the following shall be substituted, namely:—

"Provided further that the budget shall normally be approved within a month of receipt of the same by the Mohkuma Parishad."

(ii) in sub-section (2) for the Second provise to clause (b), the following shall be substituted, namely:—

"Provided further that the budget shall normally be approved within a month of receipt of the same by the State Government."
