THE ASSAM LAND REVENUE AND RENT (SURCHARGE)

(AMENDMENT) ACΓ, 1976

An

Act

further to amend the Assam Land Revenue and Rent (Surcharge) Act, 1970.

Preamble. Whereas it is expedient further to amend the Assam Land Revenue and Rent (Surcharge)
Act, 1970, hereinafter called the principal Act, Assam Act in the manner hereinafter appearing;

It is hereby enacted in the Twenty-seventh year of the Republic of India as follows:—

Short title, extent and commencement.

1. (1) This Act may be called the Assam Land Revenue and Rent (Surcharge) (Amendment) Act, 1976

- (2) It shall have like extent as the principal Act.
  - (3) It shall come into force at once.

Amendment 2. In section 2 of the principal Act, after of Section 2 of Assam Act X of as clauses (4), (5), (6), and (7), namely:—

1970.

"(4) 'Sub-Deputy Collector' means an Officer appointed with that designation and includes an Assistant Settlement Officer."

- "(5) 'Collector' means the Deputy missioner and includes the Additional Deputy Commissioner, Subdivisional Officer and Sadar Subdivisional Officer within whose jurisdiction the land in question is situated".
- "(6) 'person' means an individual, a family including a joint family, a partnership, a Company, and a body corporate".
- "(7) All words and expressions used in this Act and not defined herein shall have the same meaning as is assigned to them in the Assam Land and Revenue Regulation, 1886, or Regulation the Rules framed thereunder."

A mendment of Section 6 of Assam Act X of 1970.

- 3. In section 6 of the principal Act,—
- (1) In sub-section (1), the words "Sub-Divisional Officer of a Sub-Division or Sadar Sub-Divisional Officer, as the case may be" shall be substituted by the word "Collector."
- (2) In sub-section (2), the words "Sub-Divisional Officer" in between the words "the" and "passed" shall be substituted by the word "Collector."
